P-1/15 of 2015—Whereas, in pursuance of the Notification numbers SRO-459, SRO-483, SRO-488, SRO-496 and SRO-513, issued by the Governor of Jammu and Kashmir on 28-10-2014, 07-11-2014, 14-11-2014, 19-11-2014 and 26-11-2014 respectively, under sub-section (2) of section 27 of the Jammu and Kashmir Representation of the People Act, 1957 (IV of 1957), a general election has been held for the purpose of constituting a new Legislative Assembly for the State of Jammu and Kashmir;

authority (other than the powers vested in or exercisable by the High Court) in the State ; and

- (b) make the following incidental and consequential provisions which appear to me to be necessary or desirable for giving effect to the objects of this Proclamation :—
- (i) the operation of the following provisions of the State Constitution is hereby suspended, namely, sections 35 to 41 (both inclusive), so much of section 43 as relates to the allocation, among the Ministers, of the Business of the Government of the State, section 44, sub-section (1) of section 53, sections 54 to 60 (both inclusive), sub-section (2) of section 61 so far as it relates to clause (c) of and the first proviso to section 58 and to section 60, sections 64, 65, 66, 67, 71 and section 72, sections 74, 75 and section 76, sub-sections (3) and (4) of section 77, proviso to section 78, sub-sections (1) and (2) of section 79, sections 80, 81 and section 82, sub-section (2) of section 83, sections 84 to 88 (both inclusive) and so much of section 137 as relates to the laying of the report with a memorandum before the Legislature of the State ;
 - (ii) the Legislative Assembly of the State shall remain under suspended animation till such time as this Proclamation is revoked or varied in this regard by a subsequent Proclamation ;
 - (iii) in the exercise of the powers of the Legislature to make laws under or by virtue of this Proclamation, I shall prepare such Bills, as I may deem necessary and declare in respect of any Bill so prepared that I assent thereto ;
 - (iv) in the exercise of the powers of the Legislative Assembly to make grants under sub-section (1) of section 83 of the State Constitution, I shall, as often as
