## III. HOW TO APPLY :

- (a) The passport size photograph should be pasted (not stapled) on the Application Form. The photograph so pasted should not be attested and should not bear any imprints of seal or signature thereon.
- (b) The candidates are advised to be extremely careful while writing/filling of the form. They are also advised to verify the correctness of the entries 2 to 3 times. Incorrect form shall be outrightly rejected and no claim shall be considered at any stage of recruitment process.

## IV. PROCEDURE FOR SELECTION :

- (a) The last date of the receipt of application forms shall be the cut of date for determining the eligibility to apply for the post. The age limit, however, is determinable with reference to the first of January of the year in which advertisement is made i. e. 01-01-2015. Only such qualifications shall be considered which the application is in possession on the last date of receipt of application i. e. 16-02-2015. Any qualification acquired thereafter shall not be taken into account for any purpose. Similar will be the case with the qualification acquired in consequence of declaration of result after the last date of receipt of application.
- (b) The prescribed qualifications reflect the bare minimum requirement of the job and mere possession thereof does not entitle the candidate to be called for interview.

VIII. Application form incomplete in any manner shall stand cancelled without any future notice to the candidate.

Note :—The horizontal reservation for Ex-Serviceman and Physically Challenged persons to the extent of 6% and 3% respectively would mean the reservation which would cut across the vertical reservation and the persons selected shall have to be placed in appropriate category by making necessary adjustments. The following Act as passed by the Jammu and Kashmir State Legislature received the assent of the Governor on 13th January, 2015 and is hereby published for general information :—

**THE JAMMU AND KASHMIR STANDARDS OF  
WEIGHTS AND MEASURES (ENFORCEMENT)  
(AMENDMENT) ACT, 2011.**

**(Act No. I of 2015)**

[13th January, 2015.]

An Act to amend the Jammu and Kashmir Standards of Weights and Measures (Enforcement) Act, 1997

4. *Amendment of section 22, Act No. XXXVII of 1997.*— In section 22 of the principal Act, the colon shall be substituted by full stop and the proviso thereto shall be deleted.

5. *Amendment of section 24, Act No. XXXVII of 1997.*— In section 24 of the principal Act, after sub-section (6), the following sub-sections shall be added, namely :—

- “(7) The Government may notify the Government Approved Test Centres for verification of weights and measures.
- (8) The Government may prescribe the kinds of weights and measures for which the verification is to be done through the Government Approved Test Centre and on payment of such fee as may be prescribed.
- (9) The Government Approved Test Centres shall appoint or engage persons having such qualifications and experience and collect such fee on such terms and conditions for the verifications of weights and measures specified under sub-section (7), as may be prescribed.”.

6. *Amendment of section 32, Act No. XXXVII of 1997.*— In section 32 of the principal Act for the words, signs and figures “Every false or unverified weight or measure (other than those referred to in section 30 of the Central Act) seized under the provisions of this Act shall be liable to be forfeited to the Government”, the words, signs and figures “Every false or unverified weight or measure seized under the provisions of this Act or under the Central Act (Act No. 1 of 2010) shall be liable to be forfeited to the Government” shall be substituted.

7. *Amendment of section 33, Act No. XXXVII of 1997.*— In section 33 of the principal Act for the words “immediately before the commencement of this Act”, the words “immediately before the commencement of the Jammu and Kashmir Standards of Weights and Measures (Enforcement) (Amendment) Act, 2011” shall be substituted.

8. *Amendment of section 42, Act No. XXXVII of 1997.*— In section 42 of the principal Act for the words “Penalty for
