Subject :— Regulating sale of acid/corrosive substances.

Circular No. 01 of 2015

Dated 15-01-2015.

The Hon'ble Supreme Court vide its order dated 18-07-2014 has passed the following directions in PIL titled Laxmi (Minor) V. Union of India and others :—

- (a) All the States and Union Territories which have not yet framed rules will do well to make rules to regulate sale of Acid and other Corrosive Substances in line with the model rules framed

- (iv) No acid shall be sold to any person who is below 18 years of age.
 - (v) In case of undeclared stock of acid, it will be open to the concerned SDM to confiscate the stock and suitably impose fine on such seller up to Rs. 50,000/-.
 - (vi) The concerned SDM may impose fine up to Rs. 50,000/- on any person who commits breach of any of the above directions.
- (d) The educational institutions, research laboratories, hospitals, Government Departments and the Departments of Public Sector Undertakings, who are required to keep and store acid, shall follow the following guidelines :-
- (i) A register of usage of acid shall be maintained and the same shall be filed with the concerned SDM ;
 - (ii) A person shall be made accountable for possession and safe keeping of acid in their premises ;
 - (iii) The acid shall be stored under the supervision of this person and there shall be compulsory checking of the students/personnel leaving the laboratories/place of storage where acid is use.
- (e) The concerned SDM shall be vested with the responsibility of taking appropriate action for the breach/default/violation of the above directions.

In anticipation of the notification of the Posion Rules under section 9 of the Posions Act, 1977, the Home Department issued a detailed Circular under No. Home/240/OWP/2012/6105 dated 24-09-2013 enjoining upon all District Magistrates, SDMs and Tehsildars to give wide publicity to the aforesaid directions issued by the Hon'ble Supreme Court after translating them into local language through print and electronic media for information of the general public and ensure their strict compliance.

Annexure- 'A'

(1920 A. D.)

(Act No. XXXIV of 1977)

[Sanctioned by His Highness the Maharaja Sahib Bahadur per Chief Minister's endorsement No. 8372 dated 11th September, 1920 read with State Council Resolution No. 1 dated 8th April, 1925 (Notification No. 14-L/81)].

An Act to provide for the regulation of the possession and sale of all poisons in certain local areas, and the importation, possession and sale white arsenic generally.

Whereas, it is expedient to make provision for regulating the possession and sale of all poisons in certain local areas, and the importation, possession and sale of the white arsenic : it is hereby enacted as follows :—

1. *Short title, extent and commencement.*— (1) This Act may be called the Poisons Act, 1977.

(2) It extends to the whole of Jammu and Kashmir State. It shall come into force on the 1st day of Baisakh, 1978.

POISONS GENERALLY

2. *Power to regulate possession for sale and sale of any poison in certain cases.*— (1) [The Government] may, by rule, regulate within the limits of any municipality or cantonment the possession for sale and the sale, whether wholesale or by retail, of any specified poison.

(2) In particular, and without prejudice to the generality of the power conferred by sub-section (1), rules made thereunder may provide for, amongst other matters,—

(a) the grant of licence to possess any specified poison for sale, wholesale or by retail, and the fixing of the fee (if any) be charged for such licences ;

(2) In particular and without prejudice to the generality of the power conferred by sub-section (1), rules made thereunder may any provide, amongst other matters for all or any of the matters specified in section 2, sub-section (2).

3. Rules made under sub-section (1) may further provide that no person shall sell any powdered white arsenic unless the same is, before the sale thereof, mixed with soot, indigo or prussian blue in the proportion of half an ounce of soot, indigo or prussian blue at least to one pound of the white arsenic, and so in proportion for any greater or less quantity :

Provided that, where such arsenic is stated by the purchaser to be required for some purpose for which such admixture would, according to the representation of the purchaser render it unfit, such arsenic may be sold, without such admixture, in a quantity of not less than ten pounds at any one time.

5. *Power to regulate possession of white arsenic in certain tracts.* (1) "[The Government] may further, by rule, regulate the possession of white arsenic in any local area in which murder by poisoning with that drug or the offence of mischief by poisoning cattle therewith appears to it to be of such frequent occurrence as to render restrictions on the possession thereof desirable.

(2) In making any rule under sub-section (1), "[The Government] may direct that any breach thereof shall be punishable with imprisonment for a term which may extend to one year, or with fine which may extend to one thousand rupees, or with both, together with confiscation of the white arsenic in respect of which the breach has been committed, and of the vessels, packages or coverings in which the same is found.

OTHER POISONS

Power to apply Act to other poisons. (1) "[The Government] may, by notification in the Jammu and Kashmir Government Gazette, apply to any specified poison other than white arsenic all or any of the provisions of this Act relating exclusively to white arsenic.

(2) The person to whom the warrant is directed may enter and search the place in accordance therewith, and the provisions of the Code of Criminal Procedure relating to search warrants shall, as far as may be, be deemed to apply to the execution of the warrant.

9. *Rules.*—(1) In addition to any other power to make rules hereinbefore conferred, '[The Government] may make rules generally to carry out the purposes and objects of this Act.

(2) Every power to make rules conferred by this Act shall be subject to condition of the rules being made after previous publication.

(3) All rules made by '[The Government] under this Act shall be published in the Jammu and Kashmir Government Gazette and on such publication shall have effect as if enacted in this Act:

SAVINGS

10. *Savings.*—(1) Nothing in this Act or in any licence granted, or rule made thereunder shall extend to or interfere with anything done in good faith in the exercise of his profession or business as such

- (a) by a medical or veterinary practitioner ; or
- (b) by a chemist or druggist duly qualified to act as such under the law for the time being in force in the State ; or
- (c) by a chemist, druggist or compounder dispensing or compounding in compliance with the prescription of a medical or veterinary practitioner ; or
- (d) subject to any rules for the time being in force under section 5, by a tanner or hide merchant.

(2) Notwithstanding anything hereinbefore contained, '[The Government] may, in its discretion, by general or special order, declare that all or any of the provisions of this Act shall not be deemed to apply to any article, or class of articles, of commerce specified in such order, or to any

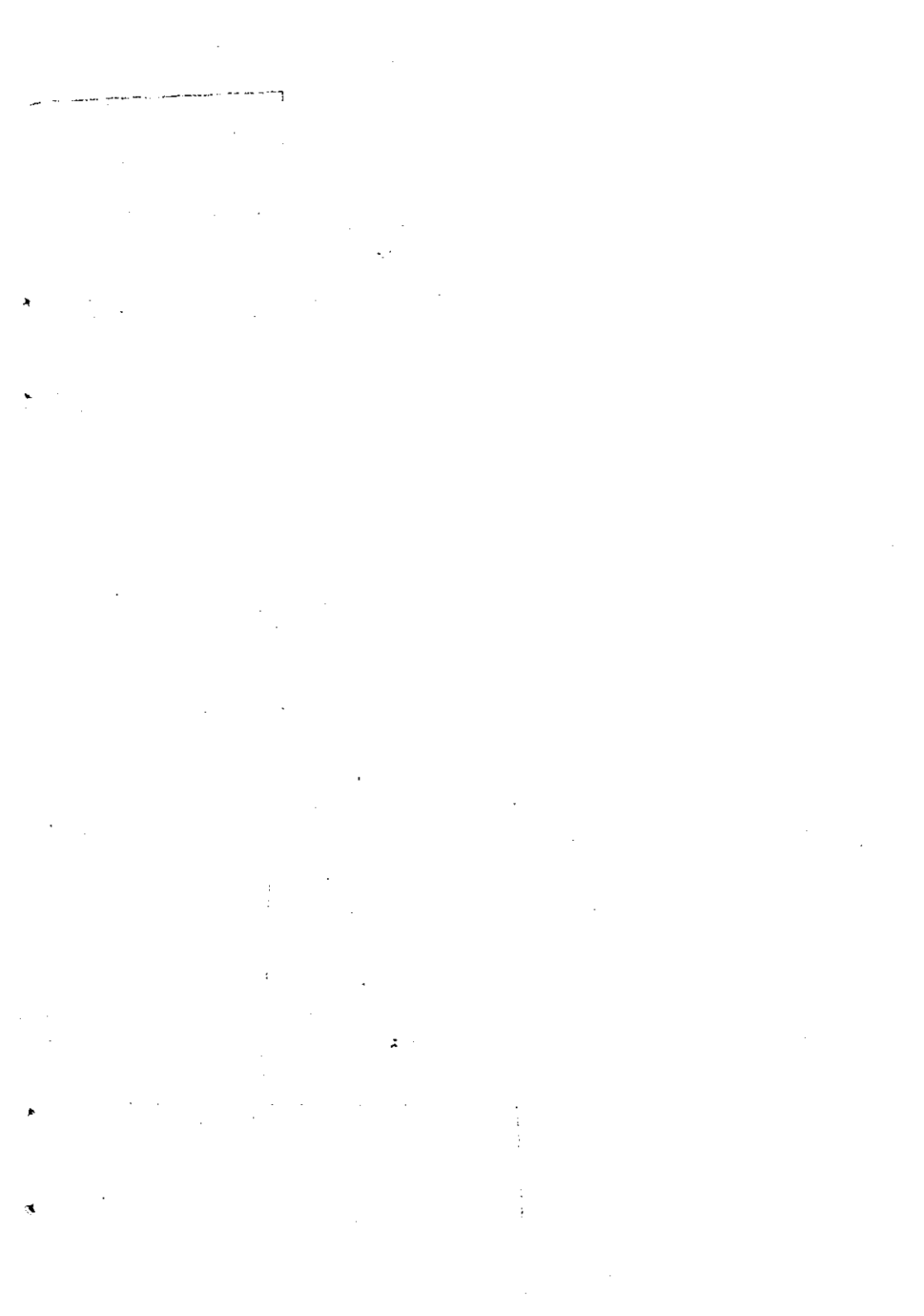
