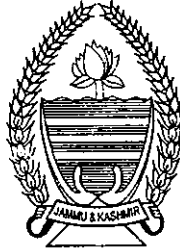

**GOVERNMENT OF JAMMU AND KASHMIR  
CIVIL SECRETARIAT—LAW DEPARTMENT**

Jammu, the 29th April, 2010.

The following Act as passed by the Jammu and Kashmir State  
Legislature received the assent of the Governor on 28th April, 2010  
and is hereby published for general information :—

**THE JAMMU AND KASHMIR CIVIL SERVICES  
(SPECIAL PROVISIONS) ACT, 2010.**

(Act No. XIV of 2010)

[28th April, 2010].

An Act to provide for regularization of the employees appointed  
on *ad hoc*, contractual or consolidated basis.

- (h) "Government" means the Government of Jammu and Kashmir ;
- (i) "post" means a post borne on the establishment of any Department of the Government ;
- (j) "recruiting agency" shall mean the Public Service Commission and Service Selection Board and shall include any other authority empowered to make selection for appointment to any post or service under the Government ;
- (k) "regularized employee" means a person whose services are regularized under section 5 ; and
- (l) "rules" mean the rules regulating the appointment to any post or service under the Government.

3. *Application of the Act.*—The provisions of this Act shall apply to such posts under the Government as are held by any person having been appointed on *ad hoc* or contractual basis including those appointed on consolidated pay provided that such appointments have been made against the clear vacancies, but shall not apply to—

- (a) persons appointed in terms of Government Order No. 125-GAD of 2001 dated 01-02-2001, on contract basis in the Personal Sections of the Ministers or other authorities enjoying the status of a Minister ;
- (b) persons appointed on tenure posts co-terminus with the life of the Project or Scheme of the State or Central Government, as the case may be, and those appointed on academic arrangement for a fixed term in any Government Department ;
- (c) non-governmental agencies or autonomous bodies or public sector undertakings or corporations or Government companies

have effect only from the date of such regularization, irrespective of the fact that such appointees have completed more than seven years of service on the appointed date or thereafter but before such regularization :

Provided further that any *ad hoc* or contractual or consolidated appointee who has not completed seven years service on the appointed day shall continue as such till completion of seven years and shall thereafter be entitled to regularization under this Act.

6. *Relaxation in upper age limit.*— (1) The upper age limit as prescribed under rules, for entry into Government service shall be relaxed, in case the *ad hoc* or contractual or consolidated appointee is otherwise eligible for regularization under this Act : provided such appointee has crossed the age limit at the time of his regularization but was within the prescribed age for appointment into the Government service at the time of his initial appointment as such or his age was relaxed by the competent authority at the time of his initial appointment.

(2) The *ad hoc* or contractual or consolidated appointee shall be treated as an in-service candidate so far as the upper age limit is concerned for direct recruitment to Government service : provided his *ad hoc* or contractual or consolidated service is subsisting on the date of issue of the advertisement notification by the recruiting agency.

7. *Fixation of pay.*—Every regularized employee shall from the date of his regularization be entitled to fixation of pay in the time scale of pay applicable to the post against which he is regularized.

8. *Test or training.*—Wherever any test or training is prescribed as a qualification for declaration of completion of probation in a service, the regularized employee shall pass such test or undergo such training within one year from the appointed day, failing which his annual increments shall be stopped and if he fails to pass such test or undergo such training even by the end of the fourth year from the date of his regularization, his services shall be terminated.

(3) The Empowered Committee shall examine such cases and notify the names of such *ad hoc*/contractual/consolidated employees who have been found eligible for regularization under said section 5 in respect of each Department within fifteen days period for filing of objections before the Committee.

(4) The Empowered Committee shall thereafter examine the complainants, if any, received and make appropriate recommendation(s) to the concerned Administrative Department with regard to regularization in respect of each case on fulfillment of the conditions specified under section 5 or rejection of the case.

(5) The concerned Administrative Department shall issue orders of regularization after seeking the approval of the Chief Minister through the Chief Secretary, in coordination.

11. *Appeal*.—(1) Any person aggrieved of the recommendation(s) made by the Empowered Committee under sub-section (4) of section 10 on account of being leftout may prefer an appeal within 30 days from the date of recommendation by Empowered Committee before the Chief Secretary or any other officer nominated by him.

(2) The appellate authority may, after hearing the appellant and after seeking comments from the Empowered Committee, pass appropriate orders in this behalf which shall be final and conclusive.

12. *Penalty*.—In case any officer or official fabricates or forges any document to give undue advantage to any person in the matter of regularization or aids and abets any person to secure any fabricated or forged document to claim regularization under this Act, he shall be liable to disciplinary proceedings and the salary drawn by such regularized employee shall be recoverable from such defaulting officer or official as arrears of land revenue.

13. *Creation of additional posts*.—Additional posts of equal number as are required for regularization and continuation of *ad hoc* or contractual or consolidated appointees may be created if the posts are not available in the Department when the regular appointments on

years, 2000 and 2001. The President and General Secretary of the association wrote a letter vide No. DTEA/16/2001 dated 12-06-2001 for release of D.A. installment in favour of the employees due from April, 2001. The association also demanded the revision of daily wager according to minimum wages notification dated 19-03-2001. There was a strike of the employees of Dharmarth Trust for these long demands.

6. That the management always remained annoyed with the President and General Secretary of the union as the union office bearer always represent the problems, demands and grievance of the employees before the management. Employees Association also held "Dharnas", "Demonstration", Rallies and Strike in support of their demands to get the demands accepted. The respondent/employer terminated the services of petitioner workman on 18-06-2001 with *malafide* intention to get rid from the office bearers of trade union which amounts to victimization of union office bearers which is unfair labour practice on the part of respondent employer under I. D. Act, 1947. The act of employer is *malafide* using his colourable exercise of power to remove the General Secretary of the union with such type of alleged letter of termination. The petitioner/workman has put eighteen years of service. The previous record of service was neat and clean. He was an important office bearer of the union. To remove the petitioner in such way is not justified and amounts to victimization which is unfair labour practice under Industrial Disputes Act, 1947. Therefore, such alleged termination order is not sustainable under law and be set aside. This order is not *bona fide* and the petitioner is entitled for reinstatement with full back wages.

7. That the petitioner/workman who is also the General Secretary of the Dharmarth Trust Employees Association, Jammu filed an application on dated 14-02-2001 to become a party in a public interest litigation case with respect to management and functioning of Dharmarth Trust before the Divisional Bench of Hon'ble High Court of Jammu and Kashmir at Jammu being PIL No. 951/2000. The Petitioner being General Secretary of Dharmarth Trust Employees Association to look after the interest of the employees and also find ways to redress the grievances of the employees. The respondent/employer to get revenge from the union office bearers and workman and to sabotage the activities of the employees trade union passed the impugned order dated 18-06-2001. The alleged termination order has

10. The workman is a workman under Industrial Disputes Act, 1947 and is permanent employee and he is entitled all benefits under Industrial Disputes Act, 1947. The service of workman cannot be terminated without any inquiry. The workman is a workman under the section 25F of the Act and its provisions are to be complied with if he had put 240 days of service in a year prior to date of termination.

11. Thereafter file was posted for filing of the objections whereupon respondent filed objections on 16-03-2007 averring therein—

- i. That the above titled petition is liable to be dismissed outrightly as the Learned Court/Forum has no jurisdiction to entertain and adjudicate upon the subject matter ;
- ii. That neither the petitioner workman falls within the definition of workman as specified in Industrial Disputes Act nor the respondent employer comes within the definition of employer as provided in the said Act ;
- iii. That the above titled petition is also not maintainable on the ground that the Dharmarth Trust Council is a religious and charitable trust and the provisions of Industrial Disputes Act are not applicable to it as the same does not fall within the definition of industry as provided under the said Act. It is further humbly submitted that the Hon'ble High Court of J&K vide its judgement dated 24-05-2004 passed in OWP 60/2003 titled J&K Dharmarth Trust Council Vs. State of J&K and in OWP 1064/2001 titled J&K Dharmarth Trust Council Vs. State of J&K has held that the said trust does not fall within the definition of establishment or employer as definition under payment of Gratuity Act as well as under Shops and Establishment Act and set aside the order passed by the Controlling Authority under payment of Gratuity Act, Jammu ;
- iv. That the above titled petition is also hit by the provisions of *res judicata*. The respondent employer humbly submits that petitioner workman herein has earlier filed a petition in

not been arrayed as a party in this petition ;

- vii. That the above titled petition is hopelessly time barred. In this regard it is humbly submitted that the petitioner workman has challenged his order of termination dated 18-06-2001 by filing the present petition in the year, 2007.

12. It is also submitted that the petitioner workman was working as a Room Attendant and vide Order No. 2471-73 dated 25-11-2000 was attached in the Central Office till further orders. It is further humbly submitted that the said termination order has been passed under rules and is legal and proper as already been adjudicated upon by the Civil Court.

13. It is further submitted that the services of the petitioner workman were terminated vide order dated 18-06-2001 with entitlement of a sum equivalent to the amount of his pay plus allowances for a period of one month which the petitioner was drawing immediately before the termination of his services.

14. However, it is reiterated that Industrial Disputes Act is not applicable to the respondent employer.

15. The petitioner has filed the rejoinder to the objections of the respondent thereby denying the objections and reiterated the contents of the statement of claim already filed by him.

16. **Heard arguments and perused the material available on record.** From the perusal of the record, it appears that the maintainability of the petition is in question. Before proceeding further, it is imperative to see whether the petitioner can be benefitted by the provisions of Industrial Disputes Act. For that we have to see whether, the petitioner is a workman and if so then whether the provisions of Industry Disputes Act are applicable to the petitioner. So let us see the definition of a workman under the Industry Dispute Act, 1947.

17. Section 2(S) deals with the definition of a workman, which is reproduced as under—

1[(j) "Industry" means any systematic activity carried on by co-operation between any employer and his workmen (whether such workmen are employed by such employer directly or by or through any agency, including a contractor) for the production, supply or distribution of goods or services with a view to satisfy human wants or wishes (not being wants or wishes which are merely spiritual or religious in nature), whether or not,—

- (i) any capital has been vested in for the purpose of carrying on such activity ; or
- (ii) such activity is carried on with a motive to make any gain or profit, and includes,—
  - (a) any activity of the Dock Labour Board established under Section 5-A of the Dock Worker (Regulation of Employment) Act, 1948 (9 of 1948) ;
  - (b) any activity relating to the promotion of sales or business or both carried on by an establishment, but does not include,—
    - (1) any agricultural operation except, where such agricultural operation is carried on in an integrated manner with any other activity (being any such activity as is referred to in the foregoing provisions of this clause) and such other activity is the predominant one.

*Explanation* :—For the purposes of this sub-clause, "agricultural operation" does not include any activity carried on in a plantation as defined in clause (f) of section 2 of the Plantation Labour Act, 1951 (69 of 1951) ; or

- (2) hospitals or dispensaries ; or
- (3) educational, scientific, research or training institutions ; or
- (4) institutions owned or managed by organization wholly or substantially engaged in any charitable, social

intend is clear in this regard. Since expression employee and employer have been specifically defined under the provisions of Payment of Gratuity Act, 1972, same cannot be borrowed from the other statute including Shops and Establishment Act. From the reading of the provisions referred to above, it is clear that trust does not fall within the definition of establishment or employer. Contention of the respondent of the respondents that alternate efficacious remedy is available also cannot be accepted for the reasons that writ petition was entertained in the year, 2001 and it is too late to dislodge the petitioner on the ground of availability of alternate remedy. Apart from this, it is settled proposition of law that where impugned order is without jurisdiction, alternate efficacious remedy of writ jurisdiction under Article 226 of Constitution of India read with section 103 of Constitution of State of Jammu and Kashmir is no bar. In the present case, orders impugned are clearly without jurisdiction and therefore, the remedy of invoking writ jurisdiction is available to the petitioner. For what has been stated above, these petitions are allowed.

22. There is no doubt that the respondent is a trust known as "Dharamarth Trust Council dealing with the religious and charitable activities". The trust as per section (2) J, is not amenable to the provisions of the Industrial Dispute Act, 1947.

23. For what has been discussed above and in the facts and circumstances of the case, it is safe to hold that the petitioner is not protected under the Industrial Dispute Act, 1947.

24. In brief it is opined that "No Relief" can be granted to the petitioner as the respondent is a charitable institution and is immune from the provisions of Industrial Dispute Act, 1947. The reference is answered and disposed of accordingly and a copy of the same be sent to the Government for its publication under rules.
