Circular No. 07-GAD of 2015

Dated 10-02-2015.

Instructions have time and again been issued, impressing upon all the concerned to ensure voluntary disclosure of information in terms of section 4 (1)(b) of the Right to Information Act, 2009. The issue has also been highlighted on numerous occasions during the CoS meetings held under the Chairmanship of the Chief Secretary. However, it has

been observed that most of the departments are still deficient with regard to hosting the requisite information on their official websites and in some cases, the official websites are not being updated on regular basis. Besides, some departments continue to be without the official websites thereby defeating the mandate of the Act for ensuring transparency and accountability in the system.

The information, if available on the official websites, would also help in reducing the need for providing the information to the information seekers, who can easily have access to the information hosted on the website.

The issue also came up for discussion, during an interaction of the Commissioner/Secretary to the Government, General Administration Department, with the State Chief Information Commissioner, J&K, and a statement showing (forming Annexure to this Circular) the status of different departments regarding creation of websites, disclosure under section 4(l)(b) of the Right to Information Act and appointment of Public Information Officer/First Appellate Authority, was shared by the State Chief Information Commissioner, J&K, with him, indicating the deficiencies in respect of different departments.

Besides the above, it was also indicated that inspite of repeated instructions being issued by the General Administration Department, some officers/officials have failed to indicate their names and designations while exchanging official communications.

Accordingly, the instructions issued on the subject(s), are reiterated and it is impressed upon all the concerned including the Administrative Secretaries, Divisional Commissioners, Heads of Departments and Deputy Commissioners to ensure that—

1. all the departments viz. administrative as well as line departments, disclose information in terms of section 4(l)(b) of the Right to Information Act, 2009, and their official websites are created/made functional immediately. They shall also ensure that these websites shall be updated on daily basis.

2. the deficiencies reflected in the statement furnished by the State Information Commission, J&K, in respect of launching of website, disclosure of information under section 4 (1)(b) of the Right to information Act, 2009 and appointment of Public Information Officers/First Appellate Authorities, are made good immediately, under an intimation to the General Administration Department.
3. all the officers/officials shall indicate their names and designation below their signature while initiating or endorsing any note/proposal for consideration of the Competent Authorities and on the communications exchanged with different departments. The other details like telephone numbers, e-mail addresses should also be mentioned on such communications, without fail.
