No. 576/Exit/2014/SDR-Vol. I.—Whereas, the schedules for the General Elections to the House of the People, 2014 and the State Legislative Assemblies of Andhra Pradesh, Arunachal Pradesh, Odisha and Sikkim 2014 and bye-elections in the State Legislative Assemblies of Bihar, Gujarat, Himachal Pradesh, Madhya Pradesh, Maharashtra, Mizoram, Uttar Pradesh, Tamil Nadu and West Bengal were announced by the Commission vide Press Notes bearing No. ECI/PN/10/2014 dated 5th March, 2014, No. ECI/PN/13/2014 dated 10th March, 2014 and No. ECI/PN/17/2014 dated 27th March, 2014 ;

2. And whereas, as per the provisions of Section 126A of the R. P. Act, 1951, there shall be restrictions on conduct of any exit poll and publication and dissemination of result of such exit poll during such period, as may be notified by the Election Commission in this regard.

3. Now, therefore, in exercise of the powers under sub-section (1) of section 126A of the R. P. Act, 1951, the Election Commission, having regard to the provisions of sub-section (2) of the said section, hereby notifies the period between 7.00 A. M. on 07th April, 2014 (Monday) and 06.30 P. M. on 12th May, 2014 (Monday), as the period during which conducting any exit poll and publishing or publicizing by means of the print or electronic media or dissemination in any other manner whatsoever, the result of any exit poll in connection with the current General Elections to the House of the People, 2014 and the State Legislative Assemblies of Andhra Pradesh, Arunachal Pradesh, Odisha and Sikkim 2014 and bye-elections from assembly constituencies in the State Legislative Assemblies of Bihar, Gujarat, Himachal Pradesh, Madhya Pradesh, Maharashtra, Mizoram, Uttar Pradesh, Tamil Nadu and West Bengal to be held simultaneously with the General Election to Lok Sabha shall be prohibited.

4. It is further clarified that under Section 126(1)(b) of the R. P. Act, 1951, displaying any election matter including results of any opinion poll or any other poll survey, in any electronic media, would be prohibited during the period of 48 hours ending with the hours fixed for conclusion of poll in the respective polling areas in connection with aforesaid General Elections and bye-elections.

Award

1. This is a direct industrial dispute filed by the workmen under section 33(c), sub section(2) of Industrial Disputes Act, 1947 read with section 15, sub-section 3 of Payment of Wages Act for recovery of the amount of leave salary due to the Petitioner (hereinafter to be referred as the "Act". It is stated in the claim by the workmen that he was appointed as orderly in the year of 1966 (1-12-1966 in J&K Project Construction Corporation, Srinagar and retired on 03-06-2006.

2. The petitioner was given the leave salary for four (4) months only at the time of his retirement. The petitioner has further contended that respondent, JKPCC was brought withinin the domain of the State Government vide SRO No. 27 dated 05-02-1998 and the rules and regulations as applicble to the employees of the State are also applicable to the employees of the JKPCC. Since all the rules and regulations as per CSR are applicable to the State Government Employees, so the petitioner was also entitled to the same privileges as of the State Government Employees at par.

3. That as per SRO-124 dated 17-04-1998 all the Government Employees are entitled to 10 months leave salary, so the petitioner is also entitle to leave salary of 10 months equivalent 300 days. The petitioner has been given only 4 months leave salary and 6 months leave salary is outstanding. The leave salary being the retirement benefit falls within the provisions of section 33(c) (2) of Industrial Dispute Act, 1947. It is also submitted by the petitioner that he has been deceived and dogged by the respondent and due to the inaction of the respondent, the petitioner has filed



the present petition seeking the recovery of outstanding leave salary of six months along with interest @18% and compensation and compansation on account of mental agony of petitioner.

4. Upon being served, the respondent filed the objections, inter alia pleading that the petitioner is the employee of the corporation who has got all the pensionary benefits as admissible under the corporation rules. It is further submitted that no cause of action has accrued to the petitioner as he has received all the pensionary benefits along with the other retired personnel of the corporation. The corporation has its own service rules and as per the rule, the corporation pays salary, gratuity etc. to its employees from its own resources, no budget support is made by the Centre or State Government. The Respondent has admitted that as per the approval of the competent authority of the Corporation (JKPCC), the J&K Service (Leave Rules) have been incorporated and made admissible to the employees of the corporation w.e.f. 01/04/2008 and prior to 01/04/2008 the employees of the corporation were entitled to only 120 days leave encashment as per rules and regulations of JKPCC. The employees of JKPCC were entitled to only 120 days leave encashment and the same has been paid to the petitioner. After a long gap, the petitioner has disputed the leave salary which cannot be permitted at the belated stage.

5. The petitioner has relied upon the photostate copy of service book and one certificate of last pay drawn certificate duly issued by the D.D.O.

Heard and considered.

6. The petitioner has reiterated the contents of the petition in his arguments whereas the counsel for the respondent prayed for the dismissal of the petition on the plea of no cause of action has accrued to the petitioner and the statement of claim is not maintainable on the ground of latches/belated stage.

7. The moot question for the adjudication by this tribunal is that whether the workman is entitle to leave salary of 300 days and if so whether the said claim is maintainable under section 33c (2) of I. D. Act, 1947. To answer this question it is a pity to reproduce section 33 C (2) of Industrial Disputes Act, 1947 which reads as under :—

“Where any workman is entitled to receive from the employer any money or any benefit which is capable of being computed in terms of money and if any question arises as to the amount of money due or as to the amount at which such benefit should be

computed then the question may subject to any rules that may be made under this Act be decided by such Labour Court as may be specified in this behalf by the appropriate Government within a period not exceeding three months provided where the Presiding officer of Labour Court considers it necessary and expedient so to do, he may for the reasons to be recorded in writing extend such period by such further period as he may think fit.”

8. It is also pertinent to reproduce section 15, sub-section 3 of Payment of Wages Act, which reads as under :—

“When any application under sub-section (2) is entertained, the authority shall hear the applicant and the employer or the other person responsible for payment of wages under section 3, or give them an opportunity of being heard, and after such further inquiry (if any) as may be necessary, may, without prejudice to any other penalty to which such employer or other person is liable under this Act, direct the refund to the employed person of the amount deducted, or the payment of delayed wages, together with the payment of such compensation as the authority may think fit, not exceeding ten times the amount deducted in the former case and [not exceeding twenty-five rupees in the later, and even if the amount deducted or the delayed wages are paid before the disposal of the application, direct the payment of such compensation, as the authority may think fit, not exceeding two thousand rupees]”.

9. The Ld. Counsel for the respondent has argued that in a case entitled “Krishan Prasad Gupta Vs. Controller, Printing and Stationery” published as AIR 1996 Supreme Court 408, the Hon’ble Supreme Court has observed that—

“The character and function of the Labour Court under the Industrial Disputes Act as also the Authority under the Payment of Wages Act are similar in purpose and both are designed to produce the same result particularly as some of the provisions under both the Act prescribe the same thing to be done. The Industrial Disputes Act, 1947 and the Payment of Wages Act, 1936 are, therefore,

“Corresponding Law” qua each other particularly as both are part of the same social legislative canopy made by the Parliament for immediate amelioration of workmen’s plight resulting from non-payment, or delayed payment, or, for that matter, short payment of their wages.”

10. In AIR 2010 Supreme Court 3563 in a case entitled “Vijaya Bank Vs. Shyamal Kumar Lodh” the same view was taken. It was observed that—

“12. From a plain reading of section 33C(2), it is evident that money due to a workman has to be decided by such Labour Court” as may be specified in this behalf by the appropriate Government.” Section 7 of the Industrial Disputes Act, 1947 inter alia confers power to the appropriate Government for constitution of one or more Labour Courts for the adjudication of industrial disputes. It also prescribes qualification for appointment as Presiding Officer of a Labour Court. Explanation appended to section 33-C of the Act provides to include any Court constituted under any law relating to investigation and settlement of industrial disputes in force in any State as Labour Court. The underlying object behind inserting explanation seems to be varying qualification prescribed for appointment of Presiding Officers of Labour Court by different State enactments. The Parliament took note of the fact while inserting explanation that there different kinds of that Labour Courts constituted under Industrial Disputes Act and State Acts and a question may arise whether a Labour Court constituted under Acts, Central or State could entertain a claim made under section 33C(2) of the Act.

13. An explanation is appended ordinarily to a section to explain the meaning of words contained in that section. In view of the explanation aforesaid Labour Court shall include any Court constituted under any law relating to investigation and settlement of industrial disputes in force in any State. Money due to an employee under section 33C(2) is to be decided by “Labour Court as may be specified in this behalf by the appropriate Government”. Therefore, the expression “Labour Court” in

section 33C (2) has to be given an extended meaning so as to include Court constituted under any law relating to investigation and settlement of industrial disputes in force in any State. It widens the choice of appropriate Government and it can specify not only the Labour Courts constituted under section 7 of the Industrial Disputes Act, 1947 but such other Courts constituted under any other law relating to investigation and settlement of industrial disputes in force in any State.”

11. So in view of the above, it is safe to hold that that this Tribunal is competent to adjudicate dispute raised by the workman.

12. From the perusal of record it is established which is not also disputed by the respondent that the petitioner herein above was an employee of the JKPCC. It has also been admitted by the respondent that J&K Service (Leave) Rules have been made applicable to the employees of JKPCC with effect from 01/04/2008 dated 10/07/2008 and prior to 1-04-2008, the employees of JKPCC were entitled to 120 days Leave encashment and after 1-04-2008 when the J&K Service (Leave) Rules were made applicable to the employees of the corporation. It is also not out of place to mention that against the clear admission of the respondents, there was no scope for this tribunal to hold further enquiry.

13. To solve the controversy, it is profitable to reproduce SRO-124 dated 17-04-1998, which reads as under :—

Notification

Dated Jammu, the 17th April, 1998.

SRO-124.—In exercise of the powers conferred by proviso to section 124 of the Constitution of Jammu and Kashmir, the Governor is pleased to direct that the following amendments shall be made in the J&K Civil Services Regulations, J&K Civil Services (Leave) Rules, 1979 and J&K Civil

Services (LTC) Rules, 1996 :—

II. In J&K Civil Services (Leave) Rules, 1979—

- (a) The following shall be inserted as 2nd proviso below Rule 26 (b) (1) :—

“Provided that with effect from 01-07-1997, the maximum limit for accumulation of Earned Leave shall be 300 days”.

- (b) The following shall be inserted as proviso below Rule 37 (2) (1) :—

“Provided that with effect from 01-07-1997, the payment of cash equivalent of leave salary shall be limited to a maximum of 300 days of Earned Leave”.

Cash in lieu of leave salary.— (1) A Government servant may be paid cash equivalent of leave salary in respect of period of Earned Leave at his credit at the time of retirement on superannuation.

- (2) This concession will be subject to the following conditions :—

- (i) The payment of cash equivalent of leave salary shall be limited to a maximum of 240 days of Earned Leave ;
- (ii) The cash equivalent of leave salary thus admissible will become payable on retirement and will be paid in one lump sum as a one time settlement ;
- (iii) Cash payment will be equal to leave salary admissible for earned leave and dearness allowance admissible on the leave salary at the rates in vogue on the date of retirement. No other allowance like Compensatory Allowance, Border Allowance, Muffasil Allowance, House Rent Allowance or any other allowance will be admissible as part of leave salary.

14. The purport of SRO-124 dated 17-04-1998 is that the State Government Employees regulated under the JKPCC, CSR, J&K Civil Services (Leave) Rules, 1979 and J&K Civil Service Rules (LTC) is entitled to maximum limit for accumulation of earned leave of 300 days w. e. f. 1-07-1997

15. As per Article 82 of Sub-Clause V of the Memorandum and Articles of Association of JKPCC, the directors shall have the powers with the sanction of the Governor i.e. to say :

“(V) To appoint and promote and at their discretion remove, retire or suspend such managers, secretaries, officers, clerks, agents and servants, for permanent, temporary or special service as they may, from time to time think fit and to determine their powers and duties and fix their salaries and emoluments and to require security in such installments and to such amount as they think fit provided that no appointment, the maximum pay of which is Rs.3000 or more per mensem shall be made without the prior approval of the Governor : Provided that such appointment, retirement and removal shall be made in accordance with the provisions of Jammu and Kashmir Civil Service Rules ,1956, Government Servant Conduct Rules, Recruitment Rules and other service rules and regulations in force in the State from time to time.”

16. The next leg of the arguments is that JKPCC has adopted the J&K Civil Service Rules, 1979, Civil Service (Medical Attendance and Allowance) Rules, 1990 and T/E Rules vide order No. 82 dated 10-07-2008. It is imperative to reproduce the Order No. 82/2008 passed by the respondent, JKPCC, which reads as under :—

“Subject :— Implementation of the Jammu and Kashmir Civil Service (Leave) Rules, 1979, Civil Services (Medical Attendance and Allowance) Rules, 1990 and T.A Rules.

Reference :—Decision taken by the Budget/Establishment Sub-Committee of JKPCC Ltd. under the Chairmanship of Commissioner/Secretary to Government Finance Department on 10th of April, 2008 vide Order No. 82 of 2008 dated 10-07-2008.

---

Consequent upon the approval formally conveyed by the Board of Directors in its 83rd meeting held on 17-06-2008 under the Chairmanship of Hon'ble Minister for R&B (Chairman JKPCC Ltd.), sanction is accorded to the implementation of the Jammu and Kashmir Civil Services (Leave) Rules and T.A Rules as applicable to the State Government employees shall henceforth apply strictly to the employees of the Corporation. This will, however, take effect from 01-04-2008. However, cases already settled after 01-04-2008 to the date of issuance of orders shall not be reopened.

17. Now the question arises whether the petitioner who retired prior to the issuance of Order No. 82 dated 10.07.2008 is entitled to leave encashment of 10 months as leave salary. The answer would be in negative because of the reason that the leave rules known as J&K Civil Service Rules (Leave Rules), 1979 has been adopted by the Corporation w. e. f. 1-04-2008. The Order No. 82 of 2008 crystal clear states that—

“The Jammu and Kashmir Civil Services (Leave) Rules, 1990 and T.A Rules as applicable to the State Government employees shall henceforth apply strictly to the employees of the Corporation and

cases already settled after 01-04-2008 to the date of issuance of order shall not be reopened”.

18. The petitioner has received the benefit under Leave Rules, 1979 as the same were adopted by JKPC w.e.f. 1-04-2008. The employees on his retirement shall be entitled to leave salary of 10 months vide SRO-124 dated 17-04-1998, if an employee owns leave to credit. If we go by the contention of the petitioner that all the employees who retired before 01.04.2008 are entitled to the benefit of leave salary then all the employees of the State are entitled to leave encashment of 10 months irrespective of year of their retirement on or before 01-07-1997.

19. The petitioner has also submitted that the petitioner has been ignored of his legitimate right of leave salary encashment of 10 months and same has been withheld, whereas other blue eyed employees of the corporation were given the leave encashment of 10 months. Though SRO-124 was issued on 17-04-1998 by the Government of Jammu and Kashmir and the employees of the State Govt. were given the benefit of leave encashment/leave salary of 10 months on their superannuation w. e. f. 01-07-1997 but the said rules known as JKCSR Leave Rules, 1997 were adopted by the respondent only on 10-07-2008 giving the benefit of leave salary of 10 months to its employees on their superannuation w. e. f. 01-04-2008.

20. On this account also the petitioner is not found any benefit of Order No. 82 of 2008 of the JKPC dated 10-07-2008. So far as the petitioner's argument that some of the employees were provided the benefits of leave salary of 10 months as SRO-124 passed by the authority under the payment of Wages Act, there is nothing on the record which could prove that the said order passed by the authority under the Payment of Wages Act, District Srinagar (Assistant Labour Commissioner, Srinagar) was challenged by the competent authority or not. The petitioner has failed to prove that he is entitled to leave salary of 10 months on his superannuation on 30-06-2006.



21. The next limb of arguments of the petitioner is that he has been requesting the respondent time and again for the release of his leave salary also does not influence the Court in the absence of any proof of filing any receipt of filing of any application of representation before the competent authority. If the plea of the petitioner is admitted for arguments sake then there will be a flood gate of litigation by all the retired employees before 01-04-2008.

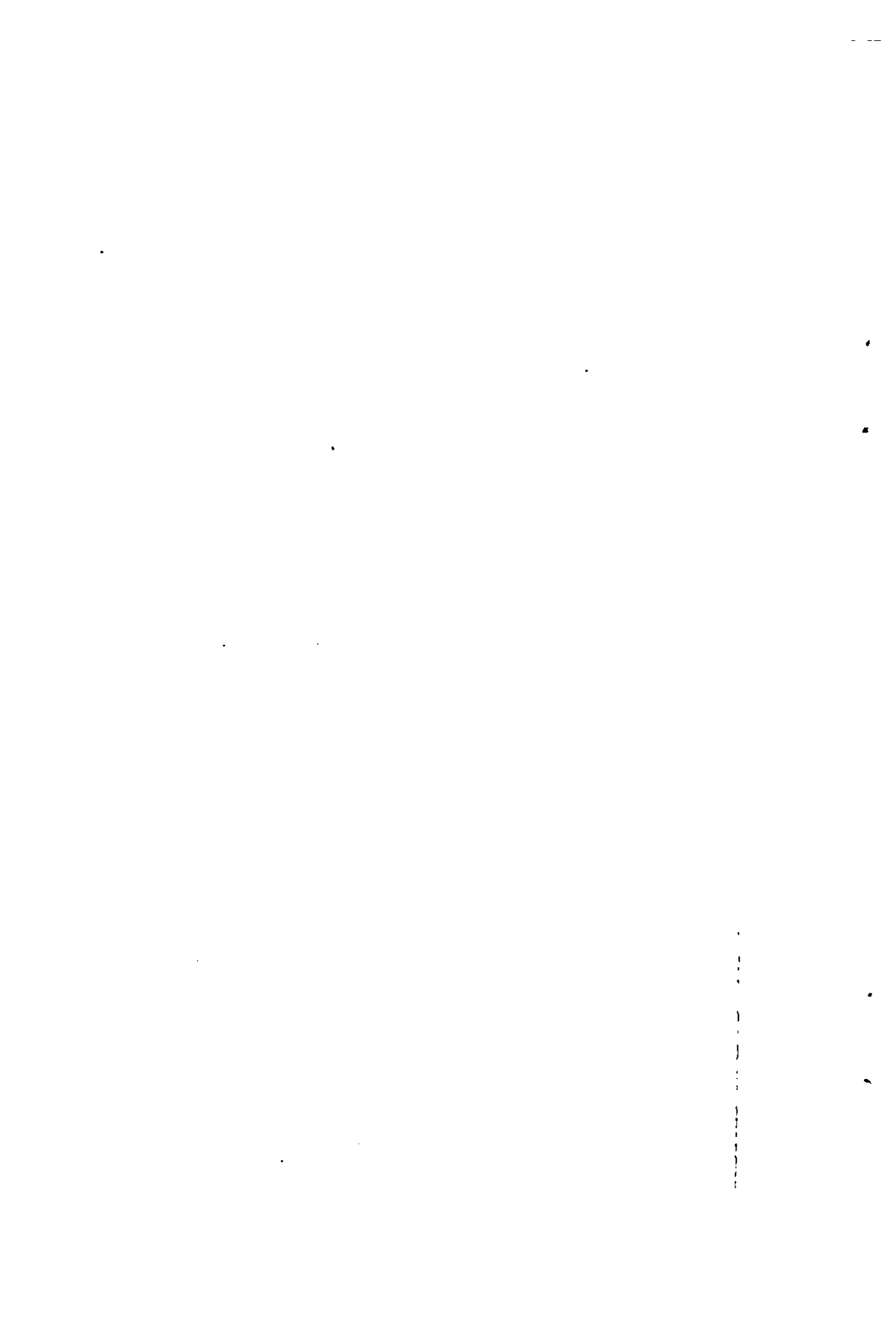
22. For what has been discussed above, I am of the concerned view that the workman/petitioner is not entitled to the relief claimed by him. The petition deserves to be dismissed and the same is dismissed accordingly. File to go to record under rule.

Award

1. Direct Industrial Dispute filed by the workman. As per statement of claim, the petitioner joined the services of the respondents as workman in one of the unit of the respondent No. 1, Hotel Jammu Ashok at Jammu in the year 1972 and after completion of service of more than 32 years, petitioner was superannuated on 31-12-2004 as Sr. Assistant (Store), Hotel Jammu Ashok. The services of the petitioner was covered under the certified Standing Orders of India Tourism Development Corporation having its unit Hotel Jammu Ashok, Jammu and petitioner served the respondents with utmost sincerity and devotion till his superannuation.

2. That vide leave application dated 20-11-1976, the petitioner applied for privilege leave of 90 days w. e. f. 1st January, 1977 to 30th March, 1977 and after the receipt of the application by the manager of respondent No. 2, the same was processed for its sanction but the respondent refused to grant the leave and consequently vide letter dated 11th September, 1978 it was informed that encashment of leave will be given to the petitioner in the event of his quitting the service of the respondents. Copy of letter dated 27th December, 1976 and 11th September, 1978 are enclosed herewith as Annexure 'A' and 'B'.

3. That immediately after quitting the service by way of superannuation, the petitioner applied for grant of leave encashment of three months w. e. f. 1st January, 1977 to 30th March, 1977. Copy of application addressed to respondent No. 3 is enclosed herewith as Annexure 'C'. The last pay drawn by the petitioner from the respondents was Rs. 14,069/- and in view of refusal of leave by the respondents for 90 days, as has been stated hereinabove, the petitioner is entitled to total amount of Rs. 42,207/- as three month's Leave Encashment Salary from the respondents. The said amount has illegally and without any justification has been withheld by the respondents.

4. That the petitioner has been given all other benefits by the respondents at the time of his superannuation but the respondents have not released three months Leave Encashment w. e. f. 1st January, 1977 to 30th March, 1977 amounting to Rs. 42,207/- to the petitioner despite repeated requests and reminders on the part of the petitioner, the respondents failed to release an amount of Rs. 42,207/- to the petitioner and infact the said amount has illegally and without any justification been withheld by the respondents.

5. That the respondents vide letter dated 10th August, 2005 have categorically admitted that petitioner applied for Privilege Leave of 90 days w. e. f. 1st January, 1977 to 30th March, 1977 and same was refused and vide letter dated 11th September, 1978, it was made clear that if leave applied for by any employee is refused, the same can be encashed by the concerned employee only in the event of his quitting services of the hotel. The respondents in the letter dated 10th August, 2005 stated that petitioner prior to his retirement did not submit any application to the Management for Encashment of leave of ninety days as approved by the Headquarters vide Memo dated 11th September, 1978. It is pertinent to mention here that the averments made in the letter dated 10th August, 2005 are totally incorrect. Infact petitioner all along made representations from time to time for encashment of his leave and even prior to retirement submitted written application before the respondent No. 3 for encashment of ninety days leave salary.

6. That the petitioner has served the respondents for more than 32 years and his right to get Leave Encashment of ninety days at the time of quitting his services from the respondent by way of superannuation, has been denied without any justifiable cause. The petitioner is entitled to an amount of Rs. 42,207/- by way of leave encashment of three months salary from the respondents.

7. And finally prayed for the release and payment of an amount of Rs. 42,207/- as Leave Encashment Salary w.e.f. 1st January, 1977 to 30th March, 1977 to the petitioner along with interest @ 12% per annum.

8. Thereafter, file was posted for filing of the objections, whereupon respondents filed objections on 14-12-2006 averring therein that no cause of action has accrued to the petitioner against the answering respondents as such, the above titled petition against the respondents is not maintainable and is liable to be dismissed as the above titled petition is required to be dismissed since the suit does not disclose any procedural irregularity necessitating judicial review by this Hon'ble Court. The petition is as such, required to be dismissed.

9. That the petitioner has not come before this Hon'ble Court with clean hands in so much as he has misstated and misrepresented the facts in his petition.

10. That the contents of para No. 1 to the extent that the petitioner Shri M. M. Gupta joined Hotel Jammu Ashok, a unit of India Tourism Department Corporation (A Govt. of India undertaking) on 1st May, 1972 as an Assistant Storekeeper is a matter of record therefore, need no comments.

11. That the contents of para No. 2 of the petition has not been rightly stated as such, denied. The fact remains that petitioner applied for 90 days Privilege leave w.e.f. 01-01-1977 to 30-03-1977. On receipt of said application from the petitioner, the answering respondent No. 2 forwarded the same to its head office, with the recommendations of the then General Manager, hotel Jammu Ashok with the recommendations that a special case, leave for 90 days may be encashed to the petitioner. However, the same was declined by the Head Office since, in the year

1976-77, there was no such provision of encashment of leave for the employee of Indian Tourism Development Corporation.

12. That the contents of para No. 3 are wrong and misconceived as such, most vehemently denied. The fact remains that the answering respondent vide APO's memo bearing No. P/JM/G(MM) dated 11-09-1978, informed the petitioner that the privilege leave applied by the petitioner and refused by the answering respondents can be encashed to him only in the event if the petitioner quit the service of the hotel. This is being so if the provisions of the J&K Shops and Establishment Act, 1966 were made applicable to the employee of Hotel Jammu Ashok, by Indian Tourism Development Corporation as far as the leaves were concerned. The petitioner could have accumulated 90 days leave in his credit, if Mr. Gupta would have resigned or quitted his service at that time and he would have been paid encashment of 90 days leave as there was no provision at that time for encashment of leaves in ITDC and the provision of J&K Shops and Establishment Act, 1966 were applicable as far as the leave was concerned.

13. That the contents of para No. 4 of the petition are wrong and misonceived as such, most vehemently denied. As has been submitted hereinabove, that petitioner was not entitled to leave encashment in the year 1977 since the same was not allowed to the employees of ITDC. It is further submitted that entitlement of leave encashment was implemented in ITDC w. e. f. 01-07-1978 in terms of wage agreement signed between Joint Action Committee and the Management of India Tourism Development Corporation. The HCE employees were allowed encashment leave as per settlement signed with the Trade Unions on 28-01-1980. Since the encashment of leave was not applicable to HCE employees in the year 1977 i.e. the date on which the petitioner was refused 90 days leave, the question of allowing him of encashment of leave for the said period does not arise.

14. It is pertinent to mention that petitioner himself was Branch President of AITUC, Branch Hotel, Jammu, Ashok, Jammu who was the major partner of Joint Action Committee who signed the agreement with the management. It is further submitted that the petitioner after the implementation of leave encashment policy, petitioner has availed

encashment of leave salary for 24 times i.e. of one year and 6 months and 2 days after the implementation of Leave Encashment Policy in ITDC.

15. That the contents of para No. 5 are wrong and misconceived therefore, most vehemently denied. The fact remains that as per the rules of the Govt. of India, an employee can accumulate 240 days leave in the account which can be encashed to him at the time of his retirement. Accordingly, petitioner who retired from the services of the corporation after attaining the age of superannuation on 31-12-2004, his accumulated leaves of 240 days were encashed to him and the payment of the same was released/made to him by the answering respondents vide cheque bearing No. 235501 to 503 dated 18-04-2005 amounting to Rs. 1,12,552.00 in addition to his other benefits like CPF, Gratuity etc. as per rules.

16. It is further submitted that the petitioner encashed one year six months and two days leave after the implementation of the Encashment policy and moreover accumulated 240 days leaves as per rules which was encashed to him also at the time of his retirement. Question of extra leave or otherwise to encash him without any provisions of rules of the Government of India does not arise. The claim of the petitioner is illegal and contrary to the provisions and the rules as such can not be allowed.

17. On the absence of the respondents and their counsel, *ex parte* proceedings were initiated against them vide this Court order dated 19-06-2008 which came to be set-aside on 17-11-2008 subject to payment of costs of Rs. 700/-. Again on 4th March, 2011, the *ex parte* proceeding were initiated against the respondents on their failure to attend the proceedings of the case. An application for setting-side *ex parte* proceedings are filed which came to be dismissed by this Court on 16-11-2012. The petitioner has led the evidence of the following witnesses :—

1. Roomal Singh.
2. Madan Mohan Gupta.

Their statements are as under—

18. P. W. 1. Roomal Singh has deposed that he is acquainted with the petitioner who was working in Ashok Hotel as he worked with him



since 1972 to 2004 and retired in the year of 2004. The Privilege Leave of the petitioner was sanctioned but not allowed nor released in favour of the petitioner.

19. Petitioner Madan Mohan Gupta stated that he was appointed as Assistant Storekeeper in Hotel Ashok Jammu and till 31-12-1977, he did not avail any Privilege Leave and on 20-11-1976 he applied for leave of 3 months w. e. f. 01-01-1977 to 31-03-1977 which was sanctioned but the then unit Manager did not allow him to avail the leave on the plea of non-availability of a suitable person to hand over the charge. On 11-09-1978, he was communicated that he will be provided cash in lieu of leave as per shops and establishment Act. On 31st of December, 2004 he retired from the services and applied for the release of three months leave encashment salary and the same was refused by the respondent, Manager of Hotel Ashok.

20. The respondents has not lead any evidence except the denial of the claim or the petitioner by filing the written statements/objections.

Heard and Perused.

21. From the perusal of the record it reveals that the petitioner is agitating for the release of leave encashment for three months on the basis of a letter marked as Annexure-B. It is imperative to reproduce the contents of the said annexure in order to reach at a conclusion and also for the just decision of the case. "Annexure-B".

#### "MEMORANDUM"

"Assistant Personnel Officer(s) To Manager, Jammu Motel  
P/JM/G(MM) date 11th September, 1978.

Please refer to your memo No. P/JM/Per/(MM-25)77-3572  
dated 13-10-1977 regarding encashment of leave to  
Shri M. M. Gupta who was sanctioned leave with effect

from 01-01-1977 to 30-03-1977 but did not avail it, as he was not allowed to proceed on leave by you.

The matter has been examined and it has been decided that the leave applied for and refused can be encashed by the concerned employee only in the event of his quitting service of the hotel provided such a provision exists in the Jammu and Kashmir Shops and Esstt. Act, 1966.

(V. P. Saxena).

CC :—M. M. Gupta Asstt. Storekeeper Jammu Hotel ”.

22. Now the question arises whether the petitioner is entitled to leave encashment of three months in addition to the leave encashment of 240 days at the time of his retirement. In this regard the Ld. Counsel for the respondents has argued that the petitioner was granted leave encashment at various occasions/intervals and he has got the leave encashment for 24 time for the period of 552 days and the leave of 90 days as claimed by the petitioner does not fall within the policy formulated by the respondents. Policy was formulated with mutual understanding of the management and the employees of Indian Tourism Development Corporation. The policy is known as “wage agreement duly signed by joint action community and the management of ITDC w. c. f. 01-07-1978”. Since the claim of the petitioner with regard to the entitlement of leave encashment for the entitlement of leave encashment for three months pertains to the period prior to 01-07-1978, so he is not entitled to any relief. On the other hand counsel for the petitioner have referred the letter of M. S. Pathania, Manager of Jammu Motel, Jammu dated 13-10-1977 wherein strong recommendations were made by him for the release of leave encashment in favour of the petitioner.

23. L. C. for the respondents has further submitted that the claim of the petitioner was refused by Deputy General Manager(P) dated 19-07-1992, on the plea that the HCE Employees were entitled to benefits as per settlement signed with the trade union on 28-01-1980. Since the encashment of leave was not applicable to HCE employees as on 01-77 that is the date on which Shri Gupta was refused 90 days. The question of allowing him encashment of leave for the said period does not arise.

24. Definitely the respondents cannot be directed to deviate from the rules and regulations of the corporation or the agreement settled between the management and the employees of the ITDC. Now the question arises whether the Annexure-B entitles the petitioner to get leave encashment.

25. Perusal of Annexure-B reveals that "the leave applied for and refused can be encashed by the concerned employees only in the event of his quitting the service of Jammu Hotel provided such a provision exist in the Jammu and Kashmir Shops and Esstt. Act, 1966".

26. It is the admitted fact that petitioner applied for earned leave for three months w. e. f. 01-01-1977 and 30th March, 1977 but was not allowed to avail the leave because of non availability of his substitute. Meaning thereby he was not granted the leave applied for the same was refused. On refusal the leave of 90 days, the petitioner claimed encashment for the leave refused by the corporation. The perusal of Annexure "A" reveals that the leave applied for was recommended for its sanction for three months with some condition. Annexure "A" reads that it is advised that Shri Gupta may please be sanctioned 90 days Privilege Leave from 01-01-1977 to 31-03-1977 vide communication between Assistant Personal Officer(D) and the Manager, Jammu Motel. This letter now here implies that the petitioner was granted leave as applied for.

27. Two issues are involved for its adjudication :—

1. Whether the petitioner is entitled to get leave encashment for three months for the leave applied for.
2. Whether the provision J&K Shops Establishment Act, are applicable to Hotel Jammu Ashok (Motel).

28. So far as the first question is concerned in this regard as already discussed above, the petitioner could get the benefit of leave encashment for three months only in the event of his quitting the job. But not at the time of his retirement/superannuation. There is lot of difference between the retirement and the quit. Definitely the petitioner has not quitted the job which may entitled him to get the leave encashment for three months as claimed by him, as per the provisions of J&K Shops and Establishment

Act, 1966 but this is a case of superannuation and he has been sanctioned and paid leave encashment for 8 months i. e. 240 days at the time of his retirement and as per the rules and regulation of the ITDC. A communication was made by the General Manager, of Hotel Jammu Ashok, Jammu dated 10-08-2005 about the applicability of J&K House and Shops Establishment Act. The Ld. Assistant Labour Commissioner has clarified that the Provision of House and Shops Establishment Act, are not applicable to the unit of the respondents.

29. In this regard, the letter dated 19-07-2005 written by Deputy Labour Commissioner is self speaking that Hotel, Jammu is not covered under the J&K Shops and Establishment Act, 1960. He has further opined that in view the section 26(2) of the J&K House and Shops Establishment Act.—

“an employee is entitled to leave under sub-section 1 is discharged by his employer before he has been allowed the leave, or if having applied for and having been refused the leave, he quits his employment before he has been allowed the leave, the employer shall pay him the amount payable under section 27 of the leave ”.

30. In the backdrop of the discussions made herein above the petitioner is not found to any relief as claimed by him because of the reason that he has not quitted the job but superannuated and has got the leave salary of 240 days at the time of his retirement.

31. Since there is a bipartite agreement between the management and employees of ITDC and both the parties are under an moral as well as statutory obligation to comply with the terms and conditions of the agreement. None of the parties can be allowed to deviate from the terms and condition of the agreement signed between the parties. Since the parties have entered to an agreement by virtue of a memorandum signed by the management of the respondent and the Joint Action Committee of the employees and the rules with regard to non availability of the leave encashment were only made applicable w. e. f. 1978.

32. Since the claim of the petitioner for the encashment of earned leave for three months pertains to the period w. e. f. 01-01-1977 to 30-03-1977 which is much prior to the M. O. U. signed between the management of the respondents and its employees. Prior to the agreement signed between the parties, there was no provision for the leave encashment for the leave refused by the management. It is the admitted fact that the leave as claimed by the petitioner was never sanctioned so the question of its refusal does not arise. Supposingly for arguments sake only that the leave was sanctioned and refused by the management, that does not entitle the petitioner for any relief of encashment as there was no provision at the relevant time.

33. So far as the next question for determination of, "whether the provision of J&K Shops and Establishment are applicable" in this regard the letter written by the Assistant Labour Commissioner is self speaking and both the Ld. counsel for parties have fairly admitted that the provision of J&K Shops Establishment Act, are not applicable to the unit of the respondents. So, this issue is decided accordingly.

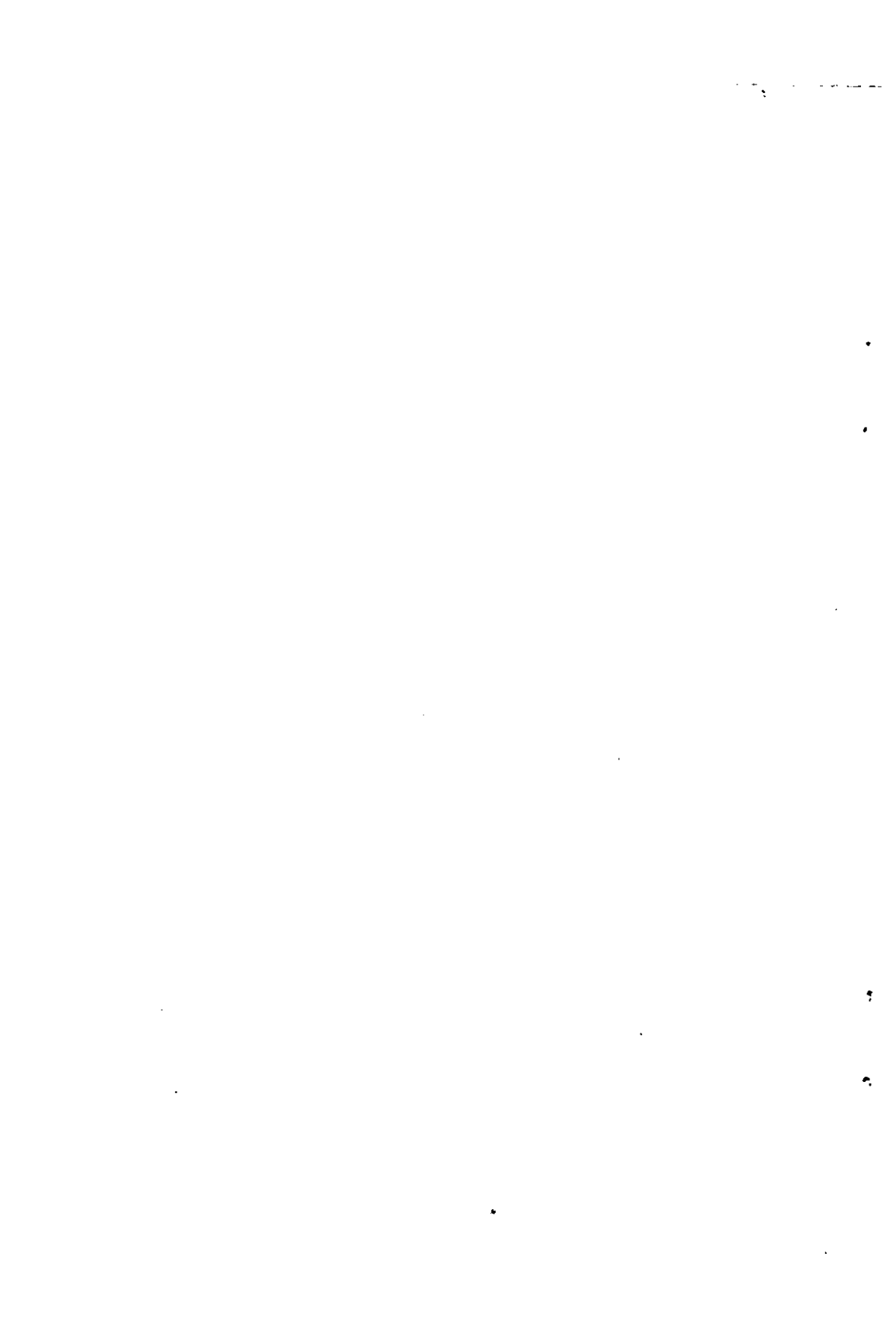

No. 3/4/ID/2014/SDR-Vol. I.—Whereas, section 61 of the Representation of the People Act, 1951 provides that with a view to preventing impersonation of electors, so as to make the right of genuine electors to vote under section 62 of that Act more effective, provisions may be made by rules under that Act for use of Elector Photo Identity Card for electors as the means of establishing their identity at the time of polling ; and

2. Whereas, Rule 28 of the Registration of Electors Rules, 1960, empowers the Election Commission to direct, with a view to preventing impersonation of electors and facilitating their identification at the time of

poll, the issue of Electors Photo Identity Card to electors bearing their photographs at State cost ; and

3. Whereas, Rules 49H (3) and 49K (2) (b) of the Conduct of Elections Rules, 1961, stipulate that where the electors of a constituency have been supplied with Electors Photo Identity Card under the said provisions of Rule 28 of the Registration of Electors Rules, 1960, the electors shall produce their Electors Photo Identity Card at the polling station and failure or refusal on their part to produce those Electors Photo Identity Card may result in the denial of permission to vote ; and

4. Whereas, a combined and harmonious reading of the aforesaid provisions of the said Act and the Rules, makes it clear that although the right to vote arises by the existence of the name in the electoral roll, it is also dependent upon the use of the Electors Photo Identity Card, where provided by the Election Commission at State cost, as the means of establishing their identity at the time of polling and that both are to be used together ; and

5. Whereas, the Election Commission made an Order on the 28th August, 1993, directing the issue of Electors Photo Identity Card (EPIC) to all electors, according to a time bound programme ; and

6. Whereas, Electors Photo Identity Card has been issued to more than 97% registered electors in the country ; and

7. Whereas, the Commission has directed that '**Authenticated Photo Voter Slip**' shall be distributed to the electors.

8. Now, therefore, after taking into account all relevant factors and the legal and factual position, the Election Commission hereby directs that for General Elections to the House of the People, 2014 and the State Legislative Assemblies of **Andhra Pradesh, Arunachal Pradesh, Odisha and Sikkim** and bye-elections from 27 Assembly Constituencies being held simultaneously, which have been notified/to be notified on 13-03-2014, 14-03-2014, 15-03-2014, 19-03-2014, 29-03-2014, 02-04-2014, 12-04-2014 and 17-04-2014, all electors who have been issued EPIC shall produce the EPIC for their identification at the polling station before casting their votes.

Those electors who are not able to produce the EPIC shall produce one of the following alternative photo identity documents for establishing their identity :—

- (i) Passport ;
- (ii) Driving License ;
- (iii) Service Identity Cards with photograph issued to employees by Central/State Govt. PSUs/Public Limited Companies ;
- (iv) Passbooks with photograph issued by Bank/Post Office ;
- (v) PAN Card ;
- (vi) Aadhar Card ;
- (vii) Smart Card issued by RGI under NPR ;
- (viii) MGNREGA Job Card ;
- (ix) Health Insurance Smart Card issued under the scheme of Ministry of Labour ;
- (x) Pension document with photograph ; and
- (xi) Authenticated Photo Voter Slip issued by the election machinery.

9. In the case of EPIC, clerical errors, spelling mistakes, etc. should be ignored provided the identity of the elector can be established by the EPIC. If an elector produces an Electors Photo Identity Card which has been issued by the Electoral Registration Officer of another Assembly Constituency, such EPICs shall also be accepted for identification provided the name of that elector finds place in the electoral roll pertaining to the polling station where the elector has turned up for voting. If it is not possible to establish the identity of the elector on account of mismatch of photograph, etc. the elector shall have to produce one of the alternative photo documents mentioned in Para 8 above.

10. Notwithstanding anything in Para 8 above, overseas electors who are registered in the electoral rolls under Section 20A of the Representation of the People Act, 1950, based on the particulars in their Passport, shall be identified on the basis of their original passport only (and no other identity document) in the polling station.

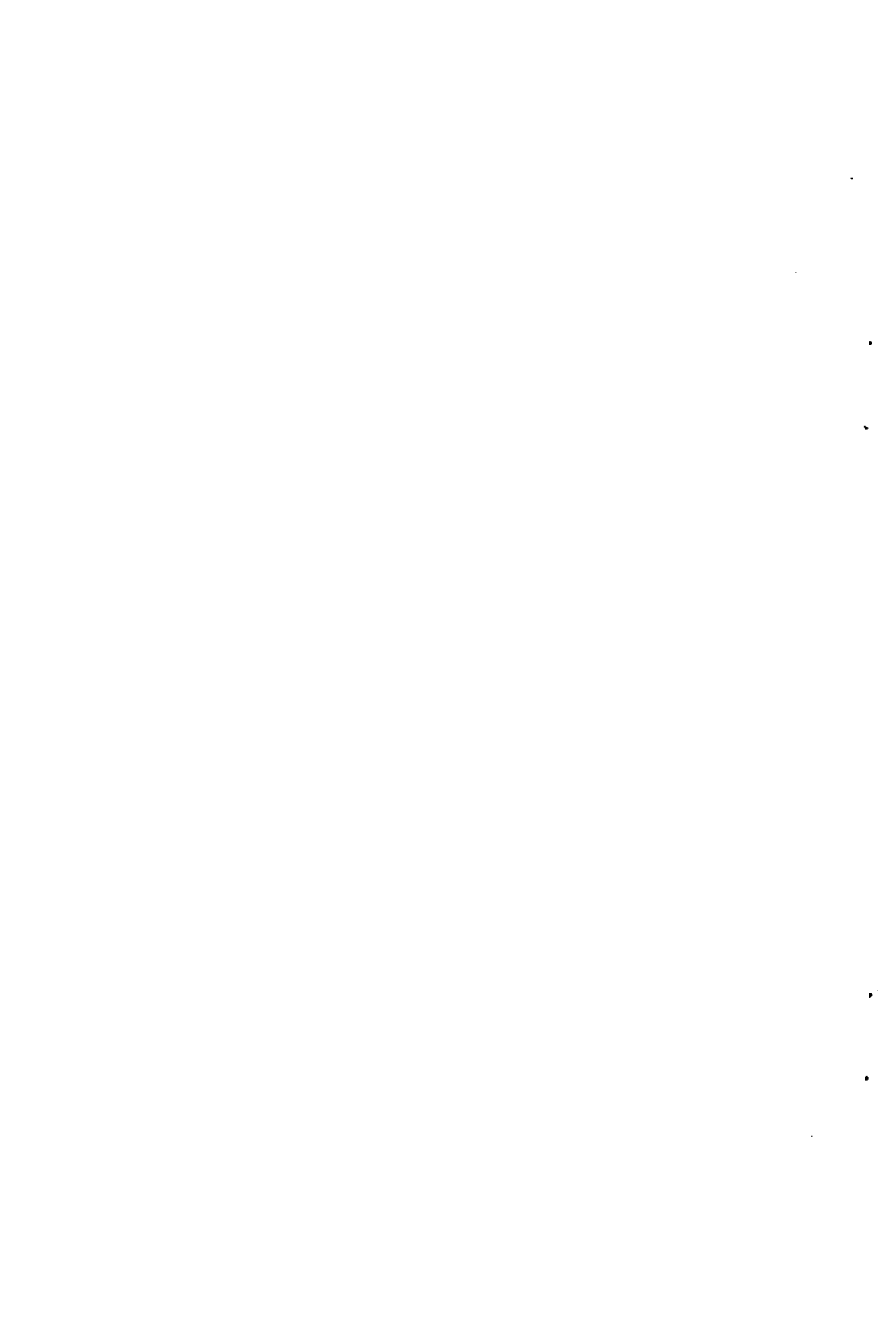

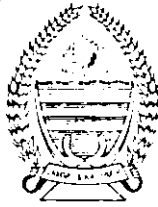

SRO-32.—In exercise of the powers conferred by the proviso to section 124 of the Constitution of Jammu and Kashmir, the Governor hereby makes the following rules, namely :—

1. *Short title and commencement.*—(1) These rules may be called the Jammu and Kashmir Employment (Subordinate) Service Recruitment Rules, 2014.

(2) They shall come into force from the date of their publication in the Government Gazette.

2. *Definitions.*—In these rules, unless the context otherwise requires,—

- (a) “Administrative Department” means the department of the Government in the Civil Secretariat holding the administrative charge of the service ;
- (b) “Board” means the Jammu and Kashmir Service Selection Board ;
- (c) “Cadre” means the cadre of the service as indicated in Schedule-I ;
- (d) “Government” means the Government of Jammu and Kashmir ;
- (e) “Head of the Department” means the Major Head of the Department holding the administrative control of the organization ;
- (f) “Member of the Service” means a person appointed to a post in the service under the provisions of these rules ;
- (g) “Post” means a permanent post carrying a definite time scale sanctioned by the Competent Authority ;
- (h) “Rules” means the Jammu and Kashmir Employment (Subordinate) Service Recruitment Rules ;
- (i) “Schedule” means the Schedule annexed to these rules ;
- (j) “Service” means the Jammu and Kashmir Employment (Subordinate) Service ;
- (k) “State” means the Jammu and Kashmir State ; and

“Words and expressions” used in these rules but not defined shall have the same meaning as are assigned to them in the Jammu and Kashmir Civil Service (Classification, Control and Appeal) Rule, 1956/Jammu and Kashmir Civil Service Regulations.

3. *Constitution of service.*—(1) From the date of commencement of these rules there shall be constituted the “Jammu and Kashmir Employment (Subordinate) Service”.

(2) The Government may, at the commencement of these rules, appoint to the service any person who at the commencement of these rules is holding substantively any post included in the cadre of the service :

Provided that for the purposes of initial constitution of service, the person holding any post in a substantive capacity to which he/she was appointed by the competent authority under rules included in the cadre of the service in its sanctioned scale of pay shall be deemed to have been appointed to the service under these rules if he/she is fully qualified to hold the post under these rules.

*Explanation :* The word holding means holding a post by a person included in the cadre of the Jammu and Kashmir Employment (Subordinate) Service in its sanctioned scale of pay on regular basis under orders of the competent authority and will not cover the person holding a post on ex-cadre/deputation basis or on ad hoc basis or in a stop-gap arrangement.

4. *Strength and composition of the service.*— (1) The authorized permanent and temporary strength of the cadre and the nature of the posts included therein shall be determined by the Government, from time to time shall, at the initial constitution of the service under these rules, be such as specified in the Schedule-I annexed to these rules :

Provided that the Government may create temporary posts in the cadre or the service for specified period or purpose as may be considered necessary from time to time.

(2) The Government shall, at the interval of every five years or at such other intervals as may be necessary, re-examine the strength and composition of the cadre of the service and make such alterations therein as it deems fit.

5. *Qualification and method of recruitment.*— (1) No person shall be eligible for appointment or promotion to any post in any class, category or grade in the service unless he/she possess the qualifications as laid down in the Schedule-II and fulfills other conditions of recruitment as provided in the rules and orders for the time being in force.

(2) Initial appointment to a service or class may be made

(a) by direct recruitment ; or

(b) by promotion ; or

(c) partly by direct recruitment and partly by promotion in the ratio and in manner as mentioned against each post in Schedule-II :

Provided that all the posts under direct recruitment shall be filled through J&K Service Selection Board as per the rules/orders of the Government issued for the purpose, unless any post/category of post is exempted from the preview of the board.

Provided further all posts to be filled by promotion/transfer shall be filled through Departmental Promotion Committee.

6. *Probation.*--(1) Persons appointed to the service, either by direct recruitment shall be on probation for two years and their confirmation for class or category shall be made under the provisions of Jammu and Kashmir Civil Services (Classification, Control and Appeal) Rules, 1956.

(2) The pay of a person appointed to the service under these rules shall be regularized as per the provisions of J&K Civil Service Regulations or general rules as issued from time to time.

7. *Reservation in appointments.* While making appointments either by direct recruitment or promotion, reservation shall be made in accordance with the rules and orders issued from time to time for members of Scheduled Castes/Scheduled Tribes/Backward Classes or any other category or class of permanent residents of State under the provisions of Jammu and Kashmir Reservation Act, 2004, and reservation rules in force.

8. *Training and Departmental Examinations.* --Persons appointed to the service by competitive examination shall be required to undergo such training from time to time during the course of probation and to pass during the period of probation such departmental examination as the Government may prescribe.

9. *Eligibility of Government Services for Direct Recruitment.*

A person already in the Government service may apply through proper channel for direct recruitment to a vacant post in any particular class or category in the service if he/she possesses the educational and other qualifications prescribed for recruitment to such class or category of post. The upper age limit of such Government servants shall be as provided in the general rules.

10. *Maintenance of seniority lists.* Seniority of the members of the service shall be regulated under the Jammu and Kashmir Civil Service (Classification, Control and Appeal) Rules, 1956. The Head of the Department shall maintain an up-to-date and final seniority list of members of the service.

11. *Residuary matters.* In regard to matters not specifically covered by these rules, the members of the service shall be governed by rules/regulations and orders applicable to the State Civil Service in general.

12. *Interpretation.* -If any question arises relating to the interpretation of these rules the matter shall be referred to the Administrative Department whose decision thereon shall be final and binding.

13. *Repeal and savings.* -(1) All rules corresponding to these rules and in force immediately before the commencement of these rules are hereby repealed.

(2) Notwithstanding such repeal, any appointment order, made action taken under the provisions of the rules so repealed, shall be deemed to have been made or taken under the corresponding provisions of these rules.
