Provided further that, no workshop of vehicles shall be permitted to operate near the water bodies. The concerned local authority, while

allowing use of any shop for repairing of vehicles, in its jurisdictions shall obtain prior no objection certificate from concerned District Magistrate and Regional Transport Officer”.

Whereas, to finalize and approve the market value and rates for the year 2014-15 in District Udhampur under section 74, read with section 27-A of the J&K Stamp Act, Svt. 1977 (Vol. XL of 1977), Tehsil Level Sub-District Valuation Committee under the Chairmanship of Assistant

Commissioner, Revenue, Udhampur in respect of Tehsil Chenani/Majalta and Udhampur and Sub-Divisional Magistrate, Dudu-Basantgarh in respect of Tehsil Ramnagar, were directed to assess and recommend fresh Stamp Duty Rates for the year 2014-15 to the District Level Committee.

Whereas, Sub-District Valuation Committee at Tehsil level vide their letter Nos. ACR/U/SQ/SDR-2014-15/3137 dated 20-03-2014, ACR/U/SQ/SDR-2014-15/3132 dated 18-03-2014 and ACR/U/SQ/SDR-2014-15/3048 dated 08-03-2014 has recommended their findings in respect of Tehsil Chenani, Majalta and Udhampur respectively and in respect of Tehsil Ramnagar, SDM, Dudu-Basantgarh vide letter No. SDM/DB/921 dated 20-03-2014 has assessed and recommended the findings to the District Level Committee ;

Whereas, District Valuation Committee (DVC) headed by Deputy Commissioner, Udhampur examined the proposal in depth in a meeting held on 4-03-2014 and further submitted its recommendations for approval to Divisional Valuation Board (DVB) headed by Divisional Commissioner vide this office No. DCU/SDR/2014-15/SQ/3149-53 dated 25-03-2014 ;

Whereas, Divisional Valuation Board (Divisional Commissioner), Jammu has accorded their approval with regard to the rates in respect of District Udhampur under the Jammu and Kashmir Stamp Act, Svt. 1977 (Vol. XI of 1977) endorsed vide No. CSSJ/1081-1091 dated 29-03-2014 for the year 2014-15. The District Valuation Committee, Udhampur shall notify these rates for the year 2014-15 in terms of sub-rule (1) of rule 4 of SRO-303 dated 04-10-2011 read with SRO-379 dated 22-12-2012. These rates shall remain in force from 1st April, 2014 to 31st March, 2015 ;

Whereas, after thorough deliberations, the Divisional Valuation Board also approved that in rural areas, the rates of the 'unirrigated lands' shall be applicable to 'uncultivable lands' if, the rates for 'uncultivable land' have not been proposed by the District Valuation Committee. In urban areas where the nature of the land is not already classified as 'residential' or 'commercial', the rates of 'residential' or 'commercial' would be applicable

depending on the land use of the said land as defined in the Master Plan of the area ;

Whereas, so far as classification of land falling in notified urban areas having master plan, the use permitted shall be the basis for calculation of the Stamp Duty but where there is no master plan for a notified urban area the recourse of provisions of sections 31 & 32 of Jammu and Kashmir Stamp Act, Svt. 1977 will be applicable for calculation of the Stamp Duty Rates ;

Whereas, with regard to Stamp Duty fixation for falling partially within the notified areas, the Stamp Duty rates in the urban areas of villages will be assessed as per the Khasra Nos. notified by the Government for the Urban Local Bodies and the remaining areas shall be assessed as per Stamp Duty Rates for rural areas ;

Whereas, the Divisional Valuation Board approved that the rates of the prevailing PWD Schedule of Rates (SoR) for Jammu Division, fixed by the CE, R&B, Jammu shall be applicable while determining the value of a building as per Form-II of Jammu and Kashmir Preparation of Revision of Market Value Guidelines Rules, 2011 (SRO-303 of 2011).

Now, since the polling has been completed in the State, the Election Commission of India has observed as under :—

“.....all normal administrative work/development activities of the State of Jammu and Kashmir and Uttrakhand may now be taken up, except in such districts where re-poll, if any, is pending.”

No officials connected with the conduct of elections can be transferred till the entire election process is completed and no review meetings can be held by the Ministers or any other political functionaries with the election related officials”.

The above instructions are brought to the notice of all the concerned for taking further action keeping in view the relaxed conditions conveyed by the Election Commission of India.

Government Order No. 475-GAD of 2014

Dated 13-05-2014.

In amplification of Government Order No. 394-GAD of 2014 dated 04-04-2014, it is hereby ordered that :—

- (i) the payment of ex-gratia compensation to family of polling personnel who die or sustain injuries while on election duty will be applicable to all personnel deployed in all types of election related duties. all security personnel including (CAPFS, SAPs, State Police, Home Guards, etc), any private persons like drivers, cleaners, etc. hired for deployment for election duty.
- (ii) the applicable period of election duty would start from the date of the announcement of the elections.
- (iii) it would be resonable to consider a person on election duty as soon as he/she leaves his/her residence/office to report for any election related duty including training and until he/she reaches back his/her residence/office after performance of his/her election related duty. If any mishap takes place during this period, it should be treated as having occurred on election duty subject to condition that there should be a causal connection between occurrence of death/injury and the election duty.
- (iv) the payment of ex-gratia compensation prescribed by the Commission vide its letter dated 25-03-2014 will also be applicable to the CAPs/SAPs and other security forces personnel deployed for the election duty and this will be in addition to the compensation already being paid by the MHA under extant guidelines issued by DOP and PW, MHA and State Governments.
- (v) the expenditure on account of payment of ex-gratia compensation to the Polling personnel is wholly borne by the Government of India during election of Lok Sabha and by the State Government during elections to the Legislative Assemblies and shared on a 50:50 basis during simultaneous elections to the Lok Sabha and Legislative Assembly by the Government of India and concerned State Governments. The share of the Government of India is paid by the Ministry of Law, Justice and Company Affairs (Legislative Department).
- (vi) in case of Lok Sabha elections, the payment of ex-gratia compensation shall be made by the State Government initially and the claims shall be made to the Government of India later on.

- (vii) the CEOs and DEOs shall track death/injury cases and send a consolidated report from time to time to the Commission.

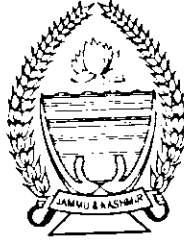
