3. If the Video Conferencing facility is not available in any office listed above, the officers shall attend the conference at the nearest available facility, irrespective of the service.

4. The State Civil Services Officers, shall also participate in the celebrations at the nearest available venue, if not busy with official work.

5. The Heads of the Offices, in whose offices the Civil Services Day will be celebrated, shall also organize the conduct of workshops on the themes of Good Governance, Delivery of the Public Services, and Rural and Urban Sanitation.

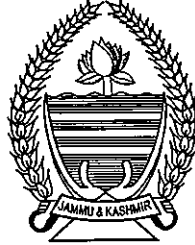

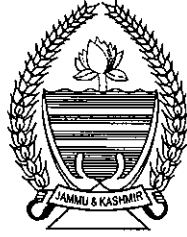

SRO-147.—In exercise of powers conferred by sub-section (1) of section 12 of the Code of Criminal Procedure, Samvat 1989, the Government hereby appoint Shri Irshad Ahmad Budoo, Tehsildar, in Divisional Commissioner, Kashmir to be the Executive Magistrate of the First Class who shall exercise all the powers of an Executive Magistrate of the First Class with such jurisdiction as may be assigned to him by the Divisional Commissioner, Kashmir.
