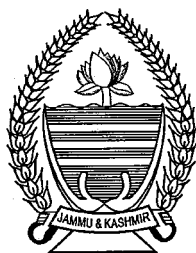

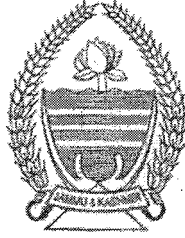

**THE JAMMU AND KASHMIR CURBING THE MENACE  
OF STRAY DOGS BILL, 2015.**

[L. A. Private Members' Bill No. 5 of 2015.]

A Bill to regulate and control the dangerous, menacing or breed of stray dogs in the State.

Be it enacted by the State Legislature in the 66th Year of the Republic of India as follows :—

1. *Short title and commencement.*—(1) This Act may be called the Jammu and Kashmir Curbing the Menace of Stray Dogs Act, 2015.

(2) It shall come into force from the date of its publication in the Government Gazette.

2. *Definitions.*—

- i. "Act" means the Jammu and Kashmir Curbing the Menace of Stray Dogs Act, 2015 ;
- ii. "Authority" means any authority as designated by the State Government ;
- iii. "Stray Dogs" means the dogs which are not under the control of anybody and are wandering from place to place ;
- iv. "Government" means the Government of the State of Jammu and Kashmir.

3. *Curbing the population of stray dogs.*—The Government should make every effort to curb and check the population of stray dogs without any failure and should make use of scientific technology to control such menace.

4. The Authorities of Municipal Corporation and the Municipal Committee besides the members of Panchayati Raj Institutions should



be allowed to assign the job of restricting the population of most dangerous stray dogs to such persons as prescribed under rules :

Provided that in extreme cases killing of dogs may also be allowed by the Government, after seeking permission from the Tehsildar concerned.

5. *Compensation to the victims' of dogs.*—The Government shall pay compensation—

- i. to the tune of Rupees ten lacs to the next of kin of the deceased, if any, person is killed by a stray dog ;
- ii. to the tune of Rupees five lacs or rupees one lac, as the case may be, if a person is disabled/diseased as to be beyond recovery or is partially disabled by an injury caused by a stray dog.

6. *Power to make rules.*—The Government may by notification in the Government Gazette, make rules for carrying out the purpose of the Act.

---

**STATEMENT OF OBJECTS AND REASONS**

It is evident from the last several years that the population of stray dogs have increased manifold resulting in causing many deaths and injuries to a number of persons particularly little kids. People in general and children in particular feel insecure to venture out their homes for day to day work and schools. If this population of the dogs is not checked at this point of time it will prove disastrous for the society as such strict law on the subject is inevitable.

Hence the Bill.

**THE JAMMU AND KASHMIR FOREST (AMENDMENT)  
BILL, 2015.**

[L. A. Private Members' Bill No. 7 of 2015.]

A Bill to amend the Jammu and Kashmir Forest Act, Svt. 1987 (1930 A. D.).

Be it enacted by the Jammu and Kashmir State Legislature in the 66th Year of the Republic of India as follows :—

1. *Short title and commencement.*—(1) This Act may be called the Jammu and Kashmir Forest (Amendment) Act, 2015.

(2) It shall come into force from the date of its publication in the Government Gazette.

2. *Amendment of section 26.*—In sub-section (2) of section 26 of the Forest Act, Svt. 1987, the words “Divisional Forest Officer” be substituted by words “Judicial Magistrate of the 1st Class”.

---

**STATEMENT OF OBJECTS AND REASONS**

While dealing with the confiscation proceedings the Divisional Forest Officer is an authorized officer in terms of section 26 (2). He is not a law knowing person and therefore is not acquainted with the legal niceties of a case. While terminating any confiscation proceeding though belatedly he assumes the position of a Judge in his own cause and the justice gets derailed. The proceedings are not conducted in judicious manner and the cases get linger on thus prolonging the justice delivery in such cases, which dents the legal principle that justice delayed is justice denied. Therefore, it becomes imperative to vest the powers of being authorized officer in the hands of Judge for the purpose so that the cases are decided as per the provisions of law and expeditiously.

Hence the proposed amendment.

(Ordinance No. I of 2015)

[30th May, 2015.]

Promulgated by the Governor in the Sixty-sixth Year of the  
Republic of India.



An Ordinance to amend the Jammu and Kashmir Legal Services Authorities Act, 1997.

Whereas, the State Legislature is not in session and the Governor is satisfied that circumstances exist which render it necessary for him to take immediate action.

Now, therefore, in exercise of the powers conferred by section 91 of the Constitution of Jammu and Kashmir, the Governor is pleased to promulgate the following Ordinance :—

1. *Short title and commencement.*—(1) This Ordinance may be called the Jammu and Kashmir Legal Services Authorities (Amendment) Ordinance, 2015.

(2) It shall come into force at once.

2. *Amendment of section 3, Act No. XXXIII of 1997.*— In section 3 of the Jammu and Kashmir Legal Services Authorities Act, 1997 (hereinafter referred to as ‘the principal Act’), sub-section (3) shall be substituted by the following, namely :—

“(3) The Government may, in consultation with Chief Justice of the High Court, appoint a person belonging to the Higher Judicial Service, not lower in rank than that of a District Judge, as the Member-Secretary of the State Legal Services Authority, to exercise such powers and perform such duties under the Executive Chairman of the State Authority as may be prescribed by the Government or as may be assigned to him by the Executive Chairman of the State Authority.”
