The Dates of Birth of the members as reflected in the Final Seniority List shall be subject to authentication and verification from the Service Book/ Date of Birth Certificate of the concerned employee, as envisaged under rules.

The Reserved Category status of the officials in the Final Seniority List shall be subject to authentication and verification from the competent issuing authority at the time of placement/regularization against higher posts.

If the Reserved Category Certificate(s) furnished by any official turns out to be false/fake lateron, the same shall deemed to have been cancelled *ab initio* along with all such benefits which the official(s) would have availed on the basis of such false/fake certificates. Besides, action under rules shall also be taken against him/her.

1. Examination Fee :

2. Centre of Examination :

Final Award

On the indent of Project Director, NHAI, PIU, Jammu vide his office letter No. PD/JMU/15011-5633 dated 10-01-2007, land acquisition proceedings were initiated under Jammu and Kashmir State Land Acquisition Act, 1990 BK, situated at Village Mand, Tehsil and District Udhampur for widening of National Highway up to its four lanning. The revenue documents were got prepared for the land under acquisition from the revenue field agency and the Indenting Department was requested to authenticate the same which were returned duly authenticated by the Indenting Department.

Accordingly, notification under section 4 (1) of Land Acquisition Act No. X of Svt. 1990 was issued by this Collectorate vide No. LA/ADC/613-17 dated 20-06-2007 and was served upon the owners/interested persons through Tehsildar, Udhampur. The land owners/interested persons

have not filed any objection in response to the notification issued under section 4 (1) of Land Acquisition Act within the stipulated period.

Thereafter, the Financial Commissioner, Revenue, Jammu and Kashmir Government was requested vide this Collectorate letter No. LA/ADC/761-64 dated 30-08-2007 for issuance of declaration under sections 6, 7 and 17 of Land Acquisition Act. The Financial Commissioner, Revenue Jammu and Kashmir Government has issued declaration under sections 6&7 vide Notification No. 178/FC of 2007 dated 19-11-2007 under endorsement No. FC-LS/LA-2569/07 dated 19-11-2007 under sections 6, 7 and Notification No. 03-RD of 2008 under endorsement No. Rev(LAJ) 180/2007 dated 02-07-2008 under section 17 is issued for land measuring 1577 Kanals 11 Marlas. Thereafter, this office has requested to FC revenue (J&K Govt.) to modify the declaration under sections 6, 7 and 17 of the Land Acquisition Act issued vide declaration No. 178/FC of 2007 and Revenue Department's Notification No. 03-RD of 2008 for land measuring 553 Kanals 4 Marlas falling under Khasra No. 1856/1745/313 (47K-03M), 1719/1618/706 (44K-18M), Khasra No. 34 Min (142K-08M), Khasra No. 336 (52K-08M), Khasra No. 561 min (17K-05M), Khasra No. 708 min (95K-10M) and Khasra No. 869 min (153K-12M). The Financial Commissioner (Rev.), J&K, Jammu vide endorsement No. FC-LS/LA-2569/06 dated 22-12-2011 modified the declaration under sections 6&7 of the Act made vide No. 178/FC of 2007 dated 19-11-2007 deleting the area measuring 553 Kanals 04 Marlas. Accordingly, Revenue Department, Civil Secretariat, J&K Govt. vide No. Rev/LAJ/180/07 dated 06-02-2012 de-notified the notification, under section 17 of Land Acquisition Act, issued vide No. 03-RD of 2008 dated 02-01-2008 for land measuring 553K-04M.

Consequent upon this, notification under sections 9&9 (A) vide this Collectorate No. LA/ADC/52-54 dated 10-06-2008 was issued and got pasted on conspicuous places for information of the land owners/interested persons and was also served upon the Indenting Department to State their respective claims with regard to compensation and to intimate their objections, if any, regarding measurement of land and compensation.

Principle of compensation :

The Tehsildar, Udhampur at the time of preparation of revenue documents has intimated vide his office letter No. 1593/OQ dated 27-01-2007 the three years sale deed rate @ Rs. 13,757/- per Kanal. The Tehsildar, Udhampur recommended market rate of the tune of Rs. 3.00 (three lakh) per Kanal. The land under acquisition falls alongside the Jammu-Srinagar National Highway and carries a great commercial/potential value. The developmental activities are going on very fast day by day. The population is eager to settle themselves nearer to the land under acquisition. Therefore, a rate of Rs. 3.00 Lakh (Rupees Three Lakh only) per Kanal irrespective of classification of kind of soil was proposed in this case. The above said proposed rate was discussed in the committee of Collector's Chaired by Deputy Commissioner-cum-District Collector, Udhampur on 28-10-2009, in which the rate of Rs. 2.00 lakh (two lakh) per Kanal for cultureable land, Rs. 1.00 lakh per Kanal for BQ (Banjar Qadeem) land and Rs. 0.75 lakh for GM (Gair-Mumkin) type of land was approved in the instant case.

Since some structures, fruit bearing and non-fruit bearing trees have come within the alignment. The Superintending Engineer, PWD (R&B), Circle Udhampur and Executive Engineering, PWD (R&B) Division, Udhampur assessed the structures and communicated assessment reports to this Collectorate vide their Nos.
