Whereas, the land, specifications whereof are given in Annexure "A" to this notification, is required for public purposes viz for widening of Reasi-Arnas Road by GREF ; and

Whereas, on the basis of an indent placed by Officer Commanding, 110 RCC, GREF vide No. 2100/RAM/LA/110/E2 dated 17-08-2010, a notification under section 4(1) was issued by Collector, Land Acquisition (ADC), Reasi for land measuring 34 Kanals-01Marla & 01½ Sirsai situated in Village "Gran", Tehsil & District Reasi ; and

Whereas, the notification issued by the Collector, Land Acquisition (ADC), Reasi under section 4(1) of the J&K State Land Acquisition Act, was served upon the interested persons for filing objections ; and

Whereas, the Collector, Land Acquisition (ADC), Reasi, vide his letter No. Col/LA/ADC/RSI/15/354-357 dated 04-09-2015 has informed that some land owners have filed objections with the plea that they have received the land compensation for 20-30 feet width of road earlier acquired but the field staff has shown the width of earlier road as 50 feet ; and

Whereas an opportunity of being heard was given to all the objectors by the Collector, Land Acquisition (ADC), Reasi, and it has been found that objections filed by them are devoid of merit and are liable to be maintainable ; and

Whereas, the report furnished by Collector, Land Acquisition (ADC), Reasi vide letter referred to above, duly endorsed by Deputy Commissioner, Reasi vide No. DC/RSI/15-16/1691-92/SQ dated 08-09-2015, Divisional Commissioner, Jammu vide No. 502/2490/widening/Rsi-Arnas-Road/Gran/15/1888-90 dated 19-10-2015 and Financial Commissioner (Revenue), J&K vide his No. FC-LS/LA-4421/2015 dated 11-04-2016, concludes that the objections filed by the land owners are not maintainable and are liable to be rejected ; and

Whereas, the Government is satisfied on the basis of the report as aforesaid that the land particulars whereof are mentioned in Annexure "A" to this notification, is required for public purpose viz. for widening of Reasi-Arnas Road by GREF.

Now, therefore, in pursuance of Section 6 of the J&K State Land Acquisition Act, Samvat, 1990, It is declared that the 34 Kanals-01 Marla and 01½ Sirsai situated in Village "Gran", Tehsil and District Reasi, details whereof are indicated in Annexure "A" to this notification is required for public purposes i.e. for widening of Reasi-Arnas Road by GREF. Further, the Collector, Land Acquisition (ADC), Reasi is directed under section 7 of the said Act to take order for acquisition of the said land after giving prescribed notice to the interested person(s) as required under the Land Acquisition Act/Rules.

However, the Collector, concerned shall be personally responsible for proper title verification of all types of land involved in the case and

apportionment of compensation in respect of all the interested persons/rightful claimants in accordance with the relevant laws/rules in force, while making final award in the case.

Subject :—Partial modification of under section 144 Cr. P. C. for prohibition of sale of meat and liquor.

Whereas, it has been made to appear to me that sale of meat and liquor had been prohibited in Katra town and Bhawan Vaishno Devi by virtue of "Prohibition of Sale of Meat and Liquor" vide Notification

No. 19 issued by the then Prime Minister under endorsement No. G. B. 211 dated 21st January, 1933 during pilgrimage period i. e. approximately October to December to upkeep the sanctity and sacredness of the Holy Shrine and its adjoining area ;

Whereas, it has further been made to appear to me that now yatra to the Holy Cave had increased manifold and thousands of devotees from all over the country and abroad are visiting the Holy Shrine, every day, throughout the year. Thus, the requirement of prohibition of sale/possession/consumption of liquor and non-vegetarian food such as Eggs, Chicken, Meat, Mutton, Sea Food, Fish, Prawns, Lobster etc. has become expedient to be extended in time of uphold the religious sentiments of yatris and holiness of the pilgrimage and also to be extended in area to areas adjoining Katra town as whole of the area is used for yatra ;

Whereas, as per directions of Hon'ble High Court in OWP No. 03-03-2014 CMA No. 389/2014, Tehsildar, Reasi was asked to seek opinion of public of these villages on this issue and send report along with his recommendations, Tehsildar, Reasi had submitted his report along with recommendations.

Now, therefore, taking into consideration the opinion of public of these villages and in supersession of all earlier orders, I, Neelam Khajuria, KAS, Sub-Divisional Magistrate, Katra by virtue of powers vested in me under section 144 Cr. P. C. do hereby prohibit sale/possession/consumption of liquor and non-vegetarian food such as Eggs, Chicken, Meat, Mutton, Sea Food, Fish, Prawn, Lobster etc. in the following area of Katra :—

1. Track of Holy Cave to Katra and villages on both sides of track having distance up to 2 Kms. from track.
2. Katra Town, Village Arli, Hansali, Matyal up to Railway Station.
3. Tikri road including Villages Chamba, Serli and Bhagta.
4. Jammu road including Village Kundrorian, Kotli Bajallian, Nomain and up to Maghal.
5. Katra-Reasi road : 100 Meters on the both side of road from Katra to Nau Devian and Aghar Jitto and Nau Devian Markets.

This order shall remain in force for two months from the date of its issue.

The following Ordinance as promulgated by the Governor on
16th February, 2017 and is hereby published for general
information :—

THE JAMMU AND KASHMIR PANCHAYATI RAJ
(AMENDMENT) ORDINANCE, 2017

(Ordinance No. 1 of 2017)

[16th February, 2017.]

Promulgated by the Governor in the Sixty-eighth Year of the
Republic of India.

Whereas, the Jammu and Kashmir Panchayati Raj (Amendment) Ordinance, 2016 (Ordinance No. II of 2016) was promulgated by the Governor on 12th December, 2016 ;

And whereas, the Bill to replace the said Ordinance could not be introduced in the State Legislature ;

And whereas, after passing of The Jammu and Kashmir Panchayati Raj (Amendment) Act, 2016 (Act No. XIII of 2016), certain consequential amendments are required to be made in the Jammu and Kashmir Panchayati Raj Act, 1989 ;

And whereas, the State Legislature is not in session and the Governor is satisfied that circumstances exist which render it necessary for him to take immediate action.

Now, therefore, in exercise of the powers conferred by section 91 of the Constitution of Jammu and Kashmir, the Governor is pleased to promulgate the following Ordinance :—

1. *Short title and commencement.*—(1) This Act may be called the Jammu and Kashmir Panchayati Raj (Amendment) Ordinance, 2017.

(2) It shall come into force with effect from 13th of February, 2017.

2. *Amendment of section 4, Act No. IX of 1989.*—In section 4 of the Jammu and Kashmir Panchayati Raj Act, 1989 (hereinafter referred to as the 'principal Act'), in sub-section (3), in first proviso thereto, the words, "to be filled by the direct elections" shall be omitted.

3. *Amendment of section 36, Act No. IX of 1989.*—In section 36 of 'the principal Act', in sub-section (1), the

second proviso thereto shall be substituted by the following, namely :—

“Provided further that for purposes of holding general elections under this Act in the year 2017, the superintendence, direction and control of the preparation of electoral rolls and conduct of, all elections in accordance with this Act shall vest in the Chief Electoral Officer.”

4. *Amendment of section 36-D, Act No. IX of 1989.*—
In section 36-D of the ‘principal Act’, in sub-section (2), after clause (cc) the following proviso shall be inserted, namely :—

“Provided that for the purposes of holding general elections under this Act in the year 2017, the power to determine and delimit halqa panchayats in accordance with this Act shall vest in the Chief Electoral Officer.”

5. *Repeal and saving.*—(1) The Jammu and Kashmir Panchayati Raj (Amendment) Ordinance, 2016 (Ordinance No. II of 2016) is hereby repealed.

(2) Notwithstanding any such repeal, anything done or any action taken or any order issued under the aforesaid Ordinance, shall be deemed to have been done, taken or issued under the corresponding provisions of this Ordinance.
