Subject :—Annual Darbar Move of Offices from Jammu to Srinagar for
the Summer Season, 2017.

Government Order No. 466-GAD of 2017

Dated 12-04-2017.

It Is hereby ordered that :

1. The offices, as indicated at Annexures “A” and “B” to this order shall move to Srinagar, ‘In Full’ and ‘In Camp,’ respectively for

the Summer Season-2017. The offices observing five-day week shall close at Jammu on 28th April, 2017 (Friday) after the office hours and the offices observing six-day week shall close on 29th April, 2017 (Saturday) after the office hours. All the offices shall reopen at Srinagar on 8th May, 2017 (Monday). All the departments shall ensure that records are packed in boxes after the working hours on the last working day.

2. The offices moving in camp shall carry only 33% of the staff strength in that particular office or 10 officials, whichever is minimum or otherwise, as specifically indicated.
3. All the departments shall depute their advance parties on 24th April, 2017 (Monday), consisting of one Gazetted Officer and four to five Non-Gazetted Employees who shall receive the records at Srinagar.
4. The departments shall ensure that records are properly packed in boxes/trunks and their keys reach the advance parties at Srinagar, well in time. The SP, Security, Civil Secretariat shall furnish a list of defaulting departments in this regard to the Government (General Administration Department) at Srinagar.
5. J&K SRTC shall make available sufficient number of buses in good condition for transportation of Srinagar-based employees on 29th and 30th April, 2017 and Jammu-based employees on 6th and 7th May, 2017. The booking of buses shall be for destination of the employees, wherever feasible. Tickets shall be issued by the SRTC in advance i. e. from 21st April, 2017, both from the Civil Secretariat as well as from the main booking counters of SRTC.
6. J&K SRTC shall also make available trucks for shifting the records from Jammu to Srinagar. The trucks shall be requisitioned by the departments from SRTC and the departments shall draw advance for meeting carriage and packaging charges. The trucks shall be allowed to enter the Secretariat premises, Jammu on

29th April, 2017. Loading of trucks shall commence on the day following the last working day. Loading of records in the offices located outside the Secretariat Premises observing six-day week shall take place after the working hours on the last working day. The loaded trucks shall leave for Srinagar on 30th April, 2017, in a convoy.

7. S.P. (Security), Jammu will supervise the packing/loading of records of the offices located outside the Secretariat from the security point of view and issue clearance certificates to the Drivers who, in turn, shall show them to the SP (Security), Civil Secretariat to allow them to be included in the convoy. The SP (Security), Civil Secretariat shall ensure entry of trucks/records in the Civil Secretariat, Jammu/Srinagar after proper scrutiny.
8. J&K SRTC shall ensure that one crane, two empty buses and two empty trucks accompany the convoy on the respective days so that the employees do not face inconvenience due to any break down of buses/trucks on the way. Mobile workshop(s) shall also accompany the convoy.
9. J&K Police shall escort the convoy carrying employees and the 'Records Convoy' all along the route upto their respective destinations besides also ensuring that the move convoy is given precedence in crossing the Chenani-Nashri Tunnel and the Jawahar Tunnel. The Director General of Police will issue necessary guidelines to the field agencies accordingly.
10. The Health and Medical Education Department shall arrange medical aid facilities at Jhajjarkotli, Udhampur, Chanderkote, Ramsu, Banihal and Qazigund on the days when the employees travel from Jammu to Srinagar. The Commissioner/Secretary to the Government, Health and Medical Education shall issue necessary instructions in this behalf to the Directorates of Jammu and Kashmir Division, accordingly.

11. No moving employee shall occupy any Government/ E. P./Municipal/Residential accommodation except under proper allotment order. However, the employees can retain the Government accommodation allotted to them at Jammu for *bona fide* use of their families under intimation to the Estates Department on approved terms and conditions.
12. The moving employees having Ration Cards at Jammu shall surrender them to Director, Food, Civil Supplies and Consumer Affairs Department, Jammu and obtain a surrender certificate. The Director, Food, Civil Supplies and Consumer Affairs Department, Kashmir shall issue Ration Cards to the move employees at Srinagar on the opening of offices.
13. The employees who desire to move without families may retain the Ration Cards at Jammu for the summer season.
14. Special Move T. A. shall be paid at the uniform rate of Rs. 15,000/- per move employee. This shall be drawn and disbursed in advance. Special move T. A. shall not, however, be payable to such of the employees who do not move before/within the prescribed date.
15. Advance pay shall also be authorized in terms of Rule 14.26 of the J&K Financial Code (Vol-I) in favour of such of the Non-Gazetted moving employees who may apply for the same, which shall be recoverable in installments as per rules.
16. Salary for the month of April, 2017, in respect of all the employees working in the move offices, shall be drawn on 21st April, 2017.
17. No leave shall be admissible in combination/continuation of move days except under very exceptional circumstances. The concerned Administrative Secretaries shall sanction leave, whatever due, under very exceptional circumstances only.

18. All the Administrative Departments shall detach the staff, if any, attached by them from the subordinate offices of Jammu Division by or before 26th April, 2017. The S. P. (Security), Civil Secretariat shall withdraw the temporary identity cards from the attached staff and submit a report to the General Administration Department before closure of offices in Jammu.
19. The office timings on the reopening of offices at Srinagar shall be as under :—

Civil Secretariat and Heads of Departments located within the Civil Secretariat premises. 9:30 A. M. to 5:00 P. M.

All Moving Heads of Departments located outside the Civil Secretariat and observing six days a week. 10:00 A. M. to 4:00 P. M.

Award

To put in brief the Government of J&K vide its Notification No. 89 dated 22nd March, 2010, referred the above titled Industrial Dispute to this Court under section 10(1) (c) of the I. D. Act for adjudication on the following issues :—

1. Whether the management is legally justified in withholding the salary of its aforesaid workmen for the month of July and August, 2008 ?
2. If so, to what relief the said workmen are entitled to ?

On receipt of the reference, notices were issued to the parties who appeared and filed their respective claims/objections.

The claim of the petitioners is that their wages for the month of July and August, 2008 were withheld by the respondent for no fault of the petitioners because there was Jammu Band during the Amar Nath Shrine Board dispute and Curfew was also imposed by the State Government taking into consideration the Law and Order situation. The petitioners have not intentionally absented from the factory for some days in July, 2008 and few days in August, 2008. It was out of their control to come to the factory because no traffic was allowed due to Jammu Band and the Curfew imposed by the Government. The respondent, even aware of the circumstances, had not provided any transport to the petitioners so as to enable them to attend their duties. The petitioners have alleged that the action of respondent in withholding the wages of the petitioners is illegal and have prayed for release of their wages for July and August, 2008.

The respondent in their objections have simply stated that the wages of the petitioners were withheld because they had absented themselves from the factory. The respondent had, as such, claimed that their action in withholding the wages of the petitioners for July and August, 2008 is genuine and legal. They have prayed for dismissal of the claim of the petitioners.

The respondents have claimed that they have paid the wages to petitioners for the month of July and August, 2008 and have submitted the receipts in photostat. But failed to produce the original record despite

repeated directions as mentioned in the interim orders. Therefore cannot be relied up that they have paid the wages for these two months to petitioners as they have not produced the original record, in this regard, despite directions from the Court.

In terms of interim order dated 05-11-2011, this Court has held that the points referred for adjudication by the Government be treated as issues in the case and the parties were directed to adduce evidence on these issues.

During the course of recording evidence, the A/R for respondent Sh. Kuldip Khajuria has given statement at bar as recorded in interim order dated 10-02-2015 that they shall pay the reference amount to the petitioners, his signature is also recorded in the interim order dated 10-02-2015. Even on 03-03-2015 A/R for the respondent had again undertaken to pay the amount in question to the petitioners but after that on the following date of the hearing again disputed the claim of the petitioners and as such the case was again posted for recording of evidence.

The parties have filed written statement of witness in the shape of affidavits and the witness were cross-examined by the opposite side. The evidence was finally closed and the case was fixed for final arguments.

The parties have filed their arguments in writing.

I have perused the arguments filed by both the parties and have gone through record available on the file and the evidence produced by the parties.

It is evident from the record, evidence and other material available on record that due to Jammu Band and the Curfew imposed by the State Government in the year 2008 during the Amar Nath Shrine Board dispute some workers (the petitioners) have not attended the respondent factory for some days in the months of July and August, 2008. It was out of control of petitioners to attend their duties due to non-availability of transport during the Band and Curfew. It is an admitted fact that during these days of disturbance so many workers either to the private sector or of Government Departments did not reach there place of posting due to Curfew or Jammu Band, but their wages were not deducted by their respective management/department because the situation was not under

the control of the employees/workers. As such the same facts applies to the case of petitioners. As stated above, the respondent has in the open Court agreed to pay the withheld amount of salary to the petitioners but later on withdraw their commitment.

For the foregoing reasons and observations made, hereinabove, I hold that the respondent has illegally withheld the salary of the petitioners for the months of July and August, 2008. As such Issue No. 1 referred for adjudication by the Government to this Court is decided against the respondent and in favour of the petitioners.

As a relief mentioned in Issue No. 2 the petitioners are held entitled to receive the full salary of July and August, 2008 from the respondent. Therefore, the respondent is directed to make the payment of withheld salary for the month of July and August, 2008 to the petitioners along with interest @ 8% per annum forthwith.

An Award is accordingly passed in favour of the petitioners and against the respondent. The reference is answered accordingly.

Copy of award be sent to the appropriate Government of J&K through its Commissioner/Secretary, Labour Department for information and its publication in the Government Gazette. File shall consign to records after its due completion.

Whereas, Section 5 (1) of the J&K RTI Act, 2009 stipulates that—

“every Public Authority shall within one hundred days of the commencement of the Act, designate as many officers as the Public Information Officers in all administrative units or offices under it as may be necessary to provide information to persons requesting for the information under the Act” ;

Whereas, Section 5 (2) of the J&K RTI Act, 2009 stipulates that—

“Without prejudice to the provisions of sub-section (i), every public authority shall designate an officer within one hundred days of the commencement of the Act, at each sub-divisional level or other sub-district level as an Assistant Public Information Officer to receive the applications for information or appeals under the Act for forwarding the same forthwith to the Public Information Officer or senior officer specified under sub-section (i) of Section 16 of the State Information Commission, as the case may be” ;

Whereas, it has come to the notice of the State Information Commission that not all Public Authorities have taken action in terms of the provisions of Section 5 for appointment of the Public Information Officers (PIOs) and Assistant Public Information Officers (APIOs) ;

Whereas, Section 22 (5) stipulates that—

“If it appears to the State Information Commission (SIC) that the practice of a public authority in relation to the exercise of its functions under the Act does not conform with the provisions or spirit of the Act, it may give to the authority a recommendation specifying the steps who ought in its opinion to be taken for promoting such conformity”.

Now, therefore, the State Information Commission (SIC) through this notification recommends to all the Public Authorities in the State of J&K to take appropriate action under Section 5 for appointment of the PIOs and APIOs if such officials have not been designated and notified so far or where substitutes have not been designated and notified against vacancies that have arisen due to transfer or retirement of the incumbent.

Whereas, Section 16 prescribes designation of a senior officer in the Public Authorities as the First Appellate Authority (FAA) ;

Whereas, it has come to the notice of the SIC that such FAAs have not been designated by all the Public Authorities and in all cases in terms of Section 16 (1) of the Act.

Now therefore, the State Information Commission through this notification recommends to all the Public Authorities in the State of J&K to take appropriate action for designation of suitable senior officers in the Public Authority as FAAs in terms of Section 16(1) of the Act to hear the first appeal from the RTI applicants if such officials have not been designated and notified so far or where substitutes have not been designated and notified against vacancies that have arisen due to transfer or retirement of the incumbent.
