Whereas, the District Collector (DC), Pulwama vide No. DCP/LAS/NHW/117/Pul dated 02-06-2016 has reported that the notification issued under section 4(1) of the J&K State Land Acquisition Act by Collector, Land Acquisition (ADC) vide No. DCP/LAS-NHW/08-15/Pul dated 21-04-2016 was served upon the interested persons for filing objections, if any, to the proposed acquisition but the land owners have filed objections to the proposed acquisition of the land and after giving objectors an opportunity of being heard and due inquiry he has recommended the case for rejections of the objection and for issuance of notification under sections 6, 7 and 17 of the J&K Land Acquisition Act ;

Whereas, the report furnished by District Collector (DC), Pulwama vide his letter referred to above duly endorsed by Divisional Commissioner, Kashmir and Financial Commissioner, Revenue vide letter dated 02-10-2016 and No. FC-LS/LA-4493/2016 dated 29-11-2016 respectively has been examined and it has been found that the objections filed by the objectors/interested persons are baseless and deserve to be rejected ;

Whereas, the Government is satisfied that the land particulars whereof are given above is required for public purpose viz. for shifting of 132 KV transmission line falling in ROW of project Highway ;

Whereas, the Indenting Department/Collector have expressed urgency for taking over the possession of the land.

Now, therefore, in pursuance of section 6 of the J&K State Land Acquisition Act, Samvat 1990, it is declared that land measuring 03 Kanals, 03 Marlas, 2 Sirsai and 25 Sft. situated in Village Kandizal, Tehsil Kakapora and Namblabal and Kadlabal, Tehsil Pampore, District Pulwama, particulars whereof are given in Annexure to this notification is required for public purpose viz. for shifting of 132 KV transmission line falling in ROW of project Highway. On the indent of Project Director, PIU, Jammu vide his No. PD/JMU/LA-Udhampur/2016/1030 dated 11-05-2016, the proceedings under the provisions of Jammu and Kashmir Land Acquisition Act X-Svt. 1990 were initiated for acquisition of land measuring 01 kanal 06 marlas 03 Sarsai comprising Khasra Nos. 1356/833 min situated in Village Bali, Tehsil and District Udhampur for widening of National Highway up to four laning.

Accordingly notification under section 4(1) of Land Acquisition Act No. X of Svt. 1990 was issued by this Collectorate vide No. LA/ADC/275-83 dated 23-05-2016 under the State Land Acquisition Act

1990 B. K. The copies of the said notice were served upon the land owners/interested persons through Tehsildar, Udhampur. The land owners/interested persons have not filed any objection in response to the notification issued under section 4(1) of Land Acquisition Act within the stipulated period.

Thereafter, the District Collector was requested vide this Collectorate's letter No. LA/ADC/467 dated 02-07-2016 for issuance of declaration under sections 6, 7 & 17 of the Land Acquisition Act. The District Collector further submitted the instant case to the Government vide his office letter bearing No. DCU/SQ/1154-56 dated 19-07-2016 for the issuance of declaration of under sections 6 & 7 of Land Acquisition Act. Revenue Department, Civil Secretariat J&K Government vide Notification No. 121-Rev (LAJ) of 2016 dated 17-10-2016 under endorsement No. Rev/LAJ/172/2016-Bali dated 17-10-2016 issued notification under sections 6 & 7 of Land Acquisition Act and communicated the same to this Collectorate.

Consequent upon this notification under sections 9 & 9(A) under Land Acquisition Act, 1990 Svt. was issued vide this Collectorate No. LA/ADC/916-24 dated 02-12-2016, calling upon the land owners/interested persons and the Indenting Department to file their objections and interest in the land, amount and particulars of the claims to the compensation within 15 days. In response to this notification, interested persons on 14-12-2016 filed their objections wherein they have stated that they have no objection in the instant acquisition but they must be paid land compensation @ Rs. 2.00 lakhs per marla.

The Tehsildar, Udhampur at the time of preparation of revenue documents vide his No. 56/OQ dated 20-04-2010 has not intimated three years sale deed rate and present market rate instead has recommended the rate of land compensation of land acquired earlier in the same village for widening/four laning of National Highway. The Final Award for land measuring 20 kanals 14 marlas has been issued vide this Collectorate No. LA/ADC/463-67 dated 27-09-2011 in which land compensation @ Rs. 1.75 lakh per kanal irrespective of kind of soil is paid. The stamp duty rates for the year 2016-17 for Village Bali (Lower) are Rs. 2.31 lakh per kanal for irrigated and Rs. 1.85 lakh per kanal for unirrigated land. Undersigned has personally visited the land under acquisition and

being immediately adjoining to the existing National Highway, it bears a huge commercial potential. Hence, keeping in view the location of land under acquisition and its potential value, the land compensation @ Rs. 5.00 lakh per kanal irrespective of kind of soil is genuine and reasonable.

The Draft Award was prepared and submitted to District Collector, Udhampur for approval of rates. The case was discussed threadbare in the Committee of Collectors under the Chairmanship of District Collector, (Deputy Commissioner), Udhampur held on 01-03-2017. The rates in the instant case have been approved as Rs. 5.05 lakh per kanal (five lakhs five thousand only) for unirrigated kind of soil is reasonable and genuine.

Accordingly the Revised Draft Award was announced vide this Collectorate No. LA/ADC/1330-34 dated 10-03-2017 amounting to Rs. 779948/- and District Collector, Udhampur was requested to accord sanction of rates and approval of awarded amount as the awarded amount in the instant case is below one crore and falls within the pecuniary jurisdiction of Deputy Commissioner, Udhampur. The District Collector (Deputy Commissioner, Udhampur) vide office letter No. DCU/LA/SQ/4609 dated 11-03-2017 has accorded approval of rates and sanction of awarded amount in favour of this Collectorate with the direction to disburse the compensation to the rightful land owners/ interested persons strictly in accordance with the provisions of J&K Land Act and rules read with LB-10 circular dated 23-02-1980.
