3. Whereas, during the course of investigation site plane of place of occurrence was prepared and statement of witnesses acquainted with facts

Whereas, during investigation, it was revealed that the accused Syed Ali Shah Geelani S/o Peer Mohammad Shah Geelani R/o Peerbagh, Srinagar and Mohammad Yousf Makroo S/o Mohammad Shaban R/o Arwani Bijbehara had visited village Arwani and raised anti national slogans and instigated the youth of the area against the sovereignty and integrity of the country. Subsequently the accused Mohammad Yousf Makroo was arrested in the case ; and

Whereas, on the basis of investigation, statements of witnesses, recorded and other evidence collected, the Investigating Officer has established a *prima facie* involvement of below mentioned accused persons for commission of offence punishable under section 13 Unlawful Activities (Prevention) Act, 1967 :

3. Whereas, during investigation the accused was arrested in the case and 01 flag of ISIS JK outfit with UBGL grenade was recovered from his possession. The accused disclosed that he alongwith other three accused namely Shahid Fayaz Kumar S/o Fayaz Ahmad R/o Narabata Hazratbal (2) Umar Fayaz Mir S/o Fayaz Ahmad R/o Nadihal (3) Ahtisham-ul-Haq Bhat S/o Gh. Nabi Bhat R/o Chittaybandy were working for the terrorists of ISIS JK outfit. Subsequently all the 03 accused persons were arrested in the case and 01 matrix sheet was recovered from the possession of accused Shahid Fayaz Kumar ; and

4. Whereas, during further course of investigation one more accused namely Ahtisham-Ul-Haq Dar S/o Syad Hussain Dar R/o Gamroo was arrested in connection with case and during questioning 04 live Rounds with 02 matrix were recovered form his possession ; and

5. Whereas, during the course of investigation, site plan of place of occurrence and seizure memo was prepared and statement of witnesses acquainted with the facts and circumstances of the case were recorded under the relevant provisions of law ; and

6. Whereas, during investigation it was revealed that the accused persons were working as OGWs for the terrorists of ISIS JK outfit and were providing logistic support to the terrorists of the outfit for carrying out the subversive activities in the Aragam area ; and

7. Whereas, on the basis of investigation, statement of witnesses recorded and other evidence collected, the Investigating Officer has established *prima facie* involvement of below mentioned accused persons in the commission of offences punishable under section(s) as shown against each of Unlawful Activities (Prevention) Act, 1967 :ô
