- iii. Suggestions/feedback received and the departmental disposal of the same shall also be published online along with the information as to how the feedback has been addressed in the final regulation.
- iv. Any new additional regulation/service/permission automated through www.jklabour.com & https://singlewindow.jk.gov.in shall be updated in 'Online Wizard System' within 30 days as recommended under BRAP.
- v. Live Online MIS dashboard shall be activated for all e-service approvals and grievance/query applied through www.jklabour.com
 & https://singlewindow.jk.gov.in for better transparency and monitoring compliance.
- vi. Industrial/Investor query received on the www.jklabour.com & https://singlewindow.jk.gov.in shall be addressed/resolved within 7 working days by concerned authority. In case of any observation, initial respose shall be initiated within 7 days. If the issue pertains to policy matters, the same shall be disposed within 15 days of receipt.
- vii. All the inspections shall be carried out as per notified procedure and defined checklist, with prior intimation to the concerned

- - viii. All surprise and complaint based inspections shall be conducted with prior written permission of the concerned head of department in light of the records maintained on the portal.
 - ix. All the services under BRAP including Registrations, Licenses, Notices, Fines, Penalties, Inspections/Verification Reports, Returns filed by the occupires/unit holders/employers, Applications, Payments/Fees etc. uner Labour Laws shall be provided only in Online Mode through www.jklabour.com and no ofline submission/processing of application etc. shall hence forth be entertained.

Subject :ô Preliminary Notification under Section-11(1) of ::Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013@ for acquisition of Land measuring 07 Kanals 19 Marlas 7½ Sirsai coming under the alingnment of construction of road from Tumlahal to Chandgam at Village Tumlahal Tehsil and District Pulwama.

Whereas, the formal indent of land has been placed by Superintendent Engineer R&B Circle Pulwama vide his No. SE/PS/1373-75 dated 29-06-2021 for construction of road from Tumlahal to Chandgam reportedly approved under District Sector.

Whereas, it appears to the Collector that a total area of land 07 Kanals 19 Marlas 7½ Sirsai (0.998 acre) is required in Village Tumlhal Tehsil and District Pulwama for public purpose, namely acquisition of land for construction of road from Tumlahal to Chandgam at Village Tumlhal Tehsil and District Pulwama.

Whereas, Social Impact Assessment study was carried out by a team constituted by District Collector vide No. DCP/LA/2020/610-30 dated 25-08-2020 as laid down under rule 4. A detailed SIA report has been submitted through Tehsildar Pulwama vide his No. TPóOQ/1543 dated 16-12-2021 which is reflected herein as under :ô

- 1. That the proposed acquisition of land serves the public purpose, as it connects two villages namely Tumlahal and Chandgam.
- 2. The land proposed for the acquisition is absolute bare-minimum needed for the project as reported by R&B authorities.
- 3. That reportedly the acquisition at an alternate place has not been considered by the Indenting Department.
- 4. That there is no utilized land which has been previously acquired in the area for this purpose.
- 5. There is no unutilized acquired land to be utilized for such public purpose in the said village.

Therefore, it is notified that a piece of land 7 Kanals 19 marlas 7½ Sirsai of standard measurement, whose detailed description is as under needs to be acquired for public purpose namely for construction of road from Tumlahal to Chandgam at Village Tumlahal Tehsil and District Pulwama;

NOTIFICATION

In pursuance of sub–section (1) of Section 10 of the Delimitation Act, 2002 (33 of 2002) and Part–V of the Jammu & Kashmir Reorganisation Act, 2019, the following Order made by the Delimitation Commission under sub–section (2) of Section 9 read with sub–section (2) of Section 4 of the Delimitation Act, 2002 and Part–V of the Jammu & Kashmir Reorganisation Act, 2019, in respect of the delimitation of Parliamentary and Assembly Constituencies in the Union Territory of Jammu & Kashmir is hereby published.

ORDER NO. 2

WHEREAS, in pursuance of Sections 8 and 4 of the Delimitation Act, 2002 (33 of 2002), as amended by the Delimitation (Amendment) Act, 2003(3 of 2004), and Part–V of the Jammu & Kashmir Reorganisation Act, 2019, the Delimitation Commission has, by its Order No.1 dated 14th March, 2022 published in the extraordinary issue of the Gazette of India and the Union Territory of Jammu & Kashmir Gazette on 14th March, 2022, determined–(i) the total number of seats in the House of the People to be allocated to the Union Territory of Jammu & Kashmir as five (5) of which Zero(0) seat shall be reserved for Scheduled Castes and Zero(0) seat shall be reserved for the Scheduled Tribes, and (ii) the total number of seats to be assigned to the Legislative Assembly of the Union Territory as Ninty (90) of which, Seven (7) seats shall be reserved for the Scheduled Castes and Nine (9) seats for the Scheduled Tribes; and

WHEREAS, in pursuance of sub–section (1) of Section 5, read with sub-section (1) of Section 9 of the Delimitation Act, 2002 and Part–V of the Jammu & Kashmir Reorganisation Act, 2019, the Delimitation Commission associated with itself the Associate Members from the Union Territory with the proceedings for the delimitation of Parliamentary and Assembly Constituencies in the Union Territory; and

WHEREAS, in pursuance of sub–section (2) of Section 9 of the Delimitation Act, 2002 and Part–V of the Jammu & Kashmir Reorganisation Act, 2019, the Delimitation Commission published its draft proposals, for the delimitation of Parliamentary and Assembly Constituencies in the Union Territory on the basis of the relevant published figures of 2011 Census, in the extraordinary issue of the Gazette of India and in the Jammu & Kashmir Union Territory Gazette on 14th March, 2022, inviting objections and suggestions in relation to the aforesaid proposals by 21st March, 2022; and

WHEREAS, in pursuance of the said sub-section (2) of Section 9 of the Delimitation Act, 2002 and Part-V of the Jammu & Kashmir

Reorganisation Act, 2019, the Commission's Order No. 1 mentioned above and the above referred draft proposals of the Commission was published in the local newspapers on 14th March, 2022 and given further publicity through radio and television and other media of mass communication; and

WHEREAS, in pursuance of the said sub–section (2) of Section (9) of the Delimitation Act, 2002 and Part–V of the Jammu & Kashmir Reorganisation Act, 2019, the Commission also issued a public notice on 25th March, 2022 specifying the places and dates of its public sittings to consider all objections and suggestions; and

WHEREAS, in pursuance of the said sub–section (2) of Section 9 of the Delimitation Act, 2002 and Part–V of the Jammu & Kashmir Reorganisation Act, 2019, the Commission held public sittings on 4th April, 2022 at Jammu and on 5th April, 2022 at Srinagar and heard the members of the public and afforded them full opportunity of making oral and written submissions, in addition to the written representations already sent, if any, to the Commission; and

WHEREAS, the Commission has considered all objections and suggestions made at the aforesaid public sittings and/or received by it otherwise, in relation to its said proposals, in the light of the relevant provisions of the Constitution and the said Acts.

NOW, THEREFORE, in pursuance of clause (d) of sub–section (2) of Section 9 read with sub–section (2) of Section 4 of the Delimitation Act, 2002, as amended and Part–V of the Jammu & Kashmir Reorganisation Act, 2019, the Delimitation Commission hereby determines as follows:—

1. Ninety territorial Assembly Constituencies into which the Union Territory of Jammu & Kashmir shall be divided for the purpose of elections to the Legislative Assembly of the Union Territory and the extent of each such Constituency shall be as shown in Table–A

[As envisaged in Section 14(4) of The Jammu and Kashmir Reorganisation Act, 2019 (34 of 2019), 24 seats have not been taken up for the purpose of delimitation].

- 2. The territorial Parliamentary Constituencies into which the Union Territory of Jammu & Kashmir shall be divided for the purpose of elections to the House of the People and the extent of each such Constituency shall be as shown in Table–B.
- 3. Where the name of a Constituency as shown in Table–A or Table–B is distinguished by the brackets and letters "(SC)" the seat in that Constituency is reserved for the Scheduled Castes.
- 4. Where the name of a Constituency as shown in Table–A or Table–B is distinguished by the brackets and letters "(ST)" the seat in that Constituency is reserved for the Scheduled Tribes.
