- (iv) witnesses suffering from õmental illnessö as defined under section 2(s) of the Mental Healthcare Act, 2017 read with section 118 of the Indian Evidence Act, 1872;
- (v) any witness deem to have a threat perception under the Witness Protection Scheme, 2018 of the Union Government as approved by the Supreme Court in Mahender Chawla Vs. Union of India (2019) 14 SCC 615;
- (vi) any speech or hearing impaired individual or a person suffering from any other disability who is considered to be a vulnerable witness by the competent court;
- (vii) such other witness as may be deemed vulnerable by the trial court for reasons therefor to be recorded in writing.ö
