S.O.-343.—Whereas, on 24-01-2022, the Police Station, Bijbehara, received a written docket to the effect that joint Naka was established by Police/Security Forces at Nilandrus near Geology and Mining Store, Bijbehara. During checking a person while seeing the Naka Party tried to escape but was chased down on the spot and identified as Shakir Bashir

Bhat S/o Bsshir Ahmad Bhat R/o Bandipora, Bijbehara. During his personal search the Police recovered 15 AK rounds form his possession; and

- 2. Whereas, based on the above, a case FIR No. 12/2022, under section 7/25 Arms Act, and 18, 39 of ULA(P) Act, came to be registered in Police Station, Bijbehara and the investigation of the case was taken up. Subsequently, during the investigation, Sections 3/4 ESA, 23, 20 and 38 of ULA (P) Act, were added in the case; and
- 3. Whereas, during course of investigation, the site plan of the place of occurrence and seizure memos—were prepared and the statement of witnesses acquainted with the facts and circumstances of the case were recorded under the relevant provisions of law; and
- 4. Whereas, during the investigation, on the disclosure of accused viz. Shakir Bashir Bhat, a Hand Grenade was also recovered from his residential house. The accused was found in contact with a terrorist of HM banned outfit namely, Rayees Ahmad Bhat S/o Abdul Hamid Bhat R/o Shahabad Beeri, who provided a hand grenade and AK ammunition to the accused viz. Shakir Bashir Bhat in order to promote terrorist activity in the area; and
- 5. Whereas, during investigation, it was established that the accused viz. Shakir Bashir Bhat was working as Over Ground Worker (OGW) for the terrorists of HM banned outfit particularly terrorist viz. Rayees Ahmad Bhat and was providing logistic support to them besides under well knit criminal conspiracy procured a hand grenade and AK ammunition for the said terrorist for carrying out the terrorist activities in the area; and
- 6. Whereas, the accused terrorist namely, Rayees Ahmad Bhat has been killed in an encounter with the Security Forces and proceedings under the law would abate against him; and
- 7. Whereas, on the basis of the investigation, the statement of witnesses recorded and other evidence collected, the Investigating Officer has established a *prima facie* involvement of below mentioned accused

for the commission of offences punishable under sections of the Unlawful Activities (Prevention) Act, 1967, as shown against his name:—

Whereas, after perusing the Case Diary File, the relevant documents and also taking into consideration the views of the Authority appointed under sub-section (2) of section 45 of the Unlawful Activities (Prevention) Act, 1967, the Government is of the view that there is sufficient material and evidence available against the above mentioned accused for their prosecution under the provisions of law.

S.O.361.ô Whereas, on 11-02-2022, the Police Station, Dangiwacha. received a docket to the effect that a reliable information was received regarding presence of some terrorists of Al Badr banned outfit in the Village Rawoocha, Pethpora, equipped with illegal arms/ammunition conspiring to carry out terrorist act. Subsequently, a Joint Cordon and Search Operation was launched and during the search, three terrorists identified as Waris Kamran Tantray S/o Ab. Lateef Tantray

- 2. Whereas, based on the above, a Case FIR No. 14/2022 under Sections 7/25 Arms Act, 16, 18, 20, 38 of ULA (P) Act, was registered in the Police Station, Dangiwacha, and the investigation of the case was taken up. Subsequently, during the investigation Sections 17, 18-B, 23 and 39 of ULA (P) Act, were added and Section 16 of ULA (P) Act, was dropped from the case; and
- 3. Whereas, during the course of investigation, the site plan of place of occurrence and the seizure memos were prepared and the statements of witnesses acquainted with the facts and circumstances of the case were recorded under the relevant provisions of law; and
- 4. Whereas, during the investigation, the accused viz Waris Kamran Tantray, Amir Sultan Wani and Tariq Ahmad Bhat, were found in contact with three PoK based terrorists of Al-Badr banned outfit namely, Yousuf Balooch R/o Pakistan, Furqan R/o Handwara A/P PoK and Zaffar Hussain Bhat @ Khursheed S/o Sonaullah Bhat R/o Zagund Liver, Srigufwara, Anantnag. The PoK terrorist viz. Yousuf Balooch, sent an amount of Rs. 8 Lakhs to the accused viz. Waris Kamran Tantray, through an unknown person and also sent an amount of Rs. 3,97000/- to him through one Ashraf Nazir Bhat S/o Nazir Ahmad Bhat R/o Arin, Bandipora, for procurement of arms/ammunition. The accused viz Waris Kamran Tantray, handed over Rs. 8 Lakhs to his associate viz Tariq Ahmad Bhat and Rs. 4 Lakhs to accused viz Ashraf Nazir Bhat for procurement of arms/ammunition; and
- 5. Whereas, the accused viz Ashraf Nazir Bhat, procured arms/ammunition from an unknown person from Lolab and handed over to the accused viz Waris Kamran Tantray and kept 1 Pistol with Magazine and 6 rounds in his possession. Subsequently, the said accused was arrested in the case and arms/ammunition i.e. 1 Pistol with Magazine and 6 rounds were recovered at his instance; and

- 6. Whereas, the accused viz. Tariq Ahmad Bhat, motivated three persons namely Mohammad Ashraf Malik S/o Mohammad Akbar Malik R/o Drangso, Handwara, Shabir Ahmad Shah S/o Gh. Hussan Shah R/o Sherhama, Mawer, Handwara and Mohammad Afzal Thoker S/o Ab. Aziz Thoker R/o Qalamabad, Handwara, for procuring of arms/ammunition and provided an amount of Rs. 4 lakhs to them. The above three accused procured arms/ammunition from Lolab area from an unknown person. Subsequently, all the three accused were arrested and during investigation the said arms/ammunition viz. 1 UBGL with 2 UBGL grenades, 2 Hand grenades and an amount of Rs. 1,86,500/- were recovered from their instances. During the investigation, an amount of Rs. 2 Lakhs was also recovered at the instance of accused viz Tariq Ahmad Bhat; and
- 7. Whereas, during the investigation, it was found that the accused viz. Amir Sultan Wani, alongwith two unknown persons also procured arms/ammunition from an unknown person at Sopore and handed over the same to active terrorist of Al-Badr banned outfit namely, Mohammad Rafi Lone S/o Gh. Mohammad Lone R/o Nathipora, Bomai. The said terrorist was motivating youth of the area to join the terrorist ranks and to lob the grenades upon the Police/Security Forces in the area; and
- 8. Whereas, during the investigation, it was established that the accused viz. Waris Kamran Tantray, Amir Sultan Wani and Tariq Ahmad Bhat, were members of Al-Badr banned outfit. The PoK based terrorists viz. Yousuf Balooch. Furgan and Zaffar Hussain @ Kursheed motivated and provided arms/ammunition to them and under a well knit criminal conspiracy were raising funds for the terrorist outfit. The other accused namely, Ashraf Nazir Bhat, Mohammad Ashraf Malik, Shabir Ahmad Shah and Mohammad Afzal Thoker, were working as OGWs for the above terrorists and were providing logistic support to them, besides, under a well knit criminal conspiracy were facilitating the transportation of arms/ammunition from one place to another, besides, were raising funds for the terrorist outfit for carrying out the terrorist activities. The accused namely, Mohammad Rafi Lone, was motivating youth of the Sopore area to join the Al-Badr banned outfit and after receiving funds from his handlers was distributiing the same among the youth for hurling grenades upon the Police/Security Forces in the Sopore area: and

- 9. Whereas, the investigation in respect of the unknown accused whose identification could not be ascertained during the investigation, shall continue to ascertain their identity and to bring out their role/involvement, in the case; and

Whereas, on the basis of the investigation, the statements of witnesses recorded and other evidence collected, the Investigating Officer, has established *prima facie* involvement of the below mentioned accused for the commission of offences punishable under sections of the Unlwful Activities (Prevention) Act, 1967, as shown against their names :ô

Mohammad Dar R/o Zoowastan, Tral and Shamin Ahmad Sofi S/o Gh. Mohammad Sofi R/o Satoora, Tral, in Village Zantrag, conspiring to carry out terrorist

- 2. Whereas, based on the above, a Case FIR No. 03/2020 under Sections 302, 307 IPC, 7/27 Arms Act, 16, 18, 20, 38 of ULA (P) Act, was registered in the Police Station, Khrew and the investigation of the case was taken up. Subsequently, during the investigation, Sections 19 and 39 of ULA (P) Act were added in the case; and
- 3. Whereas, during the investigation, one dead body was recovered from the place of encounter, who was later on identified as Abu Saifullah R/o Pakistan, a terrorist of JeM banned outfit. During the search arms/ammunition viz. 01 AK-47 Rifle, 08 Magazines, 35 AK Rounds, 02 Pouch and 01 AK UGBL, were recovered from the encounter site. During the encounter, the above two terrorists of the JeM banned outfit viz. Rayees Ahmad Dar and Shamin Ahmad Sofi, managed their escape; and
- 4. Whereas, during the course of investigation, the site plan of the place of occurrence and the seizure memos were prepared and the statements of witnesses acquainted with the facts and circumstances of the case were recorded under the relevant provisions of law; and
- 5. Whereas, during the investigation, one more dead body was recovered in Zantrag Forests, identified as the terrorist of JeM banned outfit namely Rayees Ahmad Dar, who escaped from the encounter site. During the investigation, it was found that the said terrorist while escaping from the encounter site got injured and later succumbed to his injuries in Zantrag Forests; and
- 6. Whereas, during the investigation, 03 more accused namely Mohd Amin Mir S/o Assadullah Mir, Mohd Rafiq Mir S/o Mohd Akber Mir Rs/o Zantrag, Khrew and Fayaz Ahmad Lone S/o Sonaullah Lone R/o Naginder, Khrew, were found involved in the case. Subsequently, the accused were arrested and were found in contact with the above terrorists viz. Abu Saifullah R/o Pakistan, Rayees Ahmad Dar and Shamin Ahmad Sofi; and

- 7. Whereas, during the investigation, it was established that the accused viz. Mobd Amin Mir, Mohd Rafiq Mir and Fayaz Ahmad Lone, were working as Over Ground Workers (OGWs) for the terrorists of JeM banned outfit particularly killed terrorists viz. Abu Saifullah R/o Pakistan, Rayees Ahmad Dar and Shamin Ahmad Sofi, and were providing logistic support to them, besides, the accused viz. Mohd Amin Mir, was voluntarily harbouring the above terrorists, for carrying out the terrorist activities in the area; and
- 8. Whereas, the accused terrorists namely Abu Saifullah R/o Pakistan and Rayees Ahmad Dar, were killed in the said encounter and the other terrorist viz. Shamin Ahmad Sofi, was also killed in encounter with the security forces at Wagad, Tral on 13-10-2021 and the proceedings under the law would abate against them; and

Whereas, on the basis of the investigation, the statement of witnesses recorded and other evidence collected, the Investigating Officer, has established a *prima facie* involvement of the below mentioned accused for the commission of offences punishable under sections of the Unlawful Activities (Prevention) Act, 1967, as shown against their name :ô

S.O.-341—Whereas, on 25-01-2022, the Police Station, Shaheed Gunj, received a written docket to the effect that some unknown terrorists lobbed a Hand Grenade upon the Police/Security Force at Hari Singh High Street, Srinagar with the intention to kill them which exploded on road, resulting in injuries to some pedestrians and damage to some vehicles and adjacent shops. The unknown terrorists after commission of the crime escaped from the spot; and

- 2. Whereas, a case FIR No. 07/2022, 307 IPC, 7/27 Arms Act, came to be registered in Police Station, Shaheed Gunj and the investigation of the case was taken up. Subsequently, during the investigation, Sections 16, 23, 39 of ULA (P) Act, 427 IPC and 3 PPD Act, were added in the case; and
- 3. Whereas, during course of investigation, the site plan of the place of occurrence and seizure memos were prepared and the statement of witnesses acquainted with the facts and circumstances of the case were recorded under the relevant provisions of law; and
- 4. Whereas, during the investigation, one auto driver identified as Aijaz Ahmad Wani S/o Late Fayaz Ahmad Wani R/o Malik Angan, Fateh Kadal at present Sazgharipora Hawal, Srinagar, was found involved in the commission of crime. Subsequently, the accused was arrested in the case and was found working for the terrorists of TRF (an offshoot of LeT banned outfit); and
- 5. Whereas, during investigation, it was established that the accused viz. Aijaz Ahmad Wani was working as Over Ground Worker (OGW) for the terrorists of TRF (an offshoot of LeT banned outfit) and was providing logistic support to them besides on 25-01-2022 hurled the hand grenade upon the Police/Security Force at Hari Singh High Street, Srinagar with the intention to kill them which resulted in injuries to some pedestrians and damage to some vehicles on the spot; and
- 6. Whereas, on the basis of investigation, the statement of witnesses recorded and other evidence collected, the Investigating Officer has established a prima facie involvement of below mentioned accused for the commission of offences punishable under sections of the Unlawful Activities (Prevention) Act, 1967, as shown against him name:—

- 4. Whereas, during the investigation, the accused viz. Mohammad Musaib Kanwalo was found in contact with an unknown terrorist of LeT banned out fit and procured the said hand grenade from the said terrorist for lobbing the same upon the Police/Security Forces in the area with the intention to kill them and damage their property; and
- 5. Whereas, during the further investigation, it was established that the accused viz. Mohammad Musaib Kanwalo was working as Over Ground Worker (OGW) for the terrorists of LeT banned outfit and was providing logistic support to them besides under a well knit criminal conspiracy procured hand grenade from an unknown terrorist of the LeT banned outfit to carry out the terrorist activities in the area; and
- 6. Whereas, the investigation, in respect of unknown terrorist of LeT banned outfit who provided the hand grenade to the accused viz. Mohammad Musaib Kanwalo shall continue to ascertain his identity and to bring out his role/involvement in the area; and
- 7. Whereas, on the basis of investigation, the statement of witnesses recorded and other evidence collected, the Investigating Officer has established, a *prima facie* involvement of below mentioned accused for

#### Award

Petition under section 2-A of Industrial Disputes Act, 1947 came to be filed by Shiv Kumar Rattan challenging his termination dated 20-04-2018 as Foreman.

Synopsis of this case is that petitioner joined the respondent company in the year 2014 on fixed contract basis and since then was working continuously as #Foremanø against salary of Rs. 20,000/- on monthly basis and on 20-04-2018 his services were terminated verbally without assigning any reasons and without putting him on show cause notice/termination letter. Allegedly there was no misconduct on the part of the petitioner yet his services were terminated verbally without showing any cause to him as such challenge is thrown to verbal order dated 20-04-2018 of respondent who is in *ex-parte* since 31-07-2019. Petitioner led evidence in *ex-parte* to prove his case against respondent.

Besides appearing himself as witness in the shape of evidence he examined Sh. Joginder Kumar, Post Masterø, Bari Brahmna who appeared as a witness on 20-11-2019 and deposed w. r. t. delivery of Registered post on 11-05-2019 at the office of respondent RSS, Food Park. Since both the aforementioned witnesses were not subjected to cross examination, hence the evidence goes unrebutted.

Heard. Representative of petitioner Sh. Harbans Chowdhary vehementally argued and tried to persuade this Tribunal that Petitioner was condemned unheard by respondent and was arbitrarily terminated from his services without showing any cause in colourable exercise of power. Considered submissions and meticulously perused material on record. It appears that initially Conciliation Officer Samba was approached by petitioner on 28-04-2018 where in the process, respondent did appear once and subsequently absented himself from proceedings before conciliation officer who later issued certificate under Section 2a (2) (3) of Industrial Disputes Act, 1947.

According to petitioner present claim petition was filed by him against the respondent employer as petitioner was working in factory of the respondent since 2014 regularly as Foremen and prior to that also the plant machinery was installed in 2014 by the petitioner on contract basis and subsequently he joined the regular service. Even letter dated 29-09-2014 is evident of the fact that petitioner was respondent employee and even a notice dated 30-01-2016 issued by

Considered various submissions put forth herein. The entire evidence led herein *prima facie* strengthens the case of the petitioner that he was under employment of respondent company and was drawing Rs. 20,000/- at the time of termination which is quite evident from salary voucher too dated 20-12-2017 placed on record. I gave my thoughtful consideration to the matter in hand and registered submissions. The main plea of petitioner is that termination is bad in eyes of law being illegal and as the same is done against principal of natural justice as such respondent be directed to allow him to continue and be further directed to pay him full wages and also his pending amount for installation of plant before joining his service.

After assessing all available material on record and relevant law, I am of the considered opinion that petitioner has remedy somewhere else and not before this Tribunal under the Industrial Disputes Act, 1947 as the petitioner is excluded from the defining of -Workmanø under section 2(3) of the Act.

A -workmanø is defined under section 2(s) of the Industrial Disputes Act, 1947, (the Act) which reads as under :ô

õWorkmanö means any person (including an apprentice) employed in any industry to do any manual, unskilled, skilled, technical, operational, clerical or supervisory work for hire or reward, whether the terms of employment be expressed or implied, and for the purposes of any proceeding under this Act in relation to any industrial dispute, retrenched in connection with, or as a consequence of, that dispute, or whose dismissal, discharge or retrenchment has led to that dispute, but does not include any such personô

- (i) Who is subject to Air Force, 1950 (45 of 1950), or the Army Act, 1950 (46 of 1950), or the Navy Act, 1957 (62 of 1957); or
- (ii) Who is employed in the police service or as an officer or other employee of a prison; or
- (iii) Who is employed mainly in a managerial or administrative capacity; or

(iv) Who, being employed in a supervisory capacity, draws wages exceeding ten thousand rupees per month or exercises, either by the nature of the duties attached to the office or by reason of the powers vested in him, functions mainly of a managerial nature.ö

However as per Section 2 (s) of the Act an employee should not be in managerial, administrative or supervisory capacity and should not draw wages exceeding Rs. 10000/- per month. The petitioner herein has in unambiguous words stated that he was working in the capacity of a Foreman and received Rs. 20,000/- per month as his salary in lieu of his job. The onus to prove that the petitioner is covered within definition of Section 2 (s) of the Industrial Disputes Act is upon him. He has not produced any evidence to prove that he was not discharging managerial duty. Hence, this Tribunal/Court can safely hold that he is not covered within the definition of Section 2 (s) of the Industrial Disputes Act and he is not entitled to claim any relief against the management. In view of the legal position his prayer is turned down and petition is dismissed in light of supra. File to go to records after the needful is done.

The reference is answered accordingly. Let this award be published in Government Press under rules.

SO-653.ô Whereas, draft amendments in the J&K Motor Vehicles Rules, 1991 were published vide notification SO-582 dated 4th of November, 2022 as required under Sub-Section (1) of Section 212 of Motor Vehicles Act, 1988, in the Official Gazette inviting objections and

Whereas, objections and suggestions received from the public on the said draft amendments in the J&K Motor Vehicles Rules, 1991 were considered by the Government of J&K.

Now, therefore, in exercise of powers conferred by Sections 96, 107, 110, 111 and 213 of the Motor Vehicles Act, 1988 (as amended by Act No. 32 of 2019), the Government of UT of Jammu and Kashmir hereby amends the following rules; namely:ô

#### 1. In rule 41-A,ô

- a. in clause (a), after the words oas per clause (b) of this ruleo, the words and figures of Provided further that no Letter of Authority is required for a vehicle which has been approved for use as a commercial passenger vehicle under Rule 274-A, and in respect of which, an All J&K Contract Carriage Permit is soughto, as proviso, shall be added.
- b. After clause (a), the following shall be inserted as clause (aa); namely:ô
  - õ(aa) Contract Carriage Permit shall be granted to a new vehicle which is compliant with BS-VI or the latest norms laid down by Bharat Stage Emission Standards of the Government of India. However, it shall not be applicable to :ô
  - Any Vehicle for which Letter of Authority (LA) has already been issued prior to the date of issuance of this notification.
  - II. Any vehicle for which All India Tourist Permit has been issued and permit holder applies for its conversion to local permit after a period of twelve years.ö
- c. Clause (c) shall be substituted by the following ; namely :ô
  - õ(c) (1) Any person intending to purchase a Passenger Transport Vehicle, to be operated under the Stage Carriage

- i. Domicile Certificate;
- ii. Present address proof;
- iii. Character Certificate issued by any Gazetted Officer;
- iv. Copy of the driving license of the applicant or of any person proposed to be engaged as driver by the applicant;
- v. Declaration in an affidavit with regard to the number of transport vehicles already owned by the applicant registered in the applicant anne/firm/company/cooperative society along with their permit numbers, in case the vehicle(s) is/are already being operated under a permit.
- (2) Any person intending to operate passenger transport vehicle to be operated under All J&K Contract Carriage Permit, shall submit an application along with below mentioned documents :ô
  - i. Domicile Certificate;
  - ii. Registration certificate of the vehicle for which the permit is sought;
  - iii. Present Address proof;
  - iv. Character Certificate to be issued by the concerned Police Station;
  - v. Copy of the driving license of the applicant or of any person proposed to be engaged as driver by the applicant;
  - vi. Declaration in an affidavit with regard to the number of transport vehicles already owned by the applicant registered in the applicant anne/firm/company/cooperative society along with their permit numbers, in case the vehicle(s) is/are already being operated under a permit;
  - vii. Declaration in an affidavit confirming the availability/ arrangement of parking space, either public or private for existing fleet as well as for the new vehicle for which the applicant desires to obtain a permit.ö

- - d. following proviso shall be added to clause (d); namely :ô

õProvided that this clause shall not be applicable in case of fresh application made before concerned Regional Transport Authority for acquiring All J&K Contract Carriage Permit.ö

2. The following shall be added as proviso first and second to Sub-Rule (3) of Rule 69; namely :ô

ŏProvided that the concerned Regional Transport Authority shall issue All J&K Contract Carriage Permit, without countersignature of other Regional Transport Authorities, after satisfying itself of the fulfillment of conditions laid down in Sub-Rule (2) within 30 working days from the date of receipt of application, completed in all respects. In case of rejection of the application, cogent reasons have to be recorded in writing by the concerned Regional Transport Authority:

Provided further that a permit shall be deemed to have been granted in case of failure of the concerned Regional Transport Authority to dispose off the application within the specified time.ö
