Subject:—Apportionment of manpower between Union Territory of Jammu and Kashmir and Union Territory of Ladakh.

Government Order No.: 1254 – JK (GAD) of 2022

Dated 17-10-2022.

WHEREAS, vide Government Order No. 1212-JK(GAD) of 2021 dated 15-11-2021 read with Government Order No. 505-JK(GAD) of 2022 dated 05-05-2022, 12,272 employees serving on substantive basis have been apportioned to Union Territory of Ladakh, on the basis of options exercised by them, in terms of Section 89 of the Jammu and Kashmir Reorganization Act, 2019;

AND WHEREAS, it was further provided in the Government Order No. 1212-JK(GAD) of 2021 dated 15-11-2021 that the apportionment of

remaining employees referred by the Union Territory of Ladakh shall be considered after further verification;

AND WHEREAS, vide Order No. 255-LA(GAD) of 2022 dated 25-08-2022, the General Administration Department, Union Territory of Ladakh deputed a team of officers along with the details of 1253 employees for considering their apportionment to the Union Territory of Ladakh and based on the scrutiny so conducted, cases of 1202 employees were found in order for consideration to their apportionment to Union Territory of Ladakh;

AND WHEREAS, in terms of communication No. A/95/2021-Secy-GAD dated 16-09-2022, the Union Territory of Ladakh confirmed authentication of the service particulars of 1202 employees whose service credentials were found in order during joint verification conducted by the officers/officials of the two Union Territories;

AND WHEREAS, it was observed that a few employees out of 1202 recommended for apportionment by Union Territory of Ladakh had already retired on attaining age of superannuation and were, accordingly, excluded from the process of apportionment;

AND WHEREAS, some representations were also received in the General Administration Department, Union Territory of Jammu and Kashmir from employees seeking apportionment to Union Territory of Ladakh, and after consultations with the concerned Administrative Departments, the cases of employees of following departments have been found in order for considering their apportionment to the Union Territory of Ladakh:







Petition under section 26A of Industrial Disputes Act, 1947 came to be filed by Shiv Kumar Rattan challenging his termination dated 20-04-2018 as Foreman.

Synopsis of this case is that petitioner joined the respondent company in the Year, 2014 on fixed contract basis and since then was working continuously as Foremanøagainst salary of Rs. 20,000/- on monthly basis and on 20-04-2018 his services were terminated verbally without assigning any reasons and without putting him on show cause notice/termination letter. Allegedly there was no misconduct on the part of the petitioner yet his services were terminated verbally without showing any cause to him as such challenge is thrown to verbal order dated 20-04-2018 of respondent who is in *ex-parte* since 31-07-2019. Petitioner led evidence in *ex-parte* to prove his case against respondent.

Besides appearing himself as witness in the shape of evidence he examined Sh. Joginder Kumar ***Post Master***, Bari Brahmna who appeared as a witness on 20-11-2019 and deposed w. r. t. delivery of Registered Post on 11-05-2019 at the office of respondent RSS Food Park. Since both the aforementioned witnesses were not subjected to cross examination, hence the evidence goes unrebutted.

Heard representative of petitioner Sh. Harbans Chowdhary vehemently argued and tried to persuade this Tribunal that Petitioner was condemned unheard by respondent and was arbitrarily terminated from his services without showing any cause in colourable exercise of power. Considered submissions and meticulously perused material on record. It appears that initially Conciliation Officer, Samba was approached by petitioner on 28-04-2018, where in the process, respondent did appear once and subsequently absented himself from proceedings before Conciliation Officer, who later issued certificate under section 2A (2) (3) of Industrial Disputes Act, 1947.

According to petitioner, present claim petition was filed by him against the respondent employer as petitioner was working in factory of the respondent since 2014 regularly as Foreman and prior to that also the plant machinery was installed in 2014 by the petitioner on contract basis and subsequently he joined the regular service. Even letter dated 29-09-2014 is

Considered various submissions put forth herein, the entire evidence led herein *prima facie* strengthens the case of the petitioner that he was under employment of respondent company and was drawing Rs. 20,000/- at the time of termination which is quite evident from salary voucher too dated 20-12-2017 placed on record. I gave my thoughtful consideration to the matter in hand and registered submissions. The main plea of petitioner is that termination is bad in eyes of law being illegal and as the same is done against principal of natural justice as such respondent be directed to allow him to continue and be further directed to pay him full wages and also his pending amount for installation of plant before joining his service.

After assessing all available material on record and relevant law, I am of the considered opinion that petitioner has remedy somewhere else and not before this Tribunal under the Industrial Disputes Act, 1947 as the petitioner is excluded from the defining of :Workmanøunder section 2(3) of the Act.

A ::Workmanøis defined under section 2(s) of the Industrial Disputes Act, 1947, (the Act) which reads as under :ô

::Workman@means any person (including an apprentice) employed in any industry to do any manual, unskilled, skilled, technical, operational, clerical or supervisory work for hire or reward, whether the terms of employment be expressed or implied, and for the purposes of any proceeding under this Act in relation to any industrial dispute, retrenched in connection with, or as a consequence of, that dispute, or whose dismissal, discharge or retrenchment has led to that dispute, but does not include any such personô

(i) Who is subject to Air Force, 1950 (45 of 1950), or the Army Act, 1950 (46 of 1950), or the Navy Act, 1957 (62 of 1957); or

- - (ii) Who is employed in the police service or as an officer or other employee of a prison; or
 - (iii) Who is employed mainly in a managerial or administrative capacity; or
 - (iv) Who, being employed in a supervisory capacity, draws wages exceeding ten thousand rupees per month or exercises, either by the nature of the duties attached to the office or by reason of the powers vested in him, functions mainly of a managerial nature@

However, as per section 2 (s) of the Act, an employee should not be in managerial, administrative or supervisory capacity and should not draw wages exceeding Rs. 10000/- per month. The petitioner herein has in unambiguous words stated that he was working in the capacity of a Foreman and received Rs. 20,000/- per month as his salary in lieu of his Job. The onus to prove that the petitioner is covered within definition of Section 2(s) of the Industrial Disputes Act is upon him. He has not produced any evidence to prove that he was not discharging managerial duty. Hence, this Tribunal/Court can safely hold that he is not covered within the definition of Section 2 (s) of the Industrial Disputes Act and he is not entitled to claim any relief against the management. In view of the legal position, his prayer is turned down and petition is dismissed in light of supra. File to go to records after the needful is done.

The reference is answered accordingly. Let this award be published in Government Press under rules.
