- The Police Challan at hand was presented in the Court on 11-08-2022 by the Police Station, Banihal against accused Mohd. Naveed, Uzma Kossar (both are in Judicial lock up at District Jail, Udhampur) and in absence of accused Mohd Waheed who was not present and IO had sought time to produce the accused Mohd Waheed.

Whereas, during the investigation, it was established that on the date of occurrence i.e. 14-11-2003, the accused viz Mohammad Yaseen Malik, Chairman JKLF, a banned association, after Friday Prayers at Eidgah, Handwarw delivered a provocative and anti national speech and raised anti-national/pro freedom slogans, thereby challenged the sovereignty and integrity of the Union of India and also instigated the gathering against the Government of Jammu and Kashmir; and
