GOVERNMENT OF JAMMU AND KASHMIR CIVIL SECRETARIAT—HOUSING AND URBAN DEVELOPMENT DEPARTMENT, JAMMU/SRINAGAR

Notification

Jammu, the 21st February, 2023.

SO-86.—In exercise of the powers conferred by Section 143A of the Jammu and Kashmir Municipal Corporation Act, 2000 (hereinafter referred to as the Act), read with Sub-Section (1) of Section 84 and Sub-Section (1) of Section 88 thereof, the Government hereby notifies the following rules for levy, assessment and collection of property tax in the Municipal Corporations of Union Territory of Jammu and Kashmir.

1. Short title and commencement.—(1) These rules shall be called Jammu and Kashmir Property Tax (Municipal Corporation) Rules, 2023.

- (2) These shall come into force from 1st of April, 2023.
- 2. **Definitions.**—Unless the context otherwise requires, a reference to the "Act" shall mean a reference to the Jammu and Kashmir Municipal Corporation Act, 2000, and "Form shall mean a Form appended to these Rules. Words and expressions used herein shall have the same meaning as given to them in the Act. For words and expressions not defined therein, the definition, if any, in the Jammu and Kashmir Municipal Act, 2000, the Jammu and Kashmir Development Act, 1970, the Jammu and Kashmir Property Tax Board Act, 2013, or in the General Clauses Act, 1897, in that order of precedence, shall be used as an aid to interpretation. For other words and expressions, the meaning shall be construed according to their customary usage appropriate to the context.
- 3. **Manner of calculation of property tax.**—(1) The Taxable Annual Value (TAV) of a property under the Act and the property tax due thereon for a financial year shall be calculated in accordance with the formula given in Schedule-I to these rules.
- (2) The property tax calculated in respect of a building calculated in accordance with Sub-Rule (1) above shall hold for a block of three years unless any change to such calculation is necessitated on account of the circumstances envisaged in the Act for allowing revision in such calculation.
- (3) The first block shall commence from 1st April, 2023, and shall continue to remain in force till 31st March, 2026. The blocks shall be similarly calculated thereafter.
- (4) New buildings coming up after the commencement of the block shall have their property tax liability calculated with reference to the 1st day of the relevant block, and irrespective of their having completed three years, their liability to tax shall be calculated a new from the date of commencement of the new block of three years for the Corporation as a whole.
- (5) Where a building is liable to property tax for only a part of the year, the tax due shall be proportional to the number of completed months and parts of month not completed shall be ignored.

- 4. Procedure for assessment and collection of property tax.—The procedure prescribed in Chapter VIII of the Act, except insofar as it relates to the calculation of the tax due on a property, shall regulate the assessment and collection of property tax.
- 5. Form of return under Sub-Section (5) of Section 88 of the **Act.**—A person liable to property tax shall furnish to the Commissioner or the officer authorized by him in this behalf the particulars of the property and the tax due thereon in Form-1 by 30th May of the financial year to which the return pertains. It shall be accompanied by a proof of payment in Form-2. Acknowledgement of filing of return shall be in Form-3. A copy of the acknowledgement along with the proof of payment of the second installment of tax shall be furnished by 30th November in cases where the payment is made in two installments.
- 6. **Penalty for delay in filing of return.**—Failure to file return in due time, unless prevented by sufficient cause, shall, without prejudice to the interest due for delay in payment, make the person from whom it is due liable to a penalty of Rs. 100/- or 1% of the tax due, whichever is higher, for every month of default. The maximum penalty shall not exceed Rs. 1000/-.
- 7. Notice for **inspection.**—The notice terms of in Sub-Section (8) of Section 88 of the Act shall be in Form-4 and the date of inspection shall, unless there are reasons to be recorded in writing for giving a shorter notice, not be less than 14 days from the date of notice.
- Notice for assessment on best judgement basis.—The notice in terms of Sub-Section (9) of Section 88 of the Act shall be in Form-5 clearly mentioning the liability of property tax proposed to be determined and the basis thereof, and the date of hearing shall, unless there are reasons to be recorded in writing for giving a shorter notice, not be less than 21 days from the date of notice.
- **Notice** for re-assessment.—The notice in terms Sub-Section (10) of Section 88 of the Act shall be in Form-5A clearly mentioning the additional amount of property tax proposed to be levied and the basis thereof, and the date of hearing shall, unless there are reasons to be recorded in writing for giving a shorter notice, not be less than 21 days from the date of notice.

- 10. **Notice of demand.**—The notice of demand in pursuance of assessment or reassessment under Sub-Section (11) or Sub-Section (13) of Section 88 of the Act, as the case may be, shall be in Form-6.
- 11.11. **Appeal.**—Till such time the Jammu and Kashmir Property Tax Board in terms of the Jammu and Kashmir Property Tax Board Act, 2013 is constituted, the reference thereto in Sections 132 and 133 of the Act shall be deemed as a reference to the **Divisional Commissioner** of the concerned division.
- 12. **Exemption from payment of property tax.**—Vacant lands, not appurtenant to a structure/building shall be exempt from property tax if there's a Master Plan in force in the area, under which any construction/development on such vacant land is disallowed or if they have been put to agricultural use as per 6-monthly cropping surveys of the Revenue Department.

Similarly, all the properties of the Municipal Corporation and all places of worship, including temples, masjids, gurudwaras, churches, ziarats, etc. and cremation and burial grounds shall be exempt from payment of property tax.

All properties owned by Government of India/UT Government shall be exempted from payment of Property Tax. However, service charge at the rate 3% of the taxable annual value shall be payable to the Corporation in respect of such properties.

SO-87.—In exercise of the powers conferred by Section 71A of the Jammu and Kashmir Municipal Act, 2000 (hereinafter referred to as the Act), read with Sub-Section (1) of Section 65 and Sub-Section (1) of Section 73 thereof, the Government hereby notifies the following rules for levy, assessment and collection of property tax in the Municipalities and Municipal Councils of Union Territory of Jammu and Kashmir.

1. Short title and commencement.—(1) These rules shall be called Jammu and Kashmir Property Tax (Other Municipalities) Rules, 2023.

- (2) These shall come into force from 1st of April, 2023.
- 2. **Definitions.**—Unless the context otherwise requires, a reference to the "Act" shall mean a reference to the Jammu and Kashmir Municipal Act, 2000, and "Form shall mean a Form appended to these Rules. Words and expressions used herein shall have the same meaning as given to them in the Act. For words and expressions not defined therein, the definition, if any, in the Jammu and Kashmir Municipal Act, 2000, the Jammu and Kashmir Development Act, 1970, the Jammu and Kashmir Property Tax Board Act, 2013, or in the General Clauses Act, 1897, in that order of precedence, shall be used as an aid to interpretation. For other words and expressions, the meaning shall be construed according to their customary usage appropriate to the context.
- 3. **Manner of calculation of property tax.**—(1) The Taxable Annual Value (TAV) of a property under the Act and the property tax due thereon for a financial year shall be calculated in accordance with the formula given in Schedule-I to these rules.
- (2) The property tax calculated in respect of a building calculated in accordance with Sub-Rule (1) above shall hold for a block of three years unless any change to such calculation is necessitated on account of the circumstances envisaged in the Act for allowing revision in such calculation.
- (3) The first block shall commence from 1st April, 2023, and shall continue to remain in force till 31st March, 2026. The blocks shall be similarly calculated thereafter.
- (4) New buildings coming up after the commencement of the block shall have their property tax liability calculated with reference to the 1st day of the relevant block, and irrespective of their having completed three years, their liability to tax shall be calculated a new from the date of commencement of the new block of three years for the Corporation as a whole.
- (5) Where a building is liable to property tax for only a part of the year, the tax due shall be proportional to the number of completed months and parts of month not completed shall be ignored.

- 4. Procedure for assessment and collection of property tax.—The procedure prescribed in Chapter VI of the Act, except insofar as it relates to the calculation of the tax due on a property, shall regulate the assessment and collection of property tax.

Station, Tral, and the investigation of the case was taken up. Subsequently, during the investigation, Section 16 of ULA (P) Act, was dropped and Sections, 17, 23, 38 and 39 of ULA (P) Act, were added in the case; and

- 3. Whereas, during the course of investigation, the site plan of the place of occurrence and the seizure memos were prepared and the statements of witnesses acquainted with the facts and circumstances of the case were recorded under the relevant provisions of law; and
- 4. Whereas, during the investigation, the accused viz. Aqib manzoor Bhat and Waris Bashir Najar, were found in contact with two persons namely Mustaquem Ahanger @ Wahid S/o Gh. Mohammad Ahanger R/o Hafoo, Nigeenpora and Irshad Ahmad Bhat S/o Fayaz Ahmad Bhat R/o Wailoo, Pattan. The accused viz. Mustaquem Ahanger, was arrested by CIK, Kashmir in case FIR No. 13/2020 of Police Station, CIK, Kashmir and the other accused Irshad Ahmad Bhat, was arrested by Baramulla Police in case FIR No. 27/2017 of Police Station, Pattan. Both the above accused were lodged in Central Jail, Srinagar, wherefrom they came in contact with accused viz. Waris Bashir Najar and Aqib Manzoor Bhat through the social media; and
- 5. Whereas, during the investigation, it was found that the accused viz. Waris Ahmad Najar, alongwith other accused namely Qaisar Ahmad Dar S/o Gh. Mohammad @ Gulzar R/o Gulshanpora, Tral, received three hand grenades from an unknown person at Shaheed Park, Pulwama on the directions of accused viz. Mustaqeem Ahanger, and handed over the greandes to accused viz. Aqib Manzoor Bhat who further handed over two grenades to one Gh. Mohammad Ahanger S/o Ab. Rehman Ahanger R/o Hafoo, Nigeenpora, Tral and kept one hand grenade in his possession with the intention to lob the same upon the Police/Security Forces in the area with the assistance of accused viz. Waris Bashir Najar. Subsequently, both the accused viz. Qaisar Ahmad Dar and Gh. Mohammad Ahanger were arrested in the case and 02 hand grenades were recovered at the instances of accused viz. Gh. Mohammad Ahanger; and
- 6. Whereas, during the investigation, it was found that an amount of Rs. 30,000/- were deposited in the account of one Mudasir Ahmad

Bhat S/o Gh. Ahmad Bhat R/o Hafoo, Nigeenpora, Tral by the accused viz. Mustaqeem Ahanger, for further distribution among the OGWS of LeT banned outfit. The said accused also transferred an amount of Rs. 1000/- in the account of accused viz. Waris Bashir Najar, for carrying out the terrorists activities. Subsequently, during the investigation, the accused viz. Mudasir Ahmad Bhat was also arrested in the case: and

- 7. Whereas, during the further investigation, it was found that the accused viz. Irshad Ahmad Bhat, after his release from the Jail joined the LeT banned outfit and later on was killed in an encounter with the Security Forces. The proceedings under the law would abate against him; and
- 8. Whereas, during the investigation, it was established that the accused viz. Aqib Manzoor Bhat, Waris Bashir Najar, Mohammad Mustaqeem Ahanger, Mudasir Ahmad Bhat, Gh. Mohammad Ahanger, Qaisar Ahmad Dar were working as Over Ground Workers (OGWs) for the terrorists of LeT banned outfit particularly terrorist namely Irshad Ahmad Bhat, and were providing logistic support to them, besides, under a well knit criminal conspiracy were facilitating the transportation of arms/ammunition for the terrorists from one place to another for carrying out the terrorist activities in the area. The accused viz. Aqib Manzoor Bhat, Waris Bashir Najar, Mohammad Mustaqeem Ahanger, Irshad Ahmad Bhat and Mudasir Ahmad Bhat, were also raising funds for the terrorists for promoting the terrorists activities in the area; and

Whereas, on the basis of the investigation, the statement of witnesses recorded and other evidence collected, the Investigating Officer, has established a *prima facie* involvement of the below mentioned accused for the commission of offences punishable under sections of the Unlawful Activities (Prevention) Act, 1967, as shown against their name:—

launched in by the Police/Security Forces and during the search, the hiding terrorists fired indiscriminately upon the Search Party, with their illegal arms/ammunition, with the intention to kill them. The fire was retaliated, triggering an encounter; and

Whereas, based on the above, a Case FIR No. 108/2022 under sections 307, 452 IPC 7/27 Arms Act, 16, 18, 19, 20, 38, 39 of ULA(P) Act, was registered in Police Station, Awantipora and the investigation of the case was set into motion. Subsequently, during the investigation, the Sections 201 and 506 IPC, were added in the case; and
- 3. Whereas, during the investigation, two dead bodies were recovered from the place of encounter who were later on identified as the terrorists of LeT banned outfit namely, Shahid Ahmad Rather S/o Gh. Ahmad Rather R/o Lurow Jageer and Umeer Yousuf Seh S/o Mohammad Yousuf Seh R/o Tukroo, Shopian. During the search, arms/ammunition viz. 01 AK-56 rifles, 01 AK-47 rifles, 05 Magazines and 13 rounds were also recovered from the encounter site; and
- 4. Whereas, during the course of investigation, the site plan of place of the occurrence and the seizure memos were prepared and the statement of witnesses acquainted with the facts and circumstances of the case were recorded under the relevant provisions of law; and
- 5. Whereas, during the investigation, the accused viz. Jahangir Ahmad Lone and Umar Shafi Lone, were in arrested in the case and it was found that the accused were in contact with the killed terrorists of LeT banned outfit namely, Shahid Ahmad Rather and Umer Yousuf Seh, and were working for the terrorists; and
- 6. Whereas, during the investigation, it was established that the accused viz.
