Whereas, the Chief Engineer Kashmir Public Health Engineering department Srinagar (Kashmir) through Executive Engineer PHE Division Pulwama submitted an indent for acquisition of 01-Kanal of

Judgement

This petition under Section 15 of the Payment of Wages Act is filed by the applicant Masooda Amin who was allegedly came to be appointed as Junior Executive on 1st March, 2008 at *Karan Nagarø Srinagar Branch who performed her duties excellently and was promoted as *Executive Operations® According to her, during floods in September, 2014, she was urged to open an emergency counter at Nallahamar Road Srinagar for rendering claims of the insured and on the verbal directions of respondent No. 2 (Branch Manager) Bajaj Allianz General Insurance Company Ltd., the applicant entertained strenuously claimants/customers while receiving the claim intimations. It is a further case of the applicants that instead of appreciating the work of the applicant, the respondent No. 2 put her on notice seeking disciplinary action against her on overreaching of job portfolio which was ultimately yielded into termination of the applicant® services.

According to the applicant on finding termination arbitrary and irrational a civil suit came to be filed against them (Management) by the applicant which is pending adjudication in the Court of 1st Additional Munsiff Srinagar and in pursuit of the appropriate remedy for recovery of the genuine wages this application under the Payment of Wages Act is preferred under Section 15 of Payment of Wages Act.

It is further stated that even a criminal complaint was filed against respondent No. 2 wherein cognizance was taken and process was issued by Court of Judicial Magistrate Ist Class hence petitioner may be paid salary due from January 2014-May 2015 upto Rs. 5,95,000/-alongwith gross salary at the time of her termination as Executive Operations is equal to Rs. 3,50,000/- alongwith emulation wages payable to the applicant.

Respondents in their demurrer denied all contents of petitioner being frivolous and concocted one, besides Respondents No. 2 is not Heard .Perused objections taken by respondents as well as written submissions. Respondents have argued that the present petition is hit by Limitation Act as the same is not filed withen a period of twelve months from the date of cause of action. Respondents categorically stated in their written reply that no amounnt was ever deducted by the company as the same was not allowed to be decucted hence all the deducted and recoveries made from out of full and final settlement upon termination of services. The petitioner are in line with the Payment of Wages Act and absolutely there is no occasion for filing any petition against the respondents. According to the respondents the petitioner vide her written letter admitted that petitioner has accepted 32 claim intimations and handed over to Mr. Adil, surveyor who is working with G.N- Teli Surveyor on the panel of respondent no. 1 Hence all these illegal acts/commission and omissions done by the petitioner were not part of the duties of the petitioner who was not authorized to do so without any authority. Cosequently she was put under suspension in contemplation of a formal enquiry into the matter vide letter dated 30-12-2014 and ultimately she was terminated from services vide order dated 03-03-2015 on having and over all view of the matter by the competent authority.

Considered arguments put forth herein and entire material on record. LC for petitioner has in his petition stated that a civil suit seeking mandatory injunction came to be filed by her and an *ex-parte* injunction was granted by Ld. Munsiff Srinagar vide its order dated 06-04-2015 which was subsequently vacated by the aforesaid Court.

I have carefully perused the record and evidence affidavit of the petitioner Masooda Amin as well as of her witnesses namly Mohammad Amin Baba and Nazir Ahmad Bhat wherein both the witnesses have corroborated the statement of Masooda Amin.

Keenly perused provisions of the Payment of Wages Act (Section 15) and also of Limitation Act it appears that nowhere the petitioner has denied the assertions put forth by respondents that she has not overreached her job and handled 32 claims without instructions/orders passed by respondents even keen perusal of evidence affidavit filed by the petitioner reveals that there is no mention of any deduction part from the petitioner.

It has also came to notice of this Tribunal from record borne out here that present petition is not tenable under Section 15 read with other provisions of Payment of Wages Act as O.P has not deducted any amount and all recoveries/deductions from petitioner are done only on termination of the petitioner.

Record transpires that there is no negation of contentions put forth by the respondents in their reply hence this Tribunal has arrived at the conclusion that the petitioner has miserably failed to prove his petition beyond any shadow of doubt hence the same is dismissed being devoid of any legal force. Resultantly petitioner is held entitled to no relief as sought for through this claim petition. The reference is answered accordingly. File be consigned to records after its due compilation.
