AND WHEREAS, in pursuant of the above, 04 objections (representations) were received after issuance of tentative seniority list/notice, which have been examined and disposed off, as per **Annexure "A"** to this order.

AND WHEREAS, during the period of examination of the representations, 02 Departmental Tehsildars namely S/Shri Mohd Altaf Bhat and Mr. Abdul Gaffer Bhat were appointed to time scale of Jammu and Kashmir Administrative Service w. e. f. 12-12-2022 vide Government Order No. 177-JK(GAD) of 2023 dated 06-02-2023 issued by the General Administration Department, as such their names have been deleted from the Seniority List.

Now, therefore, the Final Seniority List of the members of the Jammu and Kashmir Revenue (Gazetted) Service (Tehsildars) as it stood on 01-01-2023 forming **Annexure "B"** to this Government order is hereby issued, subject to the following conditions that :—

Whereas, based on the above, a case FIR No. 156/2022 under Sections 7/25 Arms Act, 18, 20 and 38 of ULA was registered in the Police Station, Awantipora, and the investigation of the case was set into motion. Subsequently, during the investigation, the Section 23 of ULA (P) Act was added in the case ; and

3. Whereas, during the investigation, the site plan of place of occurrence and the seizure memos were prepared and the statements of witnesses acquainted with the facts and circumstances of the case were recorded under the relevant provisions of law; and

4. Whereas, during the investigation, the accused viz. Aamir Ahmad Parray, was found in contact with a terrorist of Al-Badr banned outfit namely, Aadil Hussain Wani S/o Mohd. Khalil Wani R/o Kutpora, Shopian, who provided the arms/ammunition to the accused viz. Aamir Ahmad Parray, in order to promote terrorist activities in the case ; and

5. Whereas, during the investigation, it was established that the accused viz. Aamir Ahmad Parray, was member of Al-Badr banned outfit and under a well knit criminal conspiracy procured arms/ammunition from the terrorist namely Aadil Hussain Wani, for carrying out the Terrorist Activities in the area ; and

6. Whereas, on the basis of the investigation, the statement of witnesses recorded and other evidence collected, the Investigating Officer, has established a *prima facie* involvement of the below mentioned accused for the commission of offences punishable under sections of Unlawful Activities (Prevention) Act, 1967, as shown against their name :—

Whereas, the Authority, appointed by the Government under Sub-Section (2) of Section 45 of the Unlawful Activities (Prevention) Act, 1967, has independently examined the Case Diary File and all the other relevant documents relating to the case and has come to the conclusion that a *prima facie* case is made out against the above accused; and

Whereas, after perusing the Case Dairy File, the relevant documents and also taking into consideration the views of the Authority appointed under Sub-Section (2) of Section 45 of the Unlawful Activities (Prevention) Act, 1967, the Government is of the view that there is sufficient material and evidence available against the above mentioned accused for their prosecution under the provisions of law.

The accused was found in contact with the terrorists of Peoples League namely Mukhtar Ahmad R/o Anantnag and Usman through the virtual mode, who provided the Hand Grenades to the accused viz. Nisar Ahmad Ahanger, in order to promote terror activities in the area ; and

4. Whereas, during the investigation, the site plan of place of occurrence and the seizure memos were prepared and the statements of witnesses acquainted with the facts and circumstances of the case were recorded under the relevant provisions of law; and

5. Whereas, during the investigation, it was established that the accused viz. Nisar Ahamd Ahanger, was working as Over Ground Worker (OGW) for the terrorists of Peoples League particularly the terrorists namely Mukhtar Ahmad and Usman, and was providing logistic support to them, besides, under a well knit criminal conspiracy procured hand grenades from the said terrorists for carrying out the terrorist activities in the area ; and

6. Whereas, the investigation, of the case shall continue to ascertain the actual identified of the accused viz. Mukhtar Ahmad and Usman, and to bring out their role/involvement in the case ; and

7. SO-46.— Whereas, Section 427 of the Jammu and Kashmir Municipal Act, 2000, provides as follows :—

"427. Power to remove difficulties :- If any difficulty arises in giving effect to the provisions of this Act or by reasons of anything

contained in this Act to any other enactment for the time being in force, the Government may, as occasion requires, by order direct that this Act shall during such period as may be specified in the order but not extending beyond the expiry of two years from the commencement orders have effect subject to such adaptations whether by way of modification, addition or omission as it may deem to be necessary and expedient".

WHEREAS, Sub-Section (1) of Section 45 of the Municipal Corporation Act, 2000 provides for appointment of the Commissioner of the Municipal Corporation which reads as under :—

"45. Appointment of Commissioner :- (1) The Government shall, by notification, in the Government Gazette, appoint a Class 1 Officer of the Government having a service of not less than fifteen years, as the Commissioner of the Corporation".

AND WHEREAS, vide notification S.O. 271 of 2022 dated 03-06-2022, the difficulty in giving effect to Sub-Section (1) of Section 45 of the Act was removed by insertion of a suitable proviso, which was deemed to come into force w.e.f 01-01-2021 for a period of two years or till it is revoked.

AND WHEREAS, the period of the said S.O. Notification has expired by efflux of time on 01-01-2023 and a difficulty has again arisen in giving effect to Sub-Section (1) of Section 45 of the Act, as the stipulation of having service of 15 years of experience as envisaged therein will lead to administrative difficulties resulting in affecting smooth functioning of the Corporations and providing better services to public at large.

Now, therefore, in exercise of powers conferred under Section 427 of the Jammu Kashmir Municipal Corporation Act, 2000, the Government hereby makes the following order, namely :—

1. Short title and commencement.— (1) This order may be called the Jammu and Kashmir Municipal Corporation (Removal of Difficulties) Order, 2023.

(2) It shall deemed to have come into force w.e.f. 01-01-2023 and shall remain in force for a period of two years or till it is revoked by the Government, whichever is earlier.

 Removal of Difficulties.— The difficulties arising in giving effect to the provisions of Section 45 of the Jammu and Kashmir Municipal Corporation Act, 2000 have been removed in the following manner, namely :—

In Section 45, after Sub-Section (1), following proviso shall be inserted namely :----

"Provided that notwithstanding anything contained in Sub-Section (1), the Government may appoint any suitable Officer as Commissioner of the Corporation, irrespective of his service experience, for the smooth functioning of the Corporations".

The accused viz. Showkat Ali, motivated other accused and handed over 01 hand grenade to the accused viz. Mohd. Abbass, who on the date of occurrence hurled the said hand grenade upon the police Post, Ind, Gool, with the assistance of other two accused viz. Shah Din Padyar and Mohd. Farooq. Subsequently, during investigation, 02 hand grenades and an amount of Rs. 44,650/- were recovered at the instances of accused viz. Showkat Ali and Mohd. Farooq respectively ; and
