This shall not only ensure materializing of fruitful ideas/initiatives, but would also foster value-addition in the governance structure, converting and idea into tangible outcome.

It is accordingly enjoined upon all Administrative Secretaries and Heads of Departments to establish these *Excellence Groups* hand make them vibrant by organizing discussions, while inviting senior officers, who have previously worked in these departments/offices. APR cycle of Gazetted Officers for the financial year 2022-23 on SPARROW platform, all the Officers who are entrusted with the role of custodians, in respect of Gazetted Officers on SPARROW platform, across all departments, shall get the requisite information of the Gazetted Officers as per the enclosed format (Annexure-'A'). Further, details of Initiating/Reviewing/Accepting Authorities of the Gazetted Officers, shall be in accordance with the rules notified vide Government Order No. 1311-GAD of 2001 dated 09-11-2001 read with Government Order No. 375-GAD of 2008 dated 26-03-2008, Government Order No. 150-JK(GAD) of 2019 dated 06-12-2019 and Government Order No. 09-JK(GAD) of 2021 dated 05-01-2021. This information shall be used by the Custodians to generate blank APRs of the Gazetted Officers for self appraisal.

Further the blank APRs for the financial year 2022-23, once generated by the Custodians shall be forwarded to the concerned Gazetted Officers through the portal for self appraisal which shall subsequently be forwarded to Initiating, Reviewing and Accepting Authorities. The APRs shall remain available in the account of the Officers for fixed timeline and thereafter shall be auto forwarded.

It is accordingly, impressed upon all the Officers, to record Annual Performance Reports as per fixed timelines and strictly in accordance with rules notified by the Government from time to time, to avoid forward at any stage, which would be treated as default on the part of the Officers concerned. Besides all the Administrative Departments shall strictly monitor and ensure timely completion of APR cycle in respect of Gazetted Officers for the financial year 2022-23.

In order to have a clear distinction under District Plan and Union Territory Level Sectoral Plans, the following schemes shall constitute the District Plan for the financial year 2023-24 starting from 1st of April, 2023:

- i. Area Development Schemes comprising of DDC/BDC grants under Grant No. 08-Finance and the Panchayati Raj Institution (PRI) grants under Grant No. 28-Rural Development Department.
- ii. The United Scheme implemented by District Development Commissioners.
- iii. The NFB Scheme implemented by District Development Commissioners.
- iv. Aspirational Block Development Scheme implemented by Planning, Development and Monitoring Department.
- v. Aspirational Panchayat Development Scheme implemented by Planning, Development and Monitoring Department.
- vi. Samridh Seema Yojina implemented by Planning, Development and Monitoring Department.
- vii. Back to Village Programme implemented by District Development Commissioners.
- viii. Infrastructure Upgradation Scheme shall include all the sector specific schemes. The DDCs shall ensure the utilization of funds under this scheme through ULBs and PRIs proportionally.
- ix. Border Area Development Scheme implemented by Planning, Development and Monitoring Department.
- x. Constituency Development Scheme of elected Members of Legislative Assembly.
- xi. MP LAD Scheme.
- xii. SDRF.
- 2. The Panchayat level Plans and Block Level Plans shall be subsumed in the District Plan.
- 3. The UT level plan shall comprise resources related to functions that are not devolved to the PRIs or are inter-district

plans or such other plans that are generally incorporated in Departmental Plans.

- 4. The DDCs shall ensure the compilation and submission of Work Plans/Action Plans in consultation with PRIs under the above mentioned schemes under District Plan as per the 11th Schedule of the Constitution of India which has been added by the 73rd Amendment Act of 1992 which contains the provisions that specify the powers, authority and responsibilities of Panchayats. The Work Plans of each District shall cover 29 matters as specified in 11th Schedule of the Constitution of India, on the basis of need assessment analysis.
- 5. Conequently, it is further clarified to all the Departments/DDCs that:
 - i. those Centrally Sponsored Schemes which are being implemented in Districts, shall also be included in the District Sector planning and developmental process for monitoring purpose. The said schemes, however, shall continue to be funded through Departments as per the prevailing practice.
 - ii. the schemes funded through NABARD which are being implemented in Districts, shall form the part of Works Plan of the Departments concerned under UT Plan from 1st April, 2023 onwards. However, these shall continue to be monitored at district level.

Any ongoing works/schemes on this account shall also be shifted and incorporated under UT Plan by the Departments after obtaining the B12 statements of all works from the DDCs and shall be adjusted against the existing sectoral ceilings of 2023-24 shown distinctly in Demands for Grants 2023-24.

The Government of J&K has introduced AB-PMJAY, SEHAT Scheme which provides free health insurance cover to all the citizens of J&K for Rs. 5 lakhs per family per year on floater basis. Subsequently,

Consequent upon the above, it has come to the notice of the Finance Department that difficulties have been faced by various beneficiaries for reimbursement of expenditure incurred on the treatment of life consuming diseases outside hospital/institute and on OPD basis.

The issue has been examined in consultation with the Health and Medical Education Department and Chief Executive Officer, State Health Society, ABPMJAY, J&K, which have clarified as under :ô

"As per the Health Benefit Packages (HBP) 2.0 issued by National Health Authority (NHA), there are 1574 treatment packages covered under Ayushman Bharat PM-JAY and AB-PM-JAY-SEHAT. Accordingly, secondary and tertiary care in-patient services including day care procedures are covered. This may include IPD/day-care-based treatment of life consuming diseases. However, OPD services, prescription given by doctor on OPD Basis and standalone diagnostics are not covered under the scheme."

Accordingly, it is clarified that the medical expenses incurred on the treatment of life consuming diseases outside hospital/institute shall continue to be reimbursed in terms of rule 5(5) of the J&K Civil Services (Medical Attendance and Allowance) Rules, 1990.
