Circular

The Government-e-Marketplace(GeM) has been setup as National Public Procurement Portal by Union Cabinet for facilitating procurement of Goods and Services required by Central and State Government organizations. The initiative was launched to create an open and transparent procurement platform for Government buyers.

GeM, presently has the mandate to facilitate procurement of Goods and services only and does not have mandate for procurement of works.

It has been observed by GeM, that the bids for procurement of works are being published by several buyers on the GeM portal, either as ::Custom bid for services@ or BOQ bids. As per GeM, the range of service providers registered on GeM for custom bids or BOQ bids may not be having the expertise in *#works* contact*@* and GeM has also not evaluated their credentials from the perspective of a works contract. This may lead to unsatisfactory performance by the service providers against the works contract concluded through GeM besides the possibility of higher rates.

Consequently, the buyers issuing such bids have been advised to cancel works related bids floated on GeM protal and to utilize suitable procurement portal for issuance of works related bids. In some cases GeM has also cancelled these bids.

All the Administrative Departments are accordingly, requested to direct their subordinate offices not to create any works related bid on GeM and use suitable procurement portal *(jktenders.gov.in)* for issuance of works related tenders.

Award/Judgment

On being reference made by Government vide SRO-327 dated 26-07-2018, present petition came to be filed in terms of Sub-Section 1 of Section 10 of Industrial Disputes Act, 1947 for adjudication on the following issues : \Box

- 1. Whether the transfer of the applicant Smt. Shruti Sharma has been done legally or not by her employer i.e. Empower Pragati, Vocational & Staffing Pvt. Ltd. ?
- 2. Whether the termination order of the applicant Shruti Sharma issued by her employer i.e. Empower Pragati, Vocational & Staffing Pvt. Ltd. is legally sound or not ?
- 3. If illegality of the action of the employer is proved, then to what relief the applicant is entitled to ?

Synopsis of the present case is that petitioner was working as :Vocational Trainerøin Jammu at :Sunjwan Stationøunder the Centrally Scheme of **'vocationalization'** of Higher Education Programme in alignment with NSQF for 1.5 years and all of sudden she was imposed to accept transfer for a far-flung border location where there is no **road connectivity.**

> 1. According to her it was quite inconvenient for her to reach at her work place being a mother of 4 years old girl child who is

not fit to travel for long routes and accordingly she made request to project coordinator and the company to consider her concern and problems but all in vain. It is further alleged that the company appointed a new Vocational Trainer at -Government Higher Secondary School, Domanaø but the vacant position was at -GHSS, Sumb, Sambaø She also represented to the company regarding this transfer order through e-mails as well for praying to set aside the impugned transfer order and further for allowing her to work at Jammu but her request was turned down.

- Being aggrieved, the petitioner approached to Conciliation Officer, Jammu for reconciliation but the same failed as no negotiation/settlement arrived between the parties and consequently failure report from Assistant Labour Commissioner, Jammu vide ALC/J/I.D. Act/18/1080 dated 28-03-2018 was forwarded to Commissioner Secretary to Government, -Labour & Employment Departmentø for reference of the dispute to Industrial Tribunal for adjudication.
- 3. The factual matrix of the present petition is that the applicant has been working as -Vocational Trainerø in Jammu at Sunjwan Stationø under the Central Scheme of Vocationalization of **'Higher** Secondary Education Program' in alignment with NSQF. On transfer of the applicant from Jammu to Samba during pendency of the dispute under reference, the petitioner was terminated from services. The applicant/petitioner has challenged this order being illegal and also alleged that the management had committed an **unfair labour** practice by transferring her from Jammu to Samba. Thereafter issued termination letter with a mala fide intention. Since dispute between the parties could not be settled amicably during conciliation proceedings, hence the matter was referred for adjudication on the aforesaid issues.

- 4. Respondents in their response denied the allegations leveled by the petitioner and contended that the non-applicant No.1 has not appointed the applicant nor has transferred her as such the present complaint/petition is liable to be dismissed against **CEO**, Jammu. Respondents have also brought to the notice of this Tribunal that the transfers of the vocational trainers has taken place in other States as well besides State of J&K. Moreover transfer is an incident of service and thus an employee is transferred to any equivalent post without any adverse consequence on his service or career prospect. Therefore scope of judicial review is very limited.
- 5. According to respondent, transfer of Smt. Shruti Sharma was made by "Empower Pragati Vocational and Staffing Pvt. Ltd.". Therefore Chief Education Officer, Jammu has no role in her transfer besides transfer order of the applicant/petitioner was issued by State Project Coordinator(J&K) Empower Pragati, Vocational & Staffing Pvt. Ltd. and the Chief Education Officer, Jammu forwarded the copy of the transfer order concerned authority for immediate to the implementation hence there is no basis for any unjustified transfer attributed to Chief Education Officer, Jammu, hence the present petition is not maintainable against the respondent non-applicant No. 2 has also (Project No.1 and even Coordinator Empower Project Vocational & Staffing Pvt. Ltd.) in their response contended that applicant/employee is transferred to an equivalent post without any adverse consequence on her service. According to respondent No. 2, the applicant/petitioner was transferred strictly as **per policy** and these are based on requirement. This being irregular activities, should not be considered as alone initiative, as in State of -J&K Vocational Trainersø have been transferred by other vocational training providers those are also working with RMSA, J&K. Moreover transfer took place in 13 other States as well. Empower Pragati is handling NSQF Project as the policy of -RMSAøis not to keep vacant any school for

more than 7 days and if this happens, a trainer who is at fault should be terminated.

- 6. Heard. Petitioner in person, considered response/objections taken by the respondents. It is pertinent to mention herein that after filing of reply to the petition by respondent, they absented themselves, consequently were set *ex parte*. Even petitioner did not examine any other witness except his own statement. Petitioner was also not subjected to cross examination as respondents were in *ex parte*, hence his evidence goes **unrebutted**.
- 7. Heard. Petitioner at length, perused her statement on oath in the shape of affidavit wherein she stated that her services were terminated illegally and with *mala fide* intention which is required to be set-aside. According to petitioner, she was engaged on contractual basis by respondent No. 2 hence cannot be transferred to any other place like regular employee.
- 8. Considered pleas put forth herein and statement of petitioner on oath. The petitioner reiterated in her arguments that her services were supposed to be supervised by the \exists RMSAø as the project of Vocational Training which was launched by -RMSAø and Empower Pragati was an executing agency. According to her, appointment was for particular place and in the advertisement, it was also mentioned that preference will be given to candidate of same district. Respondent vide letter dated 31-10-2020 also expressed their willingness to pay pending salaries i.e. Full salary for the month of February, 2018 and 15 days salary for the month of March, 2018 to petitioner/applicant. Besides respondent No. 2 in their written submissions, stated that transfer of employees in Empower Pragati is done as per Corporate HR Policy and is based on requirement and there is a regular activity which should not be considered as a standalone initiative. After consideration of entire material on record it is held that transfer is an exigency of service and an employee cannot force to serve at a particular place of her choice. In the instant case as well, petitioner was irked by her transfer order dated 02-02-2018 and did not join her new place of posting, consequently her contractual services were terminated as the respondent company was not prepared to concede all the unreasonable

demands of the applicant at any cost. From careful scrutiny of reply and documents relied upon by the company, it appears that respondent company was justified in their place by revoking the contractual services of petitioner being **not good** subordinate and also by showing annoyance at respondents on her transfer which is merely an exigency of service. Thus issue Nos. 1 & 2 are decided against petitioners and in favour of respondent. However, respondents are directed to release dues/salaries to petitioner if entitled to under rules which they have also admitted thus issue No. 3 is decided accordingly in favour of petitioner. Thus all 3 issues are decided and reference is answered accordingly. Resultantly, as it has been held that the petitionerøs termination is legal one in light of supra. Thus the award may be published accordingly.
