Circular No. 30-JK (GAD) of 2023  
Dated 11-10-2023.

The Transgender Persons (Protection of Rights), Act of 2019, prohibits the discrimination, denial or unfair treatment of members of Transgender community in educational establishments, employment, health institutions and public services etc.

The aforementioned Act makes it obligatory for the Government to take appropriate steps to secure full and effective participation of transgender persons, their inclusion in the society, to facilitate their access to welfare schemes framed by the Government and to prevent discrimination in matters relating to their employment.

In pursuance to the provisions of the aforementioned Act, the Department of Personnel and Training (DOPT), Ministry of Personnel Public Grievances and Pensions, Government of India vide Office Memorandum No. 39028/02/2016-Estt (B) dated 20-04-2020, has issued an advisory to all Ministries and Departments in Government of India, requesting for modification of the relevant Examination Rules to provide for inclusion of Transgender as a separate category of gender. DOPT has also notified Civil Services Examination Rules, 2020 on 05-02-2020, providing for inclusion of Transgender as a separate category of gender for the said exam.

Accordingly, all Administrative Departments are requested to modify the relevant Examination/Service rules, as the case may be, for inclusion of a separate category of “Third Gender/any Other Category” in the application forms in recruitment to various posts in the UT of J&K so as to ensure that the relevant rules are in conformity with the Transgender Persons (Protection of Rights), Act of 2019.

Comprehensive guidelines have been issued through Circulars No. 22-GAD of 2006 dated 30-08-2006, 21-GAD of 2007 dated 06-06-2007 and Circular No. 29-GAD of 2018 dated 19-07-2018, outlining the process for obtaining approval for the temporary assignment (Personal Visits, Training and other official purposes) of officers and officials outside the country or state.

However, it has been observed that the departments are sending/deputing officers outside the Union territory of J&K without prior consultation or approval from the competent authority, and seeking subsequently *post facto* approval. This practice is in violation of the circular instructions issued on the matter.

Therefore, it is once again emphasized to all the Administrative Secretaries that proposal related to deputation of officers for training programs or other official tasks, outside the Union territory or country, must be submitted to the competent authority, well in advance, for obtaining

approval. Administrative Secretaries are accordingly advised to desist from submitting proposals for *post facto* approval and follow the *ibid* instructions strictly.

#### **INTRODUCTION :**

The proceedings are as per the provisions of Section 23 of “The Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013” for determination of

compensation in respect of land measuring 01 Kanal 04 Marlas 05 Sirsai 20.25 Sft's under survey No. 7 min, 16 min, 61 min, 92 min, 371 min, 384 min, 392 min required for the erection of 7 towers at Village Bathen and land measuring 01 Kanal 02 Marlas 01 Sirsai 29.5 Sft's under Survey No. 3819 min, 3822 min, 3826 min, 3827 min, 3842 min required for the erection of 4 towers at Village Khrew Tehsil Pampore, the acquisition proceedings were initiated on the basis of request made by the requiring body viz. Chief Engineer JK Power Transmission Corporation Ltd., Kashmir.

**NOTIFICATION OF SOCIAL IMPACT ASSESSMENT AND REPORT OF SIA :**

The process for conduct of Social Impact Assessment report under the provisions of Section 4 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 was initiated as per this office No. ADC/AWP/LA/20-21/463-73 Dated 23-03-2021, in concurrence with the District Collector office order No. DCP/LA/2020/610-30 Dated 25-08-2020 whereby following members already nominated were assigned the task for conduct of the field survey for the proposed project.

1. Tehsildar Concerned.
2. Assistant Executive Engineer, R&B, Pampore
3. Assistant Executive Engineer (Jal Shakti) PHE Sub Division, Pampore
4. Assistant Executive Engineer, Irrigation, Sub Division Khrew
5. Range Officer SC Range Pampore
6. Agriculture Extension Officer, Zone Pampore
7. Representative of Indenting Department.

The report so prepared by the committee members for the instant land acquisition case was submitted to the Appropriate Government/ District Collector vide this office No. ADC/AWP/LA/21-22/74-76 Dated 27-05-2021 for accord of approval/authorization for issuance of Notification under Section 11 of the said Act.

**EVALUATION OF SOCIAL IMPACT ASSESSMENT REPORT :**

On the basis of the recommendations and the observations submitted by the committee constituted it was established that the land for which the indent stands placed is required for legitimate and *bona fide* public purpose which necessitates the acquisition of land identified. Direction to the Collector for proceeding ahead under the



provisions of Section 11 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 was communicated by the District Collector vide his office No. DCP/LA/2021/420-22 Dated 07-09-2021.

**PUBLICATION OF NOTIFICATION AND ISSUE OF NOTICES :**

The preliminary notification under Section 11(1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 was issued vide this office Notification No. 06 of 2021 Dated 11-10-2021 under endorsement No. ADC/AWP/LA/21-22/543-50 Dated 11-10-2021 for calling upon the objections, if any, from the interested persons/landowners. The same was got published in the official gazette on 9th December 2021 in Volume 134 and in two leading daily news papers viz. “Srinagar Times dated 14-10-2021” and “Kashmir Vision dated 15-10-2021” and wide publicity was also made. In response to the said notification, during the stipulated period of time, three objections were received, heard and accordingly submitted along with approximate cost of land acquisition as laid under Section 15 of the Act vide this office No. ADC/AWP/LA/21-22/814-18 Dated 28-03-2022 with recommendations to the District Collector Pulwama for a decision and if found appropriate issuance of declaration under Section 19 of the Act.

The case was examined by the “appropriate Government” District Collector who after thoughtful consideration was satisfied that the land under acquisition is in the interest of the public purpose, therefore, the acquisition of land outweigh the objections raised. The “appropriate Government” District Collector issued declaration under Section 19(1) of the Right to Fair Compensation and transparency in Land Acquisition, Rehabilitation and Re settlement Act, 2013 vide Notification No. 11 of Rev/LA of 2022 Dated 28-04-2022 under endorsement No. DCP/LA/2022/37-40 Dated 28-04-2022, declaring that the land measuring 01 Kanal 04 Marlas 05 Sirsai 20.25 Sft. under Survey No. 7 min, 16 min, 61 min, 92 min, 371 min, 384 min, 392 min is required for the erection of 7 towers at Village Bathen and land measuring 01 Kanal 02 Marlas 01 Sirsai 29.5 Sft under survey No. 3819 min, 3822 min, 3826 min, 3827 min, 3842 min is required for the erection of 4 towers at village Khrew Tehsil Pampore.

Public notice under Section 21(1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 was issued to the interested persons/land owners

to state the particulars of the land so needed, and to state the nature of their respective interests in the land and the amount and particulars of their claims to compensation for such interests, their claims to rehabilitation and resettlement along with their objections, if any, to the measurement made and to appear personally or by agent or advocate within a period of 30 days. The same was got published in the official gazette on 20th October 2022 in Volume 135 and in two leading daily news papers viz. “Rising Kashmir dated 30-07-2022” and “Greater Kashmir dated 30-07-2022” and wide publicity was also made. During the prescribed period of time no such objection was received by the Collectorate.

**METHODOLOGY USED FOR DETERMINATION OF COMPENSATION :**

On the basis of alignment given by the Executive Engineer TLMD-IV Pampore revenue extracts, including Khasra Paimaish were submitted by the Tehsildar Pampore. The type of land for Khasra numbers of both of the villages are recorded as Maidani. The land rates per kanal as applicable to the type of land stands notified by the Chairman District Valuation Committee vide his office order No. 12/DCP-SQ of 2021 Dated 31-12-2021 under endorsement No. DCP-SQ/20-21/1689-1703 Dated 31-12-2021 under the Market Value Guideline Rules of 2011 for the year 2022 for the corresponding year is as under :—

**POSSESSION OF LAND :**

The possession of the land proposed for the erection of 7 towers at Village Bathen and 4 towers at village Khrew Tehsil Pampore District Pulwama shall be taken after compliance of Section 38 by the Collector Land Acquisition (Additional Deputy Commissioner) Awantipora and shall be handed over to the requiring Department i. e. Executive Engineer TLMD-IV Pampore.

**MUTATION OF OCCUPANCY IN RESPECT OF THE SAID LAND BEING ACQUIRED :**

Consequent upon taking over possession of the said land and the payment of the compensation to the concerned interested persons, the Tehsildar Concerned shall ensure that the revenue records and all the relevant documents relating to the ownership/occupancy of the said land are accordingly updated and show the transfer of the said land solely in the name of Government through JK Power Transmission Corporation Ltd. Kashmir.

**APPORTIONMENT :**

Compensation amount will be paid accordingly to the latest entries in the Revenue Record and as per enquiry conducted under Section 23. In case of any dispute, which I cannot settle within reasonable time, the amount of compensation will be remitted to the Court under Section 64 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 for the determination of ownership rights.

**ENCUMBRANCES :**

The land under acquisition is free from all encumbrances and has been mentioned in the Award statement.

**DETERMINATION OF SOLATIUM :**

As per the provisions of Section 30(1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013, 100% of the market value is awarded as Solatium has been determined in the Award statement.

**COMPENSATION OF LAND AND ADMINISTRATIVE CHARGES :**

1. This criminal challan has been presented in this court after getting the same transferred from the court of learned Chief Judicial Magistrate, Ramban and same is pending for disposal before this court.

Whereas, since the presentation of challan till today accused is continuously absent in this case against him warrants were

issued regularly. On last date also Non Bailable warrant was issued against the accused through SSP Ramban and in case of non execution written explanation was sought from SSP Ramban and Tamili concerned was directed to remain present in person.

3. Said warrant received back unexecuted with detailed report of SSP Ramban and Tamili concerned has also caused presence. As per report of SSP Ramban a police team headed by ASI Neeraj Kumar No. 956090 EXJ was deputed and directed to get the accused arrested vide movement order No. 14940-45/2003 dated 30-08-2023. During search accused was not found and on enquiry made from Sarpanch, wife and mother of accused, it is found that accused is driver by profession and is not residing at his home for last year and whose whereabouts are not known nor he has any contact with his family. To this effect, statement of ASI Neeraj Kumar No. 956090 EXJ has also been recorded wherein he has prayed that he made best efforts to arrest the accused person but he could not be arrested for said reasons. On going through the material on record including report of SSP Ramban and statement of Tamili it is *prima facie* indicated that accused person is concealing himself and it is impossible to arrest him as he is avoiding arrest and there is no immediate prospects to arrest the accused and produce him in the court. Now the question is how the general warrant of arrest can be executed against the accused person. *Prima facie* I am satisfied that accused is concealing himself and evading arrest and there is no immediate prospects to arrest him. So the accused person is proceeded in terms of Section 299 Cr. P.C. Office to issue general warrant of arrest against the accused person which shall be sent to Incharge P.S. Ramban and SSP, Ramban authorizing them to arrest the accused whenever and wherever he is found within UT of J&K State and produce him before this court. Copy of general warrant of arrest be also sent to Government Press, Jammu for publication in Government Gazette. One copy of general warrant of arrest

be also sent to the Commissioner of Police, Punjab for execution and producing the accused person if found within his range. Case file is consigned to record till arrest of the accused person or till he surrenders before the Court, it shall be called from the record.

Whereas, based on the above, a case FIR No. 41/2022 under Section 7/25 Arms Act and the Sections 13, 18 and 20 of ULA(P) Act, was registered in the Police Station, Shalteng, and the investigation of the case was set into motion. Subsequently, during the investigation, the offence under Section 20 of ULA (P) Act was dropped and the offence under Sections 23 and 39 of ULA (P) Act were added in the case ; and

3. Whereas, during the investigation, the site plan of the place of occurrence and the seizure memos were prepared and the statements of witnesses acquainted with the facts and circumstances of the case were recorded under the relevant provisions of law ; and

Rouf Safeer Dar, Javid Ahmad Khanday and Mohd Iqbal Dobi, in order to promote terrorist activities in the area ; and

6. Whereas, during the investigation, it was established that the accused viz. Rouf Safeer Dar, Javid Ahmad Khanday, Mohd Iqbal Dobi, Shakir Ahmad Zargar and Waris Ramzan Gojri, were working as Over Ground Workers (OGWs) for the terrorists of LeT banned outfit and under well knit criminal conspiracy were providing logistic support to them, besides, the accused viz. Rouf Safeer Dar, Javid Ahmad Khanday, Mohd Iqbal Dobi, procured arms/ammunition from the terrorists for carrying out the terrorist activities in the area ; and

7. Whereas, on the basis of investigation, the statements of witnesses recorded and other evidence collected, the Investigating Officer has established *prima facie* involvement of the below mentioned accused for the commission of the offences punishable in terms of the provisions of Unlawful Activities (Prevention) Act, 1967, as shown against their names :—

Karamatullah, Suhail Bashir Ganie and Aadil Gani Lone, were arrested in the case and the said accused alongwith one more person namely Irshad Ahmad Kumar @ Amir S/o Manzoor Ahmad Kumar R/o Tral-e-Payeen, were found in contact with a Pakistan based terrorist of LeT banned outfit namely Faiz Ali @ Baber R/o Pakistan. Subsequently, during the investigation, the accused viz. Irshad Ahmad Kumar @ Amir, was also arrested in the case ; and

Subsequently, during the investigation, the IED was recovered at the instance of accused viz. Karamatullah and defused in presence of the Magistrate ; and



7. Whereas, the investigation, in respect of unknown persons who provided an amount of Rs. 05 lacs and the IED to the accused viz. Karamatullah and Suhail Bashir Ganie, respectively shall continue to ascertain their identity and to bring out their role/involvement in the case ; and

Whereas, during the investigation, the dead bodies of four terrorists of LeT banned outfit who were later on identified as Amir Shafi Mir S/o Mohd Shafi Mir R/o Batpora, Palpora, Rayees Ahmad Bhat S/o Mohd Sultan Bhat R/o D. K. Pora, Aftab Ahmad Wani S/o Ghulam Mohd Wani R/o Dachipora and Aqib Ahmad Malik S/o Ghulam Rasool Malik R/o Ganawpora Arsh, were recovered from the place of encounter. Faisal Nazir Mir and Umer Pathan, were recovered from the place of encounter and during the search, arms/ammunition viz. 1AK-56 rifle, 02 AK magazines, 25 rounds, 01 Chinese Pistol, 01 magazine and 03 rounds, were recovered from the place of occurrence ; and

4. Whereas, during the investigation, the site plan of the place of occurrence and the seizure memos were prepared and the statements of witnesses acquainted with the facts and circumstances of the case were recorded under the relevant provisions of law ; and

5. Whereas, during the investigation, one Arshid Ahmad Mir S/o Abdul Rahman Mir R/o New Colony, Takiabal, Brakpora, Anantnag, was found involved in the case. Subsequently, the accused was arrested and was found working for the killed terrorists viz. Faisal Nazir Mir and Umer Pathan, in order to promote terrorists activities in the area ; and

6. Whereas, during investigation, it was established that the accused viz. Arshid Ahmad Mir, was working as Over Ground Worker (OGW) for the terrorists of JeM banned outfit particularly the killed terrorists viz.

Faisal Nazir Mir and Umer Pathan, and was providing logistic support to them for carrying out the terrorist activities in the area ; and

7. Whereas, the accused terrorists viz. Faisal Nazir Mir and Umer Pathan, have been killed in the said encounter with the security forces and the proceedings under the law would abate against them ; and

Subsequently, during investigation, the offence under Sections 16, 18 and 39 of ULA (P) Act, were added in the case ; and

3. Whereas, during the investigation, the site plan of the place of occurrence and the seizure memos were prepared and the statement of witnesses acquainted with the facts and circumstances of the case were recorded under the relevant provisions of law ; and

4. Whereas, during the investigation, three persons identified as Altaf Farooq Rather S/o Farooq Ahmad Rather R/o Dharambagh, Kralpora, Suhail Ahmad Malik S/o Abdul Hameed Malik R/o Panzan, Chadoora and Faizan Khusheed Punjabi S/o Khursheed Ahmad Punjabi R/o Dharambagh, Kralpora, were found involved in the commission of crime. The accused were found already arrested by Budgam Police in Case FIR No. 147/2022 of Police Station, Chadoora. Subsequently, their custody was changed in the instant case ; and

5. Whereas, during the investigation, it was established that the accused viz. Altaf Farooq Rather, Suhail Ahmad Malik and Faizan Khusheed Punjabi, were working as Over Ground Workers (OGWs) for the terrorists and under a well knit criminal conspiracy were providing logistic support to them, besides on the date of occurrence the accused viz. Altaf Farooq Rather and Suhail Ahmad Malik, hurled a hand grenade upon the Minority Community, Kralpora in order to kill them ; and

6. Whereas, on the basis of investigation, statement of witnesses recorded and other evidence collected, the Investigating Officer has established *prima facie* involvement of below mentioned accused for the



commission of offence punishable in terms of the provisions of Unlawful Activities (Prevention) Act, 1967, as shown against their names :—

4. Whereas, during the investigation, the accused viz. Mohd Toyab Khan, was found in contact with a terrorist of Jammu Kashmir Gaznavi Force (JKGF) outfit namely Mohd Rafiq Nai @ Sultan Bhai @ Raza Raheel S/o Mohd Afsar Caste Hajam R/o Naka, Manjhari A/P PoK, through the virtual mode, who provided the arms/ammunition and explosive material to the accused viz. Mohd Toyab Khan, for further distribution among the terrorists. Subsequently, during the investigation, 02 hand grenade and 06 Pistol rounds were also recovered at his instances ; and

5. Whereas, during the investigation, it was established that the accused viz. Mohd Toyab Khan, was working as Over Ground Worker (OGW) for the terrorists of JKGF outfit particularly the PoK based terrorists namely Mohd Rafiq Nai @ Sultan Bhai @ Raza Raheel, and under a well knit criminal conspiracy was providing logistic support to him, besides, collected arms/ammunition and explosive material from the

said terrorist for carrying out the terrorist activities in the area and to wage war against the Government of India ; and

6. Whereas, on the basis of the investigation, the statement of witnesses recorded and other evidence collected, the Investigating Officer, has established *prima facie* involvement of the below mentioned accused for the commission of offences punishable under section of the Unlawful Activities (Prevention) Act, 1967, and Indian Penal Code, as shown against their names :—
