Subsequently, during the investigation, the offence under Section 427 RPC was dropped from the case; and





Rubeena Nazir, Ishfaq Ahmad Mir and Mudasir Ahmad Poswal, were working as Over Ground Workers (OGWs) for the banned terrorist organization and under a well knit criminal conspiracy, were providing logistic support to them, besides, were facilitating the transportation and selling of narcotics for the terrorists so that the money generated could be utilized to commit terrorist activities in Jammu and Kashmir and to wage war against the Government of India; and
- 8. Whereas, the sanction in respect of accused namely Rubeena Nazir, Ishfaq Ahmad Mir and Mudasir Ahmad Poswal, has already been accorded vide Notification S. O. No. 287 dated 26th May, 2023, by the Competent Authority and the investigation, of the case was continued; and

- 9. Whereas, during the further investigation, three other persons identified as Safeer Ahmad Mughal S/o Abdul Rashid Mughal R/o Taad, Karnah, Kupwara, Mohammad Rashid Thakkar S/o Mohammad Younis Thakkar R/o Dara, Barhoon, Thanamandi, Rajouri and Mohammad Rayaz Lohar S/o Hakim-ud-Din Lohar R/o Khanyal Kote, Thanamandi, Rajouri, were found involved in the commission of crime. Subsequently, the accused were arrested in the case; and
- 10. Whereas, during the investigation, it was found that the accused viz. Safeer Ahmad Mughal, was a driver by profession and on the directions of accused viz. Rubeena Nazir, Ishfaq Ahmad Mir and Mudasir Ahmad Poswal, was facilitating the terrorists for transportation of narcotics from one place to another. The accused viz. Mohammad Rayaz Lohar, on the directions of accused viz. Mohammad Rashid Thakkar and one Javid Ahmad Thakkar @ Raja Thakkar, credited an amount of Rs. 01 lac in the account of accused viz. Rubeena Nazir, which was raised through sale of narcotics by the said accused; and
- 11. Whereas, during the investigation, it was established that the accused viz. Safeer Ahmad Mughal, Mohammad Rashid Thakkar and Mohammad Rayaz Lohar, were working as Over Ground Workers (OGWs) for the banned terrorist organization and under a well knit criminal conspiracy, were providing logistic support to them, besides, were facilitating the transportation and selling of narcotics for the terrorists for promotion of terrorist activities in the area and to wage war against the Government of India; and
- 12. Whereas, the investigation, of the case shall continue to ascertain the involvement of other accused and to bring out their role/involvement in the case and the supplementary charge sheet against them would be filed in the Court of competent jurisdiction; and
- 13. Whereas, on the basis of investigation, statements of witnesses recorded and other evidence collected, the Investigating Officer has

Whereas, the Authority appointed by the Government under Sub-Section (2) of Section 45 of the Unlawful Activities (Prevention) Act, 1967 has independently examined the Case Diary File and all the other relevant documents relating to the case and has come to the conclusion that a *prima facie* case is made out against the above accused; and
- 15. Whereas, after perusing the Case Diary File, the relevant documents and also taking into consideration the views of the Authority appointed under Sub-Section (2) of Section 45 of the Unlawful Activities (Prevention) Act, 1967, the Government is of the view that there is sufficient material and evidence available against the above-mentioned accused for their prosecution under the provisions of law; and
- 16. Whereas, the Government has independently examined the Case Diary File and all the other relevant documents relating to the case and has come to the conclusion that a *prima facie* case is made out against

Now, therefore, in exercise of the powers conferred by Sub-Section (2) of Section 45 of the Unlawful Activities (Prevention) Act, 1967, and Section 196 of the Code of Criminal Procedure, 1973, the Government hereby accord sanction for launching prosecution against the accused viz. Safeer Ahmad Mughal, Mohammad Rashid Thakkar and Mohammad Rayaz Lohar, for the commission of offences punishable under the relevant sections as indicated against the each accused at Para (13) above, arising out of FIR No. 19/2022 of Police Station, CIK/SIA, Srinagar.
