Whereas, notification under sections 6 and 7 of Land Acquisition Act, Samvat 1990 was issued vide No. 27-Rev(LAJ) of 2019 dated 06-03-2019 under endorsement No. Rev/LAJ/152/2016 dated 06-03-2019 for acquisition of subject land. Collector Land Acquisition (Defence), Rajouri/Poonch, HQ, Rajouri vide No. Coll/Def/2023-24/1102-1103 dated 17-08-2023 has reported that final award has not been issued within two years due to COVID-19 pandemic with the result proceedings have lapsed in terms of Section 11-B of the J&K Land Acquisition Act, Samvat 1990; and

Whereas, Collector Land Acquisition (Defence) Rajouri/Poonch, HQ, Rajouri has further requested to revive the land acquisition proceedings of the aforementioned village/road already constructed by the GREF for public purpose i. e. Jammu-Poonch road by GREF and accordingly, submitted the case to Divisional Commissioner, Jammu vide No. Coll/Def/2022-23/2098-2101 dated 02-03-2023 read with No. Coll/Def/2023-24/1102-1103 dated 17-08-2023 for issuance of notification under sections 6 and 7 of Land Acquisition Act, Svt. 1990 for subject land required for widening of Jammu-Poonch road by GREF, who vide No. 502/197/Acq/Poonch/23/1075 dated 06-09-2023 endorsed to this department for the said purpose; and

Whereas, the report furnished by Collector Land Acquisition (Defence) Rajouri/Poonch, HQ, Rajouri vide letter referred to above, duly endorsed by Divisional Commissioner, Jammu has been examined and it has been found that the notification under Sections 6 and 7 of the said Act, stands issued by the department and as per the reports of the Collector, the final award has not been issued within the stipulated time; and

Whereas, the Government is satisfied that the aforesaid land is required for public purpose i.e. for widening of Jammu-Poonch road by GREF situated in village Lassana, Tehsil Surankote, District Poonch.

Now, therefore, In pursuance of Section 6 of the J&K Land Acquisition Act, Samvat 1990, it is declared that the land measuring 88 Kanals 03 Marlas as per description at Annexure-A situated in Village Lassana, Tehsu Surankote, District Poonch is required for public purpose i. e. widening of Jammu-Poonch road by GREF. Further, the Collector Land Acquisition (Defence), Rajouri/Poonch, HQ, Rajouri is directed under Section 7 of the said Act to take orders for acquisition of the said land after giving prescribed notice to the interested person (s) as required under the Land Acquisition Act/rules.

However, the Collector concerned shall be held specifically responsible for identification and proper title verification of all types of lands involved in the case for making apportionment of compensation amongst all the interested persons/rightful claimants, in accordance with the relevant laws/rules in force, while making the award. The Collector/Indenting Department shall also ensure that no compensation shall be made for the portion of land which has already been acquired for the road in question.

INTRODUCTION

These proceedings are under provisions of Section 23 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 for determination of compensation in respect of net area of land proposed to be acquired measuring 26 Kanalsó05 marlas for Construction of link road namely Telan to Hari Part 2nd in Village Palmar of Tehsil and District Kishtwar. The land acquisition proceedings were initiated with the publication of Preliminary Notification under Section 11 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013.

The requiring department PWD (R&B) submitted letter of indent for acquisition of land for Construction of link road namely Telan to Hari-Part 2nd in Village Palmar of Tehsil and District Kishtwar. The Tehsildar Kishtwar vide No. 3313-14/OQ/Gen. Dated 22-02-2022, had submitted the land acquisition papers to this office duly completed in all respect for further necessary action.

1. <u>PUBLICATION OF NOTIFICATIONS AND ISSUE OF NOTICES</u>:

The local SIA team was notified as Social Impact Assessment Team (SIA) under Section 4 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 for conducting Social Impact Assessment Team (SIA) vide No. ACR/LA/2023-24/97-103 Dated 02-05-2023. Accordingly, the concerned committee members had submitted the Social Impact Assessment Study report within a time bound manner and the same was submitted to the District Collector Kishtwar for appraisal under under Section 7 of the RFCTLARR Act, 2013 vide No. ACR/LA/2023-24/168 Dated 06-06-2023.

The District Collector Kishtwar, constituted a committee of expert group for appraisal of Social Impact Assessment Study report. Accordingly, the Multi-Disciplinary Expert Group for appraisal constituted vide Notification No. DCK/LA/22/F. No.102/107 Dated 08-06-2023 submitted its recommendation.

The SIA report and the recommendation of Multi-Disciplinary Expert Group was then approved and a Preliminary Notification No. ACR/LA/2022-23/207-213 Date 20-06-2023 was issued under Section 11 of the Act stating that the land described in the schedule thereto (thereafter referred to as the said land) was needed or likely to be needed for the public purpose. The notification issued for inviting objections within 60 days.

No objections were received against the Preliminary Notification. The proposal was then submitted to the Appropriate Government i. e. Deputy Commissioner (District Collector) Kishtwar, vide No. ACR/LA/2023-24/252 Dated 19-07-2023 seeking approval to proceed with acquisition process and the same was approved; and

Further on approval of Appropriate Government i. e. Deputy Commissioner (District Collector) Kishtwar, vide Declaration No. 09 of 2023 Dated 27-07-2023 read with endorsement No. DCK/LA/23/F. No. 294/181 Dated 27-07-2023, it was declared under the provisions of Section 19 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 that the land was required for the public purpose namely Construction of Link Road namely Telan to Hari-Part 2nd in Village Palmar of Tehsil and District Kishtwar to facilitate causation of the above requirements, Notice vide No. ACR/LA/2023-24/428-34 Dated 21-08-2023 was served under Section 21 of the RTFCLARR Act, 2013, stating that all persons having interest in the land may submit their objections within 30 days and may appear personally or through an agent.

Whereas, based on the above, a case FIR No. 214/2022under Sections302, 307, 120-B IPC, 7/27 Arms Act, 3/4 ESA and Sections 16, 18 and 38 of ULA(P) Act, was registered in the Police Station, Shopian, and the investigation of the case was set into motion. Subsequently, during the investigation, the offence under Section 3/4ESA was dropped and the offences under Section 224 IPC, 7/25 Arms Act and Sections 20, 23 and 39 of ULA (P) Act, were added in the case; and
- 3. Whereas, during the investigation, the site plan of the place of occurrence and the seizure memos were prepared and the statement of witnesses acquainted with the facts and circumstances of the case were recorded under the relevant provisions of law; and
- 4. Whereas, during the investigation, two persons identified as Imran Bashir Ganie S/o Bashir Ahmad Ganie and Owais Manzoor Ganie S/o Manzoor Ahmad Ganie Røs/o Herman, Shopian, werefound involved in the commission of offence. Subsequently, both the accused persons were arrested in the case; and
- 5. Whereas, during the investigation, it was found that the accused viz. Imran Bashir Ganie and Owais Manzoor Ganie, were in contact with the terrorists of LeT banned outfit namely Bilal Ahmad Bhat S/o Gh. Rasool BhatR/o Check Cholina, Shopian, and one unknown Pakistani terrorist through virtual mode. The accused viz. Imran Bashir Ganie and Owais Manzoor Ganie, on the directions of unknown Pakistani terrorist procured two hand grenade from the accused terrorist viz. Bilal Ahmad Bhat, and on his directions the accused viz. Imran Bashir Ganie, hurled the grenade upon the non-local labourers. Subsequently, during the investigation,

- 6. Whereas, during the investigation, it was established that the accused viz. Imran Bashir Ganie and Owais Manzoor Ganie, were working as Over Ground Workers (OGWs) for the terrorists of LeT banned outfit particularly the terrorists viz. Bilal Ahmad Bhat and unknown Pakistani terrorist and under a well knit criminal conspiracy procured hand grenade from them for carrying out the terrorist activities,

besides, on the date of occurrence the accused viz. Imran Bashir Ganie, hurled a hand grenade upon the non-local labourers which resulted on spot death of two labourers; and

- 7. Whereas, the accused viz. Imran Basir Ganie, has been killed in an encounter which took place between the terrorists and Security Forces for which a separate case FIR No. 215/2022 stands registered in Police Station, Shopian, and the proceedings under the law would abate against him; and
- 8. Whereas, the investigation, in respect of unknown Pakistani terrorist shall continue to ascertain his actual identity and to bring out his role/involvement in the case and supplementary charge sheet against him would be filed in the Court of competent jurisdiction; and
