The proceedings are as per the provisions of Section 23 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 for determination of compensation in respect of land measuring 4 Kanals 15 Marlas falling under Survey No. 279 recorded as Proprietary land required for the construction of Government High School Bathen at Village Bathen Tehsil Pampore, the acquisition proceeding were initiated on the basis of request made by the requiring body viz. Director School Education Kashmir.

NOTIFICATION OF SOCIAL IMPACT ASSESSMENT AND REPORT OF SIA :

The process for conduct of Social Impact Assessment report under the provisions of Section 4 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 was initiated as per this office No. ADC/AWP/LA/21-22/588-96 Dated 05-11-2021, in concurrence with the District Collector Office Order No. DCP/LA/2020/610-30 Dated 25-08-2020 whereby following members already nominated were assigned the task for conduct of the field survey for the proposed projectô

- 1) Tehsildar Pampore.
- 2) Assistant Executive Engineer R&B Pampore.
- 3) Assistant Executive Engineer (Jal Shakti) PHE Pampore.
- 4) Assistant Executive Engineer Irrigation and Flood Control Pampore.
- 5) Rang Officer Forests Pampore.
- 6) Agriculture Extension Officer Pampore.
- 7) Representative of Indenting Department.

The report so prepared by the committee members for the instant land acquisition case was submitted to the Appropriate Government/ District Collector vide this office No. ADC/AWP/LA/21-22/728-30 Dated 03-02-2022 for accord of approval/authorization for issuance of Notification under Section 11 of the said Act.

EVALUATION OF SOCIAL IMPACT ASSESSMENT REPORT :

On the basis of the recommendations and the observations submitted by the committee constituted, it was established that the land for which the indent stands placed is required for legitimate and *bona fide* public purpose which necessitates the acquisition of land identified. Direction to the Collector for proceeding ahead under the provisions of Section 11 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 was communicated by the District Collector vide his office No. DCP/LA/2022/42-43 Dated 26/05/2022.

PUBLICATION OF NOTIFICATION AND ISSUE OF NOTICES :

The preliminary notification under Section 11 (1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 was issued vide this office Notification No. 09 of 2022 Dated 04-07-2022 under endorsement No. ADC/AWP/ LA/22-23/193-200 Dated 04-07-2022 for calling upon the objections, if any, from the interested persons/landowners. The same was got published in the official gazette on 11th August 2022 in Volume 135 and in the two daily news papers viz. Srinagar Times Dated 06-07-2022, Kashmir Images Dated 07-07-2022 and wide publicity was also made. In response to the said notification. during the stipulated period of time no objection was received by this Collectorate and accordingly the case was submitted under Section 15 of the Act vide this office No. ADC/ AWP/LA/22-23/397-401 Dated 07-11-2022 with recommendations to the District Collector Pulwama for a decision and if found appropriate issuance of declaration under Section 19 of the Act.

The case was examined by the appropriate Government District Collector who after thoughtful consideration is satisfied that the land under acquisition is in the interest of the public purpose. The appropriate Government District Collector has issued declaration under Section 19(1) of the Right to Fair Compensation and Transparency in Land Acquisition. Rehabilitation and Resettlement Act, 2013 vide Notification No. 01 of Rev/LA of 2003 Dated 04-07-2023 under endorsement No. DCP/LA/2023/108-14 Dated 04-07-2023, that the land measuring 04 Kanals 15 Marlas is required for construction of Government HS School at Bathen Tehsil Pampore.

Public notice under Section 21(1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 was issued vide this office No. ADC/AWP/LA/23-24/124-31 Dated 19-07-2023 to the interested persons/land owners to state the particulars of the land so needed and to state the nature of their respective interests in the land and the amount and particulars of their claims to compensation for such interests, their claims to rehabilitation and resettlement along with their objections, if any, to the measurement made and to appear personally or by agent or advocate within a period of 30 days. During the prescribed period of time no such objection was received by this Collectorate.

The possession of the land was handed over by the land owner to the requiring department i. e. education department prior to initiating the land acquisition proceedings and the department had already constructed the two storied school building over the said land in which Government High School Bathen is functioning.

4. Whereas, during the investigation, it was found that the accused terrorist viz. Asif Ashraf Malik, got injured in an encounter with the Security Forces on 29-03-2018 at Marang crossing, Shopian for which a separate Case FIR No. 88/2018 was registered in Police Station, Shopian, and subsequently, was arrested in the said case. Later on the accused was released from the said case by the competent court of law on medical grounds due to which was not arrested in the instant case ; and

5. Whereas, during the investigation, it was established that the accused viz. Zaffer Paul, Mohd Amir Malik, Amir Yousuf Mir, Asif Ashraf Malik, Ashiq Hussain Bhat, Rahil Magray, Sameer Ahma Wani and Atimad Hussain Malik, went missing and joined the terrorist ranks of HM/LeT banned outfit for carrying out terrorist activities in the area ; and

6. Whereas, the accused terrorists viz. Zaffer Paul, Mohd Amir Malik, Amir Yousuf Mir, Ashiq Hussain Bhat, Rahil Magray, Sameer Ahma Wani and Atimad Hussain Malik, have been killed in the different encounters with the Security Forces and the proceedings under the law would abate against them ; and

 - (III) As per regulation 12 of the Aadhaar (Enrollment and Update) Regulations, 2016 the Department through its Implementing Agency, is required to offer Aadhaar enrollment facilities for the beneficiaries who are not yet enrolled for Aadhaar and in case there is no Aadhaar enrollment centre located in the respective Block or Tehsil, the Department through its Implementing Agency shall provide Aadhaar enrollment facilities at convenient locations in coordination with the existing Registrars of UIDAI or by becoming a UIDAI Registrar themselves.

2. In order to provide benefits to the beneficiaries under the Scheme conveniently, the Department through its Implementing Agency

3. In order to ensure that no *bona fide* beneficiary under the Scheme is deprived of his/her due benefits, the Department through its Implementing Agency shall follow the exception handling mechanism as outlined in the office Memorandum of Direct Benefit Transfer Mission, Cabinet Secretariat Government of India No. D-26011/04/2017-DBT dated 19-12-2017 (available on <u>https://dbtbarat.gov.in/)</u>.

Umar Bashir Bhat, was found in contact with a Pakistan based terrorists of LeT banned outfit @ Tahir Nazir, through virtual mode, who provided the arms/ammunition and explosive material to him through an unknown person, in order to promote terrorist activities in the area ; and

5. Whereas, during the investigation, it was established that the accussed viz. Umar Bashir Bhat, was associated with the terrorist organization of LeT banned outfit and under a well knit criminal conspiracy procured arms/ammunition and explosive material from Pakistan handlers viz. @ Tahir Niazi, for carrying out the terrorist activities in the area; and

6. Whereas, the investigation in respect of Pakistan handlers @ Tahir Niazi and an unknown person who handed over arms/ammunition and explosive material to the accussed viz. Umar Bashir Bhat, shall continue to ascertain their actual identity and to bring out their role/involvement in the case and the supplementary charge sheet against them would be filed in the Court of competent jurisdiction ; and

7. Whereas, on the basis of investigation, the statement of witnesses recorded and other evidence collected, the Investigating Officer, has

3. Whereas, during the investigation, the accused viz. Umar Aziz and Syed Tauseef Geelani, were arrested in the case and during the investigation, 05 Pistols, 10 magazines, 77 rounds and 10 packets of contraband were recovered at the instances of accused viz. Umar Aziz ; and

4. Whereas, during the investigation, the seizure memos were prepared and the statement of witnesses acquainted with the facts and circumstances of the case were recorded under the relevant provisions of law; and

5. Whereas, during the investigation, it was found that the accused viz. Umar Aziz and Syed Touseef Geelani, were in contact with a Pakistan based terrorist of LeT banned outfit namely Ab. Hameed Sheikh @ Mama Kumar S/o Faqeer Sheikh R/o Dhani, Taad, Karnah A/P PoK, through the virtual mode, who provided the arms/ammunition and narcotics (Heroin) to the accused viz. Umar Aziz, in order to promote terrorist activities in the area ; and

6. Whereas, during the investigation, it was established that the accused viz. Umar Aziz and Syed Touseef Geelani, were working as Over Ground Workers (OGWs) for the terrorists of LeT banned outfit particularly the PoK based terrorist viz. Ab. Hameed Sheikh @ Mama Kumar, and under a well knit criminal consistency were providing logistic support to him, besides the accused viz. Umar Aziz procured arms/ammunition and narcotics (Heroin) from across the border in order to promote terrorist activities in the area ; and

7. Whereas, on the basis of investigation, the statement of witnesses recorded and other evidence collected, the Investigating Officer, has established a *prima facie* involvement of the below mentioned accused for the commission of offences punishable in terms of the provisions
