Whereas, Deputy Commissioner, Samba vide No. DCS/ACR/LAS/2023-24/200-204 dated 01-07-2023 has forwarded the shadow file duly prepared by Collector, Land Acquisition concerned which includes copies of all relevant documents pertaining to the case :ô

- a. Land is needed purely for public purpose i.e. construction Border Out Post (BOP) by BSF at Village Nanga, Tehsil Ramgarh.

Further, the Collector, Land Acquisition (SDM), Vijaypur is directed under Section 7 of the said Act to take orders for acquisition of the said land after giving prescribed notice to the interested person(s) as required under the Land Acquisition Act/Rules.

However, the Collector concerned shall be held specifically responsible for identification and proper title verification of all types of land involved in the case for making apportionment of compensation amongst all the interested person/rightful claimants, in accordance with the relevant laws/rules in force, while making the award. The Collector/Indenting Department shall also ensure that no compensation shall be made for the portion of land which has already been acquired for the road in question.

Whereas, during the encounter, one terrorist of Albadar banned outfit identified as Shoib Ahmad Bhat S/o Mohd Shafi Bhat R/o Chursoo, Awantipora, was arrested on the spot and during the investigation, the dead bodies of four killed terrorists who were later on identified as Shakoor Ahmad Parray S/o Mohd Sideeq Parray R/o Kumdalan, Zubair Ahmad Nengroo S/o Gulzar Ahmad Nengroo R/o Aloora, Shakir-ul-Jabbar Sofi S/o Mohd Jabar Sofi R/o Kadlabal, Awantipora and Suhail Rashid Bhat S/o Ab. Rashid Bhat R/o Muradpora, were recovered from the place of encounter. 

Whereas, based on the above a Case FIR No. 10/2019 under Sections 307 RPC, 7/27 Arms Act, and the Sections 13, 16, 18, 19, 38 and 39 of ULA(P) Act, was registered in the Police Station, Yaripora, and the investigation of the case was set into motion. During the investigation, the injured DySP Shri Aman Thakur and Naib-Subedar Soom Veer of 34 RR succumbed to their injuries. Subsequently, the offence under Section 307 RPC was dropped and the offences under Sections 302, 201 RPC and the Section 20 of ULA(P) Act were added in the case; and
- 3. Whereas, during the investigation, the site plan of the place of occurrence and the seizure memos were prepared and the statements of witnesses acquainted with the facts and circumstances of the case were recorded under the relevant provisions of law; and
- 4. Whereas, during the investigation, the dead bodies of three terrorists of JeM banned outfit, who were later on identified as Raqib Ahmad Sheikh @ Abu Asim S/o Mohd Amin Sheikh R/o Shiganpora, Yaripora, Walied Bhai @ Usman Bhai and Numan Bhai @ Usma Bhai Rø/o Pakistan, were recovered from place of encounter. During the investigation, arms/ammunition viz. 01 AK 56 Rifle, 01 AK Kirenkor, 01 AK-47 Rifle, 07 AK Magazines 209 AK Rounds, 01 Pistol, 02 Magazines, 22 rounds, 07 live Hand Grenades and 02 UBGL, were also recovered from the place of occurrence; and
- 5. Whereas, during the investigation, it was found that the accused house owner viz. Sonaullah Mir alongwith his son namely Umar Suhail Mir S/o Sonaullah Mir R/o Turigam, Yaripora, voluntarily harboured the killed terrorists in their residential house and provided logistic support to them. Subsequently, during the investigation, the accused viz. Umar Suhail Mir, was arrested in the case and the accused viz. Sonaullah Mir, was evading his arrested and later on has expired due to illness; and

- 6. Whereas, during the investigation, three more persons identified as Wajid Ahmad Sheikh S/o Mohd Amin Sheikh, Tawseef Ahmad Sheikh S/o Ghulam Rasool Sheikh and Adil Gulzar Sheikh S/o Gulzar Ahmad Sheikh Rø/o Shiganpora, Yaripora, were found involved in the commission of crime. Subsequently, the accused were arrested in the case and it was found that the accused viz. Wajid Ahmad Sheikh, was facilitating the transportation of terrorists from one place to another. The investigation, in respect of other two accused viz. Tawseef Ahmad Sheikh and Adil Gulzar Sheikh, shall continue to bring out their role/involvement in the case and the supplementary charge sheet against them would be filed in the Court of competent jurisdiction; and
- 7. Whereas, during the investigation, it was established that the accused viz. Umar Suahil Mir and Wajid Ahmad Sheikh, were working as Over Ground Workers (OGWs) for the terrorists of JeM banned outfit particularly the killed terrorists viz. Raqib Ahmad Sheikh @ Abu Asim, Walied Bhai @ Usman Bhai and Numan Bhai @ Usma Bhai, and were providing logistic support to them, besides, on the date of occurrecne the accused viz. Umar Suhail Mir, voluntarily harboured the killed terrorists in his residentilal house for carrying out the terrorist activities in the area; and
- 8. Whereas, the accused terrorists viz. Raqib Ahmad Sheikh @ Abu Asim, Walied Bhai @ Usman Bhai and Numan Bhai @ Usma Bhai, have been killed in the said encounter and the accused viz. Sonaullah Mir, has expired and the proceedings under the law would abate against them; and
- 9. Whereas, on the basis of the investigation and other evidence collected, the Investigating Officer, has established *prima facie*, involvement of the below mentioned accused for the commission of offences punishable under sections of the Unlawful Activities (Prevention) Act, 1967, as shown against their name :ô



- Wajid Ahmad Sheikh S/o Mohd Amin
   Sheikh R/o Shiganpora, Yaripora.

- 10. Whereas, during the investigation, the accused viz. Wajid Ahmad Sheikh, has been found juvenile and in view of the Section 1(4) of the Juvenile Justice (Care and Protection of Child) Act, 2015, the apprehension, detention, prosecution, penalty or imprisonment shall be governed by the said Act; and
- 11. Whereas, the Authority appointed by the Government under Sub-Section (2) of Section 45 of the Unlawful Activities (Prevention) Act, 1967, has independently examined the Case Diary file and all the other relevant documents relating to the case and has come to the conclusion that a *prima facie* case is made out against the above accused; and
- 12. Whereas, after perusing the Case Diary File, the relevant documents and also taking into consideration the views of the Authority appointed under Sub-Section (2) of Section 45 of the Unlawful Activities (Prevention) Act, 1967, the Government is of the view that there is sufficient material and evidence available against the above-mentioned accused for his prosecution under the provisions of law.

Now, therefore, in exercise of the powers conferred by Sub-Section (2) of Section 45 of the Unlawful Activities (Prevention) Act, 1967, the Government hereby accords sanction for launching prosecution against the accused viz. Umar Suhail Mir, for the commission of offences punishable under Sections 13, 19 and 39 of ULA (P) Act arising out of FIR No. 10/2019 of Police Station, Yaripora.
