HIGH COURT OF JAMMU AND KASHMIR AND LADAKH (Office of the Registrar General at Srinagar)

#### Notification

No. 2539 of 2023/RG Dated 23-10-2023.

Acting in compliance to the directions of the Hon'ble Supreme Court of India in its order dated 31-07-2023 in the case titled Md. Asfak Alam vs State of Jharkhand Cr. Appeal No 2207 of 2023, the High Court of Jammu and Kashmir and Ladakh hereby notifies the directions contained in the said judgment as Guidelines on Arrest, Detention and Bail of accused, for the guidance of the Magistrates and the Criminal Courts subordinate to the High Court of Jammu & Kashmir and Ladakh. The said Guidelines are enumerated as under :ô

- 1. Both the Governments of Union Territory of Jammu & Kashmir and Union Territory of Ladakh to instruct its police officers not to automatically arrest accused when a case under Section 498-A Indian Penal Code 1860, is registered but to satisfy themselves about the necessity for arrest under parameters laid down and flowing from Section 41 Cr.PC;
- 2. All the police officers be provided with the check list containing specified sub-clauses under Section 41(1)(b)(ii);
- 3. The police officers shall forward the check list dully filled and furnish the reasons and materials which necessitated the arrest, while forwarding/producing the accused before the Magistrate for further detention:
- 4. The Magistrate while authorizing detention of the accused shall peruse the report furnished by the police officer in terms aforesaid and only after recording its satisfaction, the Magistrate will authorize detention:
- 5. The decision not to arrest an accused, be forwarded to the Magistrate within two weeks from the date of the institution of

> the case with a copy to the Magistrate which may be extended by the Superintendent of Police of the district for the reasons to be recorded in writing;

- 6. Notice of appearance in terms of Section 41-A CrPC be served on the accused within two weeks from the date of institution of the case, which may be extended by the Superintendent of Police of the district for the reasons to be recorded in writing;
- 7. Failure to comply with the directions aforesaid shall apart from rendering the police officers concerned liable for departmental action, they shall also be liable to be punished for contempt to be instituted before the High Court.
- 8. Authorizing detention without recording reasons as aforesaid by the Judicial Magistrate concerned shall be liable for departmental action by the High Court.
- 9. The aforesaid directions shall not only apply to case under Section 498- A IPC or Section-4 of the Dowry Prohibition Act, but also to such other cases where offence is punishable with imprisonment for a term which may be less than seven years or which may extend to seven years, whether with or without fine.

#### 07-10-2023

1. File taken up today, Ld. PP on behalf of UT of J&K present. Accused persons are continuously absent. Warrants of arrest issued against them and notice issued to the surety for the appearance of accused persons by this Court have been returned un-executed with the report that the accused were not found at their home and had gone to unknown places and there is also no information about the cell numbers of the accused persons as well as surety of the accused persons.

- Perusal of the challan reveals that challan against the accused was presented before the Court on 30-05-2019 and thereafter vide order dated 23-07-2019 charge against the accused was framed. The accused persons have been bailed out by this Court and since then they are not appearing before the Court despite warrants issued by this Court and same have been received with the report that accused are not available at home and the presence of executing agency has been awaited for recording their statement in order to record the satisfaction whether accused would be available for facing the trial or not. The personal bonds of the accused have already been forfeited. However the Court has also issued notice to surety to cause the appearance of accused and was also asked to file objections as to why Surety furnished by him be not forfeited in the event of not producing the accused in the Court. This Court directed SSP Ramban to constitute a team and in view of the same SSP Ramban constituted a team headed by ASI Karnail Singh who along with his team visited Punjab and started the search of accused persons with the assistance of concerned police but they have not been found and today ASI Karnail Singh appeared before the Court and his statement has been recorded in which he has stated that accused were not found at their home as they had gone to unknown places and there is also no information regarding the cell numbers of the accused persons as well as surety of the accused persons and there is no immediate chance of arrest of the accused person and prayed for initiating proceeding U/s 299 Cr. PC against the accused persons.
- 3. The statement of executing agency comprising of ASI Karnail Singh has been recorded be made part of the file As per the statement it appears that imminent apprehension of accused are not possible as they have left their place of residence and evading their arrest. Accordingly it is fit case to initiate proceeding U/S 299/512 Cr. PC against the accused persons.
- 4. I am of the considered opinion that accused have absconded and imminent apprehension of accused is not possible in near future. Hence proceeding U/s 299/512 Cr. PC are initiated against the accused namely Kulwant Singh S/o Tara Singh R/o Jeevan Basti Tehsil Jagroan District Ludhiana Punjab and Sukhdev Singh S/o Surjeet Singh

R/o Ietyana Tehsil Rajkot District Ludhiana. Office to issue requisite warrants to the concerned agencies for securing their presence before the Court. One copy each of the warrant be forwarded to S.H.O. Police Station Banihal and Senior Superintendent of Police Ramban and SSP Ludhiana (Pb) for execution. One copy of the warrant is forwarded to General Manager, Government Ranbir Press, Jammu for publication in the Official Gazette. Ld. PP on behalf of UT of J&K has stated at bar that he does not want to lead the prosecution evidence in absence of accused persons as such the challan file is consigned to record and shall be taken up again when the accused persons caused their appearance or produced before the Court.

- This criminal challan has been presented in this Court after getting the same transferred from the Court of the Learned Chief Judicial Magistrate, Ramban and same is pending for disposal before this Court.
- 2. Heard and gone through the contents of challan and documents allied thereto. Whereas, since the first date of hearing till today accused persons are continuously absent in this case against him Warrants were issued regularly. On last date also Non Bailable warrant was issued against the accused through SSP Ramban and in case of non execution Tamili concerned was directed to remain present in person.
- 3. Tamili concerned has caused presence and his statement has been recorded in which he stated that he was deputed by SSP Ramban and during search of the accused persons he reached their homes but they were not found and enquiry made from their family members, it is found that both the accused persons were not found. He has prayed that he made best efforts to arrest the accused persons but they could not be arrested for said reasons. On going through the material on record and statement of Tamili it is prima facie indicated that accused persons are concealing themselves and it is impossible to arrest them as they are avoiding arrest and there is no immediate prospects to arrest the accused persons and produce them in the Court. Now, the question is how the general warrant of arrest can be executed against the accused persons. Prima facie I am satisfied that accused persons are concealing themselves and evading arrest and there is no immediate prospects to arrest them. So the accused persons are proceeded in terms of Section 299 Cr. P.C.. Office to issue General warrant of arrest against the accused persons which shall be sent to Incharge Police Station Ramban and SSP Ramban authorizing them to arrest the accused whenever and wherever they are found with U.T of J&K and produce them before this Court. Copy of general warrant of arrest be

also sent to Government Ranbir Press, Jammu for publication in Government Gazette. Case file is consigned to record till arrest of the accused persons or till they surrender before the Court, it shall be called from the record.

The terrorists committed the act in order to spread terror among the general public; and

Whereas, based on the above, a case FIR No. 142/2019 under Sections 307, 302 RPC, 7/27 Arms Act and the Sections 13, 16, 18, 19, 20, 38 and 39 of ULA (P) Act, was registered in the Police Station, Kulgam, and the investigation of the case was set into motion. During the investigation, the dead bodies of five non local labourers identified as Mursaleen Sheikh, Rafiq Sheikh, Qamer Din Sheikh, Naseem Din Sheikh and Rafiqul Sheikh Røs/o Sager, Daggi, Murshiabad, West Bengal, were recovered from the place of occurrence. Subsequently, the offences under Sections 19 and 39 of ULA (P) Act were dropped and the offence under Section 364 RPC was added in the case; and
- 3. Whereas, during the investigation, the site plan of the place of occurrence and the seizure memos were prepared and the statement of witnesses acquainted with the facts and circumstances of the case were recovered under the relevant provisions of law; and
- Whereas, during the investigation, it was found that three terrorists of HM banned outfit namely Farooq Ahmad Bhat @ Nali S/o Abdul Gani Bhat R/o Chaki Dessan, Khanpora, Yaripora, Sheeraz Ahmad Lone @ Molvi S/o Abdul Rashid Lone R/o Souch, Kulgam and Adil Ahmad Thoker S/o Abdul Gani Thoker R/o Pumbai, Kulgam, abducted the non local labourers from their rented accommodation at Katrasoo, Kulgam, and fired indiscriminately upon them with their illegal arms/ammunition; and
- 5. Whereas, during the investigation it was established that the accused viz. Farooq Ahmad Bhat @ Nali, Sheeraz Ahmad Lone @ Molvi and Adil Ahmad Thoker, were members of HM banned outfit and on the date of occurrence fired indiscriminately upon the non local labourers which resulted death of five non local labourers and injuries to some other persons on the spot; and

transportation of arms/ammunition for the terrorists from one place to another for carrying out the terrorist activities in the area; and

- 2. Whereas, based on the above, a case FIR No. 36/2023 under Sections 18 and 39 of ULA(P) Act, was registered in Police Station, Tral, and investigation of the case was set into motion. Subsequently, during the investigation, the offences under Section 7/25 Arms Act and Sections 20, 23 and 38 of ULA(P) Act were added in the case; and
- 3. Whereas, during the investigation, the accused viz. Bashir Ahmad Laway, was arrested in the case and during the investigation, 01 AK-47 Rifle, 02 Magazines and 56-AK Rounds were recovered at his instance; and
- 4. Whereas, during the investigation, the seizure memos were prepared and the statements of witnesses acquainted with the facts and circumstances of the case were recorded under the relevant provisions of law; and
- 5. Whereas, during the investigation, one more person identified as Gulzar Ahmad Dar S/o Ghulam Nabi Dar R/o Nagbal, Tral, was found involved in the case. Subsequently, the said accused was arrested and during the investigation, 03 Pistols, 06 Magazines and 04 Rounds were recovered at his instances; and
- 6. Whereas, during the investigation, it was found that the accused viz. Bashir Ahmad Laway and Gulzar Ahmad Dar, were in contact with a terrorist of JeM banned outfit namely Feroz Ahmad Ganie S/o Ghulam Nabi Ganie R/o Noorpora, Awantipora A/P Pak, through the virtual mode, who provided the arms/ammunition to them through an unknown person in order to promote terrorist activities in the area; and
- 7. Whereas, during the investigation, it was established that the accused viz. Bashir Ahmad Laway and Gulzar Ahmad Dar, were working as Over Ground Workers (OGWs) for the terrorists of JeM banned outfit particularly the terrorist viz. Feroz Ahmad Ganie, and were providing logistic support to him, besides, under a well knit conspiracy procured arms/ammunition from the said terrorist through an unknown person for carrying out the terrorist activities in the area; and

- 8. Whereas, the investigation, in respect of an unknown person who handed over the arms/ammunition to the accused viz. Bashir Ahmad Laway and Gulzar Ahmad Dar, shall continue to ascertain his actual identity and to bring out his role/involvement in the case and the supplementary charge sheet against him would be filed in the Court of competent jurisdiction; and
- 9. Whereas, on the basis of investigation, and other evidence collected, the Investigating Officer, has established *prima facie*, involvement of below mentioned accused in the commission of the offences punishable under Section of the Unlwful Activities (Prevention) Act, 1967, as shown against their names:—
