An application is made by the Chief Investigating Officer, of the Criminal Case : RC-02/2021/NIA/ JMU for offences made punishable under Sections 302 read with Section 120-8 and 121 RPC 1860, Sections 16/18/20/38/39 of the UA(P) Act, 1967 and Section 27 of Arms Act, 1959, with the prayer to issue a

Mohammad Sadeeqi R/o Kursoo, Rajbagh, Srinagar, Mushtaq Ahmad Bhat @ Goga @ Mushtaq Ul Islam S/o Late Ghulam Qadir Bhat R/o Kashi Mohalla, Batmaloo and Dawood Ahmad Dar S/o Mohammad Yousuf Dar R/o Sariwarpora, Pattan, were found involved in the case. Subsequently, the accused viz. Abdul Rasheed Kumar, Abdul Majeed Kumar and Dawood Ahmad Dar, were arrested and during the investigation, 01 Pistol with magazine, 10 rounds and 11 hand grenades were recovered at the instances of accused viz. Abdul Rasheed Kumar and Abdul Majeed Kumar, respectively; and
- 5. Whereas, during the investigation, it was found that the accused viz. Tufail Ahmad Dar, has been arrested by Anantnag Police in case FIR No. 166/2022 of Police Station, Bijbehara and the accused viz. Bilal Ahmad Sadeeqi and Mushtaq Ahmad Bhat @ Goga @ Mushtaq Ul Islam, were already arrested by Srinagar Police and detained under the provisions of J&K Public Safety Act, 1978. Subsequently, the custody of the accused viz. Tufail Ahmad Dar, was changed in the instant case and the person viz. Dawood Ahmad Dar, was not found involved in the commission of crime and accordingly, was dropped from the case and was given benefit under Sections 169 Cr. P.C.; and

Tufail Ahmad Dar, Bilal Ahmad Sadeeqi and Mushtaq Ahmad Bhat @ Goga @ Mushtaq Ul Islam, were working as Over Ground Workers (OGWs) for the said terrorists and under a well knit criminal conspiracy were providing logistic support to them for carrying out the terrorist activities in the area; and
