SOó18.ô In exercise of the powers conferred by section 35 of the AdvocatesøWelfare Fund Act, 2001 read with the Government of India, Ministry of Home Affairs Notification No. U-11030/1/2001-UTL dated

- 1. **Short title and commencement.**ô (1) these rules may be called the Jammu and Kashmir Advocatesø Welfare Fund Rules, 2023.
- (2) They shall come into force on the date of their publication in the Official Gazette.
- 2. **Definitions.**—(1) In these rules, unless the context otherwise requires,ô
  - a) "Act" means the Advocatesø Welfare Fund Act, 2001 (45 of 2001);
  - b) "Government" means the Government of Jammu and Kashmir:
  - c) "Secretary" means the Secretary of the Jammu and Kashmir Advocatesø Welfare Fund Trustee Committee :
    - Provided that till the Bar Council of Union Territory of Jammu and Kashmir is duly constituted, the powers of Secretary of the Jammu and Kashmir Advocatesø Welfare Fund Trustee Committee shall be exerciseable by the Administrative Secretary, Department of Law, Justice and Parliamentary Affairs; and
  - d) "Section" means a section of the Act.
- (2) Words and expressions used in these rules, but not defined herein, shall have the same meanings as are assigned to them under the Act.
- 3. **Credit to Fund.**—(1) The Secretary shall collect all sums specified in sub-section (2) of Section 3 and deposit the same in the bank account of the Trustee Committee in a scheduled bank forthwith.
- (2) Separate accounts shall be maintained for the sums received under each of clauses (a) to (j) of sub-section (2) of Section 3.
- 4. **Office.**—The Office of the Trustee Committee shall be at Jammu/Srinagar as may be notified by the Government.
- 5. **Annual statement of accounts.**—The Trustee Committee shall prepare annual statement of income and expenditure in Form-I.
- 6. **Preparation of Budget estimates.**—The Secretary shall prepare budget estimates of income and expenditure for the coming year, which shall be placed before the Trustee Committee for approval before the 31st day of March every year.

- 7. Administrative expenditure, payments and investments.—
  All administrative expenditure, payments and investments shall be approved by the Trustee Committee. An expenditure or payment of a contingent nature may be sanctioned by the Chairperson up to twenty thousand rupees and by the Secretary up to ten thousand rupees, which shall be placed before the Trustee Committee for ratification at its next meeting.
- 8. **Annual Report.**—The Trustee Committee shall prepare an annual report for financial year before the end of 30th day of June of the following year in Form-II. An authenticated copy of the annual report shall be submitted to the Government within next fifteen days.
- 9. **Meetings.**—(1) The date and time for a meeting of the Trustee Committee shall be fixed by the Secretary with the prior approval of the Chairperson and the Secretary shall give seven clear daysø notice to the Members.
- (2) In case of urgency, the Chairperson can convene a meeting of the Trustee Committee at a short notice.
- (3) An agenda for every meeting of the Trustee Committee shall be prepared by the Secretary with the approval of the Chairperson and shall be circulated to all the Members.
- (4) The quorum necessary for the transaction of business at a meeting of the Trustee Committee shall be three Members.
- (5) Where a Meeting has been adjourned for lack of quorum, the business which would have been brought before the original meeting, if there had been a quorum present thereat, shall be brought before, and may be transacted at an adjourned meeting.
- (6) The Chairperson or in his absence such other Member present as is decided by the Trustee Committee shall preside at every meeting of the Trustee Committee.
- (7) All matters brought before any meeting of the Trustee Committee shall be decided by a majority of the votes of the Members present and voting.
- (8) The Chairperson or the person presiding over a meeting shall have and exercise a second or a casting vote in all cases of equality of votes.

- (9) It shall be open to any Member to raise any matter not included in the agenda with the permission of the Chairperson.
- (10) The minutes of the Meeting shall be recorded by the Secretary and circulated to the Members, as early as possible, after approval by the Chairperson.
- (11) At the next meeting of the Trustee Committee, the approved minutes of the previous meeting shall be read and confirmed.
- (12) Meetings of the Trustee Committee shall, ordinarily, be held at its Office.
- 10. Maintenance of Records and Registers by Trustee Committee.—(1) The Secretary shall maintain the following records and registers namely :ô
  - i. Register of meetings of the Trustee Committee and minutes of such meetings;
  - ii. Register of the sums paid to the Fund under separate heads specified in Sub-Section (2) of Section 3;
  - iii. Register of all sums collected under separate heads under section 18;
  - iv. Register of Members of the Fund;
  - v. Register of payments to members of the Fund, their dependents, nomines and legal heirs under separate heads;
  - vi. Register of members of the fund under suspension;
  - vii. Register of members of the Fund who have ceased to practice;
  - viii. Register of all enquiries made by the Trustee Committee;
  - ix. Register of the staff appointed by the Trustee Commitee;
  - x. Day Book;
  - xi. Ledger;
  - xii. Cash Book;
  - xiii. Receipt Book with inner foil;
  - xiv. Voucher File;

  - xv. All Forms hereby prescribed;
  - xvi. Record of all forms, application and other documents received;
  - xvii. Record of all correspondence and other business transacted by the Trustee Committee;
- xviii. Other registers, files and records as may be required.
- (2) Registers, etc. shall be maintained in the format as laid down by the Trustee Committee in consultation with the chartered accountant appointed under Sub-Section (2) of Section 13.
- 11. Application for recognition of an association of advocates.—An association of advocates functioning in any court, tribunal or other authority shall apply for recognition to the Bar Council of Union Territory of Jammu and Kashmir under Sub-Section (1) or Sub-Section (2) of Section 16, in Form III.
- 12. **Recognition.**—(1) The Bar Council of Union Territory of Jammu and Kashmir may issue a certificate of recognition in Form IV, after conducting an enquiry for verification of antecedents and activities that are consistent with the Constitution of India on the application made under rule 11.
- (2) The Bar Council of Union Territory of Jammu and Kashmir may recognize more than one association of advocates functioning at a particular court, tribunal or other authority.
- (3) The Bar Council of Union Territory of Jammu and Kashmir shall prepare a list of recognized associations of advocates and update the same from time to time.
- 13. **Application for membership of Fund.**—(1) An advocate shall apply for admission as a member of the Fund, under Sub-Section (1) or Sub-Section (2) of Section 18, in Form V.
- (2) An advocate having membership in more than one association of advocates shall so apply from any one of them.
- (3) Any member of the Fund who fails to pay the annual subscription for any year before the 31st day of March of that year, shall be liable to be removed from the membership of the Fund.
- 14. **Application for re-admission as a member of Fund.**—An advocate shall apply for re-admission as a member of the Fund, under Sub-Section (7) of Section 18, in Form VI.

- 15. **Certificate of membership.**—The Trustee Committee shall issue a certificate of membership in Form VII.
- 16. Reduction of amount on failure to intimate removal or suspension.—(1) Every member of the Fund shall within fifteen days of his removal from the State roll under section 26-A of the Advocates Act, 1961 or suspension of practice, intimate the same to the Trustee Committee.
- (2) If a member of the Fund fails to intimate under sub-rule (1), the amount payable to him under the Act may be reduced, under Sub-Section (12) of section 18, only after conducting a suitable inquiry and the reduction shall not exceed twenty-five per cent of such amount.
- 17. **Cessation of practice and payment.**—A member of the Fund, his nominee or legal heir, as the case may be, shall intimate to the Trustee Committee as to his cessation of practice, along with the necessary proof thereof.
- (2) The Trustee Committee shall, after such inquiry as it deems necessary, pay to the claimant, the amount at the rate specified in Schedule I to the Act within thirty days of the receipt of intimation.
- 18. Schemes for benefits of members of the Fund.—The Trustee Committee may introduce schemes for any benefit for the members of the Fund and their dependents, under Section 24.
- 19. **Disposal of claims.**—An application claiming *ex gratia* grant under Section 19 or any benefit under any scheme under Section 24, after being satisfied about the genuineness of the claim, shall be disposed of by the Trustee Committee within thirty days of the receipt thereof.
- 20. **Appeal to the State Bar Council.**—(1) An appeal to the Bar Council of Union Territory of Jammu and Kashmir against any decision or order of the Trustee Committee under Sections 25, shall be in Form VIII.
- (2) The Bar Council of Union Territory of Jammu and Kashmir may devise its own procedure for hearing and disposal of an appeal.
- (3) An appeal shall be disposed of by the Bar Council of Union Territory of Jammu and Kashmir within sixty days from the date of filing thereof.

- 21. Value and Design of Stamps.—(1) Stamps shall be printed in the denominations of five rupees and ten rupees.
- (2) Every stamp shall have the emblem of the Bar Council of Union Territory of Jammu and Kashmir with the inscription of the words ::The Bar Council of Union Territory of Jammu and Kashmir along with the words ::Advocates Welfare Fund Stamp as well as its value in terms of rupees.
- 22. **Accounts of Stamps.**—(1) The Bar Council of Union Territory of Jammu and Kashmir, the Bar Associations and the AdvocatesøAssociations recognized by the Bar Council under Section 16 shall keep accounts of the stamps in Formô IX and shall also maintain the following:ô
  - i. Register showing the stock of stamps;
  - ii. Register of sale/purchase of stamps;
  - iii. Register showing printing/distribution of stamps;
  - iv. Day Book;
  - v. Ledger;
  - vi. Cash Book;
  - vii. Receipt Book with inner foil;
  - viii. Voucher File;
  - ix. Other registers, files and records as may be required.
  - (2) Registers, etc., shall be maintained in proper format.
- 23. **Cancellation of Stamps.**—(1) No vakalatnama requiring a stamp under the Act shall be filed or acted upon in any proceeding in any court, tribunal or other authority until the stamp has been cancelled.
- (2) Such officers as the Court, Tribunal or other authority may, from time to time, appoint shall, on receiving any such vakalatnama, forthwith effect such cancellation by punching out the figure and the part removed by punching shall be burnt or mutilated or otherwise destroyed.

Subsequently, during the investigation, Section 149 IPC was dropped from the case; and
- 3. Whereas, during the course of investigation, the site plan of the place of occurrence the seizure memos were prepared and the statements of witnesses acquainted with the facts and circumstances of the case were recorded under the relevant provisions of law; and
- 4. Whereas, during the investigation, eight other persons identified as Bashir Ahmad Wagay S/o Mohd Rajab Wagay, Umar Bashir Wagay S/o Bashir Ahmad Wagay, Muzaffer Ahmad Ganie S/o Ab. Rashid Ganie Røs/o Ramnagri, Shopian, Irfan Maqbool Rather S/o Mohammad Maqbool Rather R/o Poterwal, Shopian, Aijaz Ahmad Parrey S/o Abdul Rashid Parrey, Shafat Ahmad Ganie S/o Ghulam Mohammad Ganie, Imtiyaz Ahmad Bhat S/o Mohammad Abdullah Bhat and Afaq Mubarak Lone S/o Mubarak Ahmad Lone Røs/o Khasipora, Shopian, were found involved in the commission of crime. Subsequently, the said accused alongwith the accused viz. Hazim Rashid Ganie and Nisar Ahmad Wani, were arrested in the case; and
- 5. Whereas, during the investigation, it was established that on the date of occurrence the accused viz. Bashir Ahmad Wagay and Umer Bashir Wagay, raised anti national slogans and instigated the general public against the sovereignty and territorial integrity of the Union of India, besides, pelted stones upon the Police/Security Forces in order to facilitate the holed terrorists to manage their escape from the encounter site; and
- 6. Whereas, during the investigation, the other accused viz. Muzaffer Ahmad Ganie, Irfan Maqbool Rather, Hazim Rashid Ganie, Nisar Ahmad Wani, Aijaz Ahmad Parrey, Shafat Ahmad Ganie, Imtiyaz Ahmad Bhat and Afaq Mubarak Lone, were found involved in pelting stones upon the Police/Security Forces and the charge-sheet against

SO-61ô Whereas, on 21-09-2022, the Police Station, Sopore, received a docket to the effect that a reliable information was received about the presence of some unknown terrorists in Kanihal Mohalla, Botingoo. Subsequently, a Joint Cordon and Search Operation was lunched by the Police/Secuirty Forces and during the search two suspects while seeing the Search Party tried to escape but were chased down on the spot and identified as Imtiyaz Ahmad Ganie S/o Abdul Rahim Ganie and Waseem Ahmad Lone S/o Ghulam Rasool Lone R&/o Botingoo, Sopore. During their personal search, the Police recovered 01 Pistol with magazine, 08 rounds and 01 Chinese hand grenade from their possession respectively; and

- 2. Whereas, based on the above, a Case FIR No. 217/2022 under Sections 7/25 Arms Act 18, 20, 23, 38 of ULA (P) Act, was registered in the Police Station, Sopore, and the investigation of the case was taken up. Subsequently, during the investigation, Sections 18-B and 39 of ULA (P) Act, were added in the case; and
- 3. Whereas, during the course of investigation, the site plan of place of occurrence and the seizure memos were prepared and the statements of witnesses acquainted with the facts and circumstances of the case were recorded under the relevant provisions of law; and
- 4. Whereas, during the investigation, the accused viz. Imtiyaz Ahmad Ganie and Waseem Ahmad Lone, were found in contact with a terrorist of LeT banned outfit namely Bilal Hamza Mir S/o Mohd Hamza Mir R/o Brath, Sopore, who motivated the accused to work for the outfit and provided arms/ammunition and hand grenade to them in order to promote terrorist activities in the area; and
- 5. Whereas, during the investigation, it was established that accused viz. Imtyaz Ahmad Ganie and Bilal Hamza Mir, were members of LeT banned outfit and the other accused viz. Waseem Ahmad Lone was working as Over Ground Worker (OGW) for the terrorists of the outfit particularly the terrorists namely Imtiyaz Ahmad Ganie and Bilal Hamza Mir, and was providing logistic support to them, besides, under a well knit criminal conspiracy procured a hand grenade from the terrorist viz. Bilal Hamza Mir for carrying out the terrorist activities in the area; and
- 6. Whereas, on the basis of the investigation, the statements of witnesses recorded and other evidence collected, the Investigating Officer, has established *prima facie* involvement of the below mentioned accused for the commission of offences punishable under sections of the Unlawful Activities (Prevention) Act, 1967, as shown against their names :ô

Whereas, the Authority, appointed by the Government under Sub-Section (2) of Section 45 of the Unlawful Activities (Prevention) Act, 1967, has independently examined the Case Diary File and all the other relevant documents relating to the case and has come to the conclusion that a *prima facie* case is made out against the above accused; and
- 9. Whereas, after perusing the Case Diary File, the relevant documents and also taking into consideration the views of the Authority appointed under Sub-Section (2) of Section 45 of the Unlawful Activities (Prevention) Act, 1967, the Government is of the view that there is sufficient material and evidence available against the above mentioned accused for their prosecution under the provisions of law.

Now, therefore, in exercise of the powers conferred by Sub-Section (2) of Section 45 of the Unlawful Activities (Prevention) Act, 1967, the Government hereby accord sanction for launching prosecution against the accused viz. Imtiyaz Ahmad Ganie, Waseem Ahmad Lone and Bilal Hamza Mir, for the commission of offences punishable under the relevant Sections of Unlawful Activities (Prevention) Act, as indicated against the each accused at Para (6) above, arising out of FIR No. 217/2022 of Police Station, Sopore.
