Subject: Acquisition of land measuring 28 Kanals 19 Marlas situated in Village Dherewery, Tehsil Bhalessa (Gandoh), District Doda for construction of Gandoh Dherewery road.

Notification No. 09-REV(LAJ) of 2023 Dated 02-06-2023.

Whereas, on the basis of indent placed by the Executive Engineer, PMGSY Division Thathri, notification under section 4 (1) of Land Acquisition Act, Samvat, 1990 was issued vide Notification No. 212-16/LAC dated 18-06-2013 by Collector, Land Acquisition (SDM), Gandoh, for land measuring 28 Kanals 19 Marlas situated in Village

Dherewery, Tehsil Bhalessa (Gandoh), District Doda, calling upon the objections from the land owners/interested persons; and.

Whereas, Collector Land Acquisition (SDM), Gandoh vide No. 368-691/LAC dated 30-09-2019, recommended the case to District Collector (DC), Doda for issuance of declaration under sections 6 and 7 of J&K Land Acquisition Act, Samvat 1990, for construction of Gandoh Dherewery road situated in Village Dherewery, Tehsil Bhalessa (Gandoh) and District Doda who vide No. 454/LAC/D/19 dated 21-10-2019 endorsed to Divisional Commissioner, Jammu who vide No. 502/3907/PMGSY/19/Doda/3069 dated 21-12-2019 endorsed the same to Financial Commissioner (Revenue), J&K. The case was returned to clarify some observations vide No. FC-LS/LA-5198/2020 dated 11-06-2020 and No. FC-LS/LA-5198/2020 dated 29-04-2021, after addressing the observations the case was returned by the Divisional Commissioner, Jammu vide no. 502/3907/PMGSY/Doda/23/111 dated 19-04-2023 as received from Deputy Commissioner, Doda vide No. 868-69/LAC/D/22 dated 25-03-2023. Financial commissioner, Revenue, J&K vide No. FCR-land/195/2022-06-FCR dated 10-04-2023 forwarded to this department for the said purpose; and

Whereas, the report furnished by the Collector Land Acquisition (SDM), Doda vide letter referred to above, duly endorsed by District Collector (DC) Doda, Divisional Commissioner, Jammu and Financial Commissioner (Revenue), J&K has been examined and it has been found that no one has filed any abjection to the proposed acquisition; and

Whereas, the Government is satisfied that the aforesaid land is required for public purpose i.e. construction of Gandoh Dherewery road situated in Village Dherewery, Tehsil Bhalessa (Gandoh) and District Doda

Now, therefore, in pursuance of section 6 of the J&K Land Acquisition Act, Samvat 1990, it is declared that the land measuring 28 Kanals 19 Marlas (as per description at Annexure õAö) situated in Village Dherewery, Tehsil Bhalessa (Gandoh) and District Doda is required for public purposes i. e. construction of Gandoh Dherewery road. Further the Collector Land Acquisition (ACR) Kathua is directed under section 7 of the said act to take orders for acquisition of the said

land after giving prescribed notice to the interested person(s) as required under the Land Acquisition Act/Rules.

However, the Collector concerned shall be held specifically responsible for identification and proper verification of all types of lands involved in the case for making apportionment of compensation amongst all the interested persons/rightful claimants, in accordance with the relevant laws/rules in force, while making the award. The Collector/Indenting department shall also ensure that no compensation shall be made for the portion of land in the instant case which has already been acquired for any public purpose.

Notification Srinagar, the 19th of June, 2023.

Whereas, the use of Aadhaar as an identity document for delivery of services or benefits or subsidies simplifies the Government delivery processes, brings in transparency and efficiency, and enables beneficiaries to get their entitlements directly in a convenient and seamless manner by obviating the need to produce multiple documents to prove one identity; and

Whereas, the Tribal Affairs Department, is administering the Pre-matric Scholarship Scheme for Scheduled Tribes which is being implemented through the Directorate of Tribal Affairs, J&K; and

Whereas, under the Scheme, Pre-matric Scholarship is provided to Scheduled Tribe Students by the Implementing Agency as per the extant Scheme guidelines; and

Whereas, the aforesaid Scheme involves recurring expenditure incurred from the Consolidated Fund of Union Territory of Jammu and Kashmir.

Now, therefore, in pursuance of section 7 of the Aadhaar (Targeted Delivery of Financial and other Subsides, Benefits and Services) Act, 2016 (18 of 2016), the Government of Union Territory of J&K hereby notifies the following, namely :ô

- 1. A Child desirous of availing the benefits under the scheme shall hereby be required to furnish proof of possession of the Aadhaar number or undergo Aadhaar authentication.
- 2. Any Child desirous of availing the benefit under the scheme, who does not possess the Aadhaar number or, has not yet enrolled for Aadhaar, shall be required to make application for Aadhaar entrolment subject to the consent of his parents or guardians, before registering for the scheme provided that he is entitled to obtain Aadhaar as per section 3 of the said Act and such children shall visit any Aadhaar enrolment centre (list available at the Unique Identification Authority of India, UIDAI) (website www.uidai.gov.in) to get enrolled for Aadhaar.
- 3. As per regulation 12 of the Aadhaar (enrolment and update) Regulations, 2016, the department through its Implementing Agency, is required to offer Aadhaar Enrolment facilities for the beneficiaries who are not yet enrolled for Aadhaar and in case there is no Aadhaar Enrolment centre located in the respective Block or Taluka or Tehsil, the Department through its Implementing Agency shall provide Aadhaar enrolment facilities at convenient locations in coordination with the existing Registrars of UIDAI or by becoming a UIDAI Registrar themselves:

Provided that till the time Aadhaar is assigned to the Child, the benefit under the scheme shall be given to such children subject to production of the following documents, namely:ô

- (a) If the Child has been enrolled after attaining the age of five years (with biometrics collection), his Aadhaar Enrolment Identification Slip, or of bio-metric update identification slip; and
- (b) Any one of the following documents, namely :ô
 - (i) Birth Certificate; or Record of birth issued by the appropriate authority; or
 - (ii) School Identity Card, duly signed by the principal of the school, containing parents, names; and
- (c) Any one of the following documents as proof of relationship of the beneficiary with the parent or legal guardian as per the extant scheme guidelines, namely: ô
 - (i) Birth Certificate; or Record of birth issued by the appropriate authority; or
 - (ii) Ration Card; or
 - (iii) Ex-Servicemen Contributory Health Scheme (ECHS) Card; or

Employees, State Insurance Corporation (ESIC) Card ; or Central Government Health Scheme (CGHS) Card; or

- (iv) Pension Card; or
- (v) Army Canteen Card; or
- (vi) Any Government Family Entitlement Card; or
- (vii) Any other document as specified by the Department: Provided further that the above documents shall be checked by an officer specifically designated by the department for that purpose.
- (4) In order to provide benefits to the beneficiaries under the scheme conveniently, the department through Implementing Agency shall make all the required

- arrangements to ensure that wide publicity through media shall be given to the beneficiaries to make them aware of the said requirements.
- (5) In all cases, where Aadhaar authentication fails due to poor bio-metrics of the beneficiaries or due to any other reason, the following remedial mechanisms shall be adopted, namely :ô
 - (a) In case of poor fingerprint quality, iris scan or face authentication facility shall be adopted for authentication, thereby the department through its Implementing Agency shall make provisions for iris scanners or face authentication along with finger-print authentication for delivery of benefits in seamless manner:
 - (b) In case the Biometric authentication through finger prints or iris scan or face authentication is not successful, wherever feasible and admissible authentication by Aadhaar one time Password or timeóbased one time password (OTP) with limited time validity, as the case may be, shall be offered;
 - (c) In all other cases where Biometric or Aadhaar one time password (OTP) or time-based one-time password authentication is not possible, benefits under the scheme may be given on the basis of physical Aadhaar letter whose authenticity can be verified through the Quick Response (QR) code printed on the Aadhaar letter and the necessary arrangement of QR code reader shall be provided at the convenient locations by the department through its Implementing Agency.
- (6) Notwithstanding anything contained herein above, no child shall be denied benefit under the scheme in case of failure to establish his identity by undergoing authentication, or furnishing proof of possession of Aadhaar number, or in the case of a child to whom no Aadhaar number has been assigned, producing an application for enrolment. The benefit shall be given to him by verifying his identity on the basis of other documents as mentioned in clauses (b) and (c) of the proviso of sub-paragraph (3) of paragraph 1, and where

benefit is given on the basis of such other documents, a separate register shall be maintained to record the same, which shall be reviewed and audited periodically by the department through its Implementing Agency.

Notification

Jammu, the 21st June, 2023.

S.O.–331.—Whereas, draft amendments in the Jammu and Kashmir Motor Vehicles Rules, 1991 were published vide notification S.O.–208 dated 14th of April, 2023 as required under sub-section (1) of section 212 of Motor Vehicles Act, 1988, in the Official Gazette inviting

objections and suggestions from all the persons likely to be affected thereby, before the expiry of six weeks from the date on which the copy of Official Gazette containing the said notification was made available to the public; and

Whereas, no objection/suggestion was received from the public on the said draft amendments in J&K Motor Vehicles Rules, 1991.

Now, therefore, in exercise of powers conferred by Sections 65, 111, 211 and 212 of the Motor Vehicles Act, 1988 (Act No. 59 of 1988), the Government hereby make the following amendments in Jammu and Kashmir Motor Vehicles Rules, 1991; namely:—

1. In rule-44, in sub-rule (1), second proviso shall be substituted by the following namely:—

õProvided further that inspection for fitness of public service vehicles whose age is more than 15 years from the date of manufacture shall be carried out twice in a year (half yearly). The full fitness fee as notified under rule 81 of Central Motor Vehicles Rules, 1989 shall be charged at the grant of first fitness certificate during the year and a token fee of Rs. 100/- shall be charged for carrying out second six monthly fitness inspection of the vehicle, with all record in online mode.ö

2. In rule 55, proviso first shall be substituted by the following namely:—

 $\ensuremath{\tilde{\text{o}}}\xspace Provided$ that the procedure for allotment of vanity number shall be as under : —

- (i) The registration fee for e-auction will be Rs. 1000 and the registration fee including the reserve price of the number shall be paid online for all the categories. The amount of registration fee i.e. Rs. 1000 shall be non-refundable and registration shall be deemed to be complete only after the successful payment.
- (ii) The Registering Authority shall charge one-time Special Registration Fee (SRF) for allotment of a Special Registration Mark (SRM) to a motor vehicle, in addition to the registration fee, prescribed under rule 81 of the

Central Motor Vehicles Rules, 1989. In each registration series, the mode of allotment of Special Registration Mark (SRM), rate of Special Registration Fee (SRF) and the multiples of increase in the bid value shall be governed by the category of special registration mark as tabulated below:—

- (iii) After successful registration on e-auction platform, the vehicle owner shall have an option to bid for the choice registration mark in any registration marks series of registration authorities of Jammu and Kashmir. The owner of the vehicle shall be restricted to bid for only one choice registration mark for each vehicle.
- registration mark of choice. If the application shows availability of desired registration mark of choice in the RTO/ARTO series, then applicant can select the registration mark of choice and deposit Rs. 1000/- and the reserve price of the number online to reserve the number for e-auction. Once, the applicant successfully makes payment of Rs. 1000/- and the reserve price of the number, the desired registration mark of choice will be blocked from the concerned RTO/ARTO series for the e-auction period. If the number is not allotted to anybody, the same will be returned back to RTO/ARTO series.
- (v) After the completion of the online auction process, the highest bidder shall have 10 days to deposit his 100% bid amount through online mode otherwise Registration number shall be forfeited and will be available for the Auction again.
- (vi) In case of more than one applicant applying at minimum reserve price and where no further incremental bid is made by any of these applicants, the registration number of choice will be allotted to the first applicant. Further, if there is only one applicant, choice registration number shall be allotted at minimum special registration fee (SRF) mentioned in the notification.
- (vii) After the successful bidder has deposited the 100% bid amount within stipulated period, the e-auction platform shall map the choice registration number with the registration application (chassis number and engine

number) at the respective registering authority. Application for e-auction will be processed by the applicant through VAHAN registration application number generated at RTO/ARTO or dealer end.
