Subject :ô Counting of previous service on joining new service in  
UT Government/Centre Government/Autonomous Body for  
the benefit of gratuity in respect of Government employees  
covered under Defined Contributory Pension Scheme (NPS).

#### CIRCULAR

The benefit of Death-cum-Retirement Gratuity was extended to NPS employees of UT Government service vide SRO-484 dated 29-11-2017 and SO-328 dated 24-09-2021 issued by Finance Department, on the same terms and conditions as is applicable to employees covered under Defined Pension Scheme (Old Pension Scheme) on the analogy of the pattern adopted by Government of India vide O. M. No. 38/41/06-P&PW (A) dated 05-05-2009 and O. M. No. 07-05-2012-P&PW (F)/B dated 26-08-2016.

Doubts has been expressed by various departments as to whether the service rendered by NPS employees who have taken another appointment in the UT Government after quitting the former service is entitled for counting of service for pensionary benefits (Death-cum-Retirement Gratuity).

The issue has been examined in the Finance Department. The counting of service for the purpose of gratuity on mobility of a NPS Government employee from one department to another department may be regulated in the following manner :ô

- (I) On mobility from one department to another department of UT Government service, the service rendered in the previous department shall be counted for the purpose of grant of Gratuity.

- (II) On mobility from Central Government Service to UT Government Service or vice-versa, having NPS with provisions of retirement gratuity/death gratuity for its employees, the service rendered in the Central Government or in UT Government, as the case may be, shall be counted for the purpose of grant of gratuity. There shall be no sharing of gratuity liability between the Center and UT Government.
- (III) On mobility from UT Government Service to UT Autonomous Body having NPS with provisions of retirement/death gratuity for its employees, similar to that in UT Government, the service rendered in the UT Government would be counted for grant of gratuity. The Government will discharge its gratuity liability by paying the amount of retirement gratuity for the service rendered in the Government to the UT Autonomous Body. This procedure shall be followed *mutatis mutandis* in respect of NPS employees going over from one autonomous body to another autonomous body or from an Autonomous Body to UT Government having NPS with provisions of retirement/death gratuity for its employees similar to UT Government employees.
- (IV) On mobility from UT Government Service to a UT Autonomous Body, where the provision for grant of gratuity similar to that in UT Government does not exist or to a Public Sector Undertaking, the NPS Government employees shall be granted retirement gratuity as per rules for the service rendered in the UT Government subject to the condition that the total gratuity admissible in respect of the service rendered under the Government of J&K, shall not exceed the amount that would have been admissible, had the Government servant continued in Government Service and retired on the same pay which he/she drew on retirement from later organization.

The above provisions would be applicable to Government employees covered under NPS who resign (technical resignation) to take up another appointment, with proper permission, in Centre/UT Government or Central/ UT Autonomous Body or a PSU.

Subject :ô Verification of Status of GSTIN of the contractor and authenticity of GST-3B return through the Peridot App (available in the Playstore) or from the State Taxes Department.

CIRCULAR

It has come to the notice of Finance Department that dealers/contractors whose GSTIN have been cancelled or deactivated are applying for Government tenders with submission of fake/forged GST returns. Such practice happens because tender inviting departments do not cross-verify documents submitted by the tenderer with the State Taxes Department.

In terms of General Sales Tax Act, 1962, it was mandatory for the Contractors to get NOC from the State Taxes Department before applying for a tender. This practice has been done away with, post implementation of GST Act, 2017.

In order to have timely compliance of returns by contractors as well as DDOs, the State Taxes Department with the help of NIC, Jammu has recently developed an Online Web application namely APNA TDS portal which helps in identifying payment made to work contract service providers by DDOs through JK Payscale portal.

Before allotting any work contract, the status of GSTIN of the contractor and authenticity of GST-3B return submitted by the contractor can also be verified through the Peridot App (available in the Playstore) or from the State Taxes Department. Also before releasing of payment to contractor, the DDOs can verify the latest status of the GSTIN of the contractor by using the information available in Peridot App or through the State Taxes Department in order to ascertain that contractor has not defaulted in GST tax compliance. Payment to such contractor who are not fulfilling statutory obligations under GST Taxation Law should be avoided.

Accordingly all the Administrative Departments are advised to direct their subordinate officers that before allotting any contract/releasing payment to the contractor, the status of GSTIN of the contractor and authenticity of GST-3B return submitted by the contractor should be verified through the Peridot App (available in the Playstore) or from the State Taxes Department. Further, the DDOs should check latest Status of Contractor using the information available on Peridot App or from State Taxes Department. The payments in favour of those contractors who are not fulfilling Statutory Obligations under GST Taxation Law should be avoided.

and was providing logistic support to them, besides, under a well knit  
criminal conspiracy voluntarily harbouring the terrorists in the hideout

7. Whereas, the accused terrorists viz. Imtiyaz Ahmad Shah and Zahid

Whereas, the School Education Department is administering the Jammu & Kashmir "**Children of Army Personal Martyred in War**" Scheme to provide stipend to the students which is being implemented



through the Administrative Department School Education Jammu/ Kashmir and under the Scheme, Stipend @ Rs. 250/- per Month per Children (i.e., @ Rs. 3000/- Per Annum per Children) is given to the students/Children of Army Personal Martyred in War of J&K UT, studying in Director Sainik Welfare Boards, by the Administrative Department as per the extant scheme guidelines ; and

Whereas, under the Scheme “Children of Army Personal Martyred in War” is meant for *the UT of J&K* is given to the Children of Army Personal Martyred in War of J&K UT, studying in Director Sainik Welfare Boards, by the Administrative Department as per the extant Scheme guidelines;

Whereas, the aforesaid Scheme involves recurring expenditure incurred from the Consolidated Fund of Union Territory of Jammu & Kashmir.

Now, therefore, in pursuance of Section 7 of the Aadhaar (Targeted Delivery of Financial and Other Subsidies, Benefits and Services) Act, 2016 (18 of 2016) (*hereinafter referred to as the said Act*), the Government of Jammu and Kashmir hereby notifies the following, namely :—

1. (1) A student eligible for receiving the benefits desirous under the Scheme shall hereby be required to furnish proof of possession of the Aadhaar number or undergo Aadhaar authentication.
- (2) Any eligible student desirous of availing the benefit under the Scheme, who does not possess the Aadhaar number or, has not yet enrolled for Aadhaar, shall be required to make application for Aadhaar enrolment subject to the consent of his parents or guardians, before registering for the Scheme provided that he is entitled to obtain Aadhaar as per Section 3 of the said Act and such eligible student shall visit any Aadhaar enrolment centre (list available at the Unique Identification Authority of India (UIDAI) website [www.uidai.gov.in](http://www.uidai.gov.in)) to get enrolled for Aadhaar.
- (3) As per regulation 12 of the Aadhaar (Enrolment and Update) Regulations, 2016, the Administrative Department School

Education, Jammu and Kashmir, is required to offer Aadhaar enrolment facilities for the beneficiaries who are not yet enrolled for Aadhaar and in case there is no Aadhaar enrolment centre located in the respective Block or Tehsil, the Administrative Department School Education, Jammu and Kashmir, shall provide Aadhaar enrolment facilities at convenient locations in coordination with the existing Registrars of UIDAI or by becoming a UIDAI Registrar themselves :

Provided that till the time Aadhaar is assigned to the student, the benefit under the Scheme shall be given to such student subject to production of the following documents, namely :—

- (a) if the student has been enrolled (with biometrics collection), his Aadhaar Enrolment Identification slip, or of bio-metric update identification slip; and
- (b) any one of the following documents, namely:-
  - (i) Birth Certificate; or Record of birth issued by the appropriate authority; or
  - (ii) School identity card, duly signed by the Principal of the school, containing parents' names; and
- (c) any one of the following documents as proof of relationship of the beneficiary with the parent or legal guardian as per the extant Scheme guidelines, namely:—
  - (i) Birth Certificate ; or Record of birth issued by the appropriate authority; or
  - (ii) Ration Card; or
  - (iii) Ex-Servicemen Contributory Health Scheme (ECHS) Card; or Employees' State Insurance Corporation (ESIC) Card; or Central Government Health Scheme (CGHS) Card; or

- (iv) Pension Card; or
- (v) Army Canteen Card; or
- (vi) any Government Family Entitlement Card; or
- (vii) any other document as specified by the Department:

Provided further that the above documents shall be checked by an officer specifically designated by the Administrative Department of School Education, Jammu and Kashmir for that purpose.

2. In order to provide benefits to the beneficiaries under the Scheme conveniently, the Administrative Department of School Education, Jammu and Kashmir shall make all the required arrangements to ensure that wide publicity through media shall be given to the beneficiaries to make them aware of the said requirement.

3. In all cases, where Aadhaar authentication fails due to poor biometrics of the beneficiaries or due to any other reason, the following remedial mechanisms shall be adopted, namely:—

- (a) in case of poor fingerprint quality, iris scan or face authentication facility shall be adopted for authentication, thereby the Administrative Department of School Education, Jammu & Kashmir, shall make provisions for iris scanners or face authentication along with finger-print authentication for delivery of benefits in seamless manner;
- (b) in case the biometric authentication through fingerprints or iris scan or face authentication is not successful, wherever feasible and admissible authentication by Aadhaar One Time Password or Time-based One-Time Password with limited time validity, as the case may be, shall be offered;
- (c) in all other cases where biometric or Aadhaar One Time Password or Time-based One-Time Password authentication is not possible, benefits under the scheme may be given on the basis of physical Aadhaar letter whose authenticity

can be verified through the Quick Response code printed on the Aadhaar letter and the necessary arrangement of Quick Response code reader shall be provided at the convenient locations by the Administrative Department of School Education, Jammu & Kashmir.

Administrative Department, School Education, Jammu/Kashmir and under the Scheme, Stipend @ Rs. 25000/- per annum is given to the students of J&K UT studying in Rashtriya Indian Military College (RIMC), Dehradun by the Administrative Department as per the extant scheme guidelines ; and
