Dated 17-04-2023.

WHEREAS, vide Government Order No. 1212-JK(GAD) of 2021 dated 15-11-2021 read with Government Order No. 505-JK(GAD) of 2022 dated 05-05-2022 and Government Order No. 1257-JK(GAD) of 2022 dated 17-10-2022, 13,465 employees serving on substantive basis have been apportioned to Union Territory of Ladakh on the basis of options exercised by them and in terms of Section 89 of the Jammu and Kashmir Reorganisation Act, 2019;

AND WHEREAS, it was further provided in the Government Order No. 1212-JK(GAD) of 2021 dated 15-11-2021 that the apportionment of remaining employees referred by the Union Territory of Ladakh shall be considered upon recommendations of Union Territory of Ladakh after due verification of their credentials by the latter;

AND WHEREAS, vide Order No. 25-LA(GAD) of 2023 dated 30.01.2023, the General Administration Department, Union Territory of Ladakh deputed a team of Officers along with the details of 1286 employees for considering their apportionment to the Union Territory of Ladakh;

AND WHEREAS, the General Administration Department, Union Territory of Ladakh vide communication No. A/95/2021-Secy-GAD dated 06-02-2023, after due verification of their initial appointment/selection orders at its level also forwarded duly verified service records of these 1286 employees and recommended their apportionment to Union Territory of Ladakh;

AND WHEREAS, during the process of verification of records provided by General Administration Department, Union Territory of Ladakh, credentials of 1224 employees were found in order for their apportionment to Union Territory of Ladakh;

AND WHEREAS, it was further observed that ten (10) employees out of the aforesaid 1224 employees had already retired from service on attaining age of superannuation and such employees were, accordingly, excluded from the process of apportionment;

AND WHEREAS, some representations were also received in the General Administration Department, Union Territory of Jammu and Kashmir from employees seeking apportionment to Union Territory of Ladakh, and after consultations with the concerned Administrative Departments and upon their recommendations, the service records of the employees of the following departments have been found in order for their apportionment to the Union Territory of Ladakh :—

NOW, THEREFORE, on the basis of definitive recommendations of Administration of Union Territory of Ladakh and in exercise of the powers under Section 89 of the Jammu and Kashmir Reorganization Act, 2019, the Lieutenant Governor of the Jammu and Kashmir, is pleased to apportion 1221 employees figuring in Annexure to this Order, to Union Territory of Ladakh, subject to the following conditions :—

- (i) Further verification of genuineness of initial appointment orders/service records of these employees shall be carried out by General Administration Department, Union Territory of Ladakh and in the event of discovery of any deficiency subsequently, the apportionment of the employee(s) to that extent shall be deemed to have been withdrawn *ab initio*.
- (ii) Any variation in the details/credentials of the above employees shall be rectified only after considering original/verified service records by the concerned Controlling Authorities, with the approval of the competent authority.
- (iii) The employees apportioned to Union Territory of Ladakh and presently continuing their service in the Union Territory of Jammu and Kashmir shall be relieved by the concerned Administrative Departments immediately.
