Government Order No. 51-JK (FST) of 2024

Dated: 23-02-2024.

Whereas, Jammu and Kashmir Government declared its intention vide Government Order No. FST/20 of 1981 dated 4th February, 1981 to constitute Trikuta Wildlife Sanctuary; and

Whereas, the area of Trikuta Wildlife Sanctuary falls under the ownership and management of Shri Mata Vaishno Devi Shrine Board; and

Whereas, a proposal for de-notification of Trikuta Wildlife Sanctuary was considered by the Standing Committee of the State Board for Wildlife in its 3rd meeting held on 20th December, 2010, and was recommended for approval by the National Board for Wildlife; and

Whereas, the Standing Committee of the National Board for Wildlife, in its 22nd meeting held on 25th April, 2011, recommended the proposal for de-notification; and

Whereas, the conditions imposed by the State Board for Wildlife as well as the Standing Committee of the National Board for Wildlife stand fulfilled, and in accordance with the conditions imposed by the said Boards, the State Government vide SRO-47 of 2012 dated 30th January, 2012, constituted Tata Kuti Wildlife Sanctuary under the provision of subsection (1) of section 17 of the Jammu and Kashmir Wildlife (Protection) Act, 1978 in lieu of de-notification of Trikuta Wildlife Sanctuary; and

Whereas, the Hongole Supreme Court of India vide its order dated 13-03-2013 while considering the application moved by Shri Mata Vaishno Devi Shrine Board for de-notification of the entire Trikuta Wildlife Sanctuary granted permission for the same.

Now, therefore, the entire area of Trikuta Wildlife Sanctuary is hereby de-notified.

- 2. However, it has been observed that many employees have been failed to submit their property returns within the stipulated timeline and have thus made a default in this mandatory process. It has also been observed that various employees hve registered themselves on the portal but not submitted their property returns, thus they too have caused a default in submission of their details.
- 3. The failure/non-submission of the property returns by the Government employees invites a punitive action under the provisions of the Jammu and Kashmir Public men and Public Servants Declaration of Assets Act and Rules made thereunder. Further, the defaulting employees shall be guilty of committing criminal misconduct under the Prevention of Corruption Act and shall be punishable under the Said Act. Moreover, non-submission of the property returns will result in denial of the vigilance clearance of defaulting employees.
- 4. The matter has been considered in the General Administration Department and it has been decided that a last and final opportunity may be granted to these defaulting employees, who have failed to submit their property returns within the stipulated timeline. Thereafter, no more opportunity shall be granted and action as mentioned above shall be initiated against the defaulters.
- 5. Accordingly, the submission of property returns by the defaulting employees shall be allowed through online mode on the Property Return System (PRS Portal) w. e. f. 13-02-2024 to 27-02-2024.
- 6. Further, all those employees who had registered themselves on the Portal but not submitted their property returns shall submit the same, besides, the unregistered employees shall get themselves registered on the portal and subsequently submit their property returns, during the above stipulated period. In case the employees encounter issues related to OTP, they shall update their current mobile numbers and email IDs on CPIS portal and further, in case of any other issue/technical support, they may forward their concerns on support-prs@jk.gov.in for speedy redressal.

- 7. It is further emjoined upon all the Controlling Officers/Drawing and Disbursing Officer (DDOs)to ensure compliance with regard to filing of property returns by all the defaulting employees of their establishment. Further, Administrative Departments shall also assess the progress in this regard.
