Subsequently, clarifications were sought by the Administrative Departments with regard to promotion/inclusion of the employees apportioned to the Union Territory of Ladakh against cadre strength of Union Territory of Jammu and Kashmir, after the apportionment of employees among the two successor Union Territories.
