Whereas, it appears to the Government that a total of 34K-05M land is required in the village Maitra Govindpura Tehsil and District Ramban for public purpose, namely for the construction of road from T.V. Tower to Gughwal via Failty.

Whereas, the said land acquisition case was earlier processed under Jammu and Kashmir State Land Acquisition Act SVT 1990 on the Indent placed by Executive Engineer PWD (R&B) Division Ramban, notification U/Ss 6 and 7 was issued by the Divisional Commissioner Jammu vide notification No. 36 Divcom of 2010 and endorsement No. 502/1120/12-10/Acq/Rbn/4904-08 dated 22-12-2010 and tentative award was issued vide No. Acq/Gen/08 dated 06-04-2012 by the then Collector Land Acquisition (ACR) Ramban.

Whereas, the land acquisition proceedings in the Instant land acquisition case could not be finalized on account of non placement of sufficient funds by the Indenting Department and also due to non placement of fresh Indent as per the circular issued by the Commissioner Secretary to Government, Revenue Department, Civil Secretariat J&K vide No. REV/LAJK/375/2016 dated 03-12-2016 as requested by this office vide No. Acq/Gen/17/2008-10 dated 01-03-2017.

Whereas, the petitioners namely Amar Singh and Ors. approached Honøble High Court of Jammu and Kashmir and Ladakh at Jammu in Court case vide WP(C) No. 1571/2021 titled Amar Singh and Ors. V/S UT of J&K through Commissioner/Secretary PWD (R&B), Civil Secretariat Jammu/Srinagar.

Whereas, the said writ petition was disposed of by the Honøble Division Bench and passed an order dated 07-05-2022 with the directions to initiate fresh land acquisition proceedings in terms of the provisions of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013, the operative part of which is given as under :ô

"Be that as it may, this writ petition is disposed of with a direction to the respondent No. 7-Divisional Commissioner, Jammu, as also the respondent No. 8-Collector Land Acquisition (Assistant Commissioner, Revenue), Ramban to ensure that the proceedings under the Act are initiated positively within one month from the date of receipt of a certified copy of this order. In case of any default in Initiation of the proceedings, the concerned officer shall be held responsible. However, in case of any legal impediment, the said respondents can approach this Court for seeking extension of time, which will be permitted only if legitimate cause is shown".

Whereas, Chief Engineer PW (R&B) Department Jammu placed indent vide his No. CEJ/Legal/S/1141-44 dated 03-10-2022 for the acquisition of Land required for the purpose of construction of road from T.V. Tower to Gughwal via Failty.

Whereas, the Government of Jammu and Kashmir, Revenue Department Civil Secretariat, notifies the final draft rules i. e. ::The Jammu and Kashmir Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement (Social Impact Assessment and Consent) Rules, 2023 vide S.O. 440 dated 24th of August, 2023.

Whereas, the indent placed by the Chief Engineer PW (R&B) Department Jammu was perused in consonance with the provision contained in the aforementioned rules notified vide S.O 440 of 2023 dated 24-08-2023 and it was found that the Indent has not placed strictly as per the rules 3(1), (3) and (5) of the Jammu and Kashmir Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement (Social Impact Assessment and Consent) Rules, 2023 and accordingly the matter was taken up with District Collector (Deputy Commissioner) Ramban vide this office No. Acq/Gen/Rbn/23/210 dated 19-09-2023. The District Collector (Deputy Commissioner) Ramban took the matter with Chief Engineer PWD (R&B) Jammu vide No. DCR/HQA/2023-24/637-39 dated 11-10-2023 and requested to place fresh Indent alongwith requisite documents strictly as per the conditions outlined in S.O 440 of 2023 dated 24-08-2023.

Whereas, this Collectorate vide No. Acq/Gen/Rbn/23/383-85 dated 01-12-2023 again requested Chief Engineer PWD (R&B) Jammu to place indent as per conditions outlined in S.O. 440 of 2023 dated 24-08-2023 alongwith sufficient funds.

Whereas, meanwhile, this Collectorate constituted a committee vide No. Acq/Gen/Rbn/23/211-20 dated 19-09-2023 as per Rule 4 of the Rules notified vide S.O. 440 of 2023 to conduct preliminary enquiry in the said land acquisition case with the directions to submit its report within 15 days.

Whereas, the committee submitted its report duily endorsed by Tehsildar Ramban vide his No. TR/OQ/2023-24/Misc/1959 dated 02-12-2023 perusal of which reveals that the said road already stands constructed upto Failty and alternate State/Government land cannot be proposed for the road in question. Further, there is no involuntary displacement involved in the acquisition of said land and accordingly, no rehabilitation is required. The construction of road has no economic as well as social adverse impact on the local inhabitants. Land owners have no objection on the said acquistion and consent as required under Sub-Rule (2) of Rule 17 and Sub-Rule (1) of Rule 20 on Form-V (Part-A) (Prior Written Consent of the Affected Land Owners or Declaration Form) has been obtained from them. Resolution of Gram Sabha as per Sub-Rule (7) of Rule 21 on Form-V (Part B) has also been obtained.

Whereas, Chief Engineer PW (R&B) Department, Chenab Zone Batote vide his No. CECV/1481-83 dated 14-12-2023 placed a fresh Indent under the provisions of S.O. 440 of 2023.

Whereas, keeping in view the findings and recommendations of the committee constituted by this Collectorate, written consent submitted by the land owners concerned as required under Sub-Rule (2) of Rule 17 and Sub-Rule (1) of Rule 20 on Form-V (Part A) (Prior Written Consent of the Affected Land Owners or Declaration Form), resolution submitted by Gram Sabha as per Sub-Rule (7) of Rule 21 on Form-V (Part-B) and no family/families are likely to be displaced due to the instant land acquisition case, this Collectorate has decided to consider the report of the committee as Social Impact Assessment report as required under Sections 4, 5, 6, 7 and 8 of :The Jammu and Kashmir Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act 2013, and Rules 9, 13, 14, 15, 16 and 17 of :the Jammu and Kashmir Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement (Social Impact Assessment and Consent) Rules, 2023@

Whereas, based on the above, a Case FIR No. 25/2023 under Sections 8/21,29 NDPS Act and the Sections 13 and 23 of ULA (P) Act was registered in the Police Station, Trehgam, and the investigation, of the case was set into motion. Subsequently, during the investigation, the offences under Section 7/25 Arms Act, and the offences under Sections 18,38,39 and 40 of ULA (P) Act were added in the case; and
- 3. Whereas, during the investigation, the site plan of the place of occurrence and the seizure memos were prepared and the statement of witnesses acquainted with the facts and circumstances of the case were recorded under the relevant provisions of law; and
- 4. Whereas, during the investigation, the accused viz Mohd Yousuf Bokra, Showkat Ahmad Khatana, Maroof Ahmad Mir, alongwith one non local person identified as Loba Massih @ Ajay S/o Sadiq Massih R/o Awaan, Ramdas, Ajnala, Amritsar, Punjab, were arrested in the case and during the investigation, 08 packets of narcotic, 02 Chinese hand grenades and an amount of Rs. 05 lacs were recovered at their instances respectively; and

Whereas,during the investigation, it was established that the accused viz Mohd Yousuf Bokra, Showkat Ahmad Khatana and Maroof Ahmad Mir, were working as Over Ground Workers (OGWs) for the terrorists of LeT banned outfit particularly the terrorists viz Manzoor Ahmad Mir and Assad Mir, and under a well knit criminal conspiracy were providing logistic support to them and procured Narcotics (Heroin) and explosive material from the said terrorists, besides, the accused viz Loba Massih @ Ajay, was raising funds for the terrorists for carrying out the terrorist activities in the area; and

Whereas, based on the above, a Case FIR No. 282/2022under Sections 307 IPC, 7/27 Arma Act, and the Sections 16 and 20 of ULA (P) Act was registered in the Police Station, Pattan, and the investigation, of the case was set into motion. Subsequently, during the investigation, the offences under Sections 18, 18-B, 23 and 38 of ULA (P) Act were added in the case; and
- 3. Whereas, during theinvestigation, the site plan of the place of occurrence and the seizure memos were prepared and the statement of witnesses acquainted with the facts and circumstances of the case were recorded under the relevant provisions of law; and
- 4. Whereas, during the investigation, two persons identified as Jameel Ahmad Parra S/o Habibullah Parra R/o Tapper, Pattan and Rizwan Mushtaq Wani S/o Mushtaq Ahmad Wani R/o Wani Mohalla, Hamray, Pattan were found involved in the commission of crime who were already arrested in case FIR No. 117/2022of Police Station, Pattan. Subsequently, the custody of both the accused were changed in the instant case; and

Jameel Ahmad Parra and Rizwan Mushtaq Wani, along with two more terrorists of the outfit namely Shakir Majeed Najar S/o Abdul Majeed Najar and Abdul Hanan Seh S/o Farooq Ahmad Seh Røs/o Sugan, Shopian, fired indiscriminately upon the Manager Grameen Bank, Goshbugh namely Vivak Kumar S/o Ashok Kumar R/o Dehradun, Utrakhand, on the directions of accused terrorist viz. Abid Qayoom Lone; and

Whereas, during the investigation, it was established that the accused viz Jameel Ahmad Parra, Rizwan Mushtaq Wani, Shakir Majeed Najar and Abdul Hanan Seh, were members of TRF, a banned outfit, and on the directions of accused terrorist viz. Abid Qayoom Lone, fired indiscriminately upon the non local Bank employee (Manager Grameen Bank, Goshbugh) and escaped from the spot; and
- 7. Whereas, the accused terrorists viz. Shakir Majeed Najar and Abdul Hanan Seh, have been killed in an encounter with the Security Forces at Wanigam, Kreeri on 04-05-2023, and the proceedings under the law would abate against them; and

Whereas, based on the above, a Case FIR No. 18/2022 under Section 7/25 Arms Act, 13, 18 and 38 of ULA (P) Act, was registered in the Police Station, Shalteng, and the investigation of the case was set into motion. Subsequently, during the investigation, the Sections 18-B, 20, 23 and 39 of ULA (P) Act were added in the case; and
- 3. Whereas, during the course of the investigation, the site plan of the place of occurrence and the seizure memos were prepared and the statements of witnesses acquainted with the facts and circumstances of the case were recorded under the relevant provisions of law; and
- 4. Whereas, during the investigation, the accused viz. Arshid Ahmad Bhat, was found in contact with a terrorist of HM, a banned outfit, namely Tariq Ahmad Pandith S/o Bashir Ahmad Pandith R/o Karimabad, Pulwama, who was already arrested by Pulwama Police and was lodged in District Jail, Kathua. The accused viz. Tariq Ahmad Pandith, motivated the said accused viz. Arshid Ahmad Bhat, to work for the outfit and connected him with another terrorist of the HM, a banned outfit, namely Hanan-bin-Yaqoob @ Saqib S/o Mohd Yaqoob Bhat R/o Karimabad, Pulwama. The accused viz. Arshid Ahmad Bhat, procured arms/ammunition from Lawaypora area from an unknown person on the directions of the accused viz. Tariq Ahmad Pandith, in order to promote/commit terrorist activities in the area; and
- 5. Whereas, during the investigation, it was established that the accused viz. Arshid Ahmad Bhat, was working as Over Ground Worker (OGW) for the terrorists of HM, a banned outfit, particularly the terrorists viz. Tariq Ahmad Pandith and Hanan-bin-Yaqoob @ Saqib, and under a well knit criminal conspiracy was providing logistic support to them, besides, procured arms/ammunition, from the said terrorists for carrying out the terrorist activities in the area; and
- 6. Whereas, the accused terrorist viz. Hanan-bin-Yaqoob @ Saqib, has been killed in an encounter with the Security Forces on 05-10-2022, at Drach, Shopian, and the proceedings under the law would abate against him. The investigation, in respect of the accused viz. Tariq Ahmad Pandith and unknown person from whom the accused

- 7. Whereas, the sanction has already been accorded in respect of accused viz. Arshid Ahmad Bhat, vide Notification S. O. No. 32 dated 12th January, 2023, by the Competent Authority and the investigation, of the case was continued with respect to the other accused; and

Arshid Ahmad Bhat, to work for the outfit and provided arms/ammunition to him through an unknown person for carrying out the terrorist activities in the area; and

Arshid Ahmad Bhat, on the directions to terrorist Tariq Ahmad Pandith, shall continue to ascertain his actual Identity and to bring out his role/involvement in the case and the supplementary charge sheet against him would be filed in the Court of competent jurisdiction; and
