SubsequentJy, clarifications were sought by the Administrative Departments with regard to promotlon/inclusion of the employees apportioned to the Union Territory of Ladakh against cadre strength of Union Territory of Jammu and Kashmir, after the apportionment of employees among the two successor Union Territories.

Accordingly, the matter was examined in the General Administration Department and vide Circular No. 09-JK(GAD) of 2022 dated 08-03-2022, following clarifications were notified for the information of all Administrative Departments:

- i. Consequent upon the apportionment of manpower between Union Territory of Jammu and Kashmir and Union Territory of Ladakh, the promotions/appointments in Jammu and Kashmir shall be considered against the posts allocated to Union Territory of Jammu and Kashmir only. The posts allocated to Union Territory of Ladakh shall be excluded while considering any such exercise except for the services failing under the ambit of S.O. 428 dated 21-12-2021.
- ii. The employees apportioned to Union Territory of ladakh vide Government Order No. 1212-JK(GAD) of 2021 dated 15-11-2021 shall be excluded from 'Seniority List/ Eligibility Ilst' and such employees shall not be considered for promotions in the Union Territory of Jammu and Kashmir w.e.f. 15-11-2021.

Despite the earlier instructions, it has come to notice that the Departmental Promotion Committees, including the J&K Public Service Commission, are not considering the employees apportioned to the Union Territory of Ladakh for promotion/regularization to the post(s) on which they have been placed in the In-charge capacity against vacancies in the cadre prior to 15-11-2021. However, some Administrative Departments have sought clarification in the matter. Besides, the Administration of the Union Territory of Ladakh has also requested to resolve the issue at an earliest, so that the Administration can place their matter before the Union Public Service Commission/concerned DPCs for further promotions.

- i. The cases for regularization/promotion of employees apportioned to the Union Territory of Ladakh, who have been placed in the In-charge capacity on higher post(s) prior to their apportionment against the combined cadre strength, shall be placed before the J&K Public Service Commission/Departmental Promotion Committee(s), for consideration on case to case basis after observing all the rules and vacancy position in the combined cadre strength at the relevant period.
- ii. Thereafter, the recommendations of the Departmental Promotion Committee(s)/J&K PSC shall be sent to the concerned Administrative Department in the Administration of Union Territory of Ladakh along with all relevant records/documents for issuance of regularization order(s) and subsequent entry in the Service Book.
