Sanction is hereby accorded to the transfer of State land measuring 633 Kanals 05 Marlas under Khasra No.842 situated at Estate Brah, Tehsil Shangus, District Anantnag in favour of Industries & Commerce Department for establishment of Industrial Estate.

It shall be subject to the following conditions:ô
