Whereas, it appears to the Government that a total of 01K-05M land is required at the Village Champa Tehsil Batote District Ramban for public purpose, namely for the Re-alignment of Tower No. KP-169 of 220 KV D/C KPTL at Village Champa Tehsil Batote District Ramban.

Whereas, Chief Enigneer (Transmission), Jammu JKPTCL placed an indent vide his No. CE/Trans./J/JKPTCL/T/5495-99 dated 08-09-2022 for the acquisition of private land measuring 1KI-05MIs situated in Village Champa Tehsil Batote District Ramban for the purpose of ::Re-alignment of Tower No. KP-169 of 220 KV D/C KPTLøø at Village Champa.

Whereas, Tehsildar Batote prepared the revenue papers of land measuring 1K1-5Mls in consultation with the Indenting Department and submitted to this office vide his No. 647/TB/Gen/OQ dated 09-01-2023 and the same were authenticated by the Indenting Department in token of its correctness.

Whereas, the Government of Jammu and Kashmir, Revenue Department Civil Secretariat, notified the final draft rules i. e. ::The Jammu and Kashmir Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement (Social Impact Assessment and Consent) Rules, 2023 vide S.O-440 dated 24th of August, 2023.

Whereas, the indent placed by the Chief Engineer (Transmission), Jammu JKPTCL was perused in consonance with the provisions contained in the aforementioned rules notified vide S.O-440 of 2023 dated 24-08-2023 and it was found that the Indent was not placed as per the Rule 3(1), (3) and (5) of the Jammu and Kashmir Right to

Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement (Social Impact Assessment and Consent) Rules, 2023 and accordingly, the matter was taken up with District Collector (Deputy Commissioner), Ramban vide this office No. Acq/Gen/Rbn/23/231 dated 19-09-2023 wherein it was requested to place fresh Indent alongwith requisite documents and funds to the tune of Rs.40.57 lacs strictly as per the conditions outlined in S.O-440 of 2023 dated 24-08-2023.

Whereas, meanwhile, this Collectorate constituted a committee vide No. Acq/Gen/Rbn/23/221-230 dated 19-09-2023 as per Rule 4 of the Rules notified vide S.O-440 of 2023 to conduct preliminary enquiry in the said land acquisition case with the directions to submit its report within 15 days.

Whereas, the committee submitted its report duly endorsed by Tehsildar Batote vide his No. 687/TB/Gen/OQ dated 19-12-2023 perusal of which reveals that the said tower already stands erected and alternate State/Government land cannot be proposed for the said project. Further, there is no involuntary displacement involved in the acquisition of said land and accordingly, no rehabilitation is required. The erection/ construction of tower has no economic as well as social adverse impact on the local inhabitants. Land owners have no economic as well as social adverse impact on the local inhabitants. Land owners have no objection on the said acquisition and consent as required under Sub-Rule (2) of Rule 17 and Sub-Rule (1) of Rule 20 on Form-V (Part-A) (Prior written Consent of the Affected Land Owners on Declaration Form) has been obtained from them. Resolution of Gram Sabha as per Sub-Rule (7) of Rule 21 on Form-V (Part-B) has also been obtained.

Whereas, Managing Director JK Power Transmission Corp. Ltd. (PTCL) J&K Jammu/Srinagar duly endorsed by Chief Engineer (Transmission), Jammu JKPTCL vide his No. CE/Trans/J/JKPTCL/T/ 8572-76 dated 11-12-2023 placed a fresh Indent under the provisions of S.O-440 of 2023 for the purpose of ::Re-alignment of Tower No. KP-169 of 220 KV D/C KPTL at Village Champa.

Whereas, keeping in view the findings and recommendations of the committee constituted by this Collectorate, written consent submitted by the land owners concerned as required under Sub-Rule (2) of Rule 17 and Sub-Rule (1) of Rule 20 on Form-V (Part-A) (prior Written Consent of the Affected Land Owners on Declaration Form), resolution submitted by Gram Sabha as per Sub-Rule (7) of Rule 21 on Form-V (Part-B) dully signed by the Sarpanch concerned and no family/families are likely to be displaced due to the instant land acquisition case, this Collectorate has decided to consider the report of the committee as Social Impact Assessment Report as required under Sections 4, 5, 6,

Whereas, Rules 49H (3) and 49K (2) (b) of the Conduct of Elections Rules, 1961 stipulate that where the electors of a constituency have been supplied with Electors' Photo Identity Card under the said provisions of Rule 28 of the Registration of Electors Rules, 1960 the electors shall produce their Elector Photo Identity Card at the polling station and failure or refusal on their part to produce those Elector Photo Identity Card may result in the denial or permission to vote; and

4. Whereas, a combined and harmonious reading the aforesaid provisions or the said Act and the Rules, makes it clear that although the right to vote arises by the existence of the name in the electoral roll, it is also dependent upon the use of the Elector Photo Identity Card, where provided by the Election Commission at State cost, as the means of establishing their identity at the time of polling and that both are to be used together; and

5. Whereas, the Election Commission made an Order on the 28th August, 1993, directing the issue of Electors' Photo Identity Card (EPIC) to all electors, according to a time bound programme; and

- ix. Service Identity Cards with photograph issued to employees by Central/State Govt./PSUs/Public Limited Companies,
- x. Official identity cards issued to MPs/MLAs/MLCs, and
- xi. Unique Disability ID (UDID) Card. M/o Social Justice & Empowerment, Government of India.

8. In the case of EPIC, clerical errors, spelling mistakes, etc. should be ignored provided that the identity of the elector can be established by the EPIC. If an elector produces an EPIC which has been issued by the Electoral Registration Officer of another Assembly Constituency. such EPIC shall also be accepted for identification provided that the name of that elector finds place in the electoral roll pertaining to the polling station where the elector has turned up for voting. If it is not possible to establish the identity of the elector on account of mismatch of photograph, etc. the elector shall have to produce one of the alternative photo documents mentioned in Para 7 above.

SO-619.ô In exercise of the powers conferred by section 25 of the Private Security Agencies (Regulation) Act, 2005 (Act No. 29 of 2005), the Lieutenant Governor hereby makes the following rules, namely:ô

1. Short title and commencement:ô (1)These rules may be called the Jammu and Kashmir Private Security Agencies (Private Security to Cash Transportation Activities) Rules, 2023. (2) These rules shall come into force on the expiry of six months of their publication in the Official Gazette.

**2.Definitions.**ô In these rules, unless the context otherwise requires:ô

(a) "Act" means the Private Security Agencies (Regulation) Act, 2005 (29 of 2005);

(b) "ATM" means the automatic teller machine that dispenses cash or performs other banking services when an account holder of any bank inserts a Bank card therein;

**Explanation:-** For the purposes of this clause, "Bank card" includes credit card or debit card;

(c) "cash handling agency", "cash replenishment agency" or "cash-in-transit agency" means an agency or entity, by whatever name called, engaged in cash transportation activities;

(d) "cash transportation activities" means the physical transfer of cash, such as banknotes, coins, credit card, debit card or other items of value from one location to another, and includes loading cash in to, or unloading cash from, an ATM machine;

(e) "private security" or "private security agency" shall have the same meaning as assigned to it in clause (f) or clause (g) of section 2 of the Act;

(f) "Schedule" means a Schedule appended to these rules.

**3.** Private Security for cash transportation activities, etc.ô (1) No private security shall be provided by the private security agency for cash transportation activities unless he holds a license under the Act.

(2) For the purpose of providing private security for cash transportation activities, a contract may be entered into between:  $\hat{o}$ 

(a) a private security agency holding a license under the Act and the bank concerned; or

(b) a cash handling agency and the bank concerned:

Provided that in case the cash handling agency holds a license as a private security agency under the provisions of the Act, such cash handling agency may itself provide the private security to cash transportation activities in accordance with the provisions of these rules.

**4.** Use of specially designed and fabricated cash van.ô (1) No private security agency shall provide private security or private security guards to a Bank or a cash handling agency for cash transportation activities, unless such activities are carried out in a secured cash van, which complies with the conditions for design and specification specified in the First Schedule, owned by it or owned by the Bank or the cash handling agency, as the case may be.

(2) No taxi or hired vehicle shall be used for cash transportation activities by the private security agency:

Provided that a vehicle which is on long term contract with the privatesecurity agency or Bank or cash handling agency and the vehicle complies with the conditions for design and specification laid down under sub-rule (1) may be used by the private security agency:

Provided further that in case of any remote location where private security agencies are not present and not serviced by a currency chest, any vehicle at such location may be used as an exception under the strict security control and support of the local police.

**5. Requisite number of trained staff per cash van.**ô (1) The private security agency shall provide the private security for the cash transportation activities with therequisite number of trained staff, directly appointed or engaged by the private security agency, as specified in sub-rule (2).

(2) Every cash van shall have the following minimum staff, possessing the qualifications and training laid down under section 10 of the Act, on board for every single cash transportation activities, namely,

(i) Driver-one;

(ii) Armed security guardsfour; and

(iii) ATM officer or custodian-two.

(3) The cash van shall always be escorted by at least four trained armed security guards on board:

Provided that more than four armed security guards may be deputed on a cash van depending on the amount of cash carried and in accordance with the individual company's insurance guidelines or client contract or terrain of operation.

(4) Where the cash van is a medium motor vehicle, one armed guard shall sit in the front along with the driver and three in the rear portion of the van and while in transit, loading or unloading, nature's call, tea or lunch break, at least two armed security guard shall remain present with the cash van all the time.

(5) Notwithstanding any other provision in these rules, the exserviceman, otherwise eligible, may preferably be appointed or engaged by the private security agency for providing security for cash transportation activities.

**6.** Antecedent check of personnel.— (1) No private security agency shall appoint or engage or deploy any personnel for the cash transportation activities, unless such personnel has undergone thorough antecedent check and his proper KYC verification and police verification is done, before appointing or engaging or deploying them by the agency, in accordance with the provisions of the Act or any other law for the time being in force.

Explanation.ô For the purposes of this sub-rule, the expression "KYC" means the know your customer process of an agency or business identifying and verifying the identity of its clients or person associated or to be associate with the agency or business.

(2) Every private security agency shall be responsible to comply with the following checks before an individual is appointed or engaged to participate in cash transportation activities, namely:ô

(a) police clearance certificateô every individual shall obtain the police clearance certificate from his local police station before appointment or engagement ;

(b) residence verificationô the private security agency shall use i's own resources to conduct a physical verification of the residential address of every individual, including general conduct check and the individual shall furnish to the security agency the proof of residential address of at least three years before appointment or engagement for the cash transportation activities;

(c) previous employer checkô the private security agency shall use its own resources to conduct reference check with previous employers of the individual, if any;

(d) Aadhaar verificationô each individual appointed or engaged for the cash transportation activities shall be antecedent verified through Aadhaar number from the Unique Identification Authority of India;

(e) credit history checkô the private security agency shall conduct a credit history check of every individual appointed or engaged to ensure that willful credit defaulters are notappointed or engaged for the cash transportation activities;

(f) fidelity insuranceô the private security agency shall obtain a fidelity insurance in respect of every personnel appointed or engaged for the cash transportation activities.

(3) The Controlling Authority shall conduct periodic verification of any personnel appointed or engaged for cash transportation activities through field agencies.

**7.** Adequate training and certification of personnel.— (1) The private security agency shall ensure that every personnel appointed or engaged for cash transportation activities shall be imparted,

(a) the training and certified for the security and safe handling of such activities as per the requirements of training laid down in the Second Schedule;

(b) the refresher training once in every two years;

(c) periodic drills to simulate the exact crises situation.

(2) The private security agency shall ensure that every personnel appointed or engaged for cash transportation activities shall be put to psychological tests to check their mental toughness and fidelity.

**8. Live GPS tracking of cash van during operations.**— (1) Every cash transportation activities shall be carried out only in secured cash vans fitted with GPS tracking device.

Explanation-For the purposes of this sub-rule, the expression "GPS" means the global positioning system which is a space-based navigation system that provides location and time information in all weather conditions, anywhere on or near the Earth where there is an unobstructed line of sight to four or more GPS satellites.

(2) The private security agency shall ensure that each cash van shall be monitored at all times during cash transportation activities through a redundant communications protocol.

(3) The private security agency shall ensure degree of unpredictability and routine should be avoided.

(4) The private security agency shall ensure that the personnel appointed or engaged for cash transportation activities shall be given closed user group apparatus for communication.

**9. Guideline for maximum cash carrying limit in a single cashvan.**—(1) The privatesecurity agency involved in cash transportation activities shall ensure that no cash van carriescash of more than five crores rupees per trip.

(2) The private security agency shall ensure that secured cash van shall be deployed for carrying cash of more than ten lakh rupees per trip.

**10.Specification for private cash vaults used for holding and overnight vaulting of Bank currency.**— The private security agency shall ensure that all cash handling, including counting, sorting, and

(a) Location of private cash vault premises—the premises used for cash handling activities shall be located to ensure safety of activities/ operations, including areas closer to bank's cash withdrawal centre or police station and secluded areas with poor connectivity be avoided:

(b) Design of premises—the premises shall be designed to include two physical independent areas, one for general office purpose and other for secured cash processingandhandling activities and it shall accommodate space for cash deposit, collection, sortin counting and delivery and dispatch of cash on secured cash vans;

(c) Cash vault—secured area shall be designed to store cash to meet with the requirement of the Reserve Bank of India specified for cash vaults in accordance with the following specifications, namely:—

> (i) in smaller cities with limited overnight vaulting requirements of less than ten crore rupees, a strong room with defender safes;

> (ii) at operation centers with overnight vaulting requirements between ten to one hundred crore rupees, vaulting facility as per the norms of the Reserve Bank of India specified for C Class vaults;

> (iii) at large operation centers with overnight vaulting requirements of more than one hundred crore rupees, increased vaulting facility in consultation with the concerned Bank;and

> (iv) all overnigh-vaulting facilities shall have provision to store currency of multiple Banks in separate and exclusive bins;

(d) Security of cash vault—the private security agency shall ensure the following security aspects at its cash vault used for secured handling of cash on behalf of the Bank, namely:—

(i)adequate number of armed private security guards are

(ii)premises is under 24x7 electronic surveillance and monitoring ;

(iii) cash vault is provided with CCTV system with adequate number of camerashaving at least ninety daysrecording facility;

(iv) the activities at cash vault isundertaken under dual custody basis;

(v) the main cash vault area complies with all safety norms, like firefighting systems, smoke detection systems, emergency lighting, control room for monitoring the movement of vehicles, auto-dialer and burglar security systems;

(vi) security alarm with GSM based auto dialer, fire and magnetic sensor are installed;

(vii) the loading and unloading area of cash is covered by night vision CCTV cameras;

(viii) electric power supply inside the cash vault is provided through plug-in, plug- out system;

(ix) carrying of naked light inside the cash vault is strictly prohibited and drybattery operated torches or emergency lights are used inside strong rooms;

(x) emergency lighting with the help of inverter shall always be available to the security staff; and

(xi) cash processing and vault areas shall have restricted and controlled access, preferably through interlocking systems and frisking.

Explanation-For the purposes of this rule, the expression "CCTV" means the closed circuit television which is a self- contained surveillance system comprising cameras, recorders and displays for monitoring activities in a store or company.

**11. Measures for risk mitigation.**— (1) The private security agency shall ensure that the ATM under its security shall be fitted with one time

(2) The cash for loading in to an ATM machine shall be collected from the Bank on previous day or in the first half of the day so that operations can be concluded before the time stipulated in sub-rule (3).

(3) No cash loading of the ATMs or cash transportation activities shall be done:—

(a) after 9 PM in urban areas;and

(b) after 6 PM in rural areas.

# THE FIRST SCHEDULE [See rule 4(1)] DESIGN AND SPECIFICATION FOR SECURED CASH VANS

(a) Make.— The cash van shall-

(i) be a Light Commercial Vehicle, with an engine capacity of not less than 2200 CC, preferably turbocharged;
(ii) be not more than seven years old;
(iii) have tubeless tyres;
(iv) have a ground clearance of not less than 190 mm; and (v) accommodate minimum of five passengers.

(b) Layout.— The cash van shall have the compartment for storing cash, physically separated and locked from the passenger compartment unit:

(c) Cash compartment security.—(i) The cash compartment should be inaccessible from outside the van unless operated internally through manual or electronic lock and cash compartment is specially reinforced with steel with only one door and grill gate;

(ii) the entrance of the cash compartment shall be from the rearside to ensure proper visibility, operational feasibility and CCTV surveillance;

(iii) all windows and wind screen shall have wire meshprotection of not more than one square inch and each window mesh shall have a circular port-hole of six inches diameter for use of weapons;
 (iv) the panic switches for operating the hooter are available with the driver and other occupants.

(d) Cash box security.—Each of the cash boxes shall be secured to the floor with separate chains and have locks that can be opened or locked only by using separate keys kept with different custodians and

(e) Other security features.— (i) The cash van shall be provided with a small CCTV system with at least five days recording facility and three cameras installed in front, rear and inside of the cabin.

(ii) A security alarm with GSM based auto-dialer shall be provided with a motorised siren.

(iii) The cash van shall be equipped with hooter, fire extinguishers and emergency lights to ensure quick reaction in case of an attack.

Whereas, during the investigation, five other persons namely Taufeeq Ahmad Dar S/o Nazir Ahmad Dar R/o Nowroz Baba, Khag, Danish Ahmad Dar S/o Manzoor Ahmad Dar R/o Dar Mohalla, Nowroz Baba, Khag, Showkat Ali Dar S/o Ali Mohammad Dar R/o Bathipora, Khag, Ikhlaq Gulzar Thokar S/o Gulzar Ahmad Thokar R/o Amarbugh, Shopian and Tajamul Islam Bhat S/o Gh. Mohd Bhat R/o Arwani, Bijbehara, were found involved in the case. Subsequently, the accused viz Taufeeq Ahmad Dar, Danish Ahmad Dar and Showkat Ali Dar, were arrested in the case and during the investigation, some incriminatory material were recovered at their instance. The accused viz.Ikhlaq Gulzar Thokar and Tajamul Islam Bhat, were already arrested by Kulgam Police and were detained under the provisions of J&K Public Safety Act, 1978; and

5. Whereas, during the investigation, it was found that the accused viz. Hilal Ahmad Malik, Mohd Rouf Wani, Taufeeq Ahmad Dar and Danish Ahmad Dar, were in contact with a Pakistan based terrorist of LeT banned outfit (Facebook ID Tanzeer Iqbal) through the virtual mode, who provided some posters to them and the accused printed out the posters from the Common Service Centre of accused viz Showkat Ali Dar, and pasted the same in the area. Later on, the accused viz Mohd Rouf Wani, shared the photographs of pasted posters with the Pakistani hander (Tanzeer Iqbal); and

6. Whereas,during the investigation, it was found that the accused viz Ikhlaq Gulzar Thokar and Tajamulislam Bhat, were in contact with two terrorists of LeT banned outfit namely Tanveer Ahmad Wani S/o Bashir Ahmad Wani R/o Amarbugh, Shopian and Sajad Ahmad TantaryS/o Late Mohd Maqbool Tantary R/o Sherpora, Frisal, Kulgam, and on their directions transferred an amount of Rs. 52,000/- in the account of accused viz Mohd Rouf Wani, who distributed the same among the accused viz Hilal Ahmad Malik, and 'Taufeeq Ahmad Dar, respectively, in order to promote terrorist activities in the area; and

- ii. a member of the Armed Forces or Paramilitary Forces, who is a Domicile of Jammu and Kashmir and is killed while discharging the duties in connection with law and order situation or militancy/terrorist related action or as a result of enemy action.

**Explanation:-** For the purpose of this Scheme:

a. Armed Forceø means Navy, Military, Air Forces;

b. -Domicileø means domicile as defined in Section 3A of Jammu and Kashmir Civil Services (Decentralization and Recruitment) Act, 2010.

c. Family Memberømeans spouse, son, daughter (including adopted son/daughter as permissible under law), brother or sister in case of an unmarried Government Servant who was actually dependent on the Government employee;

d. :Government employeeø means the Government employee as defined under Jammu and Kashmir, Government Employees (Conduct) Rules, 1971 and who is not working on daily wages or casual or apprentice or adhoc or contract or re-employment basis.

Provided that in case of a person who has been regularized under any law for the time being in force in the Union Territory of Jammu and

Provided further that õRe-employmentö shall not include employment of ex-serviceman before the normal age of retirement to a civil post;

e. 'Para Military Force' means a force constituted under any law for the time being in force made by the Competent Legislature;

2. In Clause 2-A, after the words "dependent family member of a Government Employee", the words "or Armed Forces or Paramilitary Forces as defined in clause 2" shall be inserted.
