Whereas, pursuant to above notification, no objection was received from anyone, however, evacuee land measuring 161 Kanals 17 Marlas is also involved in the said acquisition which matter was taken up by Divisional Comrntssioner; Jammu with Custodian Department vide No.502/Border Fencing/Gen/23/1088 dated 08-09-2023 for Issuance of NOC for acquisition of the said land; and

Whereas, Custodian General, J&K vide Order No.49 of 2023 dated 25-09-2023 issued under endorsement No.CG(EP) 1386-89/Acq dated 25-09-2023 has granted necessary "NOC" to the acquisition of the evacuee land; and

Whereas, Deputy Commissioner, Samba vide No. DCS/LAS/ACR/2023-24/468-471 dated 31-10-2023 recommended the case to Divisional Commissioner, Jammu for issuance of declaration under Sections 6 & 7 of Land Acquisition Smvt. Act 1990 for acquisition of land measuring 340 Kanals 18½ Marlas situated village Nanga, Tehsil Ramgarh being acquired for public i.e. construction of 135' vide strip composite bundh by BSF. Divisional Commissioner, Jammu vide No.502/4735/Acq/135 ft./ Nanga/Smb/23/1541 (7309103) dated 02-12-2023 endorsed the same to this department for the said purpose; and

Whereas, the report furnished by District Collector (DC), Samba vide letter referred to above, duly endorsed by Divisional Commissioner, Jammu has been examined and it has been found that no one has filed any objection to the proposed acquisition; and

Whereas, the Government is satisfied that the land particulars whereof are given in Annexure :Aøto this notification is required for public purpose i.e. construction of 135´ wide strip composite bundh by BSF.

Now, therefore, in pursuance of Section 6 of the J&K Land Acquisition Act, Samvat 1990, it is declared that the land measuring 340 Kanals 18½ Marlas situated in village Nanga, Tehsil Ramgarh, District Samba is required for public purposes i.e. construction of 135' wide

However, the Collector concerned shall be held specifically responsible for identification and proper title verification of all types of lands involved in the case for making apportionment of compensation amongst all the interested persons/ rightful claimants, in accordance with the relevant laws/ rules in force, while making the award. The Collector/indenting department shall also ensure that no compensation shall be made for the portion of land which has already been acquired for the road in question.

 - (b) In case of a bye-election or a number of bye-elections held together, the period may commence from the beginning of the hours fixed for poll on and from the first day of poll and continue till half an hour after closing of the poll:
 - Provided that in case of a number of bye-elections held together on different days, the period may commence from the beginning of the hours fixed for poll on the first day of poll and continue till half an hour after closing of the last poll.
- (3) Any person who contravenes the provisions of this section shall be punishable with imprisonment for a term which may extend to two years or with fine or with both."


