- ii. The execution of the deed should be followed by publication of the change in a prominent local newspaper at the Government employee's own expense.

- iii. The change in the name shall be made with Aadhaar authentication and complete verification of record of e-HRMS.

Whereas, the matter was examined in the department and was accordingly taken up with the Director Finance, Mining Department for his opinion regarding consideration of the request of official to change his name as Shri Rahul Khatri from Shri Rahul Kreed in his service record, who conveyed as under :

A person can change his/her name at any time in his/her lifetime. However, it needs to be done legally by creating an affidavit, publishing an advertisement in the newspaper and a notification in the Gazette of India at his own expenses. After the name change is notified in the Gazette, the person can start using the new name and apply for changing the name in all ID proof documents.

Whereas, Mr. Rahul Kreed, Junior scale Stenographer has executed the requisite affidavit/deed and notice about the correction in his name has been published in a prominent local newspaper ; and

Whereas, the official has also published notification in the official Gazette for change of his name from Mr. Rahul Kreed to Mr. Rahul Khatri on his own expenses.

SO-600.—Whereas, Section 427 of the Jammu and Kashmir
Municipal Corporation Act, 2000, provides as under:ô

ô427. Power to Remove Difficulties.ô If any difficulty arises in
giving effect to the provisions of this Act or by reasons of anything
contained in this Act to any other enactment for the time being in force,
the Government may, as occasion requires, by order direct that this Act

shall during such period as many be specified in the order but not extending beyond the expiry of two years from the commencement orders have effect subject to such adaptations whether by way of modification addition or omission as it may deem to be necessary and expedient.

Whereas, Section 5 of the Jammu and Kashmir Municipal Corporation Act, 2000 provides for the duration of the Corporation, which provides as under :

5. Duration of the Corporation. (1) The Corporation, unless sooner dissolved under Section 404 of this Act, shall continue for five years from the date appointed for its first meeting.

(2) An election to constitute the Corporation shall be completed

(a) before the expiry of its duration specified in Sub-Section (1) ;

(b) before the expiration of a period of six months from the date of its dissolution :

Provided further that where the remainder of the period for which the dissolved Corporation would have continued is less than six months, it shall not be necessary to hold any election under this section for constituting the Corporation for such period :

Provided further that the first election to a Corporation constituted after the commencement of the Act shall be held within a period of two years of its constitution.

Whereas, the respective terms of elected representatives of Municipal Corporations of Srinagar and Jammu have expired ;

Whereas, a difficulty has arisen in giving effect to the provisions of the Act for the purpose of smooth administration and providing better services to public at large.

Now therefore, in exercise of the powers conferred under Section 427 of the Jammu and Kashmir Municipal Corporation Act, 2000, the Government hereby makes the following order; namely:

1. *Short title and commencement:* (1) The order may be called the Jammu and Kashmir Municipal Corporation (Removal of Difficulties) Order, 2023.

(2) It shall be deemed to have come into force with immediate effect and shall remain in force for a period of two years or till it is revoked by the Government, whichever is earlier.

2. *Removal of Difficulties*:ô The difficulties arisen on account of expiry of the term of elected representatives of Jammu Municipal Corporation and Kashmir Municipal Corporation and in giving effect to Section 5 of the Jammu and Kashmir Municipal Corporation Act, 2000 are hereby removed by appointing Commissioner of Jammu Municipal Corporation and Srinagar Municipal Corporation as Administrators of the respective Corporations for a term of two years or until the establishment of the Corporation, whichever is earlier, and they shall exercise the functions and duties of the Corporation(s) as provided under the Act.

SO-601.— Whereas, on 09-06-2023, the Police Station, Poonch, received a docket to the effect that a Joint Search Operation was carried out by the Police/Security Forces in Village Kalsan, and during the search, two suspects while seeing the Police/Security Forces tried to

escape but were chased down on the spot and identified as Mohd Safer S/o Mohd Hussain and Mohd Rashid S/o Bader Din R/o Ward No. 03, Kalsan Dara, Bagyal, Tehsil Haveli, Poonch. During search, the Police recovered 02 Chinese Hand Grenades at their instances ; and

2. Whereas, based on the above, a case FIR No. 77/2023 under Section 4/5 ESA and Sections 13 and 18 of ULA (P) Act, was registered in the Police Station, Poonch, and the investigation of the case was set into motion. Subsequently, during the investigation, the offences under Sections 8(a)/21, 22, 29 NDPS Act, and offences under Sections 17, 20, 23, 38 and 39 of ULA (P) Act were added in the case ; and

3. Whereas, during the course of investigation, the site plan of the place of occurrence and the seizure memos were prepared and the statements of the witnesses acquainted with the facts and circumstances of the case were recorded under the relevant provisions of law ; and

4. Whereas, during the investigation, the accused viz. Mohd Safer, Mohd Rashid and one Mohd Yaseen S/o Saif Din R/o Degwar, Terwan, Tehsil Haveli, District Poonch, were found in contact with a terrorist of HM, a banned outfit, namely Mohd Bashir S/o Mohd Hussain R/o Ward No. 03, Kalsan Dara, Bagyal, Haveli, Poonch A/P PoK. The accused viz. Mohd Yaseen, was already arrested by Poonch police in case FIR No. 42/2023 of Police Station, Sunderbani. Subsequently, his custody was changed in the instant case ; and

5. Whereas, during the investigation, it was found that the accused viz. Mohd Safer and Mohd Rashid, procured 02 Hand Grenades and 02 Packets of Heroine like substances from the accused terrorist viz. Mohd Bashir, with the directions to hand over the same to the accused viz. Mohd Yaseen, who already had provided an amount of Rs. 07 lakhs to them for the consignment. Subsequently, during the investigation, an amount of Rs. 07 lakhs and 02 Packets of Heroine like substance were also recovered at the instance of accused viz. Mohd Safer and Mohd Rashid, respectively; and

6. Whereas, during the investigation, it was established that the accused viz. Mohd Safer, Mohd Rashid and Mohd Yaseen, were working as Over Ground Workers (OGWs) for the terrorists of HM, a

banned outfit, particularly the terrorist viz. Mohd Bashir, and under a well knit criminal conspiracy were providing logistic support to him, besides the accused viz. Mohd Safeer and Mohd Rashid, procured explosive material and Heroine (Contraband) from the said terrorist and an amount of Rs. 07 lakhs from the accused viz. Mohd Yaseen, for carrying out the terrorist activities in the area ; and

7. Whereas, on the basis of the investigation, the statements of witnesses recorded and other evidence collected, the Investigating Officer, has established a *prima facie* involvement of the below mentioned accused for the commission of offences punishable under Sections of the Unlawful Activities (Prevention) Act, 1967, as shown against their names :

7. Whereas, the accused viz. Mohd Bashir, is absconding and the proceedings under Section 299 Cr.PC have been proposed to be initiated against him ; and

9. Whereas, the Authority, appointed by the Government under Sub-Section (2) of Section 45 of the Unlawful Activities (Prevention) Act, 1967, has independently examined the Case Diary File and all the other relevant documents relating to the case and has come to the conclusion that a *prima facie* case is made out against the above accused ; and

10. Whereas, after perusing the Case Dairy File, the relevant documents and also taking into consideration the views of the Authority appointed under Sub-Section (2) of Section 45 of the Unlawful Activities (Prevention) Act, 1967, the Government is of the view that there is sufficient material and evidence available against the above mentioned accused for their prosecution under the provisions of law.

Now, therefore, in exercise of the powers conferred by Sub-Section (2) of Section 45 of the Unlawful Activities (Prevention) Act, 1967, the Government hereby accord sanction for launching prosecution against the accused viz, Mohd Safeer, Mohd Rashid, Mohd Yaseen, and Mohd Bashir, for the commission of offences punishable under the relevant Sections of ULA (P) Act, as indicated against the accused at Para (7) above, arising out of FIR No. 77/2023 of Police Station, Poonch.

SO-602.—Whereas, the use of Aadhaar as an identity document for delivery of services or benefits or subsidies simplifies the Government delivery processes, brings in transparency and efficiency,

and enables beneficiaries to get their entitlements directly in a convenient and seamless manner by obviating the need of produce multiple documents to prove one's identity ;

And Whereas, the the Department of Food, Civil Supplies and Consumer Affairs is administering the Prime Minister's Food Supplementation for Priority Households Scheme in addition to NFSA and NPHH to provide foodgrains at affordable and subsidized rates to PHH Rationees/Beneficiaries, which is being implemented through the Department of Food, Civil Supplies and Consumer Affairs, Jammu/Kashmir and under the scheme, Rice @ Rs. 25/- Per Kg is given to the PHH, by the respective Directorates of Food, Civil Supplies and Consumer Affairs as per the extant Scheme guidelines ;

And Whereas, the aforesaid Scheme involves recurring expenditure incurred from the Consolidated Fund of Union Territory of Jammu and Kashmir.

Now, therefore, in pursuance of Section 7 of the Aadhaar (Targeted Delivery of Financial and Other Subsidies, Benefits and Services) Act, 2016 (18 of 2016) (herein referred to as the said Act), the Government of Union Territory of Jammu and Kashmir hereby notifies the following, namely :ô

1. (1) An individual eligible for receiving the benefit under the Schemes shall hereby be required to furnish proof of possession of the Aadhaar number or undergo Aadhaar authentication.
- (2) Any individual desirous of availing benefits under the Schemes, who does not possess the Aadhaar number or, has not yet enrolled for Aadhaar shall be required to make application for Aadhaar enrollment before registering for the schemes provided that he/she is entitled to obtain Aadhaar as per Section 3 of the said Act and such individuals shall visit any Aadhaar Enrollment Centre (list available at the Unique Identification Authority of India (UIDIA) website www.uidia.gov.in) to get enrolled for Aadhaar.
- (3) As per Regulation 12 of the Aadhaar (Enrollment and Update) Regulations, 2016, the department through its

Implementing Agency is required to offer Aadhaar enrollment facilities for the beneficiaries who are not yet enrolled for Aadhaar and in case there is no Aadhaar enrollment center located in the respective Block or Tehsil, the department through its Implementing Agency shall provide Aadhaar enrollment facilities at convenient locations in coordination with the existing Registrars of UIDAI or by becoming a UIDAI Registrar themselves :

Provided that till the time Aadhaar is assigned to the individual, benefits under the Scheme shall be given to such individual, subject to the production of the following documents, namely :

- (a) if he has enrolled, his Aadhaar Enrollment Identification slip ; and
- (b) any one of the following documents, namely :
 - (i) Bank or Post Office Passbook with photo ; or
 - (ii) Permanent Account Number (PAN) Card ; or
 - (iii) Passport ; or
 - (iv) Ration Card ; or
 - (v) Voter Identity Card ; or
 - (vi) MGNREGA Card ; or
 - (vii) Kissan Photo Passbook ; or
 - (viii) Driving license issued by the Licensing Authority under the Motor Vehicles Act, 1988 (59 of 1988) ; or
 - (ix) Certificate of identity having photo of such person issued by a Gazetted Officer or a Tehsildar on an official letter head ; or
 - (x) Any other document as specified by the department :

Provided further that the above documents may be checked by an officer specifically designated by the Directorate of Food, Civil Supplies and Consumer Affairs, Jammu/Kashmir for that purpose.

(2) In order to provide benefits to the beneficiaries under the scheme conveniently, the Directorate of Food, Civil Supplies and Consumer Affairs, Jammu/Kashmir shall make all the required arrangements to ensure that wide publicity through the media shall be given to the beneficiaries to make them aware of the said requirement.

(3) In all cases, where Aadhaar authentication fails due to poor biometrics of the beneficiaries or due to any other reason, the following remedial mechanisms shall be adopted, namely :

- (a) In case of poor fingerprint quality, Iris scan or face authentication facility shall be adopted for authentication, thereby the respective Directorate of Food, Civil Supplies and Consumer Affairs, Jammu/Kashmir shall make provisions for Iris scanners or face authentication along with fingerprint authentication for delivery of benefits in seamless manner ;
- (b) In case the biometric authentication through fingerprints or Iris scan or face authentication is not successful, wherever feasible and admissible authentication by Aadhaar One Time Password or Time Based One Time Password with limited time validity, as the case may be, shall be offered ;
- (c) In all other cases where biometric or Aadhaar One Time Password or Time Based One Time Password authentication is not possible, benefits under the Scheme may be given on the basis of physical Aadhaar letter whose authenticity can be verified through the Quick Response (QR) code printed on the Aadhaar letter and the necessary arrangement of QR code reader shall be provided at the convenient locations by the department through its Implementing Agency.

(4) In addition to the above, in order to ensure that no *bona fide* beneficiary under the Scheme is deprived of his due benefits, the respective Directorate of Food, Civil Supplies and Consumer Affairs, Jammu/Kashmir through its Implementing Agency shall follow the exception handling mechanism put in place by Department of Food, Civil Supplies and Consumer Affairs by way of nominee facility vide Government Order No. 61-JK(FCS&CA) of 2021 dated 04-08-2021 or as outlined in the office memorandum of DBT Mission, Cabinet Secretariat Government of India dated 19th December, 2017.

3. Whereas, during the course of investigation, the site plan of the
place of occurrence and the seizure memos were prepared and the
statements of witnesses acquanited with the facts and circumstances
of the case were recorded under the relevant provisions of law ; and

4. Whereas, during the investigation, it was found that the accused
viz. Mohammad Seediq Lone, was in contact with two terrorists of LeT,
a banned outfit, namely Adil Rehman Dantoo S/o Abdual Rehma Dantoo
R/o Arampora, Gulabad, Sopore and Usman Bhai, who provided the
recovered arms/ammunition to him in order to promote terrorist
activities in the area ; and

5. Whereas, the investigation, in respect of terrorists viz. Adil
Rehamn Dantoo and Usman Bhai, shall continue to bring out their role/
involvement in the case and the supplementary chargesheet against
them would be filed in the court of competent jurisdiction ; and

6. Whereas, during the investigation, it was established that the
accused viz. Mohammad Seediq Lone, was working as Over Ground
Workers (OGWs) for the terrorists of LeT, a banned outfit, and was
providing logistic support to them, besides under a well knit criminal
conspiracy procured arms/ammunition from the terrorists for carrying
out the terrorist activitie in the area ; and

7. Whereas, on the basis of the investigation, the statements of
witnesses recorded and other evidence collected, the Investigating
Officer, has established *prima facie* involvement of the below
mentioned accused for the commission of offences punishable under

Now, therefore, in exercise of the powers conferred by Sub-Section (2) of Section 45 the Unlawful Activities (Prevention) Act, 1967, the Government hereby accord sanction for launching prosecution against the accused viz. Mohammad Seediq Lone, for the commission of offences punishable unde Section 18, 23 and 39 of ULA(P) Act, arising out of FIR No. 78/2023 of Police Station, Kreeri.
