- ii) The Poll days indicated above shall be observed as paid holiday to every person employed in any business, trade, industrial undertaking or any other establishment and entitled to vote in his/her respective Assembly Constituencies.
- iii) No deduction or abatement of the wages of any such person shall be made on account of a holiday having been granted in accordance with Sub-Section (1) and if such person is employed on the basis that she/he would not ordinarily receive wages for such a day, she/he shall nonetheless be paid for such day the wages she/he would have drawn had not a holiday been granted to him/her on that day.
- iv) If an employer contravenes the provisions of Sub-Section (1) or Sub-Section (2), then such employer shall be punishable with fine, which may extend to five hundred rupees. This section shall not apply to any elector whose absence may cause danger or substantial loss in respect of the employment in which he is engaged.
- v) Daily wage/casual workers shall also be entitled for a holiday and wages on the day of poll.

It is further ordered that the above paid holiday(s) shall also be observed in terms of explanation to Section 25 of the Negotiable Instruments Act, 1881.

1. Name:

These Rules and Regulations may be called the Rules and Regulations of the Mubarak Mandi Jammu Heritage Society.

2. Area of Operation:

The Headquarters of the Society shall be at Mubarak Mandl Heritage Complex, Royal Dogra Palaces, Panjtirthi, Jammu, J&K.

3. Objectives:

The objectives for which the Society is formed are :ô

- I. Restoration/Conservation/Adaptive Re-use and Maintenance of Royal Dogra Palaces at Mubarak Mandi.
- II. To develop Mubarak Mandi Palace Complex as a centre of excellence, rejuvenating the 'Voice of the city and its People' of Jammu and Kashmir with its architectural grandeur resonating in building memories, associations and connections as a dynamic new medium of cultural and social exchange in Jammu city, so as to bring it on international heritage tourism map.

4. Authorities of Society:

The following shall be the authorities of the Society :ô

RULES AND REGULATIONS OF

MUBARAK MANDI JAMMU HERITAGE SOCIETY

1. Title:

These Rules and Regulations may be called the Rules and Regulations of the Mubarak Mandi Jammu Heritage Society.

2. Definitions:

In these rules and regulations, also known as the ::Rules of the Society, the following words and expressions shall have the following meaning unless repugnant to the subject or context:ô

- i. ::Act@means the Societies Registration Act, 1860;
- ii. ::Society@means the Mubarak Mandi Jammu Heritage Society;
- iii. ::Governing Body@means Governing Body of the Society;
- iv. Executive Bodyømeans Executive Body of the Society;
- v. ::Official member@means the person who by virtue of his official position becomes the member of the society;
- vi. ::Non-official member@means the person who becomes the member of the society being domain expert or any other person interested to promote the aims and objectives of the Society and whose expertise/suggestions are required by the Society for the preservation and maintenance of the Mubarak Mandi Heritage Complex;
- vii. ::Government@means the Government of Jammu and Kashmir;
- viii. :: Chairman@means Chairman of the Governing Body;
- ix. :: Member-Secretary one means the Executive Director of the Society;
- x. Words and expressions used in these rules and not defined here in but defined in the Act shall have the same meaning as assigned to them in the Act.

3. Governing Body:

The Governing Body shall consist of the following members, namely:ô

- 1. Honøble Lieutenant Governor, J&K Chairman
- 2. Honøble Advisor/Hon'ble Minister concerned, J&K Member

4. Functions and Powers of the Governing Body:

- i. The Governing Body shall be policy making authority for the MMJHS.
- ii. To frame regulations, by-laws and rules of procedure of the Society.
- iii. To constitute committees/sub-committees for specific purpose for advising/assisting the Governing Body/Society.
- iv. To delegate any of its powers to the Executive Body/Executive Director.
- v. It may in its absolute discretion apportion or allot, from time to time, available funds for anyone or more objects of the Society or deny allotment of such funds for anyone or more objects of the Society.
- vi. Subject to the provisions of these rules to do all other such acts as may be required for the maintenance of the organization and the performance of functions of Society.
- vii. A non-official member of the Governing Body shall have the term for a period of 02 years, if not otherwise disqualified by any of the rules of the society or any other law for the time being in force.
- viii. The Governing Body shall meet at least once in the year to transact business.

- ix. **Quorum** for the meeting of the Governing Body shall be not less than 50% of the total members of Governing Body.
- x. The Chairman shall preside over all the meetings of the Governing Body but in the absence of the Chairman, any other member nominated by the Chairman shall act as Chairman.
- xi. All matters before the Society in such meetings shall be decided generally by a consensus of opinion and if necessary, by a majority of votes. In case of a tie, the decision of the Chairman shall be binding upon the Society.

5. Executive Body:

The Executive Body shall consist of the following members, namely :ô

1.	Chief Secretary, J&K	Chairman
2.	Administrative Secretary, Culture	Member
3.	Divisional Commissioner, Jammu	Member
4.	Municipal Commissioner, Jammu	Member
5.	Executive Director, MMJHS	Member- Secretary
6.	Director, Archives, Archaeology and Museum	Member
7.	Director, Tourism, Jammu	Member
8.	Director, Finance, Department of Culture	Member
9.	Chief Engineer, PW(R&B), Jammu	Member

6. Functions and Powers of the Executive Body:

- i. The Executive Body of the Society shall be responsible for effective functioning and monitoring of execution of the renovation/conservation works and other related issues of the Society.
- ii. The Executive Body shall exercise such of the administrative and financial powers on behalf of the Governing Body as may be assigned to it by the later.
- iii. To consider and approve programs of the Society.
- iv. To hire such experts/professionals as it may consider necessary for carrying out the work of Society.

- - v. The Executive Body shall be empowered to constitute sub-committees for any purpose as it deems fit.
 - vi. To accept financial assistance under CSR/incentives from local bodies, individual firms, companies, corporation, organizations and other concerns etc., in furtherance to the objects of Society.
 - vii. To institute various fees, prizes and awards etc.
 - viii. The Executive Body shall meet at least once in a Quarter (3 Months).
 - ix. The quorum for the meeting shall be a simple majority of its total members.
 - x. In the absence of the Chairman, the senior most member shall preside over the meeting.

7. Executive Director (Member Secretary):

Executive Director will be the administrative head of the office of the Mubarak Mandi Jammu Heritage Society and shall be appointed by the government from the IAS Cadre/ JKAS Cadre, as the case may be, on deputation basis. The service condition and the tenure of the appointment of the Executive Director shall be governed as per government rules.

8. Powers and Functions of Executive Director:

The Executive Director shall have the following powers and functions namely :ô

- To exercise all the powers, administrative and financial, for the Society as are vested to the Major Head of the Department of the Jammu & Kashmir Government.
- ii. To be the Custodian of the records and all the properties of the society.
- iii. To conduct the official correspondence on behalf of the Society.
- iv. To issue all notices convening meetings of the bodies of the Society and of all committees or sub-committees.
- v. To keep the minutes of all the meetings of the Society.
- vi. To monitor the accounts of the Society to be operated upon by the Accounts Officer of the Society.

- - vii. To exercise such other powers as may be assigned to him by the authorities of the Society.
 - viii. To carry out the works and assignments given by the Governing Body/Executive Body from time to time.

9. Finances and its investments:

- 1. All the activities of the society shall be carried out of :ô
 - Funds provided by the Central Government and the State/UT Government.
 - ii. Grants received from the local bodies and other institutions, concerns etc.
 - iii. Money received by way of grants, donations or other contributions from members, individual firms, companies, corporations, organizations etc.
 - iv. All fees and other charges, if any, received by the Society from its activities and return on investments of its funds.
 - v. These funds shall be operated upon by designated Drawing and Disbursing Officer with the approval of the Executive Director. The capital budget for conservation and restoration of Mubarak Mandi Heritage Complex, shall be placed at the disposal of Executing Agency through BEAMS, who shall be authorized to operate upon these funds.
 - vi. The Society shall not be profit-making in character. All incomes and property of the society shall be applied solely for the promotion of its aims and objectives and no portion, thereof, shall be paid or transferred directly or indirectly by way of dividend, bonus or otherwise by way of profit to the present or past members of the society or to any person claiming through any one or more of the present or past members. No member of the Society shall have any personal claim on any movable or immovable property of the Society or make any profit whatsoever by virtue of his membership.
- 2. Revenues received shall be deposited or invested directly in the name of the Society in the concerned government treasury/bank, as per rules.

10. Accounts and Audit:

The income and expenditure statement, balance amount as on the last day of each financial year shall be worked out. These accounts shall be got audited by the Independent Statutory Auditor. The audited and certified accounts shall be submitted to the Government.

11. Miscellaneous:

- i. All the provisions of Societies Registration Act, 1860 shall be applicable to the Society.
- ii. Staff of the Society shall be posted on deputation in the Society from Government of Jammu and Kashmir. However, Executive Body is empowered to hire experts/professionals as per the requirement of Society in terms of the Rule 8(4).

12. Savings:

- i. All the assets and liabilities of Mubarak Mandi Jammu Heritage Society already established by the Government vide Order No. 561-GAD of 2008 dated 23-04-2008 shall be deemed to be the assets and liabilities of the Society established under these rules.
- ii. The Society shall be deemed to have been entrusted with the functions of the Society as provided vide Order No. 561-GAD of 2008 dated 23-04-2008, issued by the General Administration Department, Government of J&K with effect from the date it is registered under the Societies Registration Act, 1860.
- iii. All actions taken till the notification of these rules shall be saved and deemed to have been taken under these rules.

13. Legal proceedings:

The Society may sue or be sued in the name of its Chairman.

14. Amendment of these rules:

Any rule of these rules shall be amended after seeking the recommendations of the Governing Body and its approval by 2/3rd majority of the members of the Governing Body present at the meeting convened for the purpose.

15. Dissolution of the Society:

If at any point of time, an occasion arises for the dissolution of the Society, the provisions of the Societies Registration Act, 1860 shall

GOVERNMENT OF JAMMU AND KASHMIR CIVIL SECRETARIAT—HOME DEPARTMENT, JAMMU/SRINAGAR.

Notification

- **SO**—**500.**—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Lieutenant Governor, Union Territory of Jammu and Kashmir, hereby makes the following rules, namely:-
- **1. Short title and commencement.-** (1) These rules may be called Jammu and Kashmir Police (Gazetted) Service Recruitment Rules, 2024.
- (2) These rules shall come into force from the date of their publication in the Government Gazette.
- Definitions.- (1) In these rules, unless the context otherwise requires:

 "Administrative Department" means the Home Department of the Government in the Civil Secretariat holding the administrative charge of the Service;

- b. "Cadre" means the cadre of the Service;
- c. "Commission" means the Jammu and Kashmir Public Service Commission;
- d. "Government" means the Government of Jammu and Kashmir;
- e. "Member of the Service" means a person appointed to a post in the Service under the provisions of these rules or the rules superseded by these rules;
- f. "Post" means a permanent post carrying a definite time scale of pay sanctioned by the Competent Authority;
- g. "Rules" means the Jammu and Kashmir Police (Gazetted) Service Recruitment Rules, 2024;
- h. "Schedule" means the schedule(s) annexed to these rules;
- i. "Selection Committee" means the Selection Committees constituted under rule 6(4) of these rules;
- j. "Service" means the Jammu and Kashmir Police (Gazetted) Service;
- k. "Union Territory" means Union Territory of Jammu and Kashmir.
- (2) Words and expressions used in these rules but not defined shall have the same meaning as are assigned to them in the Jammu and Kashmir Civil Services (Classification, Control and Appeal) Rules, 1956 or the Jammu and Kashmir Civil Services Regulations, 1956;
- **3.** Constitution of Service. The service shall comprise the persons recruited from time to time in accordance with the provisions of the Jammu and Kashmir Police (Gazetted) Service Recruitment Rules, 2002, and holding such posts on substantive basis on the commencement of these rules, and such other persons as may be recruited to the service from time to time in accordance with the provisions of these rules.
- **4. Strength of the Service.** (1) The authorized permanent and temporary strength of the cadre and the nature of the posts included therein shall be determined by the Government, from time to time and shall, at the constitution of the service under these rules, be such as specified in the **Schedule-I**:

Provided that the Government may create temporary post in the cadre of the Service for specified period as may be considered necessary from time to time.

(2) The Government shall, after the interval of every five years or at such other intervals, as may be necessary, re-examine the strength and composition of cadre of the Service and make such alterations therein as it deems fit.

- (3) The cadre strength of the Service of the erstwhile State of Jammu and Kashmir, bifurcated in terms of SRO 935 and SRO 937 dated 28.10.2019, between the Union Territory of Jammu & Kashmir and Union Territory of Ladakh, after enforcement of the Jammu and Kashmir Reorganization Act, 2019, shall remain Joint Service/Cadre, in terms of SO 428 dated 21.12.2021, issued by the General Administration Department, till the decision regarding separate cadre for the Service in the Union Territory of Ladakh, is taken by the Competent Authority.
- **5.** Cadre of the service.- (1) The service shall comprise the following cadres:-
 - A. General
 - B. Telecommunication
 - C. Ministerial
 - D. Stenography
 - E. Photography
 - F. Police Transport Workshop
 - G. Arms/Ammunition
- **6. Qualification and method of Recruitment.-** (1) No person shall be eligible for appointment or promotion to any post in any class, category or grade in the Service unless he/she possesses the qualification as laid down in Schedule-II and fulfill other per-requisites of recruitment as provided in these rules and orders for the time being in force.
- (2) Appointment to the Service shall be made.-
 - (a) by direct recruitment; or
 - (b) by promotion; or
 - (c) partly by (a) and partly by (b), in the ratio and in the manner, as mentioned against each post in **Schedule-II**:

Provided that all the posts under direct recruitment shall be filled through Commission as per the rules/orders of the Government issued for the purpose.

Provided further, that all posts to be filled by promotion shall be filled up through Departmental Promotion Committee (DPC) of Commission / Selection Committee(s) of the Department.

The Department shall refer vacancies in the direct/promotion quota to Commission and Departmental Promotion Committee, as the case may be in terms of SRO 166 of 2005 dated 14.06.2005.

- **(3) Promotion through Commission.** The appointment by promotion in respect of the following posts shall be made on the recommendation of the Commission:
 - a. Junior Scale (Deputy Superintendent of Police) and Time Scale (Superintendent of Police) of the General Cadre.
 - b. Deputy Superintendent of Police and equivalent levels in Telecommunication, Ministerial, Stenography, Photography, Police Transport Workshop and Arms/Ammunition Cadres.
 - c. Superintendent of Police and equivalent levels in Telecommunication, Ministerial and Stenography Cadres.
- **(4)** Constitution of the Committees.- (1) The Administrative Department shall, by an order, constitute the following Selection Committees:-

Selection Committee-I

The Selection Committee-I shall be headed by the Chief Secretary and shall include Administrative Secretary, Home Department, Director General of Police, J&K as Members and Special Secretary/Additional Secretary, Home Department dealing with the Police Gazetted Service as Member-Secretary.

The Selection Committee-I shall consider the following cases and make recommendations:-

- a. Placement of eligible officers of the General Cadre in the Selection Grade-I and II of Superintendent of Police, Super Time Scale-(i) [Level 13A (131100-216600) of the Pay Matrix] and Super Time Scale-(ii) [Level 14 (144200-218200) of the Pay Matrix], or equivalent posts;
- b. Placement of eligible officers of Telecommunication, Ministerial and Stenography cadres in the Selection Grade (Non-functional) of Superintendent of Police [Level 12 (78800-209200) of the Pay Matrix];
- c. Promotion of eligible officers of Telecommunication as Director Police Telecommunication [Level 13A (131100-216600) of the Pay Matrix]; and

The Selection Committee-II shall be headed by the Administrative Secretary, Home Department and shall include Director General of Police, J&K, seniormost Additional Director General of Police, as Members and Special Secretary/Additional Secretary, Home Department dealing with the Police Gazetted Service as Member-Secretary.

The Selection Committee-II shall consider the following cases and make recommendations:-

- a. Placement of the eligible officers of the General Cadre in the Selection Grade (Non-functional) of Junior Scale [Level 10A (56600-179800) of the Pay Matrix];
- b. Placement of the eligible officers of Telecommunication, Ministerial, Stenography and Police Transport Workshop cadres in the Selection Grade (Non-functional) of Deputy Superintendent of Police [Level 10A (56600-179800) of the Pay Matrix].
- 7. **Probation.-** Persons appointed to the service through direct recruitment, shall be on probation for two years and shall be regulated in terms of provisions of the Jammu and Kashmir Civil Services (Classification, Control and Appeal) Rules, 1956 / the Jammu and Kashmir Civil Services Regulations, 1956.
- **8. Reservation in appointment.-** While making appointments either by direct recruitment or by promotion, reservation shall be provided to the eligible categories in accordance with the provisions of Jammu and Kashmir Reservation Act, 2004 and the rules and orders, as in force.
- **9.** Training and Departmental Examination.- Persons appointed to the service by direct recruitment shall be required to undergo such training from time to time during the course of probation and to pass during the period of probation such departmental examination(s) as the Government may prescribe:

Provided that the Government may exempt either wholly or partly, from such training or departmental examination, persons who have passed a departmental examination or undergone training declared by the Government to be equivalent to a departmental examination or training, prescribed under these rules.

- **10. Maintenance of seniority lists.-** Seniority of the members of the service shall be regulated under the Jammu and Kashmir Civil Services (Classification, Control and Appeal) Rules, 1956. The Administrative Department shall maintain an up-to-date final seniority list of all the members of the service.
- 11. Power to relax.- Where the Government is of the opinion that it is necessary or expedient so to do, it may by an order, for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class, category of persons or post:

Provided that while exercising the discretion, the Government shall keep in view that the discretion is exercised *bonafide* and the Commission concurs with the relaxation.

- 12. Residuary matters.- In regard to matters not specifically covered by these rules, the members of the service shall be governed by the rules, regulations and orders applicable to the Civil Service of the Union Territory in general.
- **13. Interpretation.-** If any question arises relating to the interpretation of these rules, the decision of the Administrative Department, shall be final and binding.
- **14. Repeal and Savings.-** (1) The Jammu and Kashmir Police (Gazetted) Service Recruitment Rules, 2002, are hereby repealed.
- (2) Notwithstanding such repeal, any appointment or order made or action taken under the rules so repealed shall be deemed to have been made or taken under these rules.
