- 3. Whereas, during the course of investigation, the site plan of place of occurrence and the seizure memos were prepared and the statements of the witnesses acquainted with the facts and circumstances of the case were recorded under the relevant provisions of law; and

Mohd Hussain Khateeb, Tariq Ahmad Malla and Farooq Ahmad Naikoo, for carrying out terrorist activities in the Jammu area; and
- 6. Whereas, during the investigation, nine other persons identified as Fayaz Ahmad Bhat S/o Ali Mohd Bhat R/o Bopat, Beerwah, Kifayat Rizvi S/o Sadiq Rizvi R/o Shariefabad, HMT, Srinagar A/P Pakistan, Mubashir Mushtaq Fafoo S/o Late Mushtaq Ahmad Fafoo

R/o Khawaja-Bagh A/p Kralhar near Railway Station, Baramulla, Mohd Rafiq Najar S/o Jamaldin Najar R/o Nambla, Uri, Baramulla, Aijaz Ahmad Sayam S/o Gh. Mohideen R/o Khodi, Surigam, Lolab, Kupwara, Farooq Ahmad Naikoo S/o Gh Hassan Naikoo R/o Khawajasahib, Old Town, Baramulla, Tariq Ahmad Malla @ Tariq Murtaza S/o Abdul Khaliq Malla R/o Bundzow, Pulwama, Syed Ashiq Elahi S/o Syed Mohammad Shafi Elahi R/o Surasyar, Chadoora, Budgam and Mohammad Arshad S/o Mohammad Asgar R/o Madina Basti, Malerkotla, Punjab, were found involved in the commission of crime; and

Mubashir Mushtaq Fafoo, Mohd Rafiq Najar and Aijaz Ahmad Sayam, under the instructions of HM terrorist namely Tariq Ahmad Malla @ Tariq Murtuza of Pulwama based in Pakistan, in order to promote terrorist activities in the J&K, besides, the accused viz. Mohammad Arshad, procured and provided, a Dubai based SIM Card to the accused viz. Farooq Ahmad Naikoo, for communication with the accused; and
- 9. Whereas, the sanction for launching prosecution against the accused viz. Mohd Shareef Shah, Jatinder Singh @ Babu Singh, Mohd Hussain Khateeb, Fayaz Ahmad Bhat, Kifayat Rizvi, Mubashir Mushtaq Fafoo, Mohd Rafiq Najar, Aijaz Ahmad Sayam, Tariq Ahmad Malla

- @ Tariq Murtuza, Farooq Ahmad Naikoo, Syed Ashiq Elahi and Mohammad Arshad, stands already accorded vide S.O No. 454 dated 22-09-2022, S.O No. 645 dated 01-12-2022, S.O No. 694 dated 16-12-2022 and S.O No. 75 dated 16-02-2023, respectively and the investigation in respect of some other accused was continued to ascertain their actual identity and to bring out their role/involvement in the case; and
- 10. Whereas, during the further investigation, three other persons identified as Mohd Sharief Chechi S/o Ghulam Mohd Chechi R/o Hathlanga, Uri, Baramulla, Farooq Ahmad Jungal S/o Noor Wali R/o Nambla, Uri, Baramulla and Saif Din S/o Qasim Din R/o Jullo, Gandoh, Doda A/P Javid Nagar, Nikki Tawi, Jammu, were found involved in the commission of crime. Subsequently, the accused were arrested in the case and during the investigation, an amount of Rs. 2.30 lacs were seized at the instance of accused viz. Mohd Sharief Chechi; and
- 11. Whereas, during the investigation, it was found that the accused viz. Mohd Sharief Chechi, procured 10 kgs of narcotics (Heroin) from across the LoC from three terrorists of HM, a banned outfit, namely Hamidullah Khuroo S/o Ghulam Rasool Khuroo R/o Jalalabad, Sopore A/P PoK/PaK, Farooq Ahmad Shawl S/o Late Haji Noor Din Shawl R/o Jaded, Baramulla A/P PoK/PaK and Javid Ahmad Chalkoo S/o Ali Joo R/o Hathlanga, Uri A/P PoK/PaK, on the directions of accused viz. Mohd Rafiq Najar, and handed over the consignment to him, who later on handed over 08 kgs of narcotics (Heroin) to the accused viz. Farooq Ahmad Jungal, with the directions to sell the same; and

- 3. Whereas, during the course of investigation, the seizure memos were prepared and the statements of the witnesses acquainted with the facts and circumstances of the case were recorded under the relevant provisions of law; and
- 4. Whereas, during the investigation, the accused viz. Sarjan Ahmad Wagay @ Sarjan Barkati, was arrested in the case and it was found that the accused was inciting, facilitating, aiding, advising and promoting terrorist, successionist ideologies and activities in impressionable minds and provoked youth to join the terrorist cadres; and

transferred the said fund in the accounts of her family members namely, Sugra Jan, Uzma Jan, Gazala Jan, Jan Mohammad and one person Mehraj-un-Din Naie, besides, on the directions of accused terrorist viz. Abdul Hamid Lone @ Hamid Mawar, purchased a land measuring 5 kanals and 10 marlas for establishing an institute in order to impart and promote ideology of secessionism, among the youth in the area. Advertisement rates through Hoardings.

The Committee has decided that the rate of advertisement may be fixed as Rs. 5 per sq.ft., Rs. 3 per sq.ft. (for flexes/banners)per day for prime locations and Rs. 3 per sq. ft., Rs. 1 per sq.ft. (for flexes/banners) per day for non-prime locations within the Town.

Proposal for enhancement of fee with regard to Pilgrimage.

The Committee has decided that the rent from ground and fields i.e. permission for holding religious events may be fixed as Rs. 1000 per day for Municipal Councils and Rs. 700 per day for Municipal Committees.

However, for holding events other than religious the rate may be Rs. 2000 per day for Municipal Councils and Rs. 1400 per day for Municipal Committees.

Proposal for revision of fee for permission to install Crackers.

The Committee has decided that the application fee for permission to install cracker stall may be fixed as Rs.300 per day stall Municipal Councils and Rs. 200 per stall for Municipal Committees.

However, the cracker fee may be fixed as Rs. 1500 per day for Municipal Councils and Rs. 700 per day for Municipal Committees. There may be an annual increase of 5% in the above rates after year of notification.
