down on the spot and identified as Mohammad Zameer Khanday S/o Azeem Khanday and Mohammad Naseem Khanday S/o Abdul Majeed Khanday residents of Madiyan, Kamalkote. During the search, the Police recovered 03 Hand Grenades and cash to the tune of Rs. 2,50,000/- Indian Currency, from the bags carrying by the accused respectively; and

- 2. Whereas, based on the above, a case FIR No. 144/2023 under Sections 120-B IPC, 7/25 Arms Act, 3/5 ESA and Sections 13, 17, 18, 20, 23, 38 and 39 of ULA (P) Act, was registered in the Police Station, Uri, and the investigation of the case was set into motion. Subsequently, during the investigation, the offence under Section 3/4 ESA was dropped from the case; and
- 3. Whereas, during the investigation, the site plan of the place of occurrence and the seizure memos were prepared and the statements of the witnesses acquainted with the facts and circumstances of the case were recorded under the relevant provisions of law; and
- 4. Whereas, during the investigation, one more person identified as Mohammad Manzoor Bhatti S/o Karam Din Bhatti R/o Madiyan, Kamalkote, was found involved in the case. Subsequently, the accused was also arrested and during the investigation, 01 Hand Grenade and cash to the tune of Rs. 2,17,000/- Indian currency was recovered at his instance; and
- 5. Whereas, during the investigation, it was found that the accused viz. Mohammad Manzoor Bhatti, was in contact with his brother namely, Mohammad Din Bhatti S/o Karam Din Bhatti R/o Madiyan, Kamalkote, A/P PoK, through social media, who crossed the LoC in the year 1990 and is presently operating from PoK with the terrorist organization of LeT/TRF, banned outfit; and
- 6. Whereas, during the investigation, it was found that the accused viz. Mohammad Din Bhatti, send 04 Hand Grenades and cash to the tune of Rs. 4,67,000/- Indian currency, to his brother viz. Mohammad Manzoor Bhatti, through an unknown person, for promotion of terrorist activities in the area. The accused viz. Mohammad Manzoor Bhatti, handed over 03 Hand Grenades and cash to the tune of Rs. 2,50,000/- to the accused viz. Mohammad Zameer Khanday and Mohammad Naseem Khanday, for carrying out the terrorist activities; and

- 7. Whereas, during the investigation, it was established that the accused viz. Mohammad Zameer Khanday, Mohammad Naseem Khanday nd Mohammad Manzoor Bhatti, were working as Over Ground Workers (OGWs) for the terrorists of Let/TRF, banned outfit, particularly the Pakistani based terrorist viz. Mohammad Din Bhatti, and were providing logistic support to him, besides, under a well knit criminal conspiracy procured Hand Grenades and cash from the said terrorist through an unknown person for carrying out the terrorist activities in the area; and
- 8. Whereas, the investigation in respect of unknown person who handed over the Hand Grenades and cash to the accused viz. Mohammad Manzoor bhatti, shall continue to ascertain his identity and to bring out his role/involvement in the case and supplementary charge sheet against him would be filed in the Court of competent jurisdiction; and
- 9. Whereas, on the basis of the investigation, the statements of witnesses recorded and other evidence collected, the Investigating Officer, has established a *prima facie* involvement of the below mentioned accused for the commission of offences punishable under Sections of the Unlawful Actvities (Prevention) Act, 1967, as shown against their names:

Mohammad Zameer Khanday, Mohammad Naseem Khanday, Mohammad Manzoor Bhatti and Mohammad Din Bhatti, for the commission of offences punishable under the relevant Sections of ULA(P) Act, as indicated against each accused at Para (9) above, arising out of FIR No. 144/2023 of Police Station, Uri.

and identified as Zakir Ahmad Wagay S/o Bashir Ahmad Wagay R/o Odura, Kulgam and Muheed Mashooq Bhat S/o Mashooq Ahmad Bhat R/o Khudwani, Kulgam. During their personal search, the Police recovered 21 AK Rounds and 01 Hand Grenade from thier possession respectively; and

- 2. Whereas, based on the above, a case FIR No. 109/2023 under Section 7/25 Arms Act, and Sections 13, 18, 20 and 39 of ULA (P) Act, was registered in the Police Station, D.H. Pora, and the investigation of the case was set into motion. Subsequently, during the investigation, the offence under Sections 23 and 38 of ULA(P) Act, were added in the case; and
- 3. Whereas, during the investigation, the site plan of the place of occurrence and the seizure memos were prepared and the statements of witnesses acquainted with the facts and circumstances of the case were recorded under the relevant provisions of law; and
- 4. Whereas, during the investigation, four other persons identified as Kamran Ayoub Pandith S/o Mohd Ayoub Pandith R/o Wanpora, Kulgam, Arif Ahmad Wani S/o Abdul Karim Wani, Jaleel Ahmad Dar S/o Abdul Ahad Dar residents of Nawbal, Batpora and Ather Yousuf Dar S/o Mohd Yousuf Dar R/o Dar Mohalla, Khudwani, Kulgam, were found involved in the case. Subsequently, the accused were also arrested and during the investigation, 02 Hand Grenades, 01 AK-47 Magazine and 41 AK Rounds, were recovered at their instances respectively; and
- 5. Whereas, during the investigation, it was found that the accused viz. Zakir Ahmad Wagay, Muheed Mashooq Bhat, Kamran Ayoub Pandith, Arif Ahmad Wani, Jaleel Ahmad Dar and Ather Yousuf Dar, were in contact with a terrorist of leT/TRF, banned outfit, namely, Yasir Bilal S/o Bilal Ahmad Bhat R/o Wanpoh, Kulgam, who on the directions of a Pakistani based terrorist namely, Firdous Ahmad Bhat S/o Abdul Salam Bhat R/o Thokerpora, Qaimoh A/P PoK, provided the recovered Hand Grenades and AK ammunition to the accused viz. Zakir Ahmad Wagay, Muheed Mashooq Bhat, Kamran Ayoub Pandith, Arif Ahmad Wani, Jaleel Ahmad Dar and Ather Yousuf Dar, in order to promote terrorist activities in the area; and
- 6. Whereas, during the investigation, it was established that the accused viz. Zakir Ahmad Wagay, Muheed Mashooq Bhat, Kamran

Ayoub Pandith, Arif Ahmad Wani, Jaleel Ahmad Dar and Ather Yousuf Dar, were working as Over Ground Workers (OGWs) for the terrorists of LeT/TRF, banned outfit, particularly the terrorists viz. Yasir Bilal and Firdous Ahmad Bhat, and were providing logistic support to them, besides, under a well knit criminal conspiracy procured Hand Grenades and AK ammunition from the terrorists viz. Yasir Bilal, for carrying out the terrorist activities in the area; and

- 7. Whereas, the accused terrorist viz. Yasir Bilal has been killed in an encounter with the Security Forces and the proceedings under the law would abate against him; and
- 8. Whereas, on the basis of the investigation, the statements of witnesses recorded and other evidence collected, the Investigating Officer, has established a *prima facie* involvement of the below mentioned accused for the commission of offences punishable under Sections of the Unlawful Actvities (Prevention) Act, 1967, as shown against their names:

## **Ex-parte Award**

This is to dispose an application filed by the petitioner applicant under section 15 of the P.W.Act, 1936 read with S-33-c (2) of the I. D. Act, 1947 claiming there that he was employed by respondent in her industrial unit located at Zainakote near SICOP Office, Srinagar w. e. f. September 2021, Respondent is manufacturing various kinds of the ISM products including the sanitary pads. The applicant has further sttated that he was working as a salesman and was marketing the products of the respondent's Industrial establishment. Initially his monthly salary/wages were fixed at Rs. 10.000/- P.M. but after putting hard work he gained the experience and confidence of his employer and his monthly wages were raised to Rs. 12000/-P. M. The respondent paid his salary initially for some months but thereafter did not pay his wages w. e. f. June, 2022 till September, 2022 and withheld his legal wages without any reason or justification. He further submitted that he approached his employer with request to pay his legitimate withheld dues but she did not take any step to liquidate the applicant balance and withheld wages with the result the applicant was left with no option but to resign from the job and employement of the respondent. With regard to his due wages, applicant had served a legal notice to the respondent/employer through his counsel Mr. Talib Hussain and Snober Azad Advocates dated 29-04-2023 and provided 15 days time to pay the withheld wages of the applicant, but still she did not bother about the legal notice and did not pay the wages of the applicant. After exhausting all his efforts to recover his lawful wages from his employer respondent, he approached this forum for recovering his pending wages from his employer/respondent and filed the instant application.

This court on receipt of the petition, issued notice to the respondent on her industrial unit address at Zainakote HMT, Srinagar through Registered Post but the respondent refused to accept and receive the notice as per delivery report dated 19-06-2023. Respondent did not bother to appear before this court either in person/representative,

In pursuance to the court order the applicant produced two witnesses namely, Danish Shafi Pandow 2. Suhail Ahamd besides applicant himself. The petitioner himself entered in the witness box and fully corroborated his petition. He has in his evidence affidavit stated that Initially he was paid Rs 10000/- monthly and he worked with zeal and dedication so the respondent increased his salary to Rs. 12000/-. However, subsequently the salary of the petitioner was not paid from June 2022 to September 2022. The respondent despite request did not pay his due salary forcing petitioner to give up his Job and avoided payment on one pretext or the other. An amount of Rs 48000/- is due to petitioner from respondent. He even served notice for clearing his dues but despite that the respondent did not discharge her liability so he approached the court. The petitioner to substantiate his claim has annexed copy of notice, photocopy of receipt of notice and photocopies of bank record which reveals that from time to time salary of Rs. 10000/= and Rs. 12000/- has been credited to his account.

Both the petitioners witnesses namely Danish Shafi Pandow 2. Suhail Ahamd in their statements on affidavit have deposed that they know the applicant as they are in the business occupation. The applicant was working as a salesman in the business establishment of the non-applicant since 2021 but he left the service and employment of the respondent employer w.e.f September, 2022 as his employer did not pay his monthly wages from June, 2022 till September, 2022 for unknown reasons that the applicant was being paid monthly wages of Rs. 10000/- which was later increased to Rs. 12000/- per month. As such the total amount of Rs. 48000/- four monthsø salary of the applicant are in arrears to be paid by the respondent along with the compensation and interest thereon.

The respondent on the other hand has not chosen to appear before this court and has instead refused to accept the notice which is part

The petitioner by adducing evidence on affidavits and documentary evidence on record has proved sufficiently that the claimed amount of Rs. 48000/- is due to him which the respondent failed to clear. On the other hand, silence to the notice and non-appearance of respondent in this petition proves that the claim of the petitioner is justified and She has nothing to object about it. Thus there is no reason to disallow the petition of the petitioner.

Accordingly, the petition in hand is allowed and Petitioner is held entitled to his unpaid salary of Rs. 48000/- from the month of June, 2022 to September, 2022. The amount due shall be paid to the petitioner by respondent within the period of two months failing which petitioner shall be entitled to interest @ 8% from the date it become due till realization.

This file is disposed off accordingly. Be consigned to records.
