5. Whereas, during the investigation, three more persons identified as Mohd Farooq S/o Mohd Latief caste Gujjar R/o village Guller, Rajnagar, Koteranka, Budhal, Mohd Nazir S/o Mohd Din caste Gujjar R/o Rajnagar,Koteranka,Budhal and Mohd Shabir S/o Mohd Latief caste Bakerwal R/oBehrooth,Koteranka, Budhal,were found involved in the case. Subsequently, the accused was arrested and during the investigation, 02 Hand Grenades, 01 Pistol, 02 Magazines and 28 Rounds were recovered at the instance of accused viz. Mohd Farooq and Mohd Nazir respectively, which were provided to them by the terrorist viz. Bilal; and

6. Whereas, during the investigation, it was found that the accused viz. Mohd Farooq, was in contact with the killed Pakistani based terrorist viz. Bilal, and was working for him in order to promote terrorist activities in the area; and

7. Whereas, during the investigation, it was found that the accused viz. Mohd Farooq, brought the said Pakistani based terrorist viz. Bilal, to his residential house and provided shelter to him. Later on the accused viz. Mohd Farooq handed over the said terrorist to the accused viz. Mohd Nazir, who also provided the shelter to the terrorist in his residential house for two nights. Subsequently, the accused viz. Mohd Nazir, handed over the terrorist viz. Bilal to the other accused viz. Mohd Shabir, for providing further shelter to the terrorist in his dhok at Behrooth; and

8. Whereas, during the investigation, it was established that the accused viz. Mohd Farooq, Mohd Nazir and Mohd Shabir, were working as Over Ground Workers (OGWs) for the terrorists particularly the killed Pakistani terrorist viz. Bilal, and were providing logistic support to him. Besides, under a well knit criminal conspiracy voluntarily harboued the said terrorist in their residential houses/dhok for carrying out the terrorist activities and to wage war against the Government of India. The accused viz. Mohd Farooq and Mohd Nazir, also procured arms/ammunition and Hand Grenades from the said terrorist for carrying out the terrorist activities in the area ; and

9. Whereas, the accused terrorist viz. Bilal has been killed in the said encounter and the proceedings under the law would abate against him; and

10. Whereas, the investigation, of the case shall continue in respect of unknown Pakistani handlers and their sympathizers and the Supplementary Charge Sheet against them would be filed in the Court of competent jurisdiction ; and

Srinagar, the 31stMay, 2024.

SO-320.ô In exercise of the powers conferred by Section 64 of the Wildlife Protection Act, 1972 (No.53 of 1972), the Government of Jammu and Kashmir hereby makes the following rules, namely :---

**1.** Short title, extent and commencement.—(1)These rules may be called the Jammu and Kashmir Wildlife (Protection) Rules, 2024.

(2) They shall extend to the whole of the Union Territory of Jammu and Kashmir.

(3) They shall come into force from the date of their publication in the official Gazette.

2. **Definitions.**—In these rules, unless the context otherwise requires ;

- a) õActö means the Wildlife Protection Act, 1972 (No. 53 of 1972);
- b) õ**Board**ö means Wildlife Board for Union Territory of Jammu and Kashmir;
- c) õ**Chairman**ö means the Chairman of the Wildlife Board for Union Territory of Jammu and Kashmir;
- d) õFormö means a form appended to these rules;
- e) õFeeö means amount chargeable from a permit holder;
- f) õ**Government**ö means the Government of Jammu and Kashmir;
- g) õNon-official memberö means member of Wildlife Board for Union Territory of J&K referred to in clauses (d) & (e) of Sub-Section (1) of Section 6 of the Act ;
- h) õ**Permit**ö means permission granted under the Act and Rulesmade thereunder;
- i) õSectionö means the Section of the Act;
- j) õScheduleö means a schedule to the Act; and
- k) All other words, expressions used herein but not defined in these rules shall have the same meaning as assigned to them under the Act.

3. **Terms of office**.—The term of office of a non-official member of the Board referred to in clauses (d) & (e) of Sub-Section (1) of Section 6 of the Act shall be two years from the date of his/her appointment.

4. **Resignation**.—(1)A non-official member of the Board may resign in writing under his hand addressed to the Chairman.

(2) The vacancy of the non-official member of the Board shall fall vacant from the date on which his resignation is accepted or on the expiry of thirty days from the date of receipt of intimation of resignation whichever is earlier.

(3) The power to accept the resignation of a member of the Board shall vest in the Chairman.

5. Filling of casual vacancies.—When a non-official member of the Board resigns or dies or is removed from office or becomes incapable of acting, the Government may, by notification, appoint a person to fill the vacancy.

6.**Removal from the Board.**—The Government may remove anynon-official member from the Board if he/she:ô

- a) is of unsound mind and stands so declared by a competentMedical Board ; or
- b) is an un-discharged insolvent ; or
- c) is convicted of a criminal offence involving moral turpitude ; or
- d) is held guilty by a Court of law for contravention of any of the provisions of the Act or the rules framed thereunder.

7. Allowances.—(1) The non-official member of the Board shall get travelling allowance and daily allowance as admissible to ClassIofficer(s) of the Union Territory for attending meeting of the Board.

(2) Non-official members of the board shall get sitting fee/honorarium for attending the meeting of the board at the rate as prescribed by the Government.

(3) The Secretary of the Board shall be the controlling authority in respect of payment of allowances under this rule.

8. **Quorum.**—The quorum for meeting of the Board shall not be less than 50% of the total members.

9. Entry in National Park, Sanctuary or Reserve Area.—(1) Every person desiring to enter a Sanctuary or National Park or Conservation reserve for purposes of photography/tourism/transaction

(2) A permit issued under Sub-Rule (1) shall be subject to payment of fee at the rate prescribed by the Government from time to time.

(3) Fee for entry of light vehicles in National Parks, Wildlife Sanctuaries and Conservation Reserves shall be charged at the rate as prescribed by the Government from time to time.

(4) The Departmental Officers and officials while performing their duties in the Wildlife Protected Areas shall be exempted from payment of entry fee.

10. **Cancellation of permit.**—The Chief Wildlife Warden or Incharge of the National Park or Sanctuary or the Conservation Reserve may, for good and sufficient reasons, to be recorded in writing, cancel any permit granted under these rules.

11. **Permission for making feature films.**—Permissions for making feature films, documentary films, Television Serial or Professional Photography in a National Park or Sanctuary or Conservation Reserve shall be granted by the Chief Wildlife Warden on payment of fee at the rate as prescribed by the Government from time to time.

12. **Power to exempt.**—Where it is considered necessary to expedient so to do in the public interest, the Chief Wildlife Warden may exempt any person (s) and/or vehicle (s) from the payment of the fee payable under these rules.

13. **Registration of certain persons in possession of arms.**—The registration of certain persons in possession of arms shall be as under :—

- a. For the registration of arms as provided in Section 34, the person possessing the arm shall apply to Wildlife Warden on Form II.
- b. The fee to be paid as per Sub-Section (1) of Section 34 shall be at the rate as prescribed by the Government.

c. The Wildlife Warden shall, on receipt of duly filled in Form-II along with fee, issue registration certificate on Form-III.

14. **Cognizance of offences.**—Besides the Chief Wildlife Warden, the following officers shall be authorized to make complaints under Section 55 within their respective jurisdictions;namely :—

- i. Conservator of Forests (Territorial);
- ii. Regional Wildlife Warden;
- iii. Divisional Forest Officer (Territorial);
- iv. Deputy Conservator of Forests;
- v. Wildlife Warden;
- vi. Assistant Conservator of Forests ;
- vii. Assistant Wildlife Warden;
- viii. Range Officer ;

15. **Repeal and Savings.**—(1) The Jammu and Kashmir Wildlife Protection Rules 1979, are hereby repealed.

(2) Notwithstanding such repeal, any action taken under the rules so repealed shall be deemed to have been taken under the corresponding provisions of these rules.
