# Jammu & Kashmir Government-Orders

HIGH COURT OF JAMMU & KASHMIR AND LADAKH (Exercising powers of Bar Council under Section 58 of the Advocates Act, 1961)

(Office of the Registrar General at Jammu)

Subject:—Judgment dated 10-04-2023 passed by Hon'ble Supreme Court in Writ Petition (Civil)No.82/2023 titled Ajay Shankar Srivastava Vs. Bar Council of India & Anr for implementation of Certificate and Place of Practice (Verification) Rules-2015. c/w Transferred Case (Civil) No. 126 of 2015 Titled Ajayinder Sangwan Vs. Bar Council of India and Ors.

#### Notification

No. 2807 RG/LP Dated 20-11-2024.

Whereas, the Bar Council of India, vide communication No. BCI: D: 1726/2024 dated 10-04-2024, has informed that the Hon'ble High Powered Committee constituted by the Hon'ble Supreme Court vide Judgment dated 10-04-2023 passed in Writ Petition (Civil) No. 82/2023 titled Ajay Shankar Srivastava Vs. Bar Council of India and Anr to monitor the process of verification of genuineness and validity of degrees/certificate of advocates enrolled with the State Bar Councils. The relevant portion of Judgment of the Hon'ble Supreme Court reads as under:—

- "3. In 2015, the Bar Council of India notified the Bar Council of India Certificate and Place of Practice (Verification) Rules 2015. The process of verification of certificates and place of practice commenced with efforts by the State Bar Councils and the Bar Council of India.
- 9. The above table indicates tltat a majority of advocates enrolled with the State Bar Councils

have not submitted their verification forms. The Bar Council of India apprehends that many advocates who have not submitted their forms for verification are persons who are not qualified or are "in possession of fake degrees". The Bar Council of India has submitted and, with justification, that this class of persons, without the possession of qualifications required for law practice, is known to enter upon the arena of courts for extraneous purposes, including the disruption of work. The Bar Council of India is justified in asserting that such persons have to be identified and weeded out from the list of advocates enrolled with the Bar Councils.

- *10.* The due verification of advocates who are enrolled with the State Bar Councils, is of utmost importance to preserve the integrity of the administration of justice. Persons who profess to be lawyers, but do not either have the educational qualifications or degree certificates on the basis of which they could have lawfully granted entry to the Bar, pose a grave danger to the administration of justice to citizens. Hence, it is the duty of every genuine advocate of the country to ensure that they cooperate with the Bar Council of India which is seeking to ensure that the certificates of practice are duly verified, together with the underlying educational degree certificates. Unless this exercise is carried out periodically, there is a danger that the administration of Justice would be under a serious cloud. The written submission which has been placed on the record by the Bar Council of India indicates that several such persons have been elected to State Bar Councils and some persons have thereafter occupied judicial office in the district judiciary as well".
- (i) Therefore, all those of advocates enrolled on J&K Bar Council, who have not submitted their verification forms in terms of Bar Council of India Certificate and Place of Practice (Verification) Rules, 2015, are

hereby directed to submit the same before the Principal District and Sessions Judge concerned and the Registrar Judicial, High Court Wing Jammu/Srinagar respectively along with requisite documents viz;two passport size photographs, self-attested copies of Enrolment Certificates, Matriculation/LL.B Degrees alongwith fee by way of valid Demand Draft of Rs.200(100+100 late fee) each in the name of Secretary, J&K Bar Council within 15 days from the date of issue of notice in the daily newspaper.

- (ii) All the concerned Advocates enrolled on the roll of J&K Bar Council, who have submitted their Verification Forms in terms of Bar Council of India Certificate and Place of Practice (Verification) Rules, 2015 and pursuant to the Notification No(s) 512 dated 21-07-2016, 571 dated 04-08-2016, 580 dated 07-09-2016,1990 dated 31-03-2018 and 1273 of 2023 dated 12-07-2023 of the Hon'ble High Court of Jammu and Kashmir and Ladakh are hereby directed to make up the deficiencies as per the Annexure "A" and submit the two photographs, the self-attested copies of Enrolment Certificates, Matriculation-(DOB) and LL.B Degree, if they have not submitted the same, along with their verification Forms, before the concerned Principal District and Sessions Judge and Registrar Judicial, High Court Wing Jammu/Srinagar respectively within a period of 15 days from the date of publication of this Notice in the news paper.
- (iii) The concerned Registrar Judicial's, High Court Wing, Jammu/Srinagar and Principal District and Session Judges shall receive only those verification forms that are complete in all respects under Certificate and Place of Practice(Verification) Rules, 2015 and forward the consolidated data as per Format in Excel Format on email address lpsection31@gmail.com
- (iv) The Registrar Judicials', High Court Wing Jammu/ Srinagar and all Principal District & Session Judges and the courts under their jurisdiction and the

Presiding Officers of the Tribunals shall ensure that only those of the advocates who possess the valid advocate license/Certificate of enrolment shall be allowed to practice in the concerned courts.

. APP present for UT. The file was taken up today for hearing. Perusal fof record reveals that accused is continuously absent in this case. The bail bonds of accused were forfeited on 18-04-2018. Vide Order dated 28-08-2024 non-bailable warrants were issued against accused No. 2, with the direction to tamili to remain present in case of non-execution. Since the NBW was received back unexecuted, statement of Tamili namely Mohd. Ashraf No. 1541/J P/S Nagrota was recorded who stated that the accused has absconded and there are no prospects of arresting him. The statement be made part of the file.

Upon perusal of the file and the staements of HC Mohd Ashraf, I am satisfied that the accused No. 2. Namely Zulfeker Ali S/o Lal Din R/o Lal House Tehsil Surankote District Poonch has absconded and there is no immediate prospect of arresting him. Under these circumstances, I deem it proper to proceed u/s 512 Cr. PC. against the accused. Concerned clerk is directed to issue warrants under Section 512 Cr. PC. against the accused. ### Notification

Srinagar, the 15th of May, 2024.

SO-288.—Whereas, on 12-10-2022, a credible information was recived by the Police Station, CIK/SIA, Srinagar, to the effect that OGWs of proscribed terrorist organization (s) operating within the J&K

with the active support of Pakistani based agencies, hostile to India, are involved in cross Loc smuggling of banned narcotics and drugs into J&K. The sale proceeds of such drugs are being used in order to promote terrorist activities, besides, one OGW namely Mst. Rubeena Nazir D/o Nazir Ahmad Malik R/o Panzipora, Tarzoo, Sopore, is responsible for having illegally brought up of a huge amount of banned narcotics from Pakistan and the sale proceeds of such drugs are used for the ongoing terrorist and secessionist campaign against the territorial integrity and security interests of the Union of India; and

- 2. Whereas based on the above, a Case FIR No. 19/2022 under Sections 8/21, 29 NDPS, 120-B,121,121-A IPC, and the Sections 13,17,18,39 & 40 of ULA (P) Act was registered in Police Station, CIK/SIA, Sringar and the investigation of the case was set into motion. Subsequently, during the investigation, the offences under Sections 8/21 NDPS, 120-B IPC and the Section 17 of ULA (P) Act were dropped and the offences under Sections 27-B NDPS, 201 IPC and Section 38 of ULA (P) Act were added in the case; and
- 3. Whereas, during the investigation, the accused lady viz. Mst. Rubeena Nazir, was arrested in the case and she alongwith one more person identified as Ishfaq Ahmad Mir S/o Mohammad Maqbool Mir R/o Mir Mohalla, Tarzoo, Sopore were found in contact with some LeT banned terrorists of Sopore area who had crossed the LoC and are presently operating from Pakistan through the virtual mode. Subsequently the accused viz. Ishfaq Ahmad Mir was also arrested in the case; and
- 4. Whereas, during the investigation, it was found that the accused lady viz. Mst. Rubeena Nazir, on the directions of accused viz. Ishfaq Ahmad Mir recived 47 kgs of narcotics from one Mudasir Ahmad Poswal S/o Nazir Ahmad Poswal R/o Amrohi, Tangdhar, Karnah through two persons identified as Safeer Ahmad Mughal S/o Abdul Rashid Mughal R/o Taad, Karnah and lftikhar Ahmad Sheikh S/o Abdul Lateef Sheikh R/o Amrohi Tangdhar, Karnah and delivered the same to other two persons namely Abdul Rashid Bhat S/o Ghulam Mohammad Bhat R/o Lakripore Padgampora and Abdul Rashid Mir S/o Mohammad Sultan Mir R/o Amargrah Sopore. During investigation the accused viz. Mudasir Ahmad Poswal was also arrested in the case; and

- 5. Whereas, during the investigation, it was found that the accused lady viz. Mst. Rubeena Nazir, transferred an amount of Rs. 20 Lacs and 72 thousand among the terrorists of LeT, JeM and HM banned outfit and their associates as well as their families which was generated from the proceeds of smuggled narcotics/sale of drugs. Subsequently during the investigation an amount of Rs. 199800/- were recovered at her instances; and
- 6. Whereas, during the investigation the accused viz. Safeer Ahmad Mughal alongwith two other persons identified as Mohammad Rashid Thakkar S/o Mohammad Younis Thakkar R/o Dara Barhoon Thannamandi, Rajouri and Mohammad Rayaz Lohar S/o Hakim-ud-Din R/o Khanyal Kote Thanamandi, Rajouri were found involved in the commission of crime. Subsequently the accused were arrested in the case and it was found that the accused viz. Safeer Ahmad Mughal was a driver by profession and on the directions of accused Lady viz. Mst. Rubeena Nazir, Ishfaq Ahmad Mir and Mudasir Ahmad Poswal was facilitating the terrorists for transportation of Narcotics from one place to another. The accused viz. Mohammad Rayaz Lohar on the directions of accused viz. Mohammad Rashid Thakkar, and one Javid Ahmad Thakkar @ Raja Thakkar credited an amount of Rs. 01 Lac in the account of Narcotics by the said accused; and
- 7. Whereas, during the investigation, it was established that the accused Lady viz. Mst. Rubeena Nazir, Ishfaq Ahmad Mir, Mudsir Ahmad Poswal, Safeer Ahmad Mughal, Mohammad Rashid Thakkar and Mohammad Rayaz Lohar were working as over ground Workers (OGWs) for the banned terrorist organizations and under a well knit criminal conspiracy were providing logistic support to them, besides were facilitating the transportation and selling of narcotics for the terrorists so that the money generated could be utilized to commit terrorist activities in Jammu and Kashmir and to wage war against the Government of India; and
- 8. Whereas, the Sanction in respect of accused Lady viz. Mst. Rubeena Nazir, Ishfaq Ahmad Mir, Mudsair Ahmad Poswal, Safeer Ahmad Mughal, Mohammad Rashid Thakkar and Mohammad Rayaz Lohar, has already been accorded by the Competent Authority vide Notification S.O. No. 287 dated 26th May, 2023 and Notification

- S.O. No. 436 dated 18th August, 2023, and the investigation, in respect of other accused was continued; and
- 9. Whereas during the further investigation, six other persons identified as Tariq Ahmad Malik @ Dilawar S/o Mohammad Ramzan, Mushtaq Ahmad Malik @ Rahee S/o Mohammad Yousf Malik residents of Panzipora, Sopore A/P Pakistan, Alif- ud-Din Badana S/o Ghulam-ud-Din Badana R/o Amrohi Karnah, Kupwara A/P Pakistan Mushtaq Ahmad Naik @ Usman Bhai S/o Ghulam Nabi Naik R/o Kundan Khari Ramban A/P Pakistan Firdous Ahmad Dar @ Umar Dar S/o Abdul Khaiq Dar R/o Harwan Sopore A/P Pakistan and Javid Iqbal Thakkar @ Raja Thakkar S/o Tasaduq Hussain Thakkar R/o Barhon Thannamandi, Rajouri were found involved in the commission of crime. Subsequently, during the investigation the accused viz. Javid Iqbal Thakkar @ Raja Thakkar, was arrested in the case; and
- 10. Whereas during the investigation, it was found that the accused viz. Tariq Ahmad Malik @ Dilawar, Mushtaq Ahmad Malik @ Rahee, Alif-ud-Din Badana, Mushtaq Ahmad Naik @ Usman Bhai and Firdous Ahmad Dar @ Umar Dar crossed the LoC and are presently operating from the Pakistan with the terrorist origination of LeT, a banned outfit and facilitated the delivery of narcotics from across the border in order to promote terrorist activities in the Jammu and Kashmir besides shared account numbers of the families of booked/arrested terrorists of the outfit with the accused lady viz.Mst. Rubeena Nazir for disbursement of terror fund in their accounts. The accused viz. javid Iqbal Thakkar @ Raja Thakkar, received terror fund of an amount of Rs.10 lac from the accused viz. Mohd Rashid Thakkar and disbursed the same among the other accused; and
- 11. Whereas during the investigation it was established that the accused viz. Tariq Ahmad Malik @ Dilawar, Mushtaq Ahmad Malik @ Rahee, Alif-ud-Din Bandana, Mushtaq Ahmad Naik @ Usman Bhai and Firdous Ahmad Dar @ Umar Dar, are members of LeT, a banned outfit and the accused viz. Mohd Rashid Thakkar was working as over Ground Worker (OGW) for the terrorists and was providing logistic support to them for carrying out the terrorist activities and to wage war against the Government of India; and

12. Whereas on the basis of investigation, statements of witnesses recoded and other evidence collected the investigation Officer has established *prima facie* involvement of below mentioned accused for the commission of offences punishable in terms of the provisions of Unlawful Activities (Prevention) Act, 1967 and Indian Penal Code, 1860 as shown against their name;-

- 13. Whereas, the accused viz.. Tariq Ahmad Malik @ Dilawar, Mushtaq Ahmad Malik @ Rahee, Alif-ud-Din Badana, Mushtaq Ahmad Naik @ Usman Bhai and Firdous Ahmad Dar @ Umar Dar, are absconding and proceeding under Section 299 Cr.PC have been proposed to be initiated against them; and
- 14. Whereas, the Authority appointed by the Government under Sub-Section (2) of Section 45 of the Unlawful Activities (Prevention)

Act, 1967 has independently examined the Case Diary File and all the other relevant documents relating to the case and has come to the conclusion that prima facie case is made out against the above accused; and

- 15. Whereas, after perusing the Case Diary File the relevant documents and also taking into consideration the views of the Authority appointed under Sub-Section (2) of Section 45 of the unlawful activities (Prevention) Act, 1967, the Government is of the view that there is sufficient material and evidence available against the above-mentioned accused for their prosecution under the provisions of law; and
- 16. Whereas, the Government has independently examined the Case Diary File and all the other relevant documents relating to the case and has come to the conclusion that a *prima facie* case is made out against the above accused under the aforementioned provision of the Indian Penal Code (IPC).

Now, therefore, in exercise of the powers conferred by Sub-Section (2) of Section 45 the Unlawful Activities (Prevention) Act, 1967 and Section 196 of the Code of Criminal Procedure, 1973 the Government hereby accord sanction for Launching prosecution against the accused viz.. Tariq Ahmad Malik @ Dilawar, Mushtaq Ahmad Malik @ Rahee, Alif-ud-Din Badana, Mushtaq Ahmad Naik @ Usman Bhai, Firdous Ahmad Dar @ Umar Dar and Javid Iqbal Thakkar @ Raja Thakkar, for the commission of offences punishable under the relevant Section as indicated against the each accused at Para (12) above, arising out of FIR No. 19/2022 of Police Station, CIK/SIA Srinagar.
