#### The Notification under Section 11(1) :—

The Notification under Section 11(1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and

and Resettlement Act, 2013 stands issued vide Notification No. 12 Rev of 2022 dated 14-05-2022 for inviting objections, if any, from the interested persons. The said notification stands published in Government Gazette and in two daily newspapers.

#### Hearing of Objections :-

During the stipulated period of 60 days no objection stands received by this Collectorate.

#### Declaration under Section 19:-

This appropriate Government /District Collector issued Notification under Section 19 of the Act, 2013 vide No. 03 of Rev/LA of 2022 dated 03-11-2022 endorsed under No. DCP/LA/2022/273-78 dated 03-11-2022 for the land measuring 07 Kanals 19 Marlas 7½ Sirsai in the instant acquisition case as per S.O. 17 dated 14-01-2022.

#### Notice under Section 21 :-

The Notice under Section 21 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Re-settlement Act, 2013 has been issued by this Collectorate vide No. DCP/Coll/2023/1077-84 dated 08-03-2023 to the interested/land owners to state the particulars of the land so needed and to state the nature of their respective interests in the land and the particulars of their claims to compensation for such interests, their claims to rehabilitation and resettlement along with their objections, if any, to the measurement made under Section 20 and to appear personally or by agent or advocate within a period of 30 days. During the stipulated time period no such objection was received by this Collectorate.

#### Market Value :-

The determination of the market value of the land is made on the date, on which notification under Section 11(1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Re-settlement Act, 2013 is issued/published.

#### <u>Issue of Multiplication Factor (MF)</u> :—

In exercise of powers conferred in Column No. 3 of Serial No. 2 of the first schedule read with Sub-Section (2) of Section 30 of the Right to Fair Compensation and Transparency in Land Acquisition. Rehabilitation and Resettlement Act, 2013 (30 of 2013), the Central

Government hereby notifies that in case of rural areas, the factor by which the market value is to be multiplied shall be 2.00 (Two).

The Government of J&K has issued notification vide No. Rev/LA-JK/254/2020 dated 26-08-2020 regarding multiplication factor of 2 (Two) in case of rural areas.

#### Determination of Market Value of Land by Collector:

As per the criteria provided under Section 26 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013, the Collector shall adopt the following criteria in assessing and determining the market value of the land namely :ô

- (a) The market value, if any, specified in the Indian Stamp Act 1899 (2 of 1899) for the registration of sale deeds or agreement to sell, as the case may be in the area where the land is situated or;
- (b) The average sale price for similar type of land situated in the nearest village or vicinity area or;
- (c) Consented amount of compensation as agreed upon under Sub-Section (2) of Section 2 in case of acquisition of lands for private companies or for public private partnership projects, whichever is higher;

The market value calculated as per Sub-Section (1) shall be multiplied by a factor to be specified in the first schedule.

It is further explained that the average sale price referred to in clause (b) shall be determined taking into account the sale deeds or the agreements to sell registered for similar type of area in the Village or vicinity area during immediate preceding three years of the year in which such acquisition of land is proposed to be made.

Further, while determining the market value under Section 26 and the average sale price, any price paid, as compensation for land acquired under the provisions of this Act on an earlier auction in the district shall not be taken into consideration. Further, while determining the

market value under Section 26 and the average sale price, any price paid, which in the opinion of the Collector is not indicative of actual prevailing market value may be discounted for the purpose of calculating market value. As per Section 26 (2) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 the Market value so calculated is to be multiplied by a factor to be specified in the First Schedule. Section 26 (3) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Re-settlement Act, 2013 is not applicable in this acquisition. Section 27 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 provides that having arrived at the market value, the Collector shall calculate the total amount of compensation to be paid to the land owners by including all assets attached to the land. Section 28 and 29 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 has provided for the parameters to be taken into consideration and determination of value of things attached to land or building, Section 29 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 further clarifies that for purpose of determining the value of things/assets attached to the land or building, trees and plants attached to the land, use the services of a competent Engineer or any other specialist or experienced persons in the field of Agriculture, Forestry, Horticulture, Sericulture, or any other field as may be considered necessary by him. Section 30 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 provides for award of solatium amount equivalent to one hundred percent (100%) of the compensation amount.

In addition to the market value of land assessed under Section 26 in every case, an amount calculated at the rate of twelve percent (12%) per annum on such market value is to be awarded for the period commencing on and from the date of publication of notification under Section 11(1) till the announcement of award or taking possession of land, whichever is earlier.

#### Determination of amount of Compensation :—

No. 3/J&K-HP/2024 (S).—WHEREAS, a number of electors of 1-Baramulla, 2-Srinagar and 3-Anantnag-Rajouri Parliamentary Constituency in the Kashmir Valley of Union Territory of Jammu and Kashmir had migrated because of compelling circumstances and have been temporarily residing in various places outside their place of ordinary residence; and

WHEREAS, the Election Commission of India, having regard to the right of franchise of such migrant electors, directed that these migrants

shall continue to be treated as "ordinarily residents" of their respective places for inclusion/retention of their names in the electoral roll of the concerned constituency despite their migration and as such their names were allowed to be incorporated in the electoral rolls summarily revised under the order of the Election Commission with reference to 01-01-2024 as the qualifying date;

Whereas, at the time of the elections to the State Legislative Assembly, 1996, a special scheme was devised under the then prevalent Jammu and Kashmir Representation of the People Act, 1957 and the Jammu and Kashmir Conduct of Elections Rules, 1965, which enabled these migrant voters to vote by postal ballot for their respective constituencies of their native places;

Whereas, the same facility to the above class of voters was extended at the time of the General Election to the House of People held in 1998 and 1999 by amending the Conduct of Election Rules, 1961 (Rules 27A to 27K);

Whereas, after taking into account several complaints about the delay transmission of the postal ballot in both ways by notified class of voters from different parts of the country, the Election Commission had decided during the General Election to the Legislative Assembly of J&K held in September-October, 2002 to provide these migrant voters their voting right, they should be enabled to vote in person at "special polling stations" set up outside the territorial limits of the constituency at Jammu, Udhampur and Delhi under Section 36A(1) of the then Jammu and Kashmir Representation of the People Act, 1957. Those of migrant voters who were not in a position to avail of this facility to vote in person at these special polling stations were given the option of exercising their right to vote by availing of the facility to vote by postal ballot as was done in the previous elections.

Whereas, the said scheme having worked very well, the facility was extended during general election to Legislative Assembly held in 2008, 2014 and General Election to the Lok Sabha held in 2004, 2009, 2014 and 2019;

Whereas, the Government of India vide notification dated 9<sup>th</sup> August, 2019 has abrogated Article 370 of the constitution and promulgated

The Jammu and Kashmir Reorganisation Act, 2019 and *inter alia* repealed the Jammu and Kashmir Representation of the People Act, 1957 and Union Territory of Jammu and Kashmir would go for elections the very first time since its inception.

NOW, THEREFORE, the Election Commission, in exercise of powers vested by Article 324 of the Constitution read with Section 25 of the Representation of the People Act, 1951, for the purpose of casting votes at the poll in the General Election to the House of the People of Union Territory of Jammu and Kashmir, to be held in 2024, in pursuance of the notifications to be issued by the President under Section 14 of the Representation of the People Act, 1951, directs continuation of the said scheme and accordingly hereby specifies the aforesaid migrant electors enrolled in any of the Parliamentary Constituencies of 1-Baramulla, 2-Srinagar and 3-Anantnag-Rajouri, who are residing outside their place of ordinary residence, but other than those who have been notified under clause (c) of Section 60 the Representation of the People Act, 1951 to vote by postal ballot, as the class of persons for whom special polling stations shall be provided outside the territorial limits of the Parliamentary Constituencies mentioned above.

### **ORDER**

1. Whereas, Section 61 of the Representation of the People Act, 1951 provides that with a view to preventing personation of electors, so as to make the right of genuine electors to vote under section 62 of that Act more effective, provisions may be made by rules under that Act for use of Electors Photo Identity Card for electors as the means of establishing their identity at the time of polling; and

- 2. Whereas, Rule 28 of the Registration of Electors Rules, 1960, empowers the Election Commission to direct, with a view to preventing personation of electors and facilitating their identification at the time of poll, issue of Electors Photo Identity Card to electors bearing their photographs at State cost; and
- 3. Whereas, Rules 49H (3) and 49K (2) (b) of the Conduct of Elections Rules, 1961, stipulate that where the electors of a constituency have been supplied with Electors' Photo Identity Card under the said provisions of Rule 28 of the Registration of Electors Rules, 1960, the electors shall produce their Elector Photo Identity Card at the polling station and failure or refusal on their part to produce those Elector Photo Identity Card may result in the denial of permission to vote; and
- 4. Whereas, a combined and harmonious reading of the aforesaid provisions of the said Act and the Rules, makes it clear that although the right to vote arises by the existence of the name in the electoral roll, it is also dependent upon the use of the Elector Photo Identity Card, where provided by the Election Commission at State cost, as the means of establishing their identity at the time of polling and that both are to be used together; and
- 5. Whereas, the Election Commission made an Order on the 28th August, 1993, directing the Issue of Electors' Photo Identity Card (EPIC) to all electors, according to a time bound programme; and
- 6. Whereas, Electors' Photo Identity Card have been issued to approximate 100% electors in the country.
- 7. Now therefore, after taking into account all relevant factors and the legal and factual position, the Election Commission hereby directs that for the current General Election to the Lok Sabha and Legislative Assemblies of Andhra Pradesh, Arunachal Pradesh, Odisha and Sikkim, 2024 and Bye-elections to 26 Assembly Constituencies in 13 States (as per Annexure-I) to be notified on 20-03-2024, 28-03-2024, 12-04-2024, 18-04-2024, 26-04-2024, 29-04-2024, 07-05-2024. All electors who have been issued EPIC are expected to produce the EPIC for their identification at the polling stations before casting

- (i) Aadhaar Card,
- (ii) MNREGA Job Card,
- (iii) Passbooks with photograph issued by Bank/Post Office,
- (iv) Health Insurance Smart Card issued under the scheme of Ministry of Labour,
- (v) Driving License,
- (vi) PAN Card,
- (vii) Smart Card issued by RGI under NPR,
- (viii) Indian Passport,
- (ix) Pension document with photograph,
- (x) Service Identity Cards with photograph issued to employees by Central/State Govt./PSUs/Public Limited Companies,
- (xi) Official identity cards issued to MPs/MLAs/MLCs, and
- (xii) Unique Disability ID (UDID) Card, M/o Social Justice and Empowerment, Government of India.
- 8. In the case of EPIC, clerical errors, spelling mistakes, etc. should be ignored provided the identity of the elector can be established by the EPIC. If an elector produces an EPIC which has been issued by the Electoral Registration Officer of another Assembly Constituency, such EPIC shall also be accepted for identification provided that the name of that elector finds place in the electoral roll pertaining to the polling station where the elector has turned up for voting. If it is not possible to establish the identity of the elector on account of mismatch of photograph, etc., the elector shall have to produce one of the alternative photo documents mentioned in Para 7 above.
- 9. Notwithstanding anything in Para 7 above, overseas electors who are registered in the electoral roll under Section 20A of the Representation

- 5. निर्वाचन आयोग, एतद्द्वारा भारत इलेक्ट्रॉनिक्स लिमिटेड, बंगलोर तथा इलेक्ट्रॉनिक्स कार्पोरेशन ऑफ इण्डिया लिमिटेड, हैदराबाद द्वारा यथा—विकसित इलेक्ट्रॉनिक वोटिंग मशीनों और वीवीपैट प्रिंटरों, जिन्हें सभी निर्वाचन क्षेत्रों में मत डालने और अभिलिखित करने के लिए उक्त मशीनों से जोडा जाएगा, के डिजाइन को भी अनुमोदित करता है।
