GOVERNMENT OF JAMMU AND KASHMIR CIVIL SECRETARIAT—DEPARTMENT OF LAW, JUSTICE AND PARLIAMENTARY AFFAIRS, JAMMU/SRINAGAR. (Legislation Section)

Subject :—Establishment of a Dedicated Backward Classes Commission for facilitating reservations to OBCs in Local Bodies.

Reference :—Administrative Council Decision No. 59/05/2024 dated 07-06-2024.

> Government Order No. 10622-JK(LD) of 2024 Dated 11-06-2024.

The Government of Jammu and Kashmir, in pursuance of the directions passed by the Hon'ble Supreme Court in K. Krishnamurthy v/s. Union of India. 2010 (7) SCC 202, and Vikas Krishna Rao Gawli v/s. State

of Maharashtra, AIR ONLINE 2021 SC 125, hereby constitutes a dedicated Commission to conduct contemporaneous rigorous empirical inquiry into the nature and implications of the backwardness qua local bodies with respect to the backward class of citizens in all local bodies within the Union Territory of Jammu and Kashmir, and to study the nature and effects of backwardness and to provide its recommendations :—

1. Name, extent and commencement :

- 1.1 This Commission shall be known as "Jammu and Kashmir Local Bodies Dedicated Backward Classes Commission" (hereinafter referred to as Commission).
- 1.2 The term of Commission will be forty-five (45) days from the date of publication of this Order.

2. Functions of the Commission :

The Commission, after studying on the following subject, shall submit its suggestions and recommendations to the Government of Jammu and Kashmir.

> 2.1 On the reference of the Government, empirical study and investigation in the context of the representation of backward classes in all Local Bodies before the upcoming general elections of the Local Bodies in the Union Territory and submitting its recommendations to the Government regarding proportional reservation for backward classes, Local Body-wise (Urban & Rural).

3. Terms of Reference :

- 3.1 The Commission shall conduct the contemporaneous rigorous empirical inquiry into nature and implications of the backwardness qua local bodies in the Union Territory of Jammu and Kashmir.
- 3.2 The Commission shall, on the basis of available records, reports, surveys, and other data, ascertain the proportion of population of backward class of citizens in the total population, local body-wise in order to study in light of instructions given by Hon'ble Supreme Court and to submit the report and recommendations to the Government.
- 3.3 The Commission shall submit its report to the Government within such period which may be prescribed by the Government.

- 3.4.1 take the assistance from Central and Union Territory Government Offices, various organizations, institutions or individuals for obtaining such information to its satisfaction as it may consider necessary or relevant for its purpose, in such form and manner as they may think appropriate ;
- 3.4.2 avail advices and researchers by holding meetings with them and also get assistance of recognized research institutions as and when necessary for analysis of the empirical data and also for the efficient and effective functioning of the Commission; and
- 3.4.3 arrange visits to various Local Bodies areas in the Union Territory of Jammu and Kashmir to achieve the above objectives.

4. Constitution of the Commission :

- - (a) The Commission shall comprise of three members to be appointed by the Government, from amongst such persons who may have the knowledge on the matters related to backward classes;
 - (b) Amongst the above members, one member shall be the Retired Judge of Hon'ble High Court, who shall be Chairman of the Commission.
- 5. Tenure of the Chairman and Members of the Commission :
 - 5.1 The tenure of the Chairman and Members of the Commission will be co-terminus with the term of the Commission.
- 6. Honorarium and other facilities payable to the Chairman/ Members of the Commission :

The salary and allowances payable to the Chairman and Members of the Commission and other terms and conditions shall be such as may be prescribed by the Guvernment.

7. Appointments in the Commission :

7.1 The services on the post of Secretary, Deputy Secretary, Research Officer, Review Officer, Office Assistants and other employees may be taken on deputation from other departments or may be made available by the Administrative Department. Wherever necessary services of retired officers and employees can be availed by appointment on contract as per the instructions of the Government.

- 7.2 Salaries, allowances payable and other service conditions of the officers/employees of the Commission shall be as per their parent department.
- 7.3 The Commission may take the services of experts as per the requirement for the discharge of its work and responsibilities.

8. Meetings of the Commission :

The headquarters of the Commission will be in Srinagar/ Jammu. The Commission shall hold meetings at such places, time and periods as the Chairman may deem fit.

9. Accounts and Audit :

- 9.1 The Commission shall maintain proper accounts and other relevant records and prepare statement of accounts in such form and manner as may be prescribed by the Government for this purpose.
- 9.2 The accounts of the Commission shall be audited by Directorate of Audit & Inspections at such intervals as may be prescribed.

10. Reports/Recommendations :

Reports/Recommendations of the Commission shall be presented to the Government by the Commission in relation to its objective and work. It will contain complete details of its activities, recommendations and works.

11. Administrative Arrangement and Budget :

The administrative arrangements and budget to the Commission shall be provided by the Administrative Department.

12. Chairperson, members and employees of the Commission to be public servants :

The Chairperson members and employees of the Commission shall be deemed to be public servants under section 21 of the Indian Penal Code, 1860.

13. Administrative Department :

Rural Development Department shall be Administrative Department for the Commission.

14. Amendments/Additions :

The Government may make any amendments, changes or extension in this order from time to time.

SO6576.ô Whereas, the use of Aadhaar as an identity document for delivery of services or benefits or subsidies simplifies the Government delivery processes, brings in transparency and efficiency, and enables beneficiaries to get their entitlements directly in a convenient and seamless manner by obviating the need to produce multiple documents to prove one¢s identity ; and

Whereas, the J&K Building and other Construction Workers Welfare Board is administering the Welfare Schemes to provide financial assistance, which is being implemented through Labour Department, J&K at the UT level ; and

Whereas, under the Scheme, education assistance, marriage assistance, death cum-funeral assistance, medical assistance (for injury/temporary disability/permanent disability/chronic disease/maternity) is given to the registered building and other construction workers by the Implementing Agency as per the extant Scheme guidelines ; and

Whereas, the aforesaid Scheme involves recurring expenditure incurred from the Cess Fund collected from Building and other Constructions.

Now, therefore, in pursuance of Section 7 of Aadhaar (Targeted Delivery of Financial and Other Subsidies, Benefits and Services) Act, 2016 (18 of 2016) (hereinafter referred to as the said Act) read with Section 142 of the Code on Social Security 2020, the Government of Jammu and Kashmir hereby notifies the following, namely :ô

1. (1) An individual eligible for receiving the benefits under the scheme shall hereby be required to furnish proof of possession of the Aadhaar Number or undergo Aadhaar authentication.

(2) Any individual desirous of availing benefits under the Scheme, who does not possess the Aadhaar Number or, has not yet enrolled for Aadhaar, shall be required to make application for Aadhaar enrollment before registering for the Scheme provided that he is entitled to obtain Aadhaar as per Section 3 of the Said Act, and such individuals shall visit any Aadhaar enrollment centre (list available at the Unique Identification Authority of India (UIDAI) websitewww.uidai. gov.in) to get enrolled for Aadhaar.

(3) As per Regulation 12 of the Aadhaar (Enrolment and Update) Regulations, 2016, the Department through its Implementing Agency, is required to offer Aadhaar enrollment facilities for the beneficiaries who are not yet enrolled for Aadhaar and in case there is no Aadhaar enrollment centre located in the respective Block or Tehsil, the Department through its implementing Agency shall provide Aadhaar enrollment facilities at convenient locations In coordination with the existing Registrars of UIDAI or by becoming a UIDAI Registrar themselves :

Provided that till such time Aadhaar is assigned to the individual benefits under the scheme shall be given to such individual, subject to the production of the following documents, namely :ô

- (a) if he/she has enrolled, his/her Aadhaar Enrollment Identification slip; and
- (b) any one of the following documents, namely :ô
 - (i) Bank or Post Office Passbook with photo ; or
 - (ii) Permanent Account Number (PAN) Card ; or
 - (iii) Passport ; or
 - (iv) Ration Card ; or
 - (v) Voter Identity Card ; or
 - (vi) MGNREGA Card ; or
 - (vii) Kissan Photo Passbook ; or
 - (viii) Driving license issued by the Licensing Authority under the Motor Vehicles Act, 1988 (59 of 1988); or
 - (ix) Certificate of identity having photo of such person issued by a Gazetted Officer or a Tehsildar on an official letter head ; or
 - (x) any other documents as specified by the Department. Provided further that the above documents may be checked by an officer specifically designated by the Department for that purpose.

2. In order to provide benefits to the beneficiaries under the Scheme and to the maximum number of them, the Department through its Implementing Agency shall ensure wide publicity of the same through the media to make them aware of the said requirement.

3. In all cases, where Aadhaar authentication fails due to poor biometrics of the Beneficiaries or due to any other reason, the following remedial mechanisms shall be adopted namely :ô

> (a) In case of poor fingerprint quality, iris scan or face authentication facility shall be adopted for authentication, thereby the department through its Implementing Agency shall make provisions for iris scanners or face authentication along with finger-print authentication for delivery of benefits in seamless manner ;

- (b) In case the bio metric authentication through finger prints or iris scan or face authentication is not successful, wherever feasible and admissible authentication by Aadhaar one Time Password or Time-based One-Time Password (OTP) with limited time validity, as the case may be shall be offered ;
- (c) In all other cases where bio metric or Aadhaar One Time Password or Time-based One-Time Password authentication is not possible, benefits under the Scheme may be given on the basis of physical Aadhaar letter whose authenticity can be verified through the Quick Response (QR) code printed on the Aadhaar letter and the necessary arrangement of QR code reader shall be provided at the convenient locations by the Department through its Implementing Agency.

4. The exceptional cases of authentication not covered in Rule 1 and 2 hereinabove, shall be disposed by following mechanism in conformity with the Act and regulations issued thereunder.

Whereas, based on the above a case FIR No. 109/2023 under Sections 307 IPC, 3/4 ESA Act, and the Sections 16, 18, 19, 20, 23, 38 and 39 of ULA(P) Act, was registered in the Police Station, Kokernag, and the investigation, of case was set into motion. Subsequently, during the investigation, the offences under Section 7/25 Arms Act, was added in the case ; and

3. Whereas, during the course of investigation, the site plan of the place of occurrence and the seizure memos were prepared and the statements of witnesses acquainted with the facts and circumstances of the case were recorded under the relevant provisions of law; and

4. Whereas, during the investigation, the accused house owner, viz. Reyaz Ahmad Bhat, was arrested in the case and during the investigation, four more persons identified as Ishfaq Ahmad Rather S/o Mohd Iqbal Rather R/o Rather Pora Gadoole, Mudasir Ahmad Bhat S/o Gh. Nabi Bhat R/o Bhatpora Gadoole, Mohd Ubaid Dar S/o Ab. Rashid Dar R/o Darpora, Gadoole and Basit Ahmad Rather S/o Gh. Hassan Rather R/o Ratherpora, Gadoole, were found involved in the case. Subsequently, the accused were also arrested and during the investigation, 40 AK-47 Ronds were recovered at their instance ; and

5. Whereas, during the investigation, it was found that the accused viz. Reyaz Ahmad Bhat, Ishfaq Ahmad Rather, Mudasir Ahmad Bhat, Mohd Ubaid Dar and Basit Ahmad Rather, were in contact with the terrorist viz.Uzair Ahmad Khan, who provided the recovered ammunition to them in order to promote terrorist activities in the area ; and

6. Whereas, during the investigation, it was established that the accused viz. Revaz Ahmad Bhat Ishfaq Ahmad Rather, Mudasir Ahmad Bhat, Mohd Ubaid Dar and Basit Ahmad Rather were working as Over Ground Workers (OGWs) for the terrorists of LeT a banned outfit particularly the terrorist viz. Uzair Ahmad Khan, and were providing logistic support to him, besides under a well knit criminal conspiracy procured ammunition from the said terrorist and on date of occurrence the accused viz. Reyaz Ahmad Bhat, voluntarily harboured the said terrorist in his residential house for carrying out the terrorist activities in the area ; and

7. Whereas, the accused terrorist viz. Uzair Ahmd Khan, has been killed in an encounter with the secuirty Forces and the proceedings under the law Would abate against him ; and
